Defendants file motion

EDITOR'S NOTE: In an earlier report concerning the trial of former Noblesville basketball coach Dave McCollough against Noblesville Schools and principal Jeff Bryant, the Hamilton County Reporter published a memorandum filed by McCollough following the defendants motion for summary judgment to have the case dismissed.

The defendants then filed a response to McCollough's memorandum, which the Hamilton County Reporter published.

Parts of the memorandum and parts of the response were published in editions of the Hamilton County Reporter. All of the memorandum and the response were printed on the Hamilton County Reporter's web site.

Tuesday afternoon, Noblesville Schools and principal Jeff Bryant released a reply brief in support of the defendants' motion for summary judgment.

Parts of the motion follows. All of the motion appears on the Hamilton County Reporter's web page.

REPLY BRIEF IN SUPPORT OF DEFENDANTS' MOTION FOR SUMMARY JUDGMENT

Sheridan School Board to meet Nov. 10...

Baseball coach could be let go

It's the height of football season, and yet baseball was the talk of Sheridan Tuesday.

Reports surfaced that Matt Britt will soon be out as head baseball coach of the Blackhawks. Britt has been a longtime coach for Sheridan, and led the 'Hawks to a Hoosier Heartland Conference championship.

"Out of respect for anyone involved I am not at liberty to speak on the matter especially since it relates to personnel," said David Mundy, superintendent of Sheridan Schools.

When contacted by the Reporter, Britt said that he is still the baseball coach as of now, but knows about the situation.

"I have been made aware of the fact the school board may vote me out at the Nov. 10th school board meeting," said Britt. "My current situation is rallying community support and getting as many people to the board meeting as possible."

Britt does have support: Signs have popped up in Sheridan imploring the board to "retain Matt Britt" as baseball coach. In addition, Britt's supporters are planning a petition signing from noon to 4 p.m. Sunday, Nov. 1 at Biddle Park.

CanStruction delivers cans of fun and fills pantries

As part of October's First Friday event, Noblesville Main Street presented 2015 Noblesville CanStruction, a unique contest and exhibition showcasing colossal structures made entirely out of full cans and boxes of food. The structures were designed and built by teams of architects, contractors, designers, service organizations and clubs. The art exhibitions were on display to the public until October 11, when all food was delivered to Noblesville Trustee's Office for distribution to local food pantries. Through this single project in the last three years, Noblesville Main Street has donated 14,000 non-perishable food items to Hamilton county food pantries.

"Thanks go to our partnership with Kroger and our generous sponsors and contributors who joined with Noblesville Main Street to make this event even more successful than the first two years," said Chris Owens, executive director. continued employment when the employment relationship expires on its own unambiguous written terms.

In his response, McCollough offers no meaningful rebuttal to these points, let alone an explanation of why they should not apply in this case. Instead, McCollough focuses a substantial amount of his response on "facts" that are either immaterial, unsupported by designated evidence, or (ironically) helpful to Defendants' arguments. McCollough's response to our legal arguments is also deficient - in some instances he fails to address arguments we made.

For reasons explained in much more detail below, the Defendants have affirmatively negated every aspect of McCollough's claims. Accordingly, the Court should grant summary judgment in favor of the Defendants.

Argument

The "Facts" section of McCollough's brief is replete with assertions that disregard the standard of review, as well as other deficiencies. The following addresses those deficiencies in great length, as well as parts of McCollough's designated evidence that should be struck. *See infra*, at 2-19.

Once those deficiencies are corrected and the undisputed material facts are provided under the appropriate legal standard, we explain why each of McCollough's legal claims warrants summary judgment in Defendants' favor.

I. The "Facts" Section of McCollough's Brief is Replete with Errors.

McCollough presents seventeen pages of "facts" in his brief. They fall into three categories.

- (1) assertions that are immaterial;
- (2) assertions unsupported by the designated evidence (or which fail to consider undisputed designated evidence); and
- (3) assertions that (ironically) support the Defendants' summary judgment arguments.

We note which assertions fall under which category in the information that follows.

Consistent with this review, it bears repeating that summary judgment requires the reviewing court to consider only those undisputed fact that are material; that is, those facts that affect the outcome of the case. *Williams v. Tharp*, 914 N.E.2d 756, 761 (Ind. 2009). As a corollary to this rule, the reviewing court need only draw *reasonable inferences* from the designated evidence, not speculation or other unreasonable forms of inferential reasoning. *Beatty v. LaFountaine*, 896 N.E. 2d 16, 20 (Ind. Ct. App. 2008).

The "Facts" section of McCollough's brief departs from these standards on numerous occasions, as discussed immediately below.

McCollough's summary of his coaching career on [page 1](#) is not material to the issues raised in the Defendants' summary judgment motion.

On [page 2](#), McCollough asserts Principal Jeff Bryant notified him on January 29, 2014, that a student accused him of throwing a basketball like a baseball in anger and intentionally striking the player in the head with a ball. McCollough asserts he denied the allegation and reported "he had never thrown a ball at a player in anger in any practice and never hit a player in the head with a ball." This is very careful wording: it denies an allegation which is not the one on which the Defendants acted and ignores the following undisputed evidence:

• Bryant watched the video of the practice on January 29, 2014, which showed that after Xxxxxx Xxxxxx threw the ball to McCollough, McCollough instantaneously threw the ball back at Xxxxxx. (Bryant Depo, 137:2-138:3.)

• Xxxxxx explained the situation to Bryant by describing it as he did in his deposition: McCollough caught the ball and then threw it back to Xxxxxx in the manager of a chest pass, with force. (Xxxxxx Depo. 17:10-14.) McCollough's pass was in the direction of Xxxxxx's face and was thrown from 10 feet away. (Xxxxxx Depo. 18:7-13.) Xxxxxx blocked the throw with his right hand to prevent the ball from hitting his face. (Xxxxxx Depo. 17:14-18:8.) Xxxxxx characterized this movement as reflex. (Xxxxxx Depo, 95:5-9.) After the ball hit Xxxxxx's right hand, it then skimmed off the side of his face. (Xxxxxx Depo. 95:10-12.) Xxxxxx did not catch the ball, but could only block it with his hand because he did not have time to react, as the ball was coming too fast. (Xxxxxx Depo. 18:7-11) Xxxxxx testified he told Bryant, "exactly what I told you [McCollough's counsel]." (Xxxxxx Depo. 46:24-25.)

• Bryant met with McCollough to discuss the incident and McCollough agreed that during a drill, he threw a ball at a student in anger, which hit the student, that his conduct was below the standard expected of Noblesville teachers, and coaches, and that the incident negatively impacted his relationship. (Bryant Depo. Ex. 1 (Noblesville Schools' Interrogatory Response) at 5-6.)

• Later that day, McCollough apologized to Xxxxxx for throwing the ball at him. (Bryant Depo. 142:16-17.)

• On January 31, 2014, McCollough and Bryant watched the video of the practice and Bryant asked McCollough to explain why the ball McCollough threw stopped once it reached the student. McCollough did not respond. (Bryant Depo. Ex. 1 (Noblesville Schools' Interrogatory Responses) at 6.)

• McCollough asked for and was given the opportunity to later provide his own written version. In that statement, which he provided the school on February 18, 2014, he "openly" admitted he threw a ball back towards a player out of frustration. (Defendants' Designated Evidence ("DE") Ex. G.)

• The Defendants did not suspend McCollough on an allegation he threw a basketball in the manner of a baseball and hit a player in the face. The suspension letter states that the allegation "was that on January 28, 2014, at basketball practice, in a state of anger, you threw a basketball at a student athlete and hit him with the ball." (Defendants' DE Ex. F.) The memo McCollough signed does not state McCollough made a "baseball throw" or that the ball hit the student in the face. (Defendants' DE Ex. D.) Bryant did not conclude that the ball hit the player in the head, his findings merely reflected that the ball hit the player, not that it hit him in the head. (Bryant Depo. 222:21-25; 308:12-20).

• The Defendants' rationale for suspending McCollough was *not* even that the ball *hit* the student. Bryant testified:

I had a coach who admitted to me that he threw the ball at a player out of frustration. I had a victim who also said that the ball was thrown to him after - the ball was thrown at him, so the coach admitted that. This is the important part of that, is that we had a coach who decided to respond to something, and out of frustration, and that's the word he used, and we talked about anger, we talked about frustration, that he decided to throw the ball. That is below any sort of minimal expectations of our teachers and coaches, and it's important that Dave McCollough admitted to that. So I could have continued to ask players if Dave McCollough threw the ball. I could have continued to do that. (Bryant Depo. 306:17 - 307:6); *see also* McCaffrey Depo. 127:10-17 (assistant principal's testimony that his recommendation to Bryant after the incident to immediately terminate McCollough's employment as coach would not have changed even if the ball did not hit student at all).

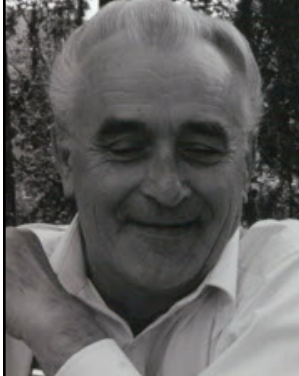

Information meeting for potential Reserve Division Deputies

The Hamilton County Sheriff's Office will be hosting an Open House informational meeting on Wednesday, October 21 at 6:30 p.m. at the Sheriff's Office for area residents interested in becoming a Sheriff Reserve Deputy. The Reserve Division is a group of unpaid volunteers empowered to assist full-time Sheriff's Office staff with upholding the law and preserving peace. The Sheriff's Office seeks qualified individuals who meet the high standards required to become part of one of the finest law enforcement agencies in Indiana and who are committed to serving the residents of Hamilton County. Re-

serves come from a variety of backgrounds and experiences as they enter a second career in the field of law enforcement. The Reserve Division consists of two distinct classifications. Road Qualified Reserves perform patrol duties, similar to Merit Deputies, in addition to special details and other assignments. These Reserves are expected to work a minimum of 24 hours each month, mostly supplementing the Patrol Division, in addition to regular training. Auxiliary Reserves also work a minimum of 24 hours each month on special details such as court services,

charity events, inmate security, and special assignments as well as supplementing Sheriff's Office staff. Reserve Deputies work alongside full-time staff in almost every aspect of the Sheriff's Office. Both Road Qualified and Auxiliary Reserves must attend a Reserve Academy sponsored by the Sheriff's Office. The academy will run from January through September 2016, meeting on evenings and weekends at the Sheriff's Office in Noblesville. Road Qualified Reserves will then complete a field training experience under the guidance of merit personnel. All Reserve Deputies must meet the same

- annual training standards as full-time deputies after completing their initial training.
- Minimum qualifications for Reserve Deputies are:
1. US Citizen or US citizenship by time of appointment
 2. Valid Driver's License with no more than six (6) active points
 3. No felony convictions or domestic violence convictions
 4. Legal ability to possess a firearm
 5. High School or equivalency diploma
 6. Ability to read and write English
 7. No Operating While Intoxicated convictions in last five (5) years
 8. No dishonorable or undesirable discharge from military
 9. No illegal drug use in last three (3) years
 10. Pass all portions of the selection process, including a background check, physical fitness assessment, medical, psychological, and drug screening, and multiple written and practical exams during the Reserve Academy
 11. Reside in Hamilton County or one of the adjacent counties
 12. Must be at least 21 years of age (no upper age limit)

South Putnam is Sheridan's 1st foe

'Hawks ground game smoking

Sheridan will open its post-season 1A tourney Friday at home against South Putnam.

The good news in that is South Putnam hasn't beaten a Class 1A football team so far this season. The not so good news, maybe, is that South Putnam hasn't played a Class 1 football team so far this season.

South Putnam's first foe in Class 1A will be Coach Bud Wright's Blackhawks Friday at Bud Wright Stadium in Sheridan.

The Eagles are 6-3. Their three losses have come to 2A North Putnam 26-18, 3A Sullivan 42-34 and 4A Northview 59-0. South Putnam has defeated 2A Cloverdale 40-6, 3A Brown County 48-0, 2A South Vermillion 47-20, 3A Greencastle 40-14, 3A West Vigo 22-16 and 2A Cascade 35-21.

Sheridan is 3-6. The Blackhawks have knocked off 1A Clinton Central 26-12, 2A Eastern 50-21 and 2A Taylor 42-41.

The Blackhawks are coming off a 32-19 loss to 1A Clinton Prairie in a game which begs for an explanation.

Sheridan had 65 running plays against the Gophers and gained 394 yards in the process.

In that game, quarterback Jake Chesney carried 32 times for 154 yards;

Kenny Burnell 12 times for 113 yards and K.J Acevedo 14 times for 111 yards.

"It's the first time I've had three players carry for over 100 yards and lost," said Wright, who is in his 51st season as a head coach.

"We allowed Clinton Prairie too many big plays," said the coach.

Prairie had only 42 plays on offense. Twenty-five were rushes and 17 were passes.

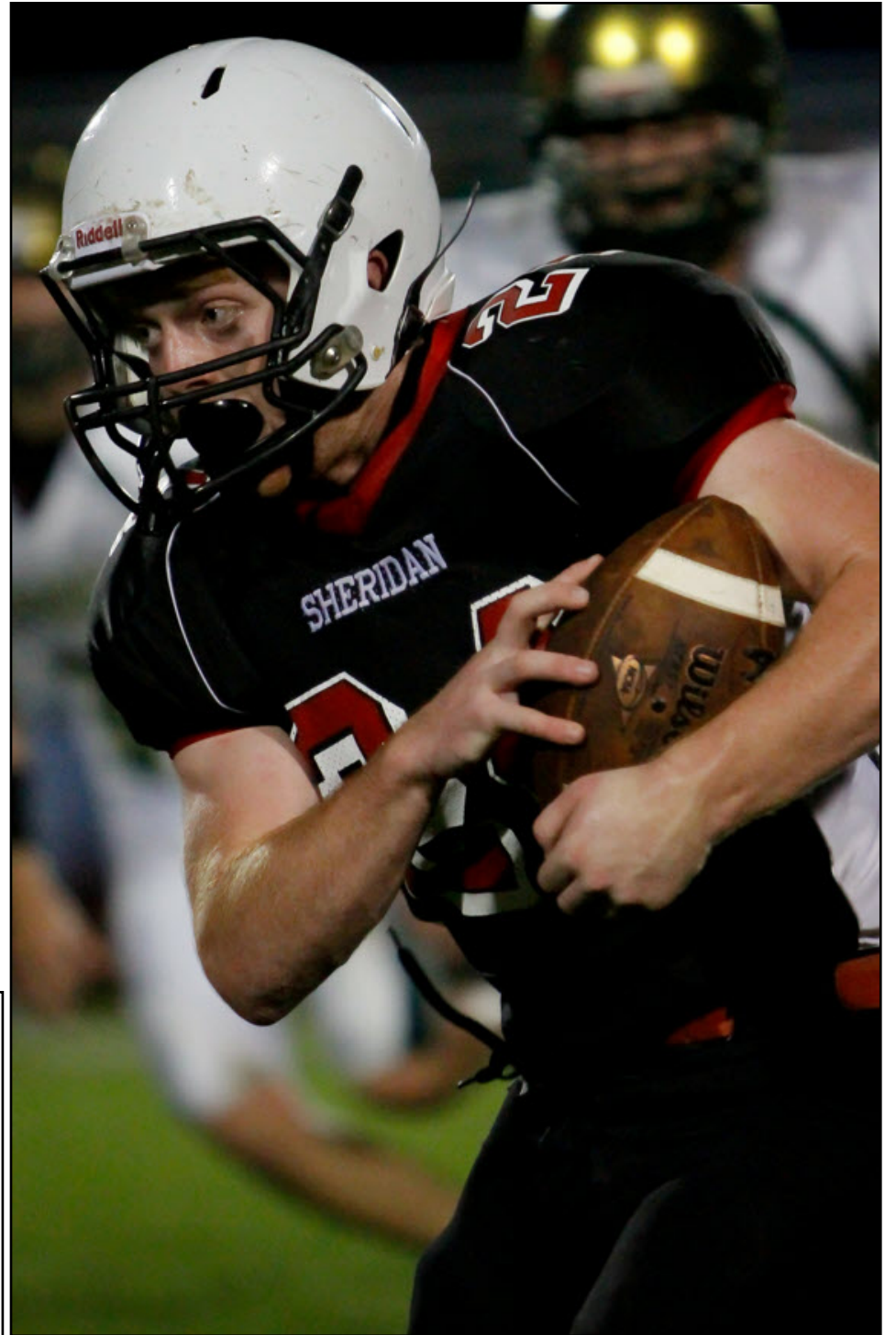
"On 17 plays they gained four yards. On the other plays they gained 193 yards," Wright pointed out.

"Two weeks ago against Taylor Chesney ran the ball 48 times. That's too many," said Wright. "Last week we got him down to 32, but that is still too many. I've told our players that Chesney's body can't take that kind of punishment. He's only 162 pounds.

"We need better play from our line, both offense and defense," Wright added.

The sectional game on Friday likely will be a ground game. South Putnam quarterback Grady McHugh is just 49-of-103 for 830 yards. He has thrown for nine touchdowns and has been intercepted five times. South Putnam has one outstanding receiver in Jimmy Ritter, with 32 catches for 626 yards.

But, much of South Putnam’s offense comes from the ground running of 190-pound junior Kyle Shaffer. He has carried 193 times for 1,289 yards.

Sheridan’s offense looks much like South Putnam’s. Chesney is 20-of-54 passing the football for 293 yards. He has fired for three touchdowns and has been intercepted seven times. On the ground, Chesney has carried 175 times for 1,317 yards; Joe Callahan 119 times for 594 yards; Acevedo 84 times for 474 yards and Kenny Burnell has 48 trips for 443 yards.

“There is no real good team in the sectional,” said Wright. “South Putnam is a good team, but not a real good team.”



Volleyball sectionals...

Second-ranked Royals hosting 4A tourney

For many Indiana high school volleyball teams, today is the calm before the storm.

That's because on Thursday, action begins at the majority of the IHSAA volleyball sectionals across the state. Forty-five of the 64 sites are five- or six-team tournaments, which means first-round matches are scheduled Thursday evening, with semi-finals Saturday morning and the championships on Saturday evening.

Hamilton County's big schools play a six-team event at Class 4A Sectional 8, at Hamilton Southeastern. The Royals have been one of the major stories of this season, as they have rampaged to a 30-2 record, a No. 2 state ranking and a Top 15 national ranking. Southeastern plays the second match Thursday night, against district rival Fishers.

But first, there will be a match between two longtime rivals: Noblesville and Westfield. The Millers and the Shamrocks start play at 6 p.m., with the Royals-Tigers match to follow.

The Noblesville-Westfield match could be a barn-burner. When the two teams met earlier in the season, the 'Rocks won in five sets, 15-10 in the fifth set. The Millers come into the match with a 15-16 record, Westfield is 13-14.

Noblesville is a young team. Its leading hitters are both juniors: Josie Sanders has hit 255 kills (an average of three per set),

while Ashley Birkhimer has smacked 206 kills. Another junior, Allie Phillips, has

handled the offense well, dishing out 716 assists this season. Phillips also leads in service aces, with 37.

A sophomore, Brenna Everingham, is next in the ace department with 35, while Berkhimer has served up 33. Switching to defense, Everingham leads in digs with 277. Sophomore Victoria Dittmar has 30 total blocks, with Sanders making the most solo blocks with 11.

Westfield is a team that trends young as well. Both of the Shamrocks' leading hitters are juniors: Abigail Huser has 224 kills on the season (4.2 per set), with Claire Stitz hitting 208 kills. A freshman, Kinsey McAfee, has handed out 423 assists, with Caroline Sinicki, a sophomore, providing 249 assists.

Westfield's serving has been strong, with 179 total aces for the team. Senior Kari Losch leads that statistic with 34 aces, followed by Huser's 33 and McAfee's 30.

On defense, Losch has 338 digs. Liene Miller has 95 blocks for the season - 33 solo and 62 assists.

The Royals have only lost to 4A No. 1 Cathedral and 4A No. 5 Brownsburg this season, while picking up wins over such powerhouses as Providence, Yorktown and Delta. Southeastern's leader is senior Hayden Huybers, who has powered her way to 435 kills for the season, an average of 4.6 per set.

Junior Makenzie Hinshaw has proved to be a strong setter, having dished out 912 assists. Four HSE players have served up 40 or more aces, led by Caitlin Kane's 50. Natalie Mills has compiled 48 aces, with Hinshaw serving 43 and Grace Kane 40.

Another junior, Olivia Burgess has 291 digs for the season. Huybers also leads the blocking with 93 - 57 solo and 36 assists.

As for Fishers, it is 22-11 for the season. Maggie Markwood has totaled the most kills for the season with 315. A freshman, Rose Duffy, has handed out 682 assists. The Tigers' serving has been strong, with six players getting 30 aces or more. Markwood has served 50 aces, and sophomore Julia Drozd has powered 48 aces.

On defense, Ellie Adams has made 355 digs for the season. Brooke Leonard leads the blocking with 79 (24 solo and 55 assists).

Meanwhile, defending 4A state champion Carmel received a bye and will play Anderson in Saturday's second semi-final, which will start around 12:30 p.m. Thursday's winners play the first semi-final at 11 a.m.

The Greyhounds are 20-11 for the season, and ranked 13th in the final 4A poll of the season. They will take on an Anderson team that is 9-19 for the season.

Carmel's two kill leaders are right next to each other: Senior Carly Cason has 252 and sophomore Maggie Armstrong has hit 251. Junior Morgan Seaman has handed out 891 assists, having recently gone over the 2000 mark for her career. Junior Emily Horvath leads the serving with 40 aces, followed by Armstrong's 36 and Seaman's 34.

Horvath leads the defense with 323 digs. Kaye Lesure has 60 blocks for the season, 26 solo and 34 assists.


