Divided council adopts “one year” resolution

A deeply divided County Council last night adopted a resolution which provides that once a request has been rejected by the council it cannot be brought back for reconsideration for one year.



The resolution is retroactive to January of this year. This covers the time earlier this year when County Commissioners requested \$3 million for construction of a Public Safety Training Center.

That request was turned down by a 4-3 vote following lengthy and emotional pleas from various public safety workers and elected officials. A near capacity crowd was in attendance with a majority favoring the request.

Although Council members favoring the new resolution did not confirm the Training Center issue was the reason for their action, the new rule will serve to keep the politically volatile matter from coming back to council until after next spring's primary election.

Members voting for the resolution were Rick McKinney, Fred Glynn, Brad Beaver and Paul Ayers. Voting against it were Steve Schwartz, Jim Belden and Amy Massillamany.

Schwartz, upset by the action, called it self-serving political move to keep the Training Center matter out of public debate. He branded it "un-American" and said individuals or organizations have a right to appear any time whether they have been previously rejected on a request or not.

Those voting to not allow repeated requests within a year said the measure will help avoid having to go over a resolved issue, thereby saving the council's time.

Two candidates favoring the Training Center have already declared they are running for the Republican nomination for council-at-large presumably intending to try to unseat McKinney and Beaver. McKinney said after the earlier showdown that he will run and be willing to take on anyone who cares to also run. Belden and Beaver have not announced that they will seek re-election.

The new candidates in the field are George Kehl, Fishers police chief, and Jeff Hern, Fall Creek Township trustee.

In the meantime, the training center appears dead at least until after next year. If there are changes on the council membership it may be back on the agenda. The center was proposed to be developed on property owned by the Town of Westfield along River Road south of Noblesville. It was to have a fire training tower, gun range, driving test track and other features designed to allow advanced training for police, fire and emergency medical workers. A classroom facility/office building exist at the site currently.

Northern Hamilton County Trail

The Hamilton County Highway Department in coordination with the communities of Arcadia, Atlanta, Cicero, and Noblesville is undertaking a study to identify the best routes to connect the 4 communities via a shared use path. The project will also investigate connections to several parks and schools within the study area. Several of the routes being investigated include SR 19, Cumberland Road, East 234th Street, Strawtown Avenue, and Jackson Street.

The master plan will identify the routes that are most feasible, construction phasing, preliminary cost estimates, standards, and possible funding sources. Livability & sustainability

EDITOR'S NOTE: The Hamilton County Area Neighborhood Development (HAND) will conduct its Neighborhoods NOW Conference on Nov. 10. HAND has created descriptions of the four prominent themes of the conference. The fourth runs today.

It is easily agreed that most Hamilton County enjoy a high quality of life, and there is also agreement that there are many ways in which we can do better. For one, long automobile commutes results in more time spent being sedentary, less time with family and far less time or energy to become fully engaged with the neighborhood. High home values also limit the ability of service workers,

including teachers and servants, to purchase or rent a home in the communities where they work.

There is often public pushback regarding multi-family housing, in spite of community master plans that indicate the need for density. Smaller communities in the northern portion of Hamilton County hold in tension the need to sustain growth while maintaining their rural character. Tax caps also stress the budgets of each of the city and towns.

The development of transit can reduce commuting costs and encourage workers from other communities to seek the many unfilled entry level jobs in Hamilton County. Transportation choices need to be available to support

workers, children, and elderly with little ability or desire to drive.

Hamilton County will continue to be attractive for people who work in Indianapolis, despite the transportation costs, because of the good school districts, home values and the general quality of life. However, planned developments which includes affordable housing options, green space, density, alternative modes of transportation, and walkable streets will keep it sustainable.

'Rocks will host 8-2 Jeff

Lafayette Jeff will come to Westfield on Friday to face the Shamrocks in the championship game of the Class 5A, Sectional 11.

The Bronchos are 8-2.

Lafayette Jeff, 8-2?

Westfield might remember the Jeff teams which for six years went 9-53 while playing in the Hoosier Crossroads Conference. Westfield defeated the Bronchos seven straight times, going back to a 37-0 Lafayette victory in 2006.

So, what's the difference? Jeff's new schedule, now playing in the North Central Conference? Jeff's new coach who in this his first year at Lafayette took the team to the 8-2 record? In 20 years of coaching football Brian Moore has won 187 games and lost only 42. The last three years Moore was at Fountain Central as athletic director and coach. Coaching, he was 28-7. Before that, Moore took Seeger to the state championship game twice, winning all the marbles in 2004.

"Jeff is definitely better than I expected them to be," said Westfield mentor Jake Gilbert. "I've been very impressed with what I've seen on film. They are fast and have a big defensive line. Their quarterback has played well and they have a special wide out.

"McCutcheon beat them by 18 points (38-20) early in the season."

Last week in the sectional opener Jeff defeated McCutcheon 41-29.

"That's impressive from their staff and team," Gilbert continued. "I've known their head coach for years and think he is one of the better coaches out there."

Lafayette Jeff's only other loss this season has been to Kokomo, 46-14. Victories have been over Twin Lakes 35-28, South Bend St. Joseph 26-0, Harrison 54-50, Anderson 40-0, Richmond 33-14, Logansport 56-6, and Tech 48-12.

Westfield, now 6-4 on the year, has defeated Harrison twice, 38-21 and 42-22.

The Shamrocks are coming off the 42-22 sectional win over Harrison.

"We got off to another horrible start but played another great second half," Gilbert talked about that game. "We are evaluating everything to get us to play better in the first quarter. Our second half was excellent

"I was happy that our defense forced four turnovers. Lucas Schultz had two interceptions and Jon Mendoza forced a fumble on a QB sack.

"Our special teams were great throughout the game. We blocked a punt and stopped a fake punt. Kickoff coverage was decent. Offensively we really established ourselves in the second half, but we hurt ourselves too much in the first. I thought Harrison did a good job with some change ups defensively from the first time we played them."

Both teams are loaded with talent.

Lafayette Jeff quarterback Devon Colonis is 176-for-290, good for 2,669 yards. Daniel Rickey has 75 receptions for 1,181 yards. Alex Albrecht has 47 catches for 586 yards and Darian Collins 38 receptions for 691 yards. Bernard Clestin has carried 111 times for 542 yards and Latrell Brown 89 times for 703 yards.

Westfield's Ryan Pepiot has thrown for 2,291 yards, hitting on 187-of-334 heaves. He also has carried 129 times for 504 yards and Brandon Karsnick 123 times for 600 yards. Evan Manley has 45 receptions for 661 yards; Milo Beam 21 receptions for 326 yards; Schultz 29 grabs for 301 yards and Max McCool 42 catches for 411 yards.

"We did lots of good things tonight," Smith said.



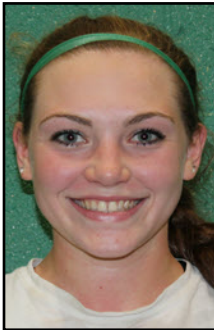



Solid rebounding leads Pacers to win

The Pacers owned the offensive glass en route to their second victory in as many days, a 100-98 win over the Boston Celtics on Wednesday night at Bankers Life Fieldhouse.
Indiana (2-3) collected 21 offensive rebounds in the victory, their highest total in that department since Feb. 25, 2014 against the Los Angeles Lakers.

Both Paul George (26 points and 10 rebounds) and Jordan Hill (16 points and 10 boards) recorded double-doubles in the victory. Monta Ellis added 13 points, five boards, and eight assists and knocked down the winning free throws in the final minute.
"Obviously we struggled, coming out of the gates 0-3," Pacers head coach Frank Vogel said after the game. "You get into situations where you just need to find a way to win. You need to have a sense of urgency

and a heightened focus and I thought the guys had that the last two games."
The Pacers led for the majority of Wednesday's contest, but Boston (1-3)

surged in front with 8:57 remaining on Isaiah Thomas' 3-pointer. Evan Turner buried a triple 1:05 later that stretched the Celtics' margin to four.
But the Blue & Gold clawed back, moving back in front on Rodney Stuckey's trey with 7:09 to play. Hill, George, and Ellis took turns knocking down jumper after jumper to keep Boston at bay, but the visitors eventually tied the game at 98 with 1:05 to play after Avery Bradley rattled off five consecutive points.
Out of a timeout, the Pacers ran a high pick-and-roll with Ellis and George. Ellis kept the ball going to his right and drew a foul on Bradley, then calmly knocked down both free throws to give the Pacers a two-point lead with 13.7 seconds to play.
"We drew a play up that (Paul George) was going to fake the screen and slip out," Ellis said of the play. "He (Avery Bradley) was just coming full steam and got in a bad position."
George harrassed Bradley on the other end, causing his 3-pointer to come up short and Lavoy Allen secured the rebound to seal the victory.
"I just knew it was either going to go to (Isaiah Thomas) or Bradley," George said. "I was able to get a back tip. George (Hill) did a great job of contesting as well, and we made it a tough shot for him."
Allen finished the night with seven points and 11 rebounds, six of them coming on the offensive glass. George Hill had 10 points and four assists while Glenn Robinson III had 10 points on 3-of-4 shooting in his first regular season action as a member of the Pacers.
Both teams were without at least one starter on Wednesday night. The Pacers did not dress starting center Ian Mahinmi, sidelined by a sore lower back, or starting small forward C.J. Miles, who was in street clothes due to a sore right ankle. Boston, meanwhile, did not have starting point guard Marcus Smart, out with a sprained toe.
The Celtics' backcourt excelled despite Smart's absence, as Thomas and Bradley combined for 48 points, including 16 in the fourth quarter. Thomas finished with 27 while Bradley added 21 and the duo knocked down 7-of-15 attempts from 3-point range, though that last miss was the difference between victory and defeat.
The Pacers return to the floor on Friday, when they will host the Miami Heat at The Fieldhouse for a special 8:00 PM tip. That game will mark the first time this year that Indiana will wear its special "Hickory" jerseys inspired by the movie *Hoosiers*.
