Election news...

Very few contests halfway through filing period

Half way through the filing period for candidates in this year's elections very few contests have developed for local offices at stake in the May 3 primary.
Most incumbents in Hamilton County's state legislative delegation have filed for re-election and remain unopposed. They include Republican representatives Donna Schaibley in Dist. 24, Kathy Richardson in Dist. 29, Tony Cook in Dist. 32, Todd Huston in Dist. 37, and Jerry Torr in Dist. 39. And for State Senate, Luke Kenley in Dist. 20.
For county offices contests are set for judge of Hamilton Superior Court 2 where David Najjar and Jon Brown will compete to succeed retiring Judge Dan Pfleging. The only other office where a contest in certain is County Council-at-large where Bill Dennis, Jeff Hern and George

Kehl have filed to oppose incumbents Brad Beaver and Rick McKinney. A third incumbent, Jim Belden has yet to file.
Thus far unopposed are incumbent Treasurer Jennifer Templeton and Surveyor and former auditor Robin Mills seeking to replace retiring Auditor Dawn Coverdale. County Commissioners Steve Dillinger and Mark Heirbrandt are unopposed in their bids for re-election. All have filed in the GOP primary.
The only Democrats filing for the primary are Allen Davidson for U.S. Congress who will likely oppose incumbent Congresswoman Susan Brooks who has yet to file, and Ryan Davis in State Representative Dist. 32 and Dana Black in Dist. 88.
With so few contests thus far, it appears the headline attraction will be for control of the County Council where

at least seven candidates are expected to vie for the three seats at stake. The present council is deeply divided on several issues including a controversial proposal to finance at Public Safety Training Center.
Another contest coming on January 30 involves choosing a new chairman for the county Republican Party following the resignation of Pete Emigh. Voting in this contest are only GOP precinct committeemen and vice committeemen. Seeking the chairmanship are Laura Campbell and Pete Peterson.
Regardless of the outcome later this month, the winner will face another election next year, and as a result dozens of candidates have made known their intentions to seek election in the party primary this year in their respective precincts.

Noblesville Parks to launch new recreation software on February 1

The Noblesville Parks and Recreation Department will be switching to a new recreation software to provide residents an easier method to register for classes, facilities, camps and other department offerings. The software, ACTIVE Net, will go live at 8 a.m. Monday, February 1.
“It will be a new registration customer website linked on parks website (www.noblesvilleparks.org),” Assistant Parks Director Mike Hoffmeister said.
ACTIVE Net is a web-based digital database instead of a physical database that the parks department currently uses. ACTIVE Net is accessible over the internet on a computer or mobile device.
“When the old website is removed we are not able to move databases. Any previous Noblesville Parks’ customer or new customers will have to create new account. That’s the only change for customers,” said Hoffmeister. “We’ve been with our existing software company for a long time and it is sometimes cumbersome. This new system is very streamlined for the customer.”
The parks staff has been training for 12 weeks for the upcoming launch of the new software.
“It will be a cleaner look with an easier process for the customers. Residents can make reservations for facilities, register for programs and sign-up for recreation annex punch passes and Parks Foundation memberships,” Hoffmeister said.
The new software also provides new opportunities for residents and the staff. “Shelters are available online to rent but we’ve never had the ability for a customer to request a reservation online. So if they are interested in a date at the Forest Park Inn and it shows it is available they can request it and our staff will get in touch with them,” said Hoffmeister. “It is an easier way to communicate with our customers. Any program open for registration will be on ACTIVE Net.”

Community meeting for new Carmel West Park master plan Tuesday

Interested in helping guide the future development of West Park? Please join us on Tuesday, January 26, 2016, from 6:30 - 8 p.m. for a community meeting at The Meeting House, 3rd Floor, 2000 N. New Market St., Carmel, located within the Village of West Clay. All members of the public are welcome and encouraged to attend.
Carmel Clay Parks & Recreation is beginning the process of creating a new master plan to guide future development within West Park, the park system's only park located west of U.S. 31/Meridian Street. The original 75 acres for West Park was purchased in 1997 and developed in three phases between 2000 and 2002 based on the 1999 West Park Site Master Plan. Some of the original amenities, such as the playground and spray pad, are nearing the end of their anticipated life and will soon need to be replaced. The park was expanded though the acquisition of adjacent property in 2003 (5 acres) and 2005 (40 acres), accounting for its current 120 acres. The new master plan will incorporate and integrate designs for both the capital repair and re-

placement of existing infrastructure and expansion into the 45 undeveloped acres.
The master planning process is anticipated to take at least six months and will incorporate a variety of opportunities for the general public to provide input on how to enhance West Park to best meet the current and future needs of the community. During the first community meeting on January 26th, interested members of the public will receive an overview of the planning process and hear preliminary findings from our consulting team. The community meeting will also include a guest speaker, who will share current trends in childhood development as it pertains to parks and playgrounds. The intent of this presentation is to share with the public the different types of play features possible, from traditional playgrounds to nature play, and solicit feedback on which of these type of amenities the public would potentially like to see in the park.
Additional community meetings will be held on February 23rd and March 22nd following a similar format. Future educational

Carmel Clay Schools’ kindergarten registration available

Carmel Clay Schools’ kindergarten registration for the 2016-17 school year is now available. The online registration form can be accessed by copying and pasting the following link into a web browser: <https://forms.ccs.k12.in.us/ParentPortal/pages/login.aspx>.

Students must be at least 5 years old by September 1, 2016, to start kindergarten in August 2016. While the state requires incoming kindergarten students to be 5 years old by August 1, 2016, Carmel Clay Schools grants a waiver to any student who will attain that age by September 1, 2016.

When registering children, parents/guardians will need an official birth certificate (not a hospital record) and proof of residency. Proof of residency consists of a rental agreement, purchase agreement, closing documents or deed and a utility (electric and/or gas) statement. Parents/guardians should also note that

immunization records must be submitted to the school by the first day of instruction. Those records may also be scanned and uploaded online, dropped off at the school or sent by a doctor’s office.

Tough now; tougher later...

Millers have tough one in Logan

Logansport, with its 10-2 record, could be one of the toughest teams on Noblesville's schedule this season. The Berries are 10-2 and ranked No. 4 in the state. They could be even tougher next season.

The Berries are led by a pair of juniors, 5-11 Matt Jennings with a 21.9 average and 6-4 Jalan Adaway with a 20.7 scoring mark.

Logan will be a tough customer for Noblesville on Saturday at Logansport.

"Logansport is a tremendous team, and they are having a great season as indicated in their No. 4 AP ranking within the past two weeks," said Noblesville coach Brian McCauley. "They have talent, speed and skill."

The Berries won their first 10 games but last week fell back-to-back to Lewis Cass 69-65 and McCutcheon 70-55.

Logansport and Noblesville have played one common opponent. Logan defeated Muncie Central 64-61 and Noblesville defeated the Bearcats 60-57.

"Logansport is very talented offensively," McCauley continued, "so we will have to defend and rebound as a team."

"It will be another challenging road environment, but one that will prepare us for late February and early March."

The Millers are 7-6 and coming off a split last weekend, losing in double overtime at Zionsville and blasting Columbus North 62-34 at The Mill. It was Noblesville's second overtime loss and third overtime setback of the season.

"Our team was really disappointed in our tough loss at Zionsville, but I was encouraged to see how we responded with our energy, effort and execution versus Columbus North," McCauley said.

"We still have a lot of room for improvement, and that is exciting because we have a lot of basketball and practices left before the start of the state tournament," the coach added.

Noblesville is led in scoring by John Kiser at 22.4 and Max Flinchum at 10.8. Kiser is averaging 7.8 rebounds a game.

"We played as hard as we have all season on Tuesday night against Roncalli," said Coach Pete Smith.

"We're having difficulty with shooting well since the Chatard win," said coach Pete Smith. "Shooting 30.9 makes it real tough to beat the teams on our schedule, as we did Tuesday night.

"Tuesday night was Cameron Lindley's first game back since the Lafayette Jeff win, and he brought back toughness we're looking for. But, our shooting has to be better Friday to beat Brebeuf."

Guerin Catholic is 5-11. Brebeuf is 7-5.

The Braves have won just two of their last six games and are coming off a 52-42 loss to Lawrence North in the Marion County Tourney

"Brebeuf is much improved from last season," said Smith. "Their guards are quick, and the Broderick kid (6-8) and Sam Snyder are both tough around the basket.

"Watching them beat Warren Central last week, they don't get down on themselves if they get in a hole. They play for 32 minutes, and with our rivalry with them, they'll be tough to beat."

Guerin Catholic has three Eagles averaging in double figures, led by Christian Munson at 22.3. Matthew Godfrey is scoring at a 13.4 clip and Jack Hansen is averaging 11.3 points a game.

‘Hawks, Huskies ready for conference tourneys

One of the big impacts of the conference changes that took place last year is the addition of basketball tournaments.

Three of Hamilton County's schools are taking part in conference tourneys: Hamilton Heights, Sheridan and University. The Trailblazers finished their conference event on Saturday, falling to Greenwood Christian 44-41 to finish fourth in the Pioneer Conference.

Now, the Huskies and the Blackhawks will begin conference play. Sheridan goes first, playing its Hoosier Heartland quarter-final game tonight vs. Clinton Prairie. That game tips off at 7:30 p.m. at Carroll. Heights, competing in the Hoosier Conference, will take on Benton Central at 10 a.m. Saturday at Northwestern in a game that will decide who advances to the championship in that conference.

The Hoosier Heartland tournament started on Tuesday with first-round games. Taylor beat Tri-County 71-48 and Frontier defeated Clinton Central 62-39. Both winning teams hosted their games.

The 'Hawks will play the second game at Carroll; the first features Rossville taking on Eastern at 6 p.m. The other two quarter-finals are at Tri-Central, with Taylor playing Carroll at 6 p.m. and Frontier facing the host Trojans at 7:30 p.m.

Sheridan and Prairie played each other earlier in the season, on Dec. 15, with the

'Hawks winning 63-48. That was a rare setback for the Gophers, who are 11-6 this year. That includes wins over several larger schools, including 4A Harrison and 3A Frankfort. Prairie has two scorers in double figures: Senior Madison Douglass is averaging 12.3 points per game, and freshman Tatum Neal adds 10.5 points per game.

Sheridan, of course, has a couple of big scorers itself. Junior Brittany Welch is pouring in 19.1 points per game, and sophomore Audrey Reed adds 17.4 points a contest.

Meanwhile, Hamilton Heights will get its first look at Benton Central, one of the top teams in Class 3A. The Bison are 18-1, and ranked fourth in the 3A division. Ironically, BC's only loss was to Noblesville; the Millers getting an overwhelming 72-40 win in the semi-finals of the Hall of Fame Tournament on Dec. 29.

Despite that loss, Benton Central has scored some noticeable wins. The Bison beat Lebanon, another 3A powerhouse, 64-50 in the Hall of Fame consolation game. Other victories came over two ranked 2A teams: No. 5 Lafayette Central Catholic 62-51 and No. 8 Delphi, 59-39.

The Huskies have been one of the hottest teams in the state over the past couple weeks. Heights has won seven games in a row, working its way back to a 9-9 record. That includes victories over strong Tipton and Western Boone teams in its last two games. The Huskies are led by Kayla Kirtley, who is averaging 12.7 points per game.
