### Atlanta Clerk Treasurer issues statement to residents of Jackson Township

To All Residents of Jackson Township,

As you may or may not have heard, the Jackson Township Board, at the recommendation of the Trustee, voted to pull out of the Jackson Fire Territory (JFT) effective July 1, 2016. Here is the back story with facts.

Prior to the establishment of the territory the county picked up the majority of the tab for Advanced Life

Support service for Jackson Township, Atlanta, and Arcadia. When the county defunded this, all three units had to look for After many meetings, other options. discussions and much exploration it was agreed that a fire territory comprised of the three units was the best option and in the best interest of all Jackson Township residents An interlocal agreement (commonly referred to as Memorandum of Understanding-MOU) was signed by all three units and recorded at the Hamilton County Recorder's Office.

Friction between Jackson Township and Arcadia and Atlanta began in mid 2014 when all three unit's 2015 COIT revenues were projected to increase. This was good news to the units because when the fire territory was established each lost a portion of their tax revenues.

Fund had \$10,903.00. It has grown to \$300,217.32. The revenue for this fund is derived from JFT ambulance runs yet the Township maintains that this revenue belongs to them (the township) not JFT. How can the township control revenue earned by the territory?

In an article in the Hamilton County Reporter the trustee stated "The Township will be able to maintain staffing and services at their current

level." She told Fox 59 that the "tax rates will be the same and no one will lose their jobs." What?? The trustee is contradicting herself. 1. If the JFT, which is its own taxing unit, goes away, then the tax rate will go away leaving each unit in the same boat it was in before the territory was established. Is everyone going to contract with Cicero for ALS service? What if Cicero is on a run and something happens to one of our kids at school? How long will we have to wait for help? 2. If everything is ok, as she is stating to the media, then why are you dissolving the fire territory?

I will tell you why. This became a personal vendetta when Mr. Phifer exposed the trustee for not following the MOU and for holding her feet to the fire (no pun intended) when it came to the alleged financial crisis. This is nothing but a political move to stick it to Atlanta and Arcadia and is not in the best interest of ANY of us living in Jackson Township. This got really ugly last year and in attempt to preserve the JFT the Atlanta and Arcadia Town Council members backed off. The councils of Atlanta and Arcadia even agreed to revisit the COIT revenue issue in the future should the need arise. I am inserting the open letter that I wrote to the Township Trustee at that time last year. Some of the figures have changed and some content may not be relevant at this time but the message about the stability and necessity of the JFT remains: During a public meeting last year the Jackson Township Board, the Trustee, and the Arcadia and Atlanta Town Boards agreed to wipe the slate clean and start fresh. Township Board Members Jeff Roberts (the same one who, in a public meeting, called all Atlanta residents "a bunch of idiots drinking from the same well) and Jerry Cook informed everyone present that they did not want to dissolve the territory. The Town Councils were in agreement. Money has been encumbered for long term projects and goals were recently set for the JFT. Considering all of this, you can imagine the shock to the Atlanta and Arcadia Town Councils when they received the letter from the Township.

A letter from Atlanta Clerk Treasurer to Jackson Township Trustee

#### Chris,

To estimate 2015 unemployment we took the total paid to state and federal from your year to date appropriation report for 2014, Fund 11, Function 11, Group 1607 which was a yearend total of \$6267.10. Your 2015 Appropriation by fund is \$14563.00 which is a significant increase.

To estimate 2015 utilities we took the 2014 year end totals from 11 11 3202 phone/internet/fax (\$1283.67), 11 11 350-2 Utility services (\$9379.56), 11 11 3531 Water (\$512.91) 11 11 3532 Trash (1268.19), 11 13 3501 Utility Services Atlanta (\$2104.98), 11 13 3502 Utilities Atlanta (\$5939.69) for a year end grand total of \$24,089. Your 2015 Appropriation by Fund Report shows a combined utility appropriation of \$29,000 which is also a significant increase.

You didn't have fire fighters living at the Atlanta station last year???

Thank you for your response regarding the EMS Fund. I am in agreement that the interlocal gives the Provider Unit the obligation to establish an equipment replacement fund in accordance with I.C. 36-8-19-8.5 and Section 7.4 of the interlocal agreement. I would argue that the EMS Fund is not an equipment replacement fund per the statute and that the revenues going into the EMS are derived from fire territory activity therefore should be controlled by the fire territory executive board.

Your own minutes from February 5th state there is no Equipment Replacement Fund. Perhaps, as things get ironed out, a new fund within the territory could be established. The township could keep the \$10,904.00 which was the 2011 yearend balance and the rest, being derived from the territory, could go into the territory coffers-just a suggestion. In other matters, I have read the minutes from the Township Advisory Board Meeting on February 5th.

Let me first say that I am truly sorry that I have put you on the defensive. I have no interest in a witch hunt. I offered to assist with the JFT budget review. To do a thorough review, I requested TONS of documents in order to see which expenses may or may not be repeated. I do everything to the nth degree and document, file, and copy to the detriment of many forests. If I am looking into JFT budget then by golly I'm going to have a filing cabinet full of research. I should have just set up camp in your office Chris and I am so sorry I didn't. I also requested documents which either don't exist or slipped through the cracks, such as copies of signed minutes which approve various purchases etc. Furthermore, I want everyone to understand that there is no power play or control issue on my part. I have made it clear to my council that I think the offer of Atlanta being the provider unit needs to come off the table. I. Don't. Care. The only thing I want is for the territory to survive. In saying that, is Atlanta capable of being the provider unit? You better believe it. I know there are those on the township board who feel that we're "all a bunch of idiots drinking from the same well" but that statement couldn't be more false or more damaging to all of our efforts to make this 'team' successful. Chris, the comment you made during your public meeting "You want to hand over \$534,000 to these towns that can't handle their own budgets? Both say they are in trouble and need funds." - is not only insulting and unprofessional it is inaccurate. In addition to 15 years experience, I am an Indiana Accredited Municipal clerk and a Certified Municipal Clerk through the International Institute of Clerks and Treasurers working towards a master certification. No one has ever said that the budget for Town of Atlanta is 'in trouble'. Is our budget tight? Always. We live within our means. We are not going to another entity trying to get into their budget to sustain ours. The matter of the COIT needs to be tabled for now. It was never agreed that it would go to the territory. It was always a selling point to the town's to join the territory and it was not mistakenly given to the towns by the State. The 2015 JFT budget was approved without any COIT contribution. For our budget analysis we have looked at all of the revenue coming into the territory, minus the COIT, and minus White River Township and, with a few easy cuts, it all fits. Chris, your own words during the Arcadia Town Council Meeting on February 2nd were "the budget is fine". On February 5th Mr. Roberts states that both the territory and the township have a surplus. There is no budget crisis. Realistically, there won't ever be. Mr. Roberts himself has stated that US 31 changes are coming. Increased businesses mean increased revenues. Let's be honest about this: more than likely things are going to improve not decline.

FACT: one of the selling points of establishing the territory was that our COIT revenues would eventually increase and offset the tax loss for each unit. Around this same time, former Atlanta Town Council Member Abe Evans resigned as Atlanta's representative to the JFT board and longtime Council Member John Phifer was appointed as his replacement. Mr. Phifer quickly noticed that the township trustee was not following the MOU for the JFT and that decisions and expenditures were being made without proper procedure.

At this same time the trustee declared that the JFT was in financial trouble and would need each unit to give their additional COIT revenues to the JFT. Members of the JFT board then agreed that a budget study was in order and asked Mr. Phifer to lead this. Knowing that I had 16 years (at that time) of budget experience Mr. Phifer asked me to assist him. I told him what documents he would need to request from the trustee and set about pulling the trustee's filed reports from the Department of Local Government and Finance website. It took months to get documents that were requested from the trustee. When we finally had all of the financial information we learned that there was no financial crisis. NONE. We also learned that there is plenty of fat to be cut from the JFT budget if there were a crisis.

FACT: The trustee pays tens of thousands of dollars a year to a financial consultant to do the same thing that I and hundreds of other clerk treasurers do ourselves; things like filing the annual report and employee compensation report to the DLGF and preparing and filing the annual budget.

FACT: Payroll is being outsourced for thousands of dollars each year and could easily be done in house.

FACT: The trustee has been paying, in fact *prepaying* at times, tens of thousands of dollars to a contractor to do jobs at the firehouse in Arcadia; jobs which have not gone through the JFT board for approval and many of which could have been done in house or at a much lower rate.

FACT: The trustee gave herself a \$12,807.50 pay raise for 2015. Does this sound like an organization that is in financial jeopardy?

FACT: When the JFT was launched in January of 2012, the Emergency Medical

It is really disappointing that the three township board members will only listen to one person and will not even look at the FACTS nor do their homework.

What the trustee is saying is not accurate. The JFT is not in financial trouble nor is it going to be in the future. She is saying that they are dissolving the JFT for financial reasons but in the same breath saying that everything is going to stay the same. The tax rate will NOT stay the same. Each entity will have to go back to fending for itself. In addition, all assets and debt of the JFT will have to be divided between all three units. Each unit will have to start over and build departments with very little money.

It sounds hopeless and overwhelming but we DO have options. We NEED for everyone in Atlanta and Arcadia to unite and work together to overcome this.

Atlanta and Arcadia have both agreed to revisit the COIT issue should the need arise. Please understand our confusion when you say your budget is fine and that there is a surplus, yet you threaten to dissolve the territory because it cannot survive without Atlanta and Arcadia's additional COIT.

As for the theory that the township brings more to the table: let's all think about this: when the Jackson Fire Territory was established, Atlanta, Arcadia, and unincorporated Jackson Township became one. We all pay our share. We are all doing our part. Is the unincorporated dollar amount higher? Yes. The unincorporated population is higher. Without the territory and its own levy THIS revenue would not even exist. We are all ONE. I agree with you Chris. We are a team!

In closing, I want to say, unless I see evidence to the contrary, I have yet to see anything that merits disbanding the JFT or eliminating jobs or closing the Atlanta station. Show me!

As clerk-treasurer for the Town of Atlanta, my part in this is finished. I am sorry I upset you Chris and anyone else who feels the same.

As a mother of a child who attends Hamilton Heights Schools and a step-mother of a child with a serious heart condition, I am passionate about this issue and no one can convince me that dissolving the fire territory is o.k. or in the best interest of the taxpavers. As a citizen of Jackson Township, I would like to be considered to be appointed to the territory board should 2 more positions be added. Mr. Roberts states that "It's hard to get people on the Board as they are volunteers and then they realize they don't have the time for this so you are always educating new people. It's hard to keep board members. It takes a long time to get people educated."

Jackson Township officials have said they will fund a township fire department that will service unincorporated Jackson Township.

Arcadia Town Council member Maurice St. Louis said, "The towns of Arcadia and Atlanta were surprised when we received a letter from the township regarding their decision."

Atlanta Clerk Treasurer Robyn Cook said, "We feel like we have been betrayed and that this decision was made behind our backs.

Several area residents voiced their concerns that Jackson Township officials made the decision without discussing it with the towns of Arcadia and Atlanta.

Jackson Township Trustee Chris Miller said the township's decision to pull out was made after a financial review was performed. "We see that in the future we are going to lose money," said Miller.

An Arcadia area resident in attendance asked Miller to produce documentation of the financial analysis. Miller stated, "I wasn't prepared to do that this evening." The same resident chastised Miller by stating, "You knew we would all be here, but you came without the numbers."

St. Louis said the Arcadia Town Council has met in executive session to discuss options for providing Arcadia residents with fire and paramedic services. St. Louis said no decision has been made as of yet.

Atlanta Town Board member John Phifer stated that he believes the township's decision to pullout was partially based on a conflict between him and Township Trustee Chris Miller. Miller stated, "I don't think so."

Phifer stated Atlanta has not made a decision regarding future fire services for residents.

Miller emphasized at the meeting the township would be more than willing to work with both towns to form an agreement to provide fire and paramedic services for their residents.

Also in attendance at last night's meeting was Hamilton County Commissioner Mark Heirbrandt. Heirbrandt spoke publicly stating, "I want to know what I can do help and get this issue worked out."


