Noblesville crash claims life

A Wednesday afternoon crash in Noblesville claimed the life of one person.

Police officers and firefighters from the Noblesville Police and Fire Departments responded to the intersection of State Road 37 and Field Drive at approximately 1:05 p.m. in reference to a report of a 2-car motor vehicle crash. Officers and firefighters arrived on the scene a short time later and began to investigate.

Based on witness statements and evidence at the scene, it appears that a 2002 Saturn passenger car was traveling

eastbound on Field Drive when, for an unknown reason(s), it pulled out into the path of a 1996 Pontiac passenger car that was traveling northbound on SR 37.

The driver of the Saturn, Betty Lou Turner, 87, of Noblesville, was transported by ground ambulance to Riverview Health and was pronounced dead. There were no additional occupants in the vehicle.

The driver of the Pontiac was identified as Cheryl A. Joy, 69, of Cicero. The driver was transported by ground ambulance to Riverview Health for non-life-threatening

injuries. There were no additional occupants in the vehicle. Investigators from the NPD Accident Reconstruction Unit were summons to the scene to collect evidence and gather information. As a result of the investigation, northbound traffic on SR 37 from SR 32 to 191st Street was closed until approximately 3:30 p.m.

This remains an ongoing investigation and further details relating to the identity of the deceased will be released after family notifications have been confirmed.

Dillon elected to County Council; Campbell in, Peterson out

An eventful day for Hamilton County Republicans on Wednesday has resulted in a new county chairman and a new county councilman.

The Indiana GOP state committee voted 13-8 to install Laura Campbell, a Carmel city councilwoman, as party chairman in Hamilton County. The decision ended a two-month dispute which saw Pete Peterson, a Fishers councilman, pitted against Ms. Campbell.

Peterson was elected earlier in the year in a party caucus after former county chairman Pete Emigh resigned on December 31. The caucus result was disputed by Ms. Campbell who had served as vice chairman and sought to move up to chairman.

Campbell appealed based on the method by which Emigh had appointed 71 precinct committeemen just before leaving office in a move to aid Peterson. Those appointees provided Peterson a margin of victory 151 to 115 in a January caucus. The state committee found yesterday that the appointments were not properly reported.

With the disputed votes eliminated, Campbell was declared the rightful winner by a vote of 115 to 96. She takes office immediately. The political fight took on importance beyond county boundaries because the county produces the largest Republican margin for statewide candidates.

Later in the day yesterday, the county precinct organization gathered for another caucus, this time to choose a county councilman to complete the unexpired term of James Belden who died last month.

With Ms. Campbell presiding, the caucus chose Dr. James Dillon on a third ballot at the Delaware Township Community Center. Five candidates en-

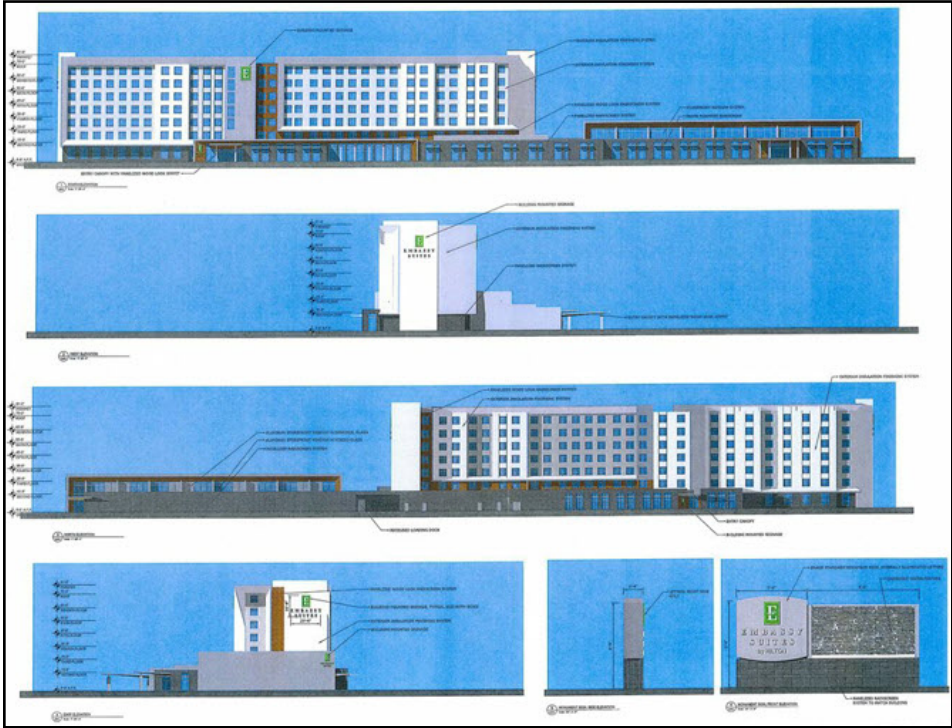
Embassy Suites preliminary development plan approved

The Noblesville Common Council has approved the preliminary development plan and ordinance for Embassy Suites Hotels.

On October 13, the Council approved the preliminary resolution for Embassy Suites, a 187,700-square-foot hotel with 198 suites, 20,000 square feet of conference space and 5,000 square feet of meeting space at the southwest intersection of Tegler Drive and Olio Road.

The development is 15.04 total acres and will be divided into seven lots, including a 1.5-acre retention pond. The seven-to-eight-floor hotel, conference center and 367-space parking is on 6.26 acres. Of the five out lots, three are planned to be marketed and sold to restaurants. Total capital investment for the land, hotel and conference center will be approximately \$30 million. The project will create 70 full time and 15 to 25 part-time jobs.

Sobriety checkpoint in Hamilton County this weekend

The Hamilton County Traffic Safety Partnership (HCTSP) will conduct a sobriety checkpoint on the night of Friday and the early hours of Saturday. At a sobriety checkpoint, law enforcement officers evaluate drivers for signs of alcohol or drug impairment at a specified point along the roadway, often depending upon the support of local property owners for the use of appropriate land. Checkpoint sites are selected based upon analysis of available crash and impaired driving arrest data and a consideration of officer safety. Vehicles are stopped in a specific sequence, such as every other vehicle, every third vehicle, every fourth vehicle or by stopping three, four, or five cars in succession and allowing other traffic to proceed while checking the stopped vehicles. The planned sequence in which vehicles are stopped depends on the number of officers available to staff the checkpoint, traffic congestion, and other safety concerns. Upon making contact with the driver, the officer advises them that they've been stopped at an HCTSP sobriety checkpoint and asks for the driver's license and the vehicle's registration. If, in the course of the contact, the officer detects that alcohol may be involved and that the driver may be impaired or if some other issue arises, then the vehicle is directed into a pull-off area for further investigation. Further investigation may involve the Standardized Field Sobriety Tests (SFSTs). On the other hand, if all looks right during the initial contact, the driver is often on his or her way in less than two minutes.

Man arrested for Carmel theft

An Indianapolis man was arrested for theft in Carmel on Friday. Carmel Police responded to a theft in progress call at 2:40 a.m. Friday in the 13300 block of Spring Farms Drive. A witness described seeing a male wearing a light colored baseball hat, dark coat and blue jeans attempting to open the door to his vehicle. Carmel Police later observed a silver Kia Soul traveling south on Springmill Road. The vehicle matched the description of a possible suspect vehicle used in recent theft from vehicles. Carmel Police conducted a traffic stop on the silver Kia Soul for minor traffic violations. Subsequently, stolen property was located inside in the Kia Soul which led to an arrest of the driver. Through further investigation, Anthony A. Jamison Jr. (32 yr. old black/male from Indianapolis, IN) was arrested for Theft (Level 6-Felony) and Unauthorized Entry into a Motor Vehicle (Class B-Misdemeanor). Jamison was later transported to the Hamilton County Jail for further processing. His bond was set at \$6,000.

The Westfield Police Department has released its annual report for 2015. The report details work undertaken by the department's various divisions, including patrol, traffic enforcement, investigations, emergency response, K9 unit, records and more. Highlights from the report include:

- Officers completed a total of 3,910 hours of training in 2015.

- WPD continued social media engagement with the community through Twitter, Facebook and Nextdoor.
- Instances of burglary, theft and robbery decreased in 2015.
- No traffic fatalities occurred in Westfield in 2015.

tered the race for the council seat for a term that will end December 31. Others in the race were John Acceturro, Bill Dennis, Robert Conn and James Brewson. Dillon led on the first ballot but lacked a majority of the 79 committeemen present. His lead increased slightly on the second ballot, and finally reached a majority on the third. Dillon is a retired heart specialist, former member of the Clay Township Board and Carmel resident. In thanking the caucus members he went on record as favoring a county public safety training center, a project that is stalled in the county council following a denial of funds last year. Dillon takes his seat on the seven member council immediately. The council next meets on April 6. Peterson who was essentially dismissed by the State Committee a few hours earlier did attend the caucus.

Noblesville saves \$2.056 million in bond refundings

The Noblesville Common Council approved the refunding of two bonds with a potential net savings of \$2,056,000 at its meeting on March 15. Each of the bonds were issued in 2008.

“We strive to be as efficient and use taxpayers’ dollars as wisely as we can. By utilizing better interest rates we are finding alternative ways to save funds,” Mayor John Ditslear said.

The city issued the Noblesville Redevelopment Authority Lease Rental Bonds in the initial amount of \$12,590,000 to construct roads and drainage improvements for the development of SMC. Payments on that bond run through February 1, 2031. By refunding, the city estimates a savings of \$1,505,000.

The second bond was issued for \$9,025,000 by the Noblesville Building Corporation First Mortgage Bonds to build Fire Station 7 on Olivo Road, the office building for the Street Department and other improvements at the street department facilities. The bond runs through July 15, 2028 and refunding to provide an estimated savings of \$551,000.

City Attorney Michael Howard said the refinancings are a result of interest rates nationally being at a lower rate than they were during 2008 when the city financed these projects.

“Based on historic low interest rates, the ability to call the bonds within the next several years, and the ability to privately place the bonds with banks which continue to seek tax-exempt bonds, the city can realize substantial savings,” he said. “By refunding bonds, we did not extend the term of any of the payments.”

Howard said refundings have taken place during the past four years. Last year, the city refinanced 10 bonds for an estimated savings of \$14,672,701 of taxpayer dollars.

“We have a team that has put together the transactions these savings with the strong support of the mayor and common council,” Howard said. “The financial experts who do these financing keep track of interest rates and when there are significant financial savings to the city. City Securities has acted as our investment counselor for years and informs us when we can realize savings by refinancing.”

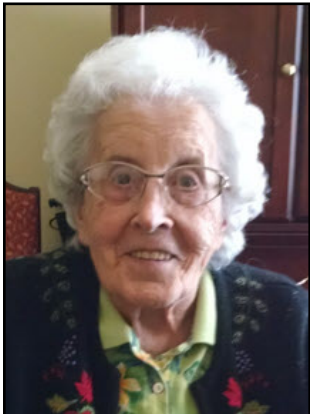

Kroger, Boy Scouts, Girl Scouts launch...

30th annual Scouting for Food Drive

Kroger Central Division leaders, Girl Scouts, Boy Scouts and others will come together at Gleaners Food Bank of Indiana this morning to formally launch the 30th annual "Scouting for Food" drive. Girl Scouts and Boy Scouts in uniform were on hand for a service project at Gleaners immediately following the news conference.

The 30th annual "Scouting for Food" drive will run in 98 Kroger stores across the operating division, including the Indianapolis metropolitan area, Terre Haute, the Fort Wayne region, Lafayette, Kokomo, Huntington, Monticello, Peru and South Bend. The food drive runs from Monday, March 14th to Saturday, April 9th.

Participating Girl Scout and Boy Scout units in metro Indianapolis, South Bend, Fort Wayne, Kokomo, Lafayette, Peru, Rochester and possibly other Hoosier communities also will be going door-to-door in local communities collecting food donations throughout the food drive. Each Scout unit will select a date that is convenient to their community. Some scout units may opt to deliver bags with attached instructions to residential neighborhoods in advance. The food donations will go to local food pantries or, if a local pantry is not designated, to regional food banks. Kroger's community ambassador in each store has a list of designated food pantries.

This year Kroger is going to try something new, allowing two ways to donate. Customers can purchase for \$3, \$5 or \$10, a "donation for meals bag". Each bag represents a certain number of meals. \$3 bag = 9 meals, \$5 bag = 15 meals and a \$10 bag = 30 meals. Collection bins will also be placed in participating Kroger stores for customers to place non-perishable items of their choice in the bins. Boy Scouts and Girl Scouts will be in local Kroger stores on March 19th during the food drive to assist customers who make donations on that day. At the conclusion of the drive, donations for the meal bags will be calculated into cash checks for local food banks and pantries, plus all collected non-perishable items will also be donated.

Pre-bag sales in stores in 2015 totaled \$24,982 or 74,946 meals. The total collected door-to-door by Scouts in 2015 was 108,135 pounds, valued at 90,112 meals for hungry Hoosiers. More than 4,000 Girl Scouts and Boy Scouts, supported by more than 1,000 adult leaders, came together in support of last year's "Scouting for Food" event. Kroger in-store contributions, combined with Scout door-to-door totals, brought the 2015 total to 165,058 meals.

According to Kroger Central Division Public Affairs Manager John Elliott, "With the combined efforts of the Girl Scouts and the Boy Scouts, as well as Kroger associates and customers, we anticipate improving on an extremely successful food drive in 2015. This partnership with Girl Scouts and Boy Scouts across the region fights hunger at a time when our regional food bank and local food pantry partners have seen the number of hungry families increase dramatically. By lending our stores as coordinating locations and drop-off points, our personnel as engaged volunteers and our resources to the "Scouting for Food" program, we hope to not only make progress in the fight against hunger, but teach valuable life lessons and provide community service opportunities for Boy Scouts and Girl Scouts. As a Boy Scout leader of many years, a former Boy Scout, the father of an Eagle Scout and the father of a Girl Scout Gold Award recipient, I am personally dedicated to ensuring this program is a resounding success, not only in terms of hunger relief, but as a character building and educational opportunity for Scouts. With far too many children in this country going hungry every day, these Boy

Scouts and Girl Scouts are not only doing a good deed, they are meeting a critical need."

"Scouting challenges youth to do a good turn daily," said Patrick Sterrett, Scout Executive, Crossroads of America Council, Boy Scouts of America. "This annual partnership with Kroger and the Girl Scouts of Central Indiana encourages Scouts to respond to the hunger within their communities through a 27-day civic service opportunity."

"According to a report by the Girl Scout Research Institute called The State of Girls in Indiana, about 20 percent of school-age Hoosier girls are living in poverty," said Deborah Hearn Smith, chief executive officer of Girl Scouts of Central Indiana. "Community service is a cornerstone of the Girl Scout Movement and we are delighted to continue our partnership with Kroger and Boy Scouts to help feed Indiana's hungry families. Indiana Hall of Fame announces inductees, honorees...

Etchison named to 2016 Silver Team

The Indiana Basketball Hall of Fame welcomes their 55th class of inductees and honors other Indiana boys’ high school basketball legends on March 23 in ceremonies to be held at Primo Banquet Hall in Indianapolis.
Highlighting the evening’s ceremony, 14 men will be inducted into the Hall, recognized with the highest honor bestowed in Indiana high school basketball.
Also, 18 men will be recognized as members of the 2016 Silver Anniversary

Team – acknowledging their spot as one of the top senior basketball players in Indiana 25 years ago. One of those is a Noblesville graduate, Tony Etchison.
Etchison was a four-year varsity starter for Hall of Fame coach Dave Nicholson, scored 1,357 career points and led Noblesville to back-to-back-to-back sectional titles. He was named all-Hamilton County four years, all-sectional and all-regional three years, all-conference, all-Indianapolis Metro and Hamilton County Player of the

Year twice, also Hoosier Basketball Magazine 1st team all-state. Etchison averaged 22.8 points, five rebounds and four assists per game as a senior. He received a scholarship from Mercer University, where he was a two-year starter earning all-academic honors four years and led the TransAmerican conference in three-point shooting. Etchison is an agent for Farm Bureau Insurance and also manages his home farm. Residing in his hometown of Noblesville, he is married with three children.

Among individuals to be inducted are Indiana boys high school basketball all-time leading scorer, state champion, Indiana Mr. Basketball and 1990 National High School Player of the Year, Damon Bailey (Bedford North Lawrence 1990), and the consensus 1993 National College Player of the Year and longtime NBA player, Calbert Cheaney (Evansville Harrison 1989). Each had notable careers playing for Indiana University.
Willie Humes (Madison 1967) set impressive scoring records at Madison High School, Vincennes University and Idaho State University, Tom Bowman (Martinsville 1959) graduated as the all-time leading scorer at Butler University and Butch Wade (Columbus 1963) set numerous records, including career scoring, at Indiana State University.
Terry Stillabower (Lafayette Jeff 1964) was a star of the Bronchos’ 1963 state finalists and 1964 state champion squad, Brad Miley (Rushville 1976) set the IHSAA state finals rebounding record and was a member of the 1979 NCAA national finalist Indiana State University Sycamores. Each were Indiana All-Stars.
Russ Grieger (Evansville Bosse 1960) was a starter for Evansville College’s 29-0 1965 national champion squad, Bill Hahn (Michigan City Elston 1959) was a noted player and won 246 games as an Indiana high school coach, Jim Fisher (Lebanon 1979) was an all-state player at Lebanon and Joe Todrank (Holland 1956) followed an outstanding playing career as a successful Southern Indiana high school coach. The late Hank Clason (Goshen 1938) was a local standout who became an all-Big Ten player at Northwestern University.
The recipient of this year’s Centennial Award to recognize contributions to Indiana high school basketball from 100 or more years ago is Bill Diddel (Indianapolis Manual, 1904) who is inducted posthumously. Diddel was a star of outstanding Manual H.S. teams that won games throughout the Midwest and continued his career as a member of Wabash College’s 1908 “Wonder Five” team that went 24-0 and were declared World Champions by numerous media outlets of the time.
Indiana Pacers 2016 Silver Medal Award recipient Mike Blake is inducted for his 40+ year career in Evansville television with a distinguished career covering high school sports as well as his numerous charitable community involvements.
