Rep. Brooks to face MacKenzie...

Fifth District caucus scheduled for Aug. 13

Republican precinct committeemen from throughout the 5th Congressional District will assemble in Noblesville on Saturday, August 13, presumably to reinstate Rep. Susan Brooks as candidate for re-election to Congress. But, another candidate, Stephen MacKenzie of Fishers, has come forward to challenge Brooks.

The incumbent Brooks had to withdraw her candidacy last month in order to seek the nomination for governor after Mike Pence left office to become the Republican candidate for vice president. She is allowed to resume her

bid for re-election, but since the position is technically vacant, she must win in the caucus to do so.

There are several hundred precincts in the 5th District including slightly over 200 in Hamilton County. The nominating caucus will be held at IVY Tech, the former Noblesville high school, at 3 p.m.

Rep. Brooks is serving her second term in Congress. A resident of Carmel, she was not successful in her bid for the gubernatorial nod, finishing a close second to Eric Holcomb. Before going to Congress she served Indianapolis mayor's assistant and as U.S. District Attorney. She and her

husband, David, are parents of two children. She has a conservative voting record in Congress, but has not been known as strident in her rhetoric.

MacKenzie, a Fishers resident since 2000, and his wife, Cynthia, are parents of three children. The candidate lists his occupation as "an executive business consultant in the franchise industry." He is a member of the U.S. Air Force Reserve and saw active duty in the Middle East including Iraq. A native of Maine, MacKenzie calls himself a political outsider with a conservative philosophy.

Elwood man arrested for child exploitation

Corbett

An Elwood man has been arrested by the Noblesville Police Department for child exploitation.

On July 19, 2016, investigators from the NPD opened an official investigation regarding a case of alleged child exploitation that included both possession and dissemination of child pornography.

After an extensive investigation, investigators petitioned for and were subsequently granted a search warrant for the address of 611 South A Street, Elwood, IN 46036. The search warrant was executed on August 3, 2016. As a result of the search, property was seized and a suspect was identified. The suspect was taken into custody and booked at the Hamilton County Jail.

The suspect is identified as David L. Corbett, 32, of Elwood. He is charged with two counts of Child Exploitation; one count is a Level 5 Felony, the other count is a Level 6 Felony.

This remains an ongoing investigation.

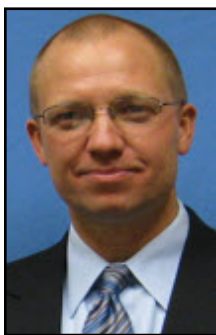

What's new at Sheridan Community Schools

Each year I find it amazing how fast summer goes. I know when I was younger and a student it felt short, but as I have learned over time it is even shorter for those who have just a few weeks to close the door on a previous year and get ready for the next. I cannot thank enough all the individuals who work diligently throughout June and July to make sure the upcoming year is something special for all our students, families, and faculty members. As a district we are continuing to expand the opportunities for our students, and we have a lot of wonderful resources to enhance their learning experience.

Technology: SCS continues to be a state leader in what we provide in regard to technology and its enhancement of the classroom. For the 2016-17 school year we have expanded our Bring Your Own Technology program to the entire SHS student body, grades 9 – 12. All students will be asked to bring the device they are most comfortable working with to every classroom where teachers can utilize these vital resources. We have also worked to make sure every student who may need assistance with this program will not be left without a device. Next year we will continue our school-provided Chromebook program throughout the entire middle school, and this year we are adding the 5th grade as well. In grades K-4 we have worked further with our teachers to provide what they felt were the best devices to assist their instruction, and we are very happy with what they will be providing. Beyond our focus on technology devices, two other items of note are the upgrading of the district's website (one of the top requests from our parents) and utilizing a more advanced and user-friendly messaging system.

Curriculum: Last year was a vital year regarding the numerous hours our teachers spent working to align curriculum Kindergarten through eighth grade year in each subject area. Our high school teachers have begun work with College and Career Ready curriculum. We still have work to be done, but our educators have done a fantastic job of approaching this effort with genuine understanding of how this will impact the enrichment of student learning. This work has positively impacted everything in the buildings: how we are running several of our programs, our textbook adoption, and what we will be utilizing as a part of our technology plan.

Facilities: As many of our citizens have recognized, and their input has been greatly appreciated, we have worked extremely hard to upgrade our entire district's facilities and aesthetics. Through our SMART meetings two years ago, this was one of the top areas those in attendance wanted us to focus on. It has meant a tremendous amount to me when our students on numerous occasions have mentioned how great the place is looking. Over these past two months we have put forth a lot of effort in this area as well. While we have completed over 40 projects in this area, some of the items of note are still in progress: installing new windows at SHS, adding a bus drive to the back of SES to lessen traffic congestion on Hinesley Road, and upgrading SHS classrooms where we have added new tables and desks, upgraded cabinets, painted the rooms and door frames, added new whiteboards, and added new projectors/screen where needed. As well,

we have upgraded the sound system in the auditorium and the gymnasium and our district fencing, reworked the parking lots, and solved the drainage issue we were having along the north side of the SHS facilities.

Solar Power: I am very happy with the support we are getting from the community regarding the movement to solar power. We will be the first and only district in Indiana to be completely reliant on solar power. While there are now many school districts moving toward this avenue to energy provision, we are about ready to launch ours. I will be giving a more comprehensive report on our solar project over the next few days.

Communication: Through the month of July, we have posted our district video and informational flyer in various locations. I have received numerous positive comments and remarks regarding those items. We have felt it was important this past summer to get the word out about what we are accomplishing and to celebrate the successes we have had as we are a very proud district and community. I recently was informed of a comment on one of our Facebook postings about our accomplishments video asking why there were no scores or numbers posted. This was a very good question; one I have addressed in many conversations. We could have posted those as we are very transparent about the work we are doing but doing so was troublesome in two ways. First, the data we receive and tests we have taken from the IDOE have changed five straight years. It makes it very difficult to do true statistical analysis with the changing of testing and expectations in each of these years. This is similar to playing a sport or activity where the rules change before each contest. Furthermore, you do not know these rules until right before game time. However, the state is working to rectify this concern for all schools as our representatives have seen this as a problem as well. Also, while we need proper data to truly make guided changes, as a smaller school, SCS has not been nor desires to be all about numbers. Our teachers review data at least quarterly, and sometimes weekly, which helps them adjust instruction to better the students in their classrooms. I have heard from our group meetings, from our SMART meetings, and in numerous situations, that the number one positive of our district is the individual attention we can give to help promote the interests of each student. Numbers and data help lead a lot of our decisions, but the focus needs to remain on kids and children successes. Are we perfect at what we are doing as a district? No, but I believe in what we are doing, and I will continue to strive to meet the expectations of the community.

Thank you for your continued support, and we look forward to a great year at SCS.

Westfield’s team, Carmel’s Hecht win at Crooked Stick

Neither rain nor heat nor darkness of night could stop the Westfield girls golf team from another invitational win Thursday.

The Shamrocks won the Crooked Stick Invitational, claiming victory on the Carmel golf course that will host the PGA's BMW Championship next month. Westfield carded a team score of 315 for its second invitational win in two days.

The meet was delayed for over an hour due to surprise thunderstorms that popped in Carmel around 1:30 p.m. As a result, several players were unable to finish due to losing daylight.

Carmel managed to get enough players in for a team score, totaling 327 to take second place as a team. Rani Hecht gave the Greyhounds an individual win, as she earned medalist honors with a 76.

"It feels awesome, especially since this is my home course," said Hecht.

Other Carmel finishers were Angie Kavanaugh 82, Nina Hecht 83 and Erin Evans 86. Hamilton Southeastern was led by Julia Eaton with 84, followed by Haleigh Gray 87 and Chelsea Morrow 93.

And then there's Gehlhausen. Waking up before the sun, she first joined the Huskies at the 16-team West Lafayette Invitational. She finished second at Purdue's Kampen Course with a score of 75.

After that, Gehlhausen and her parents headed down to Crooked Stick, where she made it in time to tee off there. She finished after sunset, but still tied for second with a 77.

"I'm overall really happy with how I played," said Gehlhausen.

Back at Kampen, the Huskies finished seventh with a team score of 404. Other Heights scores were Syd Lucas 86, Kate Biggs 111 and Ellie Arrowood 133.
