Noblesville Police Department offers...

The Noblesville Police Department would like to remind residents that the official designated hours for Trick-or-Treat this year in the City of Noblesville will be from 5:30 p.m. to 8:30 p.m. on Monday, Oct. 31. Officers from the Noblesville Police Department will be paying particular attention to motorists who are not obeying traffic laws in and around residential areas where children will be expected to be walking. We would urge all motorists to exercise due care as children sometimes make sudden or unexpected movements such as darting between parked vehicles and crossing streets in locations that are not properly marked, illuminated or designated for pedestrian crossing.

The NPD would also like to remind citizens to observe a few safety tips that will help to make this an enjoyable evening for all.

Parents:

- Make sure an adult or older responsible youth will be supervising the outing for younger children.
- Instruct your children to travel only in familiar areas and along an established route.
- Teach your children to stop only at houses or apartment buildings that are well-lit and never enter a stranger's home.
- Tell your youngsters not to eat any treat until they return home.
- Establish a return time.
- Review all the appropriate trick-or-treat safety precautions, including pedestrian/traffic safety rules.
- Remind children to walk on sidewalks, not in the street. If no sidewalk is available, have children walk on the left side of the road, facing traffic.

- Remind children to walk, do not run. Be careful crossing yards and lawns where unseen objects or uneven terrain can present tripping hazards.

Costumes and Face Design:

- Only fire-retardant materials should be used for costumes.
- Costumes should not be so long that they are a tripping hazard. (Falls are the leading cause of unintentional injuries on Halloween.)
- If children are allowed out after dark, outfits should be made with light colored materials. Strips of reflective tape should be used to make children more visible.
- Avoid masks that may obstruct a child's vision. Use facial paint instead.

Motorists:

- Watch for children darting out from between parked cars.
- Watch for children walking on roadways, medians, and curbs.
- Enter and exit driveways and alleys carefully.
- Travel at a reduced speed (10-15 mph below the posted speed limit) especially in residential areas where it is obvious that children will be walking.

Residents:

- Leave your exterior lights on near your front door if you are participating in handing out candy. Parents/children will use this as a means to identify your willingness to participate.
- Secure any pets (outside and inside) that may become startled because of the costumes, noise, or overall increase in activities on that evening.

Sobriety checkpoint takes place tonight

The Hamilton County Traffic Safety Partnership will conduct a sobriety checkpoint beginning tonight and lasting through the early hours of Saturday.

At a sobriety checkpoint, law enforcement officers evaluate drivers for signs of alcohol or drug impairment at a specified point along the roadway, often depending upon the support of local property owners for the use of appropriate land. Checkpoint sites are selected based upon analysis of available crash and impaired driving arrest data and a consideration of officer safety.

Vehicles are stopped in a specific sequence, such as every other vehicle, every third vehicle, every fourth vehicle or by stopping three, four, or five cars in succession and allowing other traffic to proceed while checking the stopped vehicles. The planned sequence in which vehicles are stopped depends on the number of officers available to staff the

checkpoint, traffic congestion, and other safety concerns.

Upon making contact with the driver, the officer advises them that they've been stopped at an HCTSP sobriety checkpoint and asks for the driver's license and the vehicle's registration. If, in the course of the contact, the officer detects that alcohol may be involved and that the driver may be impaired or if some other issue arises, then the vehicle is directed into a pull-off area for further investigation. Further investigation may involve the Standardized Field Sobriety Tests (SFSTs).

On the other hand, if all looks right during the initial contact, the driver is often on his or her way in less than two minutes.

Officers staffing the sobriety checkpoints work on an overtime basis paid by grant funds from the National Highway Traffic Safety Administration through the Indiana Governor's Council on Impaired and Dangerous Driving.

The Hamilton County Traffic Safety Partnership (HCTSP) is a consortium of law enforcement agencies in Hamilton County working to increase the usage of seatbelts, to combat aggressive driving, and to decrease impaired driving with the overall goal of creating a safer Hamilton County. The HCTSP is comprised of the Hamilton County Sheriff's Department, Fishers Police Department, Carmel Police Department, Noblesville Police Department, Westfield Police Department,

and Cicero Police Department, with the assistance of the Indiana State Police.

Impaired driving is one of our nation's most frequently committed violent crimes. Just in Indiana in 2014, alcohol-related traffic crashes killed 101 people, accounting for approximately thirteen percent of all fatal crashes, and injured another 1,880 people.

About 750 people are convicted of an impaired driving offense annually in Hamilton County alone, and nearly 100 of those are repeat offenders. In 2015 in Hamilton County, for example, the State filed 732 cases of operating while intoxicated. Of these, 106 drivers had prior convictions for operating while intoxicated within the last five years.

To combat this crime, the Hamilton County Traffic Safety Partnership will be setting up sobriety checkpoints around Hamilton County to aggressively deter, detect, and arrest those drivers who make the decision to drive impaired. Sobriety checkpoints have proven successful in both raising awareness of impaired driving and reducing the likelihood of a person driving after they have been drinking.

Sobriety checkpoints are legal in 39 states, including Indiana, and the District of Columbia. In 1990, the U.S. Supreme Court ruled that, if conducted properly, sobriety checkpoints do not constitute an illegal search and seizure. In the 2002 case of *State v. Gerschoffer*, the Indiana Supreme Court found that sobriety checkpoints are constitutional when

conducted properly. Members of the Hamilton County Prosecuting Attorney's Office work with the Partnership to ensure that each checkpoint meets constitutional requirements.

- Make sure that children have a clear path to and from your front door. Decorations or other Halloween displays can sometimes impede or present a tripping hazard for unsuspecting children.

Citizens can help to keep drains open

Autumn is upon us. The changing season brings shorter days, beautiful fall colors, and cooler temperatures. Autumn also means that the leaves are falling off the trees. Rain and wind can carry these leaves to storm drain grates. The leaves accumulate on the storm water grates or the leaves travel further and into the storm sewer system and into the open ditches. In either case, this accumulation of leaves and other debris can impede or block the flow of storm water resulting in localized flooding of yards and roadways. Ponding water in the roadways can lead to unsafe driving conditions and ponding water in

rear and side yards is a nuisance and can lead to property damage.

We can all do our part to keep storm water flowing into the drains. If you see a storm grate or roadside ditch that is clogged and can clear it without placing yourself in danger, please remove the leaves. Watch the weather forecast and remove the leaves before rain is forecasted to fall.

If a roadway grate or side ditch is clogged, use a rake to help you reach the leaves without entering the street. Please do not place yourself in danger when removing the leaves.

Leaves can be collected and placed in large paper landscape waste bags, mulched

into your lawn with a mulching lawn mower or other equipment, or composted on-site. If you choose to compost the leaves, please confirm with your homeowners association and your community that composting on-site is allowed and identify any regulations for composting activity.

Some communities offer leaf removal service. Please confirm with your community that a leaf removal service is provided, the requirements to participate, and the schedule for this service. Unless your community requires the leaves to be stockpiled along the curb in the roadway, it

is best to place leaves within the tree lawn area and not in the roadway itself.

These Storm Drain Stewards pledge to keep that storm grate clean of leaves, trash and debris and to report any polluters.

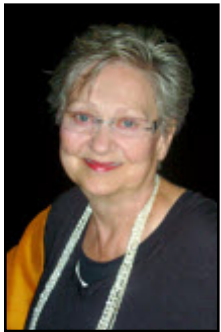

Three important dates in November

November is for Elections, Taxes and Thanks



If you don't believe it, look at the calendar.

- November 8 - National, State and Local elections.
- November 10 - Property Taxes are due
- November 24 - Thanksgiving Celebration

Maybe the third date is a celebration of the first two? In Hamilton County, there is early voting in Carmel, Fishers and Noblesville.

The lines are long (about a 30 minute wait at times) and so far over 11,000 good citizens have taken advantage of early voting. In Noblesville, early voting is held at the Judicial Center downtown Noblesville. In Fishers, the location is the City Hall on Municipal Drive and Carmel voting takes place at the Public Library, 55 4th Ave SE, check times. In addition, over 4,000 absentee ballots have been sent in to be counted. This election may set a record for the most number of voters in a National Election. That would be a good thing.

Just two days after the election, the property tax bill is due November 10th. First things first, finding the bill could be the greatest challenge. With only one bill sent for the entire yearly tax cycle, it is hard to remember just where the important document was last stored. If you have moved, forget it...just go to the Treasurer's office at the Hamilton County Court house, Noblesville and get a new copy.

Elections and paying taxes have a connection. You see the elected officials set the taxes based on a long list of calculations that few can understand, except the elected officials. Be sure to check the bottom of the page of your tax bill for deductions. If it shows all zero's, then a meeting with the Auditor is in order or an appeal can be filled at the County Court House, Noblesville (based on certain deadlines). The bill also shows the assessed value and tax summary for the property. Property taxes are constitutionally capped at 1% of property value for owner-occupied homes. The bill also breaks down how the taxes collected are distributed along with the tax rate for each taxing authority. There is a tax for weed liens and unsafe buildings, just in case. Anyway, taxes are due November 10th.

For the last important date on the calendar, Thanksgiving is to appreciate and give thanks for this great country and also that the election is over. We must give thanks that the taxes are paid up until May. But Thanksgiving, the day and the meal must have a tried and true Persimmon Pudding treat. The following is "Guaranteed the Best Pudding ever"!

Hint - buy the pulp and don't try to strain the Persimmons yourself. It is just too hard!*

Also know that the kids will not eat the pudding, it is an acquired taste. Make them Vanilla Pudding and they will as happy as the adults in the crowd who hasn't had the pudding since Grandma made it.

Persimmon Pudding like Grandma made:

- ✓ Start with a 1.5 qt. baking dish, buttered - set aside
- ✓ In a mixing bowl add the following:

½ cup melted butter - (1 stick)

1 ½ cup white granulated sugar

2 eggs beaten well

✓ Beat together the melted butter with the sugar, add the eggs and mix well

1 teaspoon baking soda

2 cups Persimmon Pulp*

✓ Stir soda into the Persimmon Pulp

1 cup half and half milk

1 cup buttermilk

✓ Add the persimmon Pulp and all the milk into the sugar mixture

1 ½ cup flour - sifted

2 teaspoons baking powder

✓ Mix together flour and baking powder, add to the mixing bowl, then stir in the two kinds of milk to the pulp mixture using a whisk. Add the flour before all the liquid is poured into the mixture.

Bake 350 degrees for 1 hour - Let cool, cut into squares and serve with homemade whipping crème.

Hints: An oblong 12 x 8 inch glass baking dish works best for baking the pudding. For glass the heat should be reduced to 325 degrees. Test the center of the pudding with a tooth pick. Continue to bake until the edges start to curl and the center test comes out clean. Refrigerate left over pudding, if there is any. The pudding can be made a day ahead. Actually, it tastes better when made ahead.

• Pudding pulp can be purchased at Gatewood Vegetable Farm, 9555 East 206th St., Noblesville. Take State Road 19 N toward Cicero, turn right onto 206th Street. Gatewood's Farm is between SR 19 and Cumberland Road on 206th Street, phone 317-773-1214.

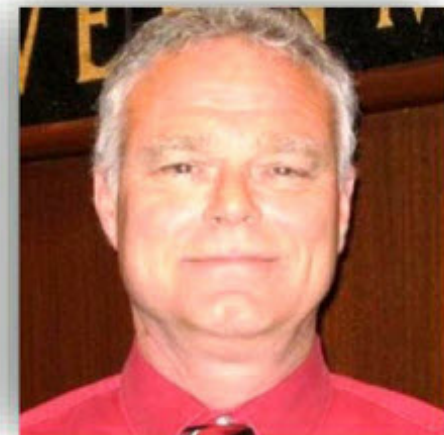

‘Hounds-Royals re-match takes place at HSE

Of all the Class 6A sectional semi-final football games being played tonight, one of the biggest clashes will be Carmel at Hamilton Southeastern.

The two teams will kick off their game at 7 p.m. at Reynolds Royals Stadium. They met back in the first week of the regular season, where HSE defeated the Greyhounds 27-21.

Since then, both teams have navigated their ways through tough schedules, but have each managed to come out with a winning record at the end of the regular season. Southeastern is 6-3, while Carmel is 5-4.

The Royals dropped their final two games of the season, falling to Waubonsie Valley (Ill.) 35-14 and to Hoosier Crossroads Conference champion Brownsburg 35-24. While it's not fun to have back-to-back losses, Southeastern coach Scott May is hopeful that the setback has made his team better and hungrier to win, saying that sometimes that wake-up call "is good for a team in the big picture."

Senior Adam Mullett has been solid as the Royals quarterback this season. In his nine games, Mullett has completed 159 of 290 passes, including 16 touchdowns, and gained 2320 yards over the air. Senior Matt Klink has caught the most receptions, with 46 for 558 yards and a touchdown, while senior Max Brooks has the most receiving TDs with seven and the most receptions yards with 588. Brooks has 33 catches overall.

On the ground, junior Jackson Sweeney has carried the ball 139 times for 793 yards, including seven touchdowns. Senior Alec Jessop has been the defensive leader, with 116 total tackles - 70 solo and 46 assists. Junior Johnny May has 102 tackles, with 64 solo and 38 assists.

Jake McDonald has also had a good year as the Carmel quarterback. McDonald is 118 of 179 in passing, with 1578 yards and 24 touchdowns. Jalen Walker has 12 of those touchdown catches; overall Walker has 43 receptions totaling 555 yards. Ethan Merriweather is next in line with 30 catches - eight of them TDs - for 449 yards.

Jerome Halsell has been a strong presence on the ground, with 132 rushes for 778 yards and six touchdowns.

Cross country

County will be well-represented at state meet

Hamilton Southeastern's Sabrina Bippus (290), Guerin Catholic's Paige Schemanske (272) and Westfield's Gabby Dilick (511) will all be running at this Saturday's IHSAA state cross country meet at the LaVern Gibson Championship Cross Country Course in Terre Haute. Bippus is one of two HSE individuals competing, while Schemanske and Dilick are running as part of their teams.

The Carmel girls cross country team will be running all over the LaVern Gibson Championship Cross Country Course in Terre Haute Saturday when the IHSAA state finals take place.

The Greyhounds also could very well be running all over the record book. Carmel will be going for a seventh consecutive state championship, which would add to its already record streak. In addition, Sarah Leinheiser will look to become only the sixth girl to win a second individual state title, adding to the blue ribbon she won last season.

The 'Hounds rumbled to a perfect score at the Shelbyville semi-state last Saturday, winning that event with 15 points, the lowest score possible. Carmel swept the top five, with Leinheiser leading the way in a time of 17:19.2. All five of those Greyhound runners finished their race under 17:50.

This will be the 36th edition of the girls cross country state finals, and Carmel has appeared in every one of them, the only school to do so. The Greyhounds have won 17 state titles and finished as runners-up eight additional times.

Five of the six schools that qualified out of the Shelbyville semi-state are from Hamilton County. Westfield will be competing in its 15th state finals; the Shamrocks are four-time state champions with wins in 1998, 2005, 2006 and 2007. Noblesville will run at the state meet for the ninth time. The Millers' best state finish is third place in 2006.

Fishers is competing in its fourth state finals. Guerin Catholic is a newcomer; the Golden Eagles qualified for state by taking sixth at Shelbyville. Hamilton Southeastern's Lulu Black and Sabrina Bippus will be competing as individuals.

Black finished sixth at semi-state with a time of 17:56.4, one of seven girls to break the 18-minute mark.

In the boys meet, look for another showdown between Hamilton Southeastern's Gabe Fendel and Oldenburg Academy's Curtis Eckstein.

The Oldenburg senior won the individual race at Shelbyville with a time of 14:34.4, while Fendel placed second in a time of 14:46.3. Those two runners were far and away the fastest; the third-place time was Cathedral's Cole Hocker, who clocked in at 15:20.9.

The Royals are one of three teams competing at the meet. Carmel and Fishers are the others. The Greyhounds won the Shelbyville semi-state with HSE the runner-up and the Tigers placing third.

Carmel's boys are looking to defend their state title, and add to their state-leading overall total of 14. This will be the Greyhounds' 43rd appearance at state - Carmel hasn't missed a state meet since 1975. Only Bloomington South has more state appearances with 45, but it did not qualify this year.

Southeastern will be running at state for the 12th time; the Royals finished as runners-up back in 2011. Fishers will be making its sixth appearance at state, all since the school re-opened in 2006. The Tigers made it to state in that very first year, and then won the state championship in 2007.

Four individuals will be competing at state: Guerin Catholic's Quinn Gallagher, Noblesville's Levi Neuzerling and Westfield's Aaron Bennett and Nicholas Leahy.

Steve Helmich named IHSAA Foundation President

IHSAA Commissioner Bobby Cox announced today that Steve Helmich, former president of Cathedral High School, has been named the first president of the new IHSAA Foundation.

In his role as chief administrator, Helmich will oversee the day-to-day operations of the Foundation including the development and fundraising efforts to support its programs and the distribution of scholarships and grants. He will begin his duties on Nov. 14.

Helmich joins the Association following a 16-year career as president of Cathedral High School where he oversaw one of the largest Catholic, private, independent high schools in the Midwest. Included in his many responsibilities was serving as chief fundraiser for the institution where his efforts resulted in nearly \$3 million annually for the Cathedral Fund and oversight of four highly-successful capital campaigns during his tenure. He is currently affiliated with three boards of directors – the Center for Leadership Development, One America Fund and the Damar Foundation – and previously the Indiana Non-Public Education Association.

Prior to Cathedral, Helmich served as president of the Community Education Coalition in Columbus, Indiana as well as president/CEO of the Columbus Area Chamber of Commerce. He also worked as president/CEO of the Richmond-Wayne County Chamber of Commerce and Executive Director of the Richmond Family YMCA.

"The IHSAA Foundation is very fortunate to obtain the expertise and excellence of Steve Helmich," said Cox. "The combination of all his professional experiences provides a robust portfolio by which our Foundation will grow and prosper. I greatly look forward to working with Steve as we collectively labor to build a dynamic organization benefiting IHSAA member schools and Hoosier student athletes."

A graduate of Indiana University, Helmich earned Big Ten All-Academic honors in football as he obtained a B.S. degree in education and a M.S. degree in secondary education and went on to spend 12 years as a classroom teacher and athletic coach at Noblesville, West Lafayette, Richmond and Columbus North high schools.

"I am honored for this great opportunity to lead the IHSAA Foundation," said Helmich. "Indiana high school athletics helped shape my life from my formative years through my adult life and I look forward to building this Foundation which will have a profound impact on the lives

of the young men and women who will participate in high school athletics in our state."

The IHSAA Foundation was created and formed by the Executive Committee in June 2015 to operate exclusively for the charitable benefits of IHSAA member schools and their student-athletes. As funding becomes available, the IHSAA Foundation will award college scholarships to student-athletes in their pursuit of post-secondary education. It also will support IHSAA member schools through a grant program designed to help fund special projects.

The Foundation is overseen by a Board of Directors which include: J. Terry Clapacs, Vice President Emeritus of Indiana University; Dr. Phil N. Eskew, Jr., retired Director of Physician and Patient Relations at St. Vincent Hospital and current professor at the IU School of Medicine; James T. Morris, Vice President of Pacers Sports & Entertainment; Blake Ress, Commissioner Emeritus of the Indiana High School Athletic Association, Inc.; Patrick Shoulders, partner in the Evansville law firm of Ziemer, Stayman, Weitzel Shoulders, LLP; Milton O. Thompson, Attorney, Indianapolis law firm of Bleeke Dillon Crandall; and Jennifer K. Wilfong, Vice President and Executive Coach at Merrill Lynch; and Bobby Cox, IHSAA Commissioner. Eskew serves as chairman of the group.
