It was in that same year, on March 11, that Hamilton County Parks and Recreation was established. From its modest beginning, the county agency that owned virtually no land, and comprised of a park board and only a few dedicated part-time staff, grew into today's highly-regarded park system. As of 2017, the park department is responsible for the management of twelve

(and increasing) county parks, one campground, and three miles of the Monon Trail; all located on more than 1,550 acres of land throughout Hamilton County. In addition, the department provides quality nature education programming and facilities, and stages popular community events throughout the year.

Hamilton County and its park department have experienced significant change and growth since 1967. One constant has remained in that fifty year span of time - the tireless dedication of a park staff committed to providing county residents and visitors the very best in recreation and nature edu-

Early morning fire in Fishers injures one

A fire on Highland Springs Drive in Fishers early Wednesday morning sent one person to the hospital. Thirty-three firefighters were on the scene and had the fire under control in 25 minutes.

Fishers firefighters responded to 13164 Highland Springs Drive for a residence fire Wednesday morning at 4:32 a.m.

Fire Investigators determined the cause of the fire was an unattended candle which caught bedding on fire, in a bonus room above the garage.

One occupant was transported with serious injuries to Eskenazi Hospital. A second had minor injuries and four additional occupants were able to escape the house without injury.

Fire official credited the owner of the residence for performing a very important task prior to exiting the home, and that was to shut the door to the room that was on fire. This action kept the fire from spreading to the rest of the house until firefighters were able to get on the scene and extinguish the blaze.

Firefighters encourage residents not to use candles, but if you choose to do so, never leave unattended or burning while sleeping.

Thirty-three firefighters were on the scene and had control the fire in 25 minutes. Firefighters were assisted by Fishers Police Department to control traffic around streets blocked by hose.

Carmel prepares businesses, community for 96th Street project

After months of outreach to individual business owners and community members, the City of Carmel is preparing to unveil more detailed drawings and plans for this year's launch of the two-year 96th Street Corridor Improvement Project, scheduled to get underway this spring. The City will be transforming traffic flow and improving access to businesses along this busy corridor from White River to Keystone Parkway, focusing on five intersections in 2017, with substantial completion by the end of 2018.

"We are being proactive in getting the word out about this exciting project that will better serve motorists traveling to and from Fishers and Indianapolis. Similar to the efforts made when we upgraded Keystone Parkway several years ago, we have focused our efforts on making sure our local business owners are prepared for the upcoming construction," said Mayor Jim Brainard.

"Since Hamilton County built the bridge over White River, traffic has continued to grow along this corridor, which is home to a number of car dealerships and businesses. Our experience has shown that by replacing these congested intersections with roundabouts, we will make this corridor safer and easier to use, especially for commuters."

The City plans to meet again with groups of local car dealers, restaurants and other businesses over the next few weeks to continue the outreach with the new updated plans. Neighborhood group meetings are also being scheduled for residents who live in the vicinity and will be impacted by construction. The most updated information available to the public is already posted on the Carmel Link 2.0 website, which is the home for all information regarding to Carmel's road construction projects.

Motorists can also download the Carmel Link 2.0 Mobile App for instant updates on your phones and devices.

Although 96th Street is shared by both the City of Carmel and the City of Indianapolis, state law requires that Cities on the north side of such common roadways handle all matters of construction, reconstruction, improvements and maintenance. An estimated average of 85,000 vehicles use 96th Street and Keystone Parkway each day with traffic studies indicating that number will increase dramatically over the next 5-10 years.

The list of corridor projects will serve commuters, shoppers and visitors by considerably reducing congestion along the 5-lane corridor across the southern border of Carmel. The cost of the corridor projects

Hamilton East Public Library announces plans for change

Hamilton East Public Library has begun the initial stages of renovating, remodeling and rejuvenating both the Fishers and Noblesville Libraries. When complete, library users will experience collaborative workspaces with fresh innovative furnishings to allow for greater flexibility in how individuals and small groups use the community gathering space. Both buildings will welcome more open concept entrances, complete with decentralized service stations and electronic signage.

Highlights of the plans include virtually all new spaces and functions in the lower levels at both buildings. In Noblesville, the children's area will be transformed with a new youth friendly theme, complete with an outside entrance and additional programming and gathering space. In Fishers, the space formerly occupied by Launch Fishers will become an arts-focused maker space. The library once again worked with Fishers start-up Iconic Digital Marketing to brand and designate the space as "Ignite Studio at HEPL", a place where ideas are sparked. While plans are not finalized, it promises to offer a variety of activity spaces for an assortment of art interests from painting and fabric arts to digital and video editing.

Library Director Edra Waterman is enthusiastic about

the new spaces and opportunities ahead. "Our plans have been in the making for several years now. Based on our latest strategic plan, it was clear that while we had a lot of space to offer, that space was not ideal for the changing needs of our users. Having met with various public groups, including those inside and outside of the arts community, we recognized a real need and desire to make available more unique spaces and services and to create flexible, dynamic environments that foster creativity and innovation." shared Waterman.

The first phase of the transformation is scheduled to begin as early as mid-2017 and estimated to take up to 2 years to complete.

is estimated to be approximately \$43 million, with \$8.5 million coming from federal exchange dollars administered through the Indiana Department of Transportation, \$2 million from Hamilton County, \$1.9 million in federal Congestion Mitigation & Air Quality improvement program funds and the rest from local County Option Income Tax bonds.

Construction plans call for the replacement of traffic lights at key intersections with roundabouts. Those intersections include:

- 96th Street and Hazel Dell Parkway
- 96th Street and Gray Road
- 96th Street and Delegates Row
- 96th Street and Priority Way
- 96th Street and Keystone Parkway (preliminary work begins in 2017)

The Keystone Parkway portion of the project will include construction of a major new interchange in 2018 with grade separation – Keystone will be elevated over 96th Street – and roundabout controlled ramps similar to other Keystone Parkway interchanges from 106th Street to U.S. 31 at 146th Street. After preliminary work this year, the interchange will be largely completed next year in a project that will include the incorporation of one more intersection improvement, 96th Street and Haverstick Road, west of Keystone.

The City plans to maintain traffic throughout the project – one lane open in each direction – although restrictions will be in place as each intersection is upgraded. In addition to the road work, construction will also include curbs and gutters to better collect and mitigate storm water and multi-use paths along the north side of the road to increase much-needed pedestrian connectivity.

Construction is expected to start in summer 2017 at Delegates Row and Gray, in September at Priority Way and Hazell Dell and will begin with construction of roundabouts. Each of those will be completed by the end of the year. Additionally in September, look for preparation work to begin in the right of way areas (but off the roadway) for the 96th and Keystone interchange project.



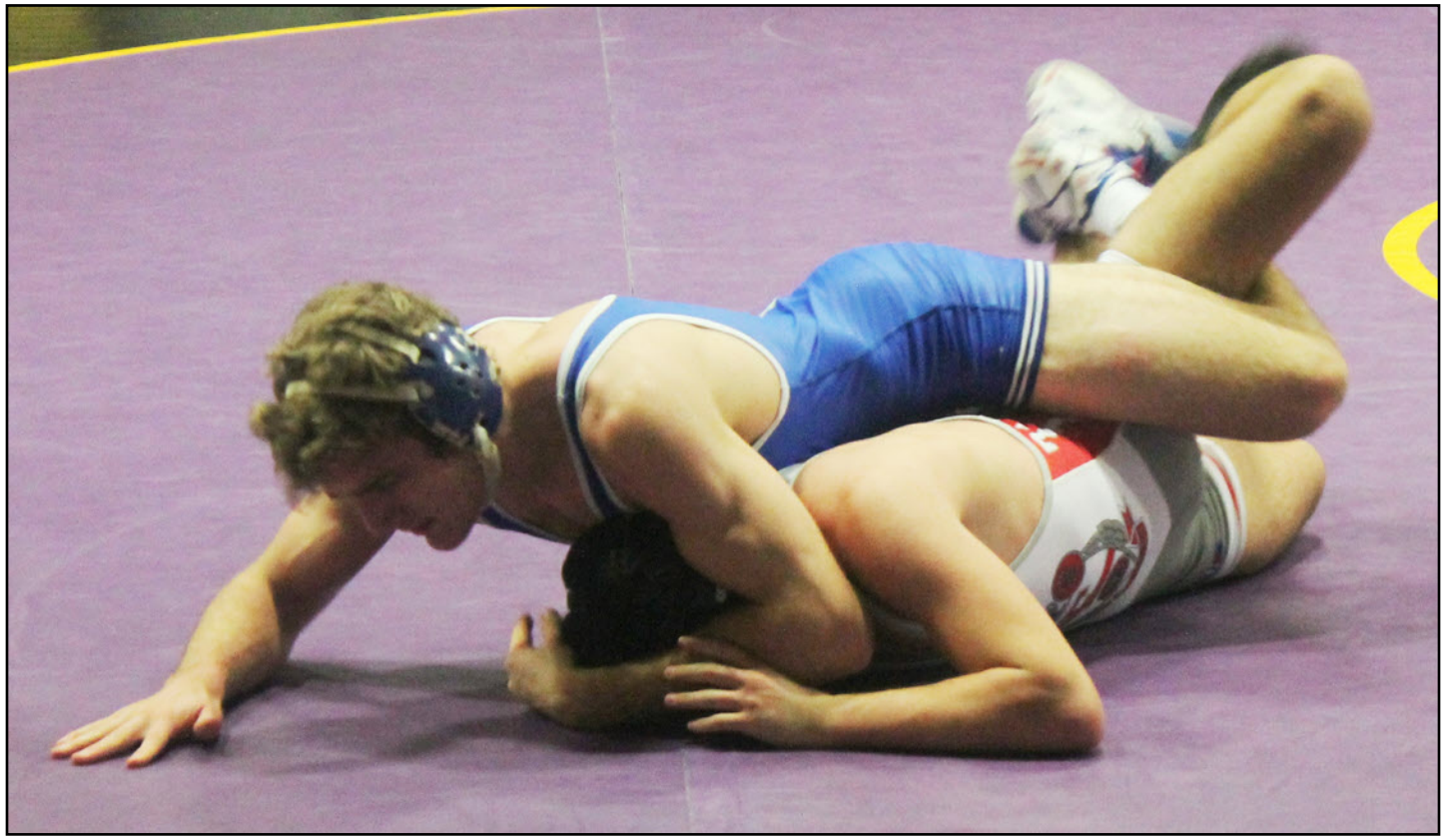

State wrestling finals set for this weekend

Two hundred twenty-four wrestlers, including seven from Hamilton County, will begin their quest for a state championship Friday evening at Bankers Life Fieldhouse in the IHSAA state wrestling finals.

The wrestlers - 16 in each of the 14 weight classes - will begin first round competition at 6 p.m. on Friday. First-round winners will return to wrestle on Saturday with quarter-final action beginning at 9:30 a.m. and semi-final matches to follow after all weight classes have concluded. Consolation bouts begin at 5 p.m. and championship matches under the spotlight are scheduled for 7:30 p.m.

Team scoring will begin with Friday night's preliminary matches. Scoring will go to eight places and, additionally, two advancement points will be awarded per match for a championship bracket victory while one (point is earned for advancement

in the consolation bracket.

Finally, points will be awarded to the top eight place-winners: 1st place: 16 points; 2nd place: 12 points; 3rd place: 9 points; 4th place: 7 points; 5th place: 5 points; 6th place: 3 points; 7th place: 2 points; 8th place: 1 point.

Six defending or former state champions are part of this year's field led by Lowell senior Colton Cummings who will attempt to become the 36th wrestler in state history and first from his school with at least three state crowns. He is 25-2 on the season and competing in the 126 pound class after winning the 113 title last year and the 106 crown in 2015.

One hundred twelve schools will be represented at this weekend's state finals with Brownsburg's and Portage's eight qualifiers and seven each from Indianapolis Cathedral and Yorktown leading the way.

Chesterton and Yorktown led the state with four semi-state champions each last weekend.

Warren Central is the defending state champion after winning its second crown in school history a year ago (also 1980). The Warriors of head coach Jim Tonte, who became the first coach to lead two different schools to the state title (also Perry Meridian in 2011, 2012, 2013), have two entries this weekend including 195 pound semi-state winner and last year's state runner-up Tristen Tonte (36-1) and semi-state runner-up at 113 pounds Skylour Turner (30-5).

Carmel, Westfield and Hamilton Southeastern each have three qualifiers at state, while Noblesville has one.

Big run sends Cavs past Pacers

In a game full of runs from both teams, the Indiana Pacers fell victim to the biggest run of the night as the Cleveland Cavaliers defeated the visiting Pacers, 113-104, on Wednesday night at Quicken Loans Arena.

Cleveland (39-16) used a 23-6 run after the Pacers tied the game early in the fourth quarter to break the game open and get a comfortable win.

The Pacers (29-27) got off to a fast start on the night, reeling off eight straight points after Cleveland's Kyrie Irving hit two free throws on the game's first possession.

Paul George (eight) and Jeff Teague (five) combined for Indiana's first 13 points of the game before Kevin Seraphin hit a jumper to extend the Pacers' lead to 15-9. Indiana led by as many as eight points, 20-12, midway through the first quarter before Cleveland starting chipping away at the lead.

The Cavs tied the game at 28 with 33 seconds to go, but the Pacers scored the last four points of the frame, including a Monta Ellis steal and fast break layup with five seconds left to give Indiana a 32-28 lead heading into the second quarter.

George ended up with 10 first quarter points while Teague added six assists.

The second quarter featured sizeable runs from each team. Cleveland started the quarter with a 14-2 stretch to take a 42-34 lead. But the Pacers responded right back with a 9-2 run to cut the deficit to one, 44-43.

The Cavs then built a 54-46 lead before Teague and Ellis each hit 3-point shots to get the Pacers back within two.

Cleveland's LeBron James briefly left the game in the second quarter after turning his left ankle. He returned to finish out the half and led all scorers at the break with 18 points.

Teague and Myles Turner led the Pacers with 11 points, while George was held scoreless in the second quarter after those 10 first quarter points. Teague had eight assists in the half and Turner grabbed five rebounds, as did George.

The game of runs continued in the third quarter, as the Cavs began on an 11-5 run to build a 68-59 lead. Glenn Robinson III scored those five points for Indiana, helping keep the deficit manageable.

Cleveland extended its lead to 12, 78-66, on a James layup with 3:11 to go in the third. The Pacers took a timeout and responded with a 10-0 run sparked by six straight points from C.J. Miles.

Miles was fouled on a 3-point attempt and made all three free throws and then hit a 3-pointer on Indiana's next possession to cut Cleveland's lead to 78-72. Two Teague free throws and a bucket from Al Jefferson capped off the run.

Irving hit five free throws to finish out Cleveland's scoring in the quarter. Ellis found Robinson on an alley-oop with one second left to make it a one-possession game, 83-80, heading into the fourth quarter. Ellis also had seven points in the quarter.

Robinson hit a 3-pointer to start the fourth quarter and tie the game at 83. However, Cleveland responded with that 23-6 run — which included five 3-pointers — to break the game open.

Kyle Korver hit three triples during the run and Irving added a pair as Cleveland led by as many as 17, 106-89.
