## Chief Tim Green to retire . . . Jim Barlow named Carmel's new top cop

Mayor Jim Brainard has appointed Jim Barlow as the new Carmel Police Chief. He will replace the retiring Chief Tim Green. In addition, the Mayor has appointed two new Assistant Chiefs - Jeff Horner to oversee Administration and Aaron Dietz overseeing Operations. The changes will become effective June 1.

"I am pleased to promote Jim Barlow to the role of our next Police Chief," Mayor Brainard said. His experience in Carmel and his knowledge of law enforcement make him perfect for this role. I also wish to thank Chief Green for his many years of service. We wish him well in his retirement."

Jim Barlow has been a member of the

Carmel Police Department for 34 years, the last six years serving as Assistant Chief. During his tenure, he also served as Commander of the SWAT team, as well as Commander of the Operations, Special Investigations, and Support Divisions. Barlow received a Bachelor's Degree from

## 5 Points roundabout construction begins

The 5 Points roundabout at Greenfield Avenue, 10th Street and Christian Avenue will begin construction on Monday, April 24 – weather permitting. Currently, the intersection has a traffic signal that must cycle through three roads. The roundabout design provides a safe, effective intersection without a stoplight and creates a new southern gateway into the City of Noblesville.

Work is expected to last 60 days and the roundabout will be open by early July. During construction, Greenfield Avenue and 10th Street will remain open. Flaggers

will be onsite when lane restrictions are necessary to assist with traffic. For the first 30 days, Christian Avenue will be closed at the intersection. Afterwards, as work continues, Christian Avenue will have periodic closures.

"While Greenfield Avenue and 10th Street will remain open, we want to remind motorists to expect delays and slower travel times as the project is under construction," City Engineer John Beery said.

The city has designated a detour route

## State Road 37 upgrade moving full speed ahead

The State Road 37 upgrade project is moving full speed ahead, with 40% of the design work already completed. There may be some lane restrictions this spring and summer, but the construction will get underway in earnest during July of 2018 and should be complete by fall of 2020.

As the plans stand now, two lanes of traffic will be maintained north and south along State Road 37 in Fishers, with a few lane restrictions occasional-

ly. The first two interchanges to be constructed will be 141st and 131st Streets. East-West traffic will be blocked as each bridge is constructed. Once the first two interchanges are complete, 126th and 146th Street interchanges will be built.

One contentious issue over drainage along 141st Street was resolved by routing the drainage north to 146th Street, then routed west from SR37.

Traffic engineers say they will be watching traffic flows carefully as the construction begins. Once officials see

## Sen. Todd Young speaks at Lincoln Day Dinner

Hamilton County Republicans staged their annual Lincoln Day Dinner Wednesday night with U.S. Senator Todd Young, introduced as a hometown boy, as the featured speaker. Young, who defeated Evan Bayh in last fall's election, spent his early years in the county graduating from Carmel High School in 1990.

Although 2017 is not an election year, one would hardly know it as several early candidates for next year's GOP primary were present. Four hopefuls seeking to unseat Sen. Joe Donnelly were introduced. They are Mark Hurt, Terry Henderson, Luke Messer and Todd Rokita. Besides the Senate candidates there were candidates and likely candidates for county sheriff in attendance. Only Bill Clifford and Jason Sloderbeck have publicly announced their intentions, but two or three others were circulating in the crowd scouting the political landscape and meeting party workers.

You may believe that only old music is respectable, or that nothing can beat a hot day and an ice cream cone from Twin Kiss, and that is completely understandable. However, the past in and of itself is not great. In many ways it was a dark time of racism, sexism, and homophobia, as well as a time of progress. Nostalgia is good, great even, but we as a country cannot place priority on wishing for a possibly falsely "great" past. Instead we must look to the unsure future to not *Make America Great Again*, but to make it better in the name of equality and justice.

# Hoosier Heritage Port Authority begins search for new Nickel Plate operator

A new operator for the Nickel Plate railroad line could be chosen by July or August. However, since there is no operator at this time, there will be no Indiana State Fair Train in 2017. The Hoosier Heritage Port Authority, which has oversight and maintenance responsibilities for the 37 miles of rail line, which extends from Tipton to downtown Indianapolis, will begin the process of legal advertising the details about requests for proposal from interested parties.

Authority President Mike Obergfell said the request for proposal will contain a scoring sheet to evaluate each submission. The owners of the rail line – Fishers, No-

blesville and Hamilton County – will then interview all the candidates. Obergfell expects the operator will be selected at the next Authority meeting scheduled for Monday, July 10th. However, if the interviews continue through July, a special meeting of the Authority will be scheduled in August. "Obviously, the time is short," said Obergfell. "We'd like to get an operator back online as soon as possible. Our owners have some other interests that they're trying to work out. So, the sooner the better." Fishers and Noblesville have proposed transforming the Nickel Plate rail line within their city limits into a biking and hiking trail. An independent inspection of the rail

raised safety concerns about the condition of the track, resulting in the cancellation of the State Fair Train in 2016, which ran for many years between the fairgrounds and Fishers. In response to a question from the audience, Obergfell said there will not be an operator in place in time to operate the State Fair Train in 2017. In response to another question from the audience, Obergfell said the request for proposal includes the entire 37 mile line. In another matter, the Authority will be losing Executive Director Rhonda Klopfenstein, who has been in that job for 17 years. Members of the Port Authority will now be searching for a new executive director. Klopfenstein is resigning due to her husband's job reassignment to Tennessee.

"As a gateway into Noblesville from the south, this roundabout will be getting similar treatment to other gateways," Beery said.

All businesses in the area will remain open and access to them will be available. In addition to the intersection, the project

will resurface Greenfield Avenue from 10th Street to Stony Creek Bridge (16th Street) and alleys directly adjacent to the intersection.

The City of Noblesville has been working with Noblesville Schools and its transportation team to address any potential issues between now and when school ends given the proximity to Stony Creek Elementary School.

As my sister and I began to grow the business, we were big on getting people trained and figuring out a way to help them become the absolute best at what they did. When we first entered the business, we learned the importance of "20 Groups". Twenty Groups are a group of twenty dealers of similar size that meet three times a year to exchange "ideas" on how to better operate the business. Furthermore, each of the twenty dealers shares their monthly financial statement and is ranked in a composite based on the best to the worst. This is done on a monthly basis.

Thus, one can see who is doing the best job in each department. For example, one person might be great at used vehicles or have a super service department. One can see how they are doing and thus, ask questions to help improve one's department.

As a result of these meetings, we began to expand certain areas of our business and some of the ideas helped us to become the largest Chevrolet Dealer in the State of Indiana. There were numerous ideas that we took back home and implemented. I will just list a few of our favorites and how they affected our business.

A cool thing about Twenty Groups is that they meet three times a year in some very awesome areas of the USA that we probably would not have visited had it not been for these meetings. I remember attending one meeting in Nantucket and we had a new member to our group. I sat next to him and we started talking about how many vehicles we sold. At that time we were both selling approximately 330 units per month. However, he was selling 300 used units and 30 new units while we were selling about 175 new units and 155 used units. As I sat next to

him during the meetings, I decided that we had to see his operation.

Thus we took our key managers to the rough side of Chicago to visit his dealership. We learned about developing a Business Development Center, about using Postcards to "get people's attention", and how to develop better relations with the banks so that we could "attempt" to get more people approved for financing. As a result of some of these ideas, we would eventually get our used vehicle business up to about 250+ used units sold per month.

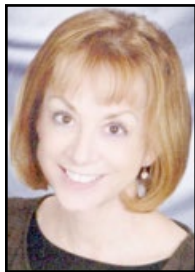
On a different occasion I was on stage at an event with a dealer from Ohio and we started discussing what was helping our Dealerships. He mentioned that he had a lot of luck with a computer program that showed when customers were in an equitable position to trade vehicles. We immediately contacted the guy that set him up with the computer program and began contacting our own customers on a regular basis. Suddenly, we were doing an additional 35-45 car deals just from this process.

My sister found a dealer who was having incredible luck with selling prepaid maintenance. She contacted the dealer and we signed up with the vendor the dealer recommended. We became a huge seller of prepaid maintenance. We started having dealers from all over the Country contacting us to find out how to best setup a Prepaid Maintenance Program.

We learned the importance of continuous learning and how we could find something small from a dealer somewhere in the United States and thus, we could continue to grow our business. Thus we developed the saying, "there are riches in niches" and every year we worked on getting both our people and ourselves in constant training so that we were always developing ways to increase our business. Furthermore, it also gave us an opportunity to travel and see different parts of the Country and the different ways that successful people do business.

# Be flexible, be safe

Typically, I address topics of nutrition as well as the importance of strength and aerobic conditioning, but I find that the subject of flexibility and movement is the most neglected area of fitness. I ask my clients to envision a triangle with each point being strength training, aerobic conditioning, and flexibility. In the middle of the triangle is nutrition. As I have often noted here that without proper nutrition, the fuel for the body, the rest will not be as effective for those people focused on a lifestyle that is active and enjoyable.

In noting the quote, I have used this week to introduce my topic you may think, well sure, but Edwin Moses is an Olympic athlete, not exactly my profession and I don't train my body the way he did. True, but remember that as we age it takes less and less activity to result in injury. Missing a stair step, tripping over a cord or small pet (yikes!) pulling an item that is too heavy from a shelf - you get the picture. As a child or young adult these actions or reactions are insignificant, and even if we did suffer a sprained ankle or wrist the recovery was relatively quick and complete. Baby Boomers, those days are gone. Our best hope is to remain strong, flexible, and balanced.

Going back to the quote above attributed to Mr. Moses, do you know that Olympic and professional athletes attribute stretching and flexibility as the most important part of their training? Gymnasts, runners, boxers, skiers, skaters, you name

it! They know that without a great deal of flexibility they are much more prone to injury which could knock them out of competition and out of a profession! In addition to increasing balance and flexibility, regular stretching transports oxygen and removes toxins from muscles, improving athletic performance.

Dynamic stretching, or stretching by moving through a challenging but comfortable range of motion repeatedly usually 10-12 times, should not be confused with old-fashioned ballistic stretching which involves a bouncing movement and which you may recall from PE classes in days gone by!

As I have mentioned previously in my columns here, although I worked in executive management for many years, I pursued my credentials in both fitness training and in nutrition and wellness coaching. For over 20 years I have enjoyed pursuing these interests when time allowed to do so but now that I am retired/rewired I have the flexibility (I couldn't resist!) to pursue my avocation. That is why I teach a class called "FlexAbility" - because I know that increased flexible movement and stretching will add a very positive dimension to our lives as we age. I have acquired additional training and certification in Full Body Flexibility and Balance Progression and I look forward to working with more groups as well as one-on-one training.

Another caveat to increased flexibility training? How about improved muscle tone, coordination, and stronger bones? Watch for another article soon on more in-depth descriptions of the different types of stretching and how you can benefit.

# Students work to help their peers "Think about it . . ."

This week, Sheridan SADD (Students Against Destructive Decisions) will launch a campaign called "Think About It..." to raise awareness for prom and graduation safety. One focus of the campaign is to raise awareness about the risks involved with underage drinking. Unfortunately, the majority of adolescents still report using alcohol before it is legal for them to do so. We must support local law enforcement efforts and refuse to accept preventable deaths caused by underage drinking.

Heavy drinking is especially dangerous for teenagers, whose brains are still developing, and alcohol-related damage incurred at a young age can have long-term effects. A study by the National Institutes of Health suggests that the region of the brain that inhibits risky behavior is not fully

formed until age 25. This information serves as a wakeup call to parents, physicians, elected officials, law enforcement officials, purveyors of alcohol - including the alcohol industry - and teens themselves. Many people believe that underage drinking is an inevitable "rite of passage" that adolescents can easily recover from because their bodies are more resilient, but the opposite is true.

To foster a greater understanding of the widespread issue of underage drinking and how it affects our community especially during prom and graduation season, Sheridan SADD is asking those in the community to continue supporting all efforts to stop friends or relatives who are over 21 from providing alcohol to minors and to remind those under 21 that the message is clear: purchase and possession of alcohol are against the law.

### What adults in the community can do

- Endorse alcohol education programs in your community, schools, and businesses.
- Support your local police and licensed beverage outlets by obeying the law.
- Remind your friends and family: for those under 21, purchase and possession are against the law.
- Support this and other SADD sponsored initiatives in your community.

where the motorists are detouring, adjustments can be made. Temporary traffic signals and stop signs are just two of the tools available to handle traffic overflows during construction.

Traffic Engineer Troy Woodruff cautioned those at the Tuesday night meeting that these are the plans for now... there could be changes as design work and data are evaluated.

An environmental impact hearing will be conducted on May 16th, 6pm, at Fishers High School. Citizens may testify and ask questions, but officials will not be able to answer those questions on the spot, the answers will come in writing later.

The State Road 37 improvement project will cost \$124 million, with \$100 million from the state and \$12 million each from the City of Fishers and Ham-

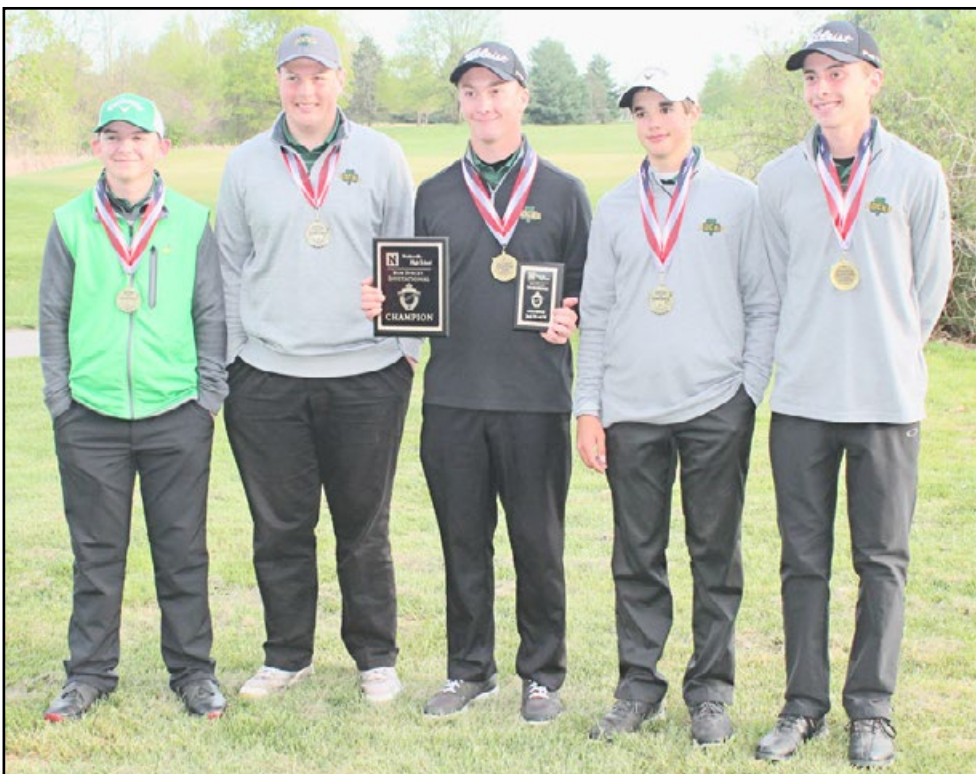

The approving opinion of Ice Miller LLP, bond counsel, together with a transcript of the proceedings relating to the issuance of the Bonds and closing papers in the usual form showing no litigation questioning the validity of the Bonds, will be furnished to the successful bidder at the expense of the School Corporation.

The 2017A Bonds are being issued for the purpose of the renovation of and improvements to Cumberland Road Elementary School and Hamilton Southeastern High School, and maintenance improvements throughout the School Corporation. The 2017B Bonds are being issued for the renovation of and improvements to school facilities, including the Central Administration Office. The Bonds will be direct obligations of the School Corporation payable out of ad valorem taxes to be collected on the taxable property within the School Corporation; however, the School Corporation's collection of the levy may be limited by operation of I.C. 6-1.1-20.6, which provides taxpayers with tax credits for property taxes attributable to different classes of property in an amount that exceeds certain percentages of the gross assessed value of that property. The School Corporation is required by law to fully fund the payment of debt service on the Bonds in an amount sufficient to pay the debt service, regardless of any reduction in property tax collections due to the application of such tax credits. The School Corporation may not be able to levy or collect additional property taxes to make up this shortfall. The School Corporation is a school corporation organized pursuant to the provisions of I.C. 20-23; the Bonds will not be "private activity bonds" as defined in Section 141 of the Internal Revenue Code of 1986, as amended.

The Bonds constitute an indebtedness only of the School Corporation. In the opinion of bond counsel, under the existing federal statutes, decisions, regulations and rulings, the interest on the Bonds is exempt from all income taxation in Indiana. In the opinion of bond counsel, under the existing federal statutes, decisions, regulations and rulings, the interest on the Bonds is excludable from gross income for purposes of federal income taxation.

The School Corporation has prepared a Preliminary Official Statement (the "Preliminary Official Statement") relating to the Bonds which it has deemed nearly final. Within seven (7) business days of the sale, the School Corporation will provide the successful bidder with up to 200 copies of the Final Official Statement (the "Final Official Statement") at the School Corporation's expense. Additional copies, at the Purchaser's expense, must be requested within five (5) business days of the sale. Inquiries concerning matters contained in the Preliminary Official Statement must be made and pricing and other information necessary to complete the Final Official Statement must be submitted by the Purchaser within two (2) business days following the sale to be included in the Final Official Statement.
