## Bragg announces run for District 29

Garen T. Bragg, Noblesville, a conservative Republican, an insurance producer and officer in the Army National Guard announced Friday he will run for Indiana State Representative in District 29.

Bragg has high praise for departing State Representative Kathy Richardson, saying "she has been a strong leader in the statehouse for years. She leaves big shoes to fill."

"Hamilton County deserves a fresh,

conservative voice in the statehouse," Bragg said. "I will fight for our shared values, for stronger schools and to make our economy more competitive. Through over six years of service in the Army National Guard I have learned what it means to serve. I am pro-life, a supporter of the second amendment and unashamed to stand for our religious liberties. I

In his **announcement video** uploaded to Facebook and YouTube, Bragg noted that "leaders behind closed doors" decided to rip out the Nickle Plate Railway in Noblesville. "We have to wonder, are they even listening?" Bragg continued, "I will fight to save the train."

Bragg says that most voters want to see a fresh face and a conservative vision in the legislature instead of the backroom dealing offered by established politicians. "Listening to the voice of the people is what should guide our government. If elected, I will listen."

## Sheriff, Coroner release details in Christmas Day double murder-suicide

Hamilton County Sheriff's Office officials released details in what is now classified as a murder-suicide on Christmas Day in Noblesville. Deputies were first called to the 11200 block of East 191st Street around 4:35 p.m. on Dec. 25 on a report of a shooting. As officers arrived, they discovered three bodies inside a residence. The deceased have been identified as Donald Moon, 84, his wife Joyce Moon, 81, and their son Todd Moon, 48.

According to investigators, the incident may have started on the afternoon of Monday, Dec. 25 when Todd Moon contacted a family member to come to the home on East 191st Street where he resided with his parents and his two juvenile children. When the family member arrived, detectives report there appeared to be an argument between Todd Moon and his mother Joyce Moon. The argument escalated to the point when Todd Moon retrieved a handgun and shot his mother. Investigators believe Todd Moon then went to a back bedroom where he shot his father, then returned to the front of the home where he shot himself in the head.

The family member quickly took the children outside to a vehicle and drove to Noblesville Fire Station 75, a short distance away from the residence. During this time, an attempt was made to call 911 but was misdialed so the initial 911 call was made by a third-party family member.

Noblesville Police officers who arrived first at the scene

found three bodies inside the residence. Hamilton County Sheriff's deputies arrived shortly after and assumed investigatory responsibilities. Joyce Moon was found in the front hallway, Donald Moon was in a rear bedroom, and Todd Moon was found near the kitchen. A medic at the scene confirmed all three were deceased.

A search of records indicat-

ed the Sheriff's Office had not responded to the residence for any calls other than a potential telephone fraud several years ago. There were no criminal charges in the backgrounds of any of the individuals involved, nor was there a known history of mental illness or domestic violence. No note was found, and detectives are still working to ascertain what may have led to the incident or the

cause of the argument.

Autopsies were conducted on Wednesday and, according to the Hamilton County Coroner John Chalfin, preliminary indications are Donald and Joyce Moon died from multiple gunshot wounds while Todd Moon died from what appeared to be a self-inflicted gunshot injury. Although toxicology results are pending, investigators do not believe alcohol or drugs were involved in the incident.

Children living at the residence are receiving care from the Indiana Department of Child Services and are staying with family members.

## Survey results are in, Noblesville Parking Task Force moving forward

Parking in downtown Noblesville has been the focus of numerous studies conducted by city officials over the past several years, and until now, not much information has been made public.

Noblesville began taking a serious look at downtown parking in 2015 when Mayor John Ditslear appointed a Parking Task Force. The Task Force is chaired by Bob Dubois, President of the Noblesville Chamber of Commerce.

Dubois's group, a panel of residents and downtown merchants, was challenged with determining if a parking problem exists, and if so, recommendations to correct the problem.

One of the first actions taken by the Task Force was to survey residents and downtown business owners. The survey primarily addressed the two-hour free parking limit, overall parking capacity, wayfinding parking signage and a downtown parking garage.

The Task Force's survey focused on an area identified as Wayne Street south to Division Street and 16th Street west to White River.

Of those responding to the survey,

## INDOT proposes changes for State Road 32

The Indiana Department of Transportation (INDOT) will hold a public hearing on Wednesday, Jan. 10, 2018, with a formal presentation beginning at 6 p.m., at the Hazel Dell Elementary School Cafeteria, 3025 Westfield Road, Noblesville, to present proposed plans for a State Road 32 redesign.

The project proposes to widen the existing lanes and add a second westbound travel lane on SR 32 in the project area to match

the five lanes existing east of the project.

The overall project proposes added travel and turn lanes between Cicero Creek and State Road 38 west junction.

West of the River Road intersection, the outside westbound lane will become a right turn lane serving two major commercial entrance drives. A northbound right turn lane will be added at the River Road intersection and a westbound right turn lane will be added at the SR 38 intersection. The turning ra-

dius will be increased in the northeast corner at SR 32/River Road. In addition, new sidewalks and a new closed storm sewer will be added to SR 32 between River Road and SR 38, and replacement of two traffic signals. The project will require 0.15 acre of new permanent right of way. In addition, temporary right of way will be needed for the reconstruction of driveways along the project.



# None injured in Friday Fishers fire

Fishers firefighters battled a house fire around 11:30 a.m. Friday as well as cold temperatures.

Fortunately, a family of three was not injured when the occupant noticed a fire on the front porch.

Early indications of the cause are from old ashes from the fireplace that were placed in a non-metal container, which the homeowner believed to be cool.

The damage is significant, but the exact cost of the loss is unknown at this time.

The fire, which was in the 10800 block of East 116th Street, caused the

street to be closed for over two hours.

The house sits back over a thousand feet from the street and firefighters used over 1,500 feet of hose to connect to the hydrants for water supply.

Firefighters remind homeowners with fireplaces to place ashes in a metal container and that ashes can remain hot for numerous days. Wet liberally with water and keep away from structures.

Assisting agencies included Fishers Police Department, Hamilton County Sheriff Department, Carmel Fire Department and Fishers Fire Corps.



# Top news stories of 2017



Each year at this time the Reporter attempts to recap the top news stories of the past year in Hamilton County.

The Number One story of the year was the double murder-suicide that occurred earlier this week in Noblesville. Todd Moon shot and killed his parents, Donald and Joyce Moon, before killing himself.

The second big story of the year was the alarming and continuing increase in deaths due to drug overdose and addiction.

By year's end the number of county residents succumbing to powerful and illegal drugs will likely exceed 40 with 36 cases now confirmed and eight more awaiting toxicology reports, according to Coroner John Chalfin. The toll may well be higher because deaths in Marion County hospitals are not routinely reported to Hamilton County authorities. As recently as three years ago there were only 18 such deaths confirmed in the county. The coroner says he believes there is a lack of understanding of how serious problem in becoming. He has found the deadly mixing of heroin and fentanyl is the greatest problem. He says law enforcement, courts and health officials are working hard to fight the problem. Chalfin has recommended legislation that would improve more accurate reporting of fatal overdose cases. Public service agencies are looking for ways to curb the epidemic, but the cases keep coming. It's part of a nationwide crisis with no immediate end in sight. Most, but certainly not all victims, are younger adults.

Number 3 is the ongoing efforts to save the Nickel Plate Railroad or at least part of it. Few issues have held the public's interest for a longer period of time. During the year the railroad line's owner, Hoosier Heritage Port Authority, essentially evicted the Indiana Transportation Museum from the rail line by handing over operation to the Nickel Plate Heritage Railroad which is a new organization formed by the County Tourism Bureau. The Nickel Plate Heritage group plans to have trains on the tracks next year from Noblesville north while cooperating with Noblesville and Fishers' wishes to see the tracks south of Noblesville converted to a walking and bike trail. At year's end the Noblesville Parks Board

agreed not to renew ITM's lease at Forest Park.

Number 4 is the continuing dynamic growth and development in the county. The new River-view Outpatient Hospital at Westfield and the much-publicized IKEA superstore at Fishers, the huge Midtown Redevelopment Project along the Monon at Carmel and the Blue Sky headquarters and Federal Hill Commons in Noblesville, are only some examples of the development during the year. There have also been hundreds of building permits issued for new homes and business buildings along with dozens of road improvements and other infrastructure projects.

Number 5 is the designation of Hamilton County's cities as the best places to live in America. Carmel, Fishers, Westfield and Noblesville have all been listed during 2017 by national publications such as Money Magazine, Forbes and SafeHome.org. Local communities have been selected because of low crime, good schools, low unemployment, reasonable housing costs and low taxes among other criteria.


The number 6 story involves the retirement or planned retirement of many prominent public officeholders. State Sen. Luke Kenley and Superior Court Judge Wayne Stur-

tevant retired, and State Rep. Kathy Richardson, Judge Steve Nation, County Councilman Paul Ayers and County Clerk Tammy Baitz have said they will end their service when terms expire next year. In addition, Sheriff Mark Bowen ends his time as sheriff due to term limits. Rarely have so many officials planned to call it quits at one time.

Number 7 was the end to a 12-year Home Place struggle to keep from being annexed by the city of Carmel. The unincorporated Home Place area founded more than 100 years ago, was the last unannexed portion of Clay Township. Residents who opposed a city tax rate and possible redevelopment in the area, decided against an expensive appeal to the state Supreme Court in order to continue their legal battle against annexation.

Number 8 was the decision by the Indianapolis Colts to move their training camp to Grand Park at Westfield. The move is believed to be a big win for the Westfield area which may see an increase in visitors who in turn will spend their money at local restaurants and motels, not to mention the publicity that always follows the Colts' activities at camp.

Number 9 is the Carmel High School girls swim team's national record

in a lake or ocean.

Number 10 is the fire that heavily damaged the former Stevens Spring Company factory at Cicero. The February blaze resulted in evacuation of a nearby apartment complex and brought fire investigators to the scene. Cause of the fire was never ruled anything other than accidental.

Rounding out the list of top stories for 2017 is the only fatal plane crash in the county during 2017. On Aug. 31, Norman Lavine, 78, Carmel, alone in his plane, crashed on takeoff from Metropolitan Airport at Fishers.

# Larry Lannan's Top 15 Fishers news stories of 2017

It is once again that time of year when we look back at what has happened since the previous Jan. 1. It has been quite a year in Fishers with no shortage of news items to cover.

It has been a number of years since I have attempted to try something like this. Why have I not done this? Because it is hard.

A project like this normally consumes a newsroom for a number of days as reporters and editors argue endlessly. Here's my problem - I have no staff. I just have me.

So, with that in mind, I present to you the top 15 news stories gleaned from items posted on my news blog during 2017. If you disagree with some or all of the list, fine, but at least I've sparked some discussion.

\*\*\*

**15. Fishers Mental Health Initiative:** This was Mayor Scott Fadness' very first project once he assumed the office. He has been persistent in continuing the initiative. It received a major boost when the Hamilton Southeastern School District, using funds from an approved operating tax referendum, began providing enhanced mental health services into all the district's school buildings through a contract with Community Health.

**14. Important Retirements:** Three key people announced retirements this year, all at the center of development in Fishers. Indiana State Senator Luke Kenley announced his retirement after years of

service and holding a key committee chairmanship. The Republican Caucus elected Victoria Spartz of Noblesville to fill the remainder of his term. Part of that Senate District includes a section of Fishers. Jim White retires at the end of 2017 after managing the Transportation Department at HSE Schools. Jim will be missed. Finally, Lynda Carlino is retiring after serving as Executive Director for the local youth sports program S.P.O.R.T.S. Lynda led the nonprofit group during massive growth in participation.

**13. Long-Time Businesses Close:** Two businesses that had been a part of Fishers for a very, very long time closed their doors during 2017. Archers Meats decided to retire and call it quits at their downtown Fishers location. Ben & Ari's entertainment center had been the site of many birthday parties for youngsters growing up in Fishers, but the owners decided it was time to end the operation and sell the land to a car dealership.

**12. Upgrades Coming to The Amphitheater:** Mayor Scott Fadness said the Amphitheater has been an example of the city being the victim of its own success. The massive crowds showing up for the concert events strained the restroom facilities with long lines at many popular events. The city is finalizing a plan to spend \$6 million to expand the stage and improve the area between the Amphitheater and City Hall. The final plans should be known in early 2018, with a completion date set for May or June of 2018.

**11. Southeastern Elementary Groundbreaking:** If the demographer is correct in his projections, this will be the final school building Hamilton Southeastern Schools will need to build in a long time. Ground was broken late this year and construction

is underway at the site on Cyntheanne Road near Southeastern Parkway. This will allow elementary students to no longer need mobile classrooms.

**10. New Geist Park:** The city is proposing a new park located on Geist reservoir. Land acquisition is continuing. It would be the first public space on the water of the lake.

**9. Money Mag Lists Fishers as Best Place to Live in America:** If you read my blog regularly, you know I am skeptical of most listing of cities, citing them as good or bad places. But the Money Magazine list is the one most people recognize. This was a major feather in the city's cap.

**8. Road Construction:** There has once again been plenty of road construction, and much of it was in 116th Street in preparation for IKEA, Portillo's and Top Golf. But Interstate 69 has been a hassle with continued construction of the additional lanes going north and south. Also, drainage work has limited lanes on State Road 37 as crews continue to prepare for the big remake of SR 37. Major construction is set to start in 2019, with a lot of questions still unanswered on how SR 37 work will unfold. Stay tuned.

**7. \$2.1 Million Lilly Grant For HSE Schools:** Foundations such as Lilly seldom make big grants to suburban school systems, but HSE must have blown Lilly Foundation officials away with a top-notch application. This grant will be used to find creative ways to provide counseling services for local students.

**6. 2,500 New Jobs:** Mayor Scott Fadness was beaming when appearing on Gerry Dick's Inside Indiana Business television program in early December. He told anchor Dick that Fishers had created 2,500 jobs during 2017 and 4,500 since he became mayor in 2015. The mayor also said during that same TV appearance he expects the jobs momentum to continue in Fishers into 2018.

**5. HSE School Board Controversies:** The Hamilton Southeastern (HSE) School Board had no shortage of controversies to handle the past year. Three come to mind. The first was sparked when Board President Matt Burke and Vice President John DeLucia asked the firm hired to help with branding the district about changing the name of the school district. After a firestorm on social media, that idea went away. Second, Board Member Amanda Shera emotionally argued that her daughter should not be assigned the book Kite Runner. Educators disagreed, saying it is

useful for certain students in specific settings. Finally, the board approved a school calendar for the next two years, starting school two days earlier and extending Thanksgiving Break by two days, on a 4-3 vote. After yet another social media firestorm, the board reconsidered and voted 8-1 to keep the calendar largely the way it is now, consistent with the recommendation from school administrators.

**4. IoT Lab:** Governor Eric Holcomb joined local officials to announce a new Internet of Things (IoT) Lab near Launch Fishers. The hope is this lab will put Fishers and Indiana into play as IoT becomes more a part of our lives in coming years.

**3. Nickel Plate Rail Line:** Fishers and Noblesville had announced prior to 2017 that the cities, along with support from the Hamilton County Commissioners, will be converting the Nickel Plate Rail Line into a trail. Those wanting to keep trains running on that line continue to fight that move. This year, the federal rail banking process, a long and bureaucratic system, continues. "Save the Train" supporters plan to fight the rail banking process. This story continued in 2017, but will almost certainly continue into 2018 (at least).

**2. Fishers Freedom Festival:** The nonprofit organization that has run the Fishers Freedom Festival since 1989 lost its city funding and announced it would not be putting on the event in 2018. The festival, held each year over a weekend in late June before the Fourth of July, requested funding from the city but was denied. The nonprofit group still owns the rights to the name "Fishers Freedom Festival." The city says it will hold the festival and run the operation itself, perhaps with a different name. The city promises a parade, fireworks, entertainment and more at the 2018 festival.

And the No. 1 Fishers news story in 2017 is...

**Growth At Exit 5:** I mentioned traffic earlier, and handling the vehicles with this area as the destination has been a challenge, but traffic has been moving. We knew it was coming, but 2017 was the year that IKEA, Portillo's and Top Golf became real in Fishers as all three opened their doors. Plans are still in the works on what restaurants will occupy The Yard development in that same area, with only two of the eateries announced late in the year. This area off I-69 is becoming a major commercial center, and 2017 was the year it started in earnest.

# Riverview implements flu restrictions

Indiana hospitals are taking precautions to prevent the spread of the flu virus among patients, staff and visitors as the state sees a surge in influenza cases.

Hospitals from South Bend to Evansville have imposed restrictions that include barring visitors other than immediate family or other significant persons.

Locally, Riverview Health is taking added precautions to protect its patients, families, staff members and community from unnecessary exposure to influenza. On Friday, Dec. 29, Riverview

Health implemented these temporary visitation restrictions:

- No visitors with influenza-like illness, fever or cough.
- No visitors under the age of 16, unless special arrangements are made.
- No visitors except immediate family, partner or significant other.

Officials from Riverview Health stated, "As we work to provide a safe environment for our patients and staff, we apologize for any inconvenience this visitation restriction may cause. We will continue to monitor the conditions and remove the restrictions as soon as it is

safe to do so."

The Centers for Disease Control and Prevention says Indiana was among 23 states with "widespread" flu activity.

WISH-TV, the Reporter's news gather partner, reported State health officials consider Indiana to have entered flu season once complaints of flu-like illnesses account for at least two percent of visits to hospitals and doctors' offices. Indiana didn't hit that two percent baseline during its last flu season until early February, but data from state health officials show the state reached that level in mid-December.

# NOBLESVILLE PARKING

80 percent (356) did not live in the focus area. Fifty-eight of those responses came from people who do not live in Noblesville.

The study sought to answer the decades-long question of whether Noblesville truly has a parking problem or not. "Regardless of the answer, the city's administration believes that parking within the downtown area can and should be improved for us to achieve the Mayor's vision of more residential and commercial development that complements and adds to the vibrancy of our historic

square," stated Noblesville Deputy Mayor Steve Cooke.

As a part of the Task Force's work in 2015, DuBois submitted a report to Ditslear that recommended four short term solutions:

1) Revise the Parking Ordinance 72 to increase the time restriction limit of all current two-hour parking within the parking study area (the White River to the west, Wayne Street to the north, Division Street to the south and 16th Street to the east) to three hours.

2) Revise Ordinance subsection 72.85-72.86

to allow non-residential parking permits purchased by businesses to be transferable for a one-time processing fee of \$20.

3) Revise Parking Ordinance 72.90 to reduce the annual fee for permits in the underutilized Lot 6 on South 8th Street to \$150 from the current fee of \$300.

4) Improve Wayfinding and Parking Identification - where possible utilize the universally identified capital block letter 'P' in the universal blue color - update street pole banners to reflect this method of identification. Identify ad-

ditional methods and opportunities to inform the public as to the locations of public parking.

Noblesville acted on three of the four recommendations. The city did not revise the two-hour free parking. Cooke commented about revising the parking limit, "We simply needed more concrete data to work from."

In 2016 and into 2017, the Task Force began the next phase which included reviewing enhanced use of meter technology and their locations, short term parking spaces and opportunities for adding sur-







face parking capacity, best practices in shared parking management, County government expansion impacts and a city-county parking garage.

Noblesville confirmed discussions with county officials regarding the construction of a city-county parking garage; however, Hamilton County Commissioner Steve Dillinger doesn't feel Noblesville has a parking problem. "I can drive around the courthouse square anytime during the day and find open spots." Dillinger followed his statement with, "Whatever problems No-

blesville has, county government is at the root of all evil. Surveys I've seen suggest that 70 to 80 percent of people coming to downtown Noblesville do so for government business."

Cooke said, "The next step is for the city and Task Force to come together again in 2018, formalize our recommendations based on the study and bring them to the public for consideration. The parking study provided relevant data to inform the Task Force and guide the city's action items and next steps.

The project will require lane closures but no detours will be required for SR 32 through traffic. Emergency services and school corporations would be contacted prior to the reduction and/or closure of travel lanes. # Millers fend off Greensburg to win Holiday Tournament

It didn't start out pretty, but the host Millers were able to bounce back from an early first quarter hole to defeat an extremely tough, physical second-ranked Greensburg squad to win the Noblesville Holiday Tournament on Friday, Dec. 29 at The Mill, 58-53.

Bailey Meyer nailed a 3-pointer from the left wing to get the Pirates on the board first at 3-0, but a pass from Maddie Knight to Emily Kiser got the Millers' first two.

Greensburg would go on an 8-2 run, highlighted by Ashlynn Meyer and Aliyah Evans treys, to take an 11-4 lead, forcing Noblesville head coach Donna Buckley call her first timeout with 3:47 left in the first.

Following the timeout, sophomore spark Sarah Etchison sank a 3-point bomb from the right to bring it to 11-7 and a pair of Mallory Johnson free throws made it a two-point game, 11-9.

The Pirates used two straight 3s by Kyra Whitaker and Aliyah Evans to pump get their largest lead of the game to 17-9, but back came the Millers again with an Etchison swish from downtown. Reghan Day tossed in a six-footer at the buzzer for a 19-12 Greensburg lead at the end of the first.

Etchison drilled a 14-foot jumper to start the second and Emily Kiser got fouled, converting the old-fashioned three-point play, cutting the gap to two at 19-17, but Micha Morrison found a way through the lane to get Greensburg back up by four, 21-17.

With the game tied at 21-21, the Millers got two huge baskets from sophomore Anna Kiser that tied it at 23 and 25 before the elder Kiser, Emily would score two straight field goals to give the Millers a 29-25 halftime lead, which they would not give up the rest of the night.

Greensburg didn't give

up the fight throughout, but only got within two on three different stints during the remainder of the game.

The Millers would lead 42-38 after three periods, but they knew the Pirates would make this a physical battle until the end.

It seems to be a trend lately for the Millers that the junior tandem of Mallory Johnson and Maddie Knight come up big in the second half and that's exactly what happened against Greensburg and that had help from fellow junior Madison Whetro.

The three juniors would combine for 23 or Noblesville's 29 second half points, including 10 from Knight.

"Those juniors played well for us all day. They did so many good things. Mallory and Maddie are kids who've played three years of varsity basketball and like I said, we expect a lot from them and they've answered that," said Noblesville head coach Donna Buckley on the junior trio that stepped up to a big challenge versus Greensburg and early Friday against New Palestine.

Mallory Johnson's three from the right side was simply the dagger that the Pirates couldn't handle in the final minutes that gave the Millers a 53-46 lead and left Greensburg forcing things from that point.

Noblesville would earn its final five points at the foul line and a last-ditch effort three by Kyra Whitaker would make for the final score of 58-53, giving the Millers the title Holiday Tournament Champions.

"They ended up just making a few more plays than we do in key moments and you gotta give 'em credit for that," Greensburg head coach Jason Simpson tipping his hat to Noblesville in a hard-fought championship game.

Greensburg (13-3) played a great pair of games Friday at Noblesville that will only help the remainder

of their season. Aliyah Evans led the Pirates with a team-high 14, while Kyra Whitaker joined her in double-figures.

Noblesville (9-7) has now won five of its last six games. Their scoring was highlighted by a 15-point, 17-rebound, seven-assist and four-block night from Emily Kiser. Just another night at the office for the Indiana All-Star candidate. She was joined in double-digit scoring by Knight (10) and Madison Whetro (10), while Johnson netted nine and Etchison pitched in another great night off the bench with eight.

Emily Kiser was voted Most Outstanding Player of the tournament, while Johnson also made the all-tournament team.

In the semi-finals, the Millers were able to pull away late from the Dragons with a 69-60 home court win to reach the championship game.

It was a back-and-forth affair throughout, which

was expected with the two evenly matched teams, so it wasn't clear who would come out on top and advance.

Emma Grable started off with 13 first quarter points to get New Pal off on the right foot. But after the score was tied 7-7, sophomore reserve Sarah Etchison came off the bench to drain three 3-pointers that helped get the Millers a 20-19 lead at the end of one.

Noblesville got started right away in the second with an Emily Kiser pair of free throws, two driving layups by junior Mallory Johnson and trey number four from Etchison that would put the host Millers up 32-29 at half.

"I do think that foul trouble did contribute, but I also think that we do have a relatively deep team and that's what I said to the girls. Whoever's in the game, there's a level of expectation and that is to perform at the level that we practice and these are the things we do

and don't do. And I think we made two or three mental mistakes and it just spiraled and have to clean that up," said New Palestine head coach Sarah Gizzi on her team's overall play against Noblesville.

The Millers pushed their lead to ten points with the trio of Kiser, Johnson and Maddie Knight in the third combining for all 17 points for a 49-39 advantage.

# Millers make championship game - and progress

While the Millers fell just short of their goal at their own Noblesville Holiday Tournament, there were quite a few positives for the team after all was said and done. Noblesville reached the championship game at the tournament, beating Broad Ripple 57-49 in the semi-finals on Thursday, Dec. 28. In the final, the Millers gave undefeated Warren Central a good battle before falling 51-37.

"I'm proud of our effort in this tournament," said Noblesville coach Brian McCauley. "We played well against Lighthouse East and then I thought we were even better against Broad Ripple this morning. It's disappointing we lost against a very good Warren Central team. But at the same time, I like the progress we've made since our Pike game."

In their morning game, the Millers played a Broad Ripple team that came into that contest with a 6-2 record. The Rockets scored the first five points of the game, then still led 9-4 midway through the first quarter.

Noblesville responded with an 11-2 run that carried over into the second period. Xavier Hines lit up the floor with three 3-pointers during that run. Eagan Keever-Hill tied the game at 9-9 with a layin, and Hines' second '3' of the game put the Millers in front, never to trail again.

"Xavier was consistent throughout the game, but he was really hot in the first quarter," said McCauley.

Broad Ripple did get within 15-14 early in the second quarter, but Noblesville made a 7-0 run to get the lead back to a comfortable 22-14. Hines drained his fourth '3' of the game, then Ryan Barnes and Zack Johnson each made layins.

The Millers led 24-17 at half-time, and kept their lead around that margin for most of the second half. The Rockets played tough, but every time they threatened to

get close, Noblesville would answer with a big basket to keep Broad Ripple at arm's length.

The Rockets did get to within 48-46 late in the fourth quarter on back-to-back 3-pointers by Xavier White and Wyatt Gordon. But the Millers responded yet again: Hines threw in his sixth '3' of the game, then Johnson's layin got Noblesville back up 53-46. Johnson and Hines both made two free throws in the final 40 seconds to secure the win.

Hines finished the game with 22 points, with Johnson adding 14 and Barnes scoring 11. Barnes also controlled the boards with seven rebounds, while Keever-Hill grabbed six.

"Ryan and Eagan did a really good job on the offensive rebounds," said McCauley. "Between those two guys, we had about five offensive rebounds."

The Warren Central team that the Millers played in the championship is ranked No. 4 in Class 4A. The Warriors shot the ball like a highly-ranked team, especially in the first quarter when it seemed like they couldn't miss.

Noblesville was able to match them basket-for-basket, though. Warren led 7-2 early in the first before Hines and Barnes made layins to cut the lead to 7-6. The Warriors then pushed ahead 13-8, but Barnes ended the quarter with another layin, keeping the Millers within 13-10.

A Keever-Hill layin in the second quarter put Noblesville within 19-16. But the Warriors jumped out on an 8-0 run after that to take a 27-16 lead; the run ended when Johnson hit a free throw with 1:52 left in the half. The Millers had to contend with Warren Central junior Jesse Bingham, who would be named the tournament's Most Valuable Player. Bingham scored 11 first-half points.

"Early they hurt us right there in the high post," said McCauley. "Bingham had three really nice shots there. We had no answer for that. He was so consistent throughout the game."

Warren led 27-17 at halftime, and kept its lead at around 10 points for the second half. But the Millers kept the pressure on for the entire half. Barnes made back-to-back layins late in the third quarter to snip a 35-22 Warrior lead to 35-26.

Warren Central then led 44-30

midway through the fourth quarter before Noblesville embarked on a 7-0 run. Barnes scored on another layin, Hines made a 3-pointer, and Riley Vitales capped the run with a rebound basket - the Millers got control of a mad scramble for the ball, and while their first shot missed, Vitales was there to make sure the putback got in.

That sent the Noblesville fans into a frenzy and cut the Warriors' lead to 44-37. Warren ended the game with a 7-0 run of their own to move to 8-0 on the season, but the Millers made sure it was not easy.

"We made them sweat a little bit. We made them think," said McCauley.

Barnes led Noblesville with 12 points. He was named to the All-Tournament Team after the conclusion of the championship game.

"Congrats to Ryan," said McCauley. "He's been a warrior for us all season. He's really improved and we'll need him to continue to get better, just like the rest of our team. But we're happy and excited for him. He earned it."

Noblesville advanced to the

semi-finals at its Holiday Tournament Wednesday, Dec. 27 with a 96-42 first-round win over Indianapolis Lighthouse East at The Mill.

The Millers were in control of the game from the beginning. Noblesville led 4-3 at the 4:54 mark of the first quarter, then made a run of 14 straight points that carried it into the second period. Barnes and Johnson both scored four points, Hines made a three-point play, and Jaron Youree opened the second quarter with a 3-pointer.

The Millers' bench had an outstanding second period. Ian Gibbons, a 6-4 junior, scored nine points, including a three-point play. Brenden Fisher added four points. Youree made an easy basket off a steal by Jordan Schmidt, and Riley Vitales scored on a putback.

"I thought that our bench was really effective tonight, right from the beginning of the game," said McCauley, who noted that his bench players scored 20 points in that period.

"It was a great opportunity for

them to gain some quality minutes and I thought they really responded well," said McCauley. "Our starters got off to a solid start and the guys who came off the bench really did a good job of coming in and being focused and being sharp."

The Millers led 44-13 at half-time and wound up with five scorers in double figures. Gibbons was the leader, with 16 points.

"Gibbons had a tremendous game off the bench for us," said McCauley.

Keever-Hill and Hines both added 13 points. Keever-Hill made the last basket of the first half, scoring off a Youree steal, then making the subsequent free throw after being fouled on the score. Keever-Hill then added back-to-back layins in the third period.

Johnson scored 12 points, while Barnes reached double-double status with 10 points and 10 rebounds. Vitales made four steals.

The Millers are now 7-4 for the season and next play at Muncie Central on Saturday, Jan. 6.

# Meme Sharp wins one-meter event at Winter Nationals

As Meme Sharp began the finals of the women's one-meter event at the USA Diving Winter Nationals, the Noblesville native said she "went on autopilot" for her last set of dives.

Soon, Sharp had flown to the top of the podium. The University of Pittsburgh senior won the one-meter championship at the Winter Nationals, which took place from Dec. 13-19 in Greensboro, N.C. Sharp, who is about to finish a great career at Pittsburgh, was the highlight of the first day of the Winter Nationals.

Sharp scored 476.75 points to win the one-meter, six points ahead of second place. She earned her highest score on her first dive of the finals, with 55.20 points on an inward one-and-a-half somersault pike.

"I didn't really focus on being super intense," Sharp said in a story on the USA Diving website. "I wasn't really focusing on my scores or where I was. I was ecstatic when I saw I was second going into the final and I just went on autopilot and dove."

Later, Sharp elaborated to the Reporter what she meant by "autopilot."

"When I say that I go into autopilot, I mean that I rely more on my muscle memory which has been

built up throughout my training," said Sharp. "My body knows how to do the dives, so I just relax my mind, and take it one dive at a time, and have a little bit of fun as well!"

Sharp qualified for the Winter Nationals last spring, when she won the NCAA Zone A championship in the three-meter event. She also placed fourth in the one-meter. This was the second time Sharp has competed in the Winter Nationals; she placed fifth in the synchronized three-meter event in 2015.

Of course, Sharp has been a name in the diving world for years. Noblesville fans got to know her when she dove for the Millers, and finished as the IHSAA state runner-up three years in a row (2012-13-14). After that, it was off to Pittsburgh, where she has compiled a spectacular resume over her college career.

Sharp was a winner from the moment she started at Pittsburgh, taking first place in her first meet as a Panther in Pitt's meet with Duke. She also finished first at the Eastern College Athletic Conference championship's one-meter event, and was the three-meter runner-up.

After that, Sharp continued the success in her sophomore and junior years, winning numerous meets on her way to a three-meter

crown at the Atlantic Coast Conference (ACC) championship her sophomore year. She has qualified for the NCAA meet the past two years after good finishes at the Zone meet, including the Zone three-meter win in her junior year.

"Competing is competing, whether I am competing in a USA diving or NCAA diving competition," said Sharp. No matter what happens at the meet, Sharp said she cheers on her friends, takes each dive one at a time, and makes the most of the experience.

Sharp, in fact, has already set three Pittsburgh school records. She holds the one-meter record (327.08), which she set during her sophomore year in a dual meet with Denison University. A month later, Sharp set the three-meter record at the ACC Championships, with her conference-winning score of 360.00. As a freshman, Sharp set the Pittsburgh platform dive record of 225.30 at the Pittsburgh Invitational.

"Being a student athlete at Pitt has been a crazy ride," said Sharp. "I have had the privilege to receive my education from a prestigious university, and I have been blessed to work with two of the best diving coaches in the nation, Julian Krug and Katie Hazelton. They both

have been mentors to me in the pool and in life."

Sharp is majoring in communication with a minor in creative writing. She lists an academic

achievement along with her diving achievements as one of her favorite moments:

Three-Meter Champion and the 2017 One-Meter National Champion, making lifelong friends, and finally getting that 4.0 this past semester," said Sharp.

# Carmel girls break through with Hall of Fame victory
