Judge strikes down sign ordinance

On Wednesday, Hamilton County Superior Court 3 Judge William Hughes struck down a controversial sign ordinance recently passed by Hamilton County Commissioners. The ordinance was challenged by Hamilton County Council candidate Rick Sharp and his attorney Timothy Stoesz. Sharp alleged the ordinance causes him

legal injury by prohibiting placing political signs anywhere in a right-of-way, as defined by the ordinance. It also prohibited placing signs larger than six square feet on private property. According to the ordinance, county workers and sheriff deputies were permitted to remove signs. Owners of the signs would then be charged a fee for reclaiming the signs.

A written opinion issued by Hughes stated, "Those restrictions and penalties either prohibit speech altogether or have a chilling effect on speech by, without limitation, authorizing Hamilton County personnel to remove such signs immediately and without notice, or requiring owners of signs to pay collection fees to the County to recover signs the County has removed."

The Court also ruled Sharp is entitled to an award of his reasonable attorney fees. Sharp was happy with the Judge's ruling. "This ordinance would have produced a very chilling effect on both political and religious free speech. I am gratified that the judge agreed with our position that this was a case of overreach on the part of county government!"

Switch Building's parking garage, housing units sold

The Fishers Redevelopment Commission had a last-minute addition to the Monday meeting agenda – the sale of the parking garage and residential units in The Switch Building downtown, from

Loftus Robinson to J.C. Hart. That sale required several changes to the project documents governing the property. The updated documents spell out the rights and responsibilities J.C. Hart will have with the parking garage and The Flats, the residential section of the complex. Loftus Robinson retains control of The

New ramp may fix Carmel traffic woes

Motorists in and around US 31 and 146th Street will soon get a traffic fix that could make getting to and from the area much easier. Hamilton County will break ground on Friday, April 13 on a new ramp that will allow motorists

to access southbound Keystone Parkway from 146th Street by traveling south on Lowes Way. Back in 2002, the county constructed a northbound off ramp from Keystone Parkway to 146th Street via Lowes Way, but improvements to US 31 between In-

terstate 465 and State Road 38 eliminated access to US 31/Keystone Parkway from Greyhound Pass, forcing motorists to use a more circuitous route. The first phase of this construction project will fix that. "The long and short of it is you can't get there

from here," says Mark Heirbrandt, president of the Hamilton County Commissioners. "For years motorists have had to find work-arounds to get where they're going. This project will give them a straight shot to



southbound Keystone.”

Phase I of this project will also connect the northbound Keystone Parkway ramp from 136th Street to the northbound Keystone ramp to Lowes Way/146th Street and change the existing signal at the entrance to Lowes Way to a roundabout.

Phase I has been award-

ed to Milestone Contractors for \$10 million. Federal funds awarded from the Indianapolis Metropolitan Planning Organization will cover approximately 48 percent of the cost. Hamilton County will cover the remaining cost with local TIF funds. Construction is scheduled to be complete October 2019.

Phase II of the project is scheduled to start in 2021. It will connect the new ramp constructed in Phase I with a Carmel-constructed roundabout at Range Line Road which will create a new connection for motorists wanting to drive east or west between Range Line Road, Keystone Parkway, and Lowes Way.

In other Redevelopment Commission items from the Monday meeting:

• The first of two public hearings was held, with no

one choosing to speak, on the changes in the financing for The Yard project. This was originally designed as a culinary project, and 100,000 square feet of space have been set aside for commercial development. The change is the addition of residential units and a parking garage. The second and final public hearing will be held on Monday, April 16 at the

next scheduled Redevelopment Commission meeting.

• The commission approved provisions of a lease for the Braden Building, now completed downtown. The lease is to run 10 years, from March 1, 2018, through March 1, 2028.

The Carmel Clay Historical Society (CCHS) was formed in 1975 by a group of local residents as part of

the nation's Bicentennial celebration and dedicated itself to the study of Carmel and Clay Township's history. That same year the City of Carmel gave the historic 1883 Monon Railroad Depot to the society, which it maintains today as a museum of local history.

CCHS's mission is to encourage an appreciation for and understanding of the settlement, growth and development of the city of Carmel and Clay Township, bringing historical relevance/ context and enrichment to the lives of its citizens and visitors. CCHS fulfills its mission by providing educational services in the following ways: Public programs about local topics, tours of the Monon Railroad Depot Museum, curriculum materials to schools on local and county history, Historic Home Tours highlighting local architecture and antiques, providing genealogical assistance to area researchers and maintaining an archive of letters, diaries, newspapers, documents and artifacts that pertain to Carmel and Clay Township.

Be a Baldrick hero, shave, give for a cause

The St. Baldrick's Foundation, the largest private funder of childhood cancer research grants, and the St. Baldrick's Be Brooks Brave Hero Fund, announced on Monday a new event to raise awareness and funds for pediatric brain tumor research while honoring a young Carmel boy.

The Be Brooks Brave and Shave event will be held 10 a.m. to 2 p.m. on Saturday, May 19 inside the Grand Park Events Center in Westfield. The Colts cheerleaders will be making an appearance, plus local celebrities and athletes who also plan to join in on the fun.

Brooks Blackmore was diagnosed with two, Stage IV, inoperable brain tumors in June 2015 at the tender age of five.

"We were told there was no cure or any effective treatment options," said Brooks' mother and founder of the Be Brooks Brave Hero Fund, Tracey Blackmore.

Brooks sadly passed away on May 21, 2016, after a hard-fought, 11-month battle with cancer.

"Brooks has forever changed our lives and we are so blessed to have

loved him even for six short years," said Blackmore. "We would do it all again, just to call him our son."

At St. Baldrick's signature head-shaving events, people volunteer to shave their heads as a way to raise money for lifesaving childhood cancer research, while also standing in solidarity with children who typically lose their hair during cancer treatment.

This year, St. Baldrick's honored Brooks by making him one of five St. Baldrick's Foundation Ambassadors. Brooks is the only "angel" of these five ambassadors – representing the reality that one in five kids diagnosed with cancer won't survive.

Funds raised through the Be Brooks Brave and Shave event will support the St. Baldrick's Be Brooks Brave Hero Fund. The Blackmore family has raised around \$100,000 since Brooks gained his angel wings and has raised more than \$10,500 in 2018 alone.

"Pediatric cancer only receives 4 percent of the U.S. government funding for cancer research, with brain tumor research only receiving 1 percent," Blackmore said. "We are

now dedicated to changing this outcome and pray this money makes the difference in helping future families faced with the same devastating news."
