Jail expansion gets underway

The REPORTER

After months of study, planning and discussion, Hamilton County Sheriff Mark Bowen and other public officials held a groundbreaking ceremony Tuesday for the expansion of the Hamilton County Jail. The \$13.5 million construction project should help alleviate issues in a facility built for 296 inmates that in 2017 averaged a population of over 380. The expansion will provide an additional 120 beds in 11 cell pods with 84 prefabricated steel cells consisting of two- and four-person cells. In addition, the construction adds space for physical activity, classrooms and a medical support area.

Judge strikes down sign ordinance

Last Wednesday, Hamilton County Superior Court 3 Judge William Hughes struck down a controversial sign ordinance recently passed by Hamilton County Commissioners.

The ordinance was challenged by Hamilton County Council candidate Rick Sharp and his attorney Timothy Stoesz.

Sharp alleged the ordinance causes him legal injury by prohibiting placing political signs anywhere in a right-of-way, as defined by the ordinance. It also prohibited placing signs larger than six square feet on private property.

According to the ordinance, county workers and sheriff deputies were permitted to remove signs. Owners of the signs would then be charged a fee for reclaiming the signs.

A written opinion issued by Hughes stated, "Those restrictions and penalties either prohibit speech altogether or have a chilling effect on speech by, without limitation, authorizing Hamilton County personnel to remove such signs immediately and without notice, or requiring owners of

that the judge agreed with our position that this was a case of overreach on the part of county government!"

signs to pay collection fees to the County to recover signs the County has removed."

The Court also ruled Sharp is entitled to an award of his reasonable attorney fees.

Sharp was happy with the Judge's ruling. "This ordinance would have produced a very chilling effect on both political and religious free speech. I am gratified that the judge agreed with our position that this was a case of overreach on the part of county government!"

Hamilton County Parks' bridges project wins third award

For a third time, a complex bridge salvage and restoration project undertaken by Hamilton County Parks and Recreation received accolades for its innovative engineering and design.

At its 30th annual Engineering Excellence Awards ceremony, the American Council of Engineering Companies (ACEC), Indiana, presented a prestigious merit award to the park department and its project partners. The effort resulted in the successful installation of a 285-foot pedestrian bridge that now spans White River in northern Hamilton County.

The project, which was first conceived more than 15 years ago, required rescuing out-of-service bridges from two separate Indiana counties, and rebuilding a third bridge with Hamilton County ties, utilizing plans drawn up in the 19th century. Prior recognition for the

engineering feat was given by The Great Lakes Park Training Institute and the Indiana Park and Recreation Association.

The creation of the unique three-span structure required the dismantlement, transportation and careful restoration of metal truss bridges that served Washington County and Wayne County travelers.

Hamilton County Bridge 21 serves as the

third and middle section of the three-section span. Bridge 21 was constructed using the bridge's original plans, drawn up in 1890. The new span now connects White River Campground to Strawtown Koteewi Park, allowing for safe passage from the campground to the park's 800 acres of recreational and educational adventures.

Flexware headquarters coming to Fishers

On the Fishers City Council agenda for the Monday night session, released last Thursday, was an item for a new office building. The

only clue regarding who might be behind it was a firm named AMP Northwest. The city announced Friday morning that office building will house the new headquarters of a local technology firm, Flexware Innovation.

This new structure will be a \$3.5 million project containing 24,000 square feet of space. Groundbreaking is projected for the fall

of this year. A total of 12,000 square feet of office space will be set aside for Flexware, with the remaining space available for other tenants.

One hundred parking spaces will be available to the office building employees during the work day and available to the public after 6 p.m. weekdays and

Carmel residents concerned about zoning change

Dozens of people asked questions last Wednesday night about a possible development on the edge of Carmel.

Some are worried it could become a hospital, and they are worried what could come of 30 acres of undeveloped land on 96th Street and Spring Mill Road.

Smack in the middle of sleepy streets of homes and a bustling commercial district sits an area waiting for development. The company Ambrose Property Group is looking to make a splash.

But for their plan to work they need a change to Carmel's zoning.

And that's when the questions come to a roar. Ambrose held a meeting to clarify zoning questions for anyone concerned.

People in the area said they have heard St. Vincent will build a hospital, maybe even with a helipad.

That concerns some residents of possible noise issues and even safety.

They say traffic is already a problem, and they imagine it would only get worse.

"It would be backed up for miles," said William Cummings, who lives near-

by the proposed ordinance change.

But at this meeting when it came to their questions, they were asked to write them down so they could be presented for a planning commission meeting. The crowd then shouted questions.

"I mean, how can you write an intelligent question unless you know who the end user is," said Cummings.

"They provided absolutely no new information. What a sham. What a scam."

Ambrose said it's a process that could take months before any potential zoning changes and hoped the meeting would help these residents feel more comfortable.

The group wouldn't talk about any possible plan with St. Vincent.

"We're focused on the zoning at this time," said Jon Dobosiewicz, a land use professional with the Indianapolis law firm Nelson and Frankenberger, which helped run the meeting. That answer was in response to being asked about whether now is the right time for these residents to be voicing their concerns.

The next planning commission meeting in Carmel is set for next week.

Parkway from 146th Street.

Phase I of this project will also connect the northbound Keystone Parkway ramp from 136th Street to the northbound Keystone ramp to Lowes Way/146th Street and change the existing signal at the entrance to Lowes Way to a roundabout.

Phase I will cost \$10 million. Federal funds, awarded from the Indianapolis Metropolitan Planning Organization, will cover approximately 48 percent of the cost. Hamilton County will cover the remaining cost with local TIF funds. Construction is scheduled to be complete October 2019.

County reveals new judicial center design

Pictured is the architect's final rendering of the new addition to the Hamilton County Government and Judicial Center. Traveling over the Conner Street bridge, motorists will get this view of the new west front of the building. Cost of the project is estimated at \$23 million. It will include about 100,000 square feet of floor space and house additional courtrooms and likely the offices of the County Auditor, Treasurer, Assessor and Recorder. Assuming bids are within the \$23 million budget, construction can begin this spring or early summer. No increase in taxes will be required, officials say.

Discounted rain barrels available to Noblesville residents, business owners

The Noblesville Clean Storm Water Program has teamed up with the Hamilton County Soil & Water Conservation District to provide Noblesville residents and business owners substantially discounted rain barrels while supplies last.

Residents may pre-order rain barrels for \$30 at the Hamilton County Soil & Water Conservation District office, 1717 Pleasant St., Suite 100, Noblesville. In order to qualify for this discount, residents and businesses must do three things:

1) Provide a City of Noblesville Wastewater Utility bill that shows your name and address.

2) Take one or more of the online clean water improvement pledges at clearchoicescleanwater.org and print the confirmation or show the email of the pledge.

3) Pre-pay \$30 (cash or check preferred) to the Hamilton County SWCD office.

Rain barrels are limited to one per address and must be pre-ordered. The barrels will be available for pickup on Friday, May 11 at the Hamilton County SWCD office. Rain barrels are available for sale to all customers, regardless of city of residence, through the SWCD office at the full price of \$75 plus tax. The discounted barrels are at a lower cost courtesy of the

A rain barrel collects

and stores rain water that would otherwise be lost. It is designed to keep debris and insects out (including mosquitoes) and saves homeowners money by allowing them to use this free water for their gardens and lawns as well as car and window washing.

The SWCD Rain barrels are all re-purposed food grade barrels that have been converted to rain barrels. Specific color or shape cannot be guaranteed, but barrels will likely be black or terra cotta colored.

Second in a series on the work of Noblesville's city departments . . .

Know your city: Noblesville's City Court, Clerk's Office

The following column is the second in a series on the various departments within the City of Noblesville. Learn more about the hard work and dedication of the department directors and staff members who keep our community of 62,000 going strong.

Today's column focuses on two departments that are both led by elected officials.

City Court

The Noblesville City Court constitutes our judicial branch of government and handles civil violations. Staffed by two full-time employees, the City Court is overseen by Judge S. Matthew Cook, who juggles his part-time duties with a full-time legal practice that he shares with his father and fellow attorney, Steve Cook. [Note: No relation to the writer of this column.]

While normally an elected position, Judge Cook was appointed by Governor Mike Pence in 2016 to fill the remaining four-year term of Judge Gregory Caldwell, who passed away after serving the City Court since 1992.

Out of 5,354 total cases filed in 2017, Judge Cook and his staff handled 4,373 infractions, such as traffic violations, and 981 ordinance violations. Nearly

60 percent of all their cases come from an agreement to handle Westfield Police Department's civil caseload in return for 50 percent of their collected fines.

In 2017, the City Court transitioned to a new court management system known as Odyssey. Staff went through an intensive two-week training as they implemented the crossover between court operating systems. The new program allows the court to be more efficient, more cost effective and be able to handle a larger case load at a faster pace.

In addition, defendants and their attorneys can locate their case online when and where it's most convenient - which is just one example of the city's concerted efforts to bring about greater transparency at the local level.

City Clerk

The business of running a city requires the collaboration of lots of individuals, including elected officials, who attend lots of meetings. Lots and lots of meetings. And from those meetings eventually come ordinances, resolutions, contracts and a slew of other public documents. Who can keep it all straight?

Answer: The city clerk - which, like the city judge,

also is an elected position.

Clerk Evelyn Lees began her first term in 2016 after Noblesville transitioned to a second class city and replaced the Clerk-Treasurer Office where Lees had served as deputy clerk-treasurer. That dual role is now split between the clerk and a controller appointed by Mayor Ditslear to serve as the city's chief financial officer.

With the help of Deputy Clerk Jacquie Thompson, Lees prepares agendas, takes minutes and keeps all records for the Common Council, all eight council committees, and the Board of Public Works and Safety. The clerk also advertises public meetings, posts legal notices and assists the public with requests for information.

In other words, the clerk's administration helps bring about even greater transparency.

It's a tremendous responsibility, with scheduling, advertising, attending and recording minutes for public and executive session meetings - about 12 in any given month - and they do a fantastic job while supporting the city

and serving the public.

The office also oversees the records of Riverside Cemetery located at the corner of Maple Avenue and 5th Street. Recently, Lees led an effort to re-

search and record infant burials from 1953 to 1975, some of which were unmarked, and to enhance this area with new fencing and signage. Thanks to the work of the Clerk's Office, Street Department and local artist Rick Hefflin, the infants interred within Babyland will forever be memorialized.

It's this type of project that exemplifies how our public servants go above and beyond their regular duties, and reflects well upon the love and dedication all our employees and elected officials show our community.

Tigers get Mudsock sweep, are 5-1 in conference play

The Fishers baseball team got three things out of its series with Hamilton Southeastern last week: A sweep, a Mudsock trophy and the lead in the Hoosier Crossroads Conference race.

The Tigers beat the Royals 16-3 in the first game in five innings. The two teams played a doubleheader on Friday, with Fishers winning the first game 10-8 and the second game 12-2, also in five innings. With that, the Tigers are now 5-1 in HCC play.

"I thought we played really, really well," said Fishers coach Matthew Cherry after the Tigers finished their sweep on Friday. "We're swinging really well right now."

THIRD-INNING HIT PARADE

Before the season started, Fishers head coach Matthew Cherry was asked to pinpoint his baseball team's strength heading into the spring.

Pitching was going to be a catalyst for the Class 4A No. 3 Tigers, Cherry noted, but he was quick to emphasize hitting first and foremost, calling his lineup a potential threat to any team.

On Thursday night, rival Hamilton Southeastern found out why.

Down 2-1 early to the visiting Royals (3-5), the Tigers' bats came to life in the bottom of the third inning, striking for 10 runs en route to a 16-3 run-rule victory to take the first in the three-game Hoosier Crossroads Conference series.

The Tigers finished the Mudsock series opener with eight extra-base hits, three home runs and 12 hits overall. Navy commit Matthew Wolff capped the onslaught by crushing a walk-off grand slam over the left-field fence in the bottom of the fifth.

Wolff led the hit parade by going 3-for-4 with a double and seven RBI. The five-hole

hitter's two-out bomb was his first home run of the season.

"This is what our guys are capable of. We've done it a few times this year already," Cherry said. "Our guys are swinging really well right now."

The defending HCC champion Tigers entered the game hitting .298 and reached double-digit runs scored twice before, but their win against HSE was the first by run-rule this season.

Fishers improved to 3-1 in the HCC. Last week, the Tigers won the first two against Noblesville, but a 6-3 loss in the

series finale versus the Millers last Friday didn't sit well.

"That loss kind of fueled the fire," Fishers senior Luke Albright said. "It fueled the fire for this series. It's our biggest rival, and we wanted to come out and bring everything we got. When you're so confident, and then you lose a tough one (to Noblesville), it's disappointing, but you come back the next day and go after it."

Albright did his part, earning the win with a three-hit performance through five innings. The Kent State recruit struck out five, walked three and retired five straight

between the first and third innings.

HSE led 1-0 in the first inning after a two-out RBI double by Greyson Droste. The Royals built a 2-1 lead in the top of the third behind an RBI-double by Matt Buckingham.

Jack DeWolf drove in the Royals' final run in the top of the fourth, bringing Jacob Daftari home after he reached with a leadoff double.

But the Royals had no answer for the Tigers' mammoth bottom of the third.

Kiel Brenczewski, a Navy commit, tied

Westfield got a run back in the bottom of the first

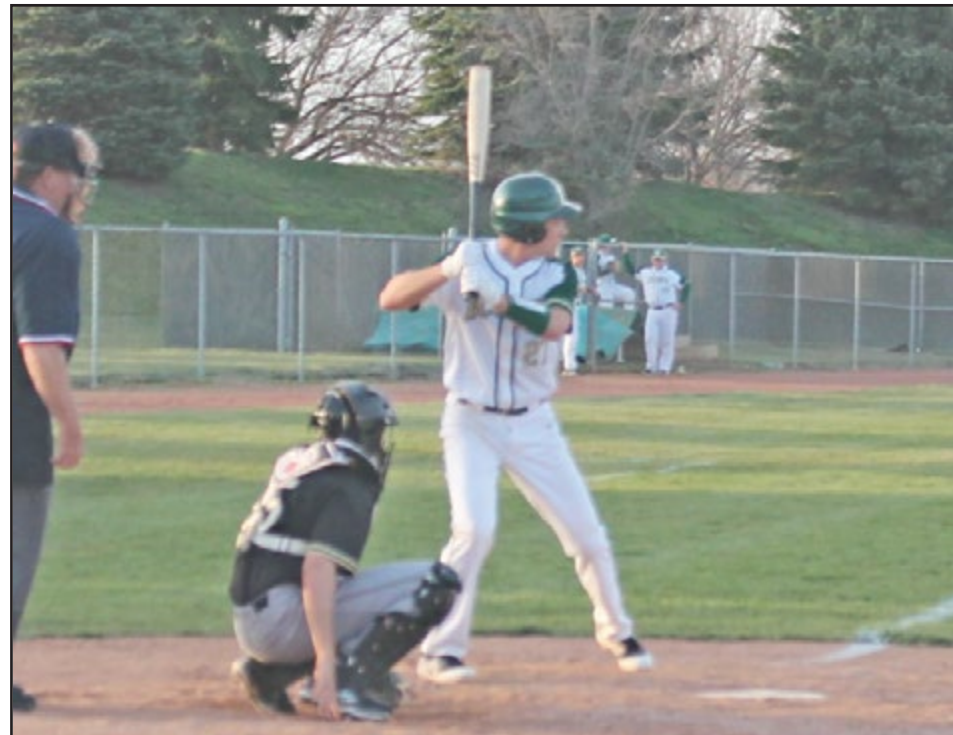
inning, when Kyle Pepiot hit a left field double to score Meyer. But the Millers scored again in the second inning when Cooper Miles got home on an error.

That would finish the scoring, although DJ Owens threatened in the fifth inning by hitting a triple. DJ Owens finished the game 2-for-4, the only player on either team to have multiple hits.

"I thought we came out and ambushed a couple pitches early in the game," said Noblesville coach Justin Keever. "The pitcher changed his approach and we didn't do the things consistently throughout the ball game to be consistent. They had to make those three runs hold up. Now give them credit, they kept making pitches and their defense made some plays, so not taking any credit away from them. But at the same time, I thought our approaches could be better."

Clay Holzworth pitched a fine game, striking out 11 in six innings of work. Kade Gorman came in for the seventh inning and got the save.

"Clay was a bulldog

tonight," said Keever. "He battled there, kind of struggled finding his footing on the mound. Anytime you go on the road there, especially for the pitcher, it's a new hill

you're not used to, and you got to find a way to get comfortable and he did that. Threw a lot of strikes and I thought defensively we played pretty well behind him as well. Kade Gorman comes in and does a really nice job as well."

Westfield's Zach Zaborowski threw four and a third innings, with six strikeouts.

"In game two, Matthew Meyer was fantastic," said Bunnell. "He was dominant at times and at other times in the game he just kept the Millers off balance. He made a nice adjustment after walking the first two batters of the game which was good to see he deserves a lot of credit for."

Meanwhile, Westfield (the designated home team) scored one run each in the first, fourth and fifth innings. The Shamrocks' first run was a sacrifice fly from Sam Eaton that scored Bryce Dorton. Payton Tamm singled in Pepiot for the second run and Meyer's fifth-inning single sent Eli Patchett home.

Meyer was just as solid at the plate, going 2-for-3. He and Logan McClurg both hit one double.

Reese Sharp pitched five innings for Noblesville, striking out eight.

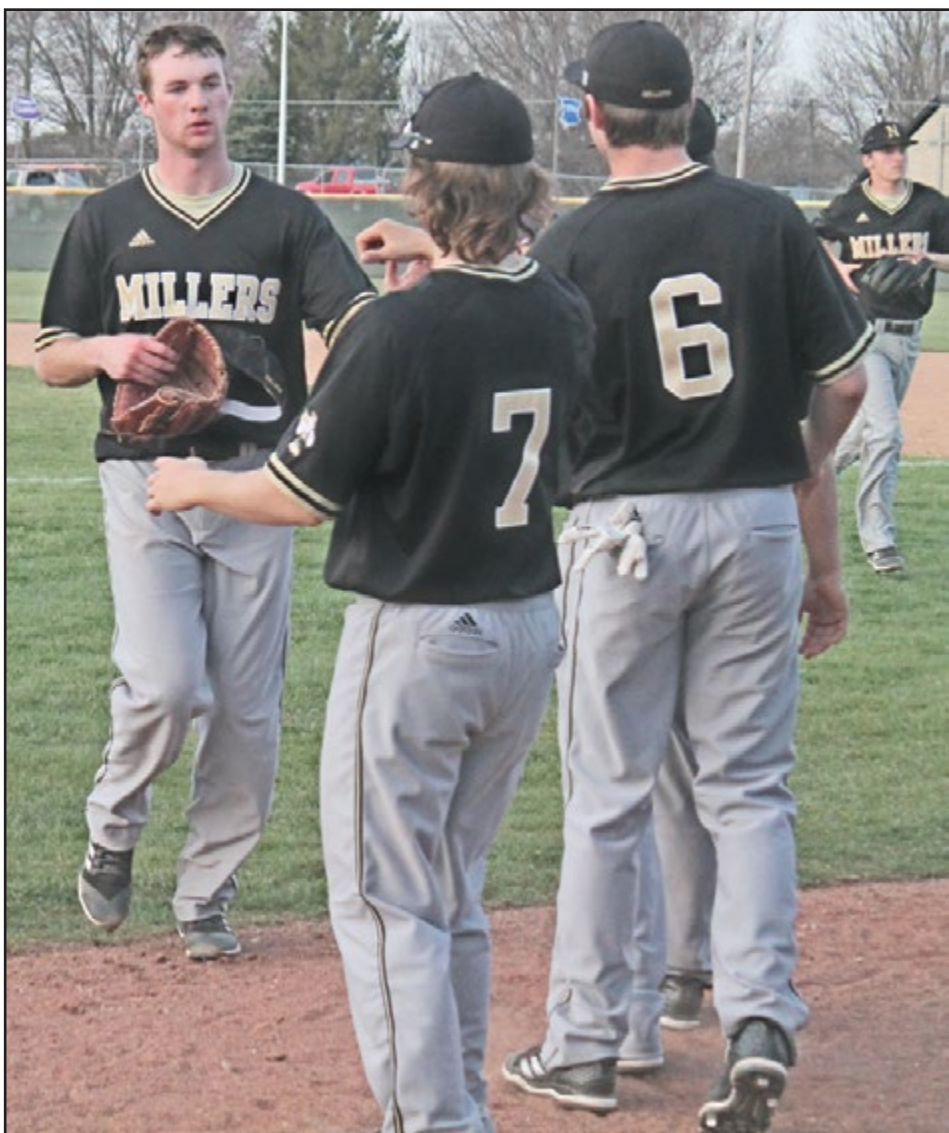
O'Hara pitched all six innings, striking out 12 while giving up three hits and no walks.

"It was really good," said Paul. "The girls fought really hard and came back in several of the matches and had to battle the wind. I'm really proud of them and they really played with a lot of confidence today."

Sophomore Sarah Clark also won a tough first set, then rolled through the second set to take the No. 2 singles match 7-5, 6-1. At No. 1 doubles, senior Rachel Dyer and freshman Katelyn Decker scored a 6-4, 6-3 victory.

The other two matches were close as well. No. 3 singles, sophomore Madi Randolph battled in a 6-4, 6-4 loss, while the No. 2 doubles team of freshman Kaylee David and junior Alex Greer took their opponents to a third-set super tiebreak before falling 6-4, 4-6, 10-5.

Armstrong has committed to play at Grace College next year.

"I just want to have a good season," said Armstrong. "It's going to be sad to be done, but I am excited for the next steps."

On Thursday, Noblesville fell to Zionsville 3-2 in a dual meet. Armstrong won her match at No. 1 singles 7-6 (4), 7-5 and No. 2 singles Clark was a 6-1, 6-2 winner.

The Millers will play at No. 6 Hamilton Southeastern on Tuesday.
