# School violence hits home

Two people were in critical condition and a suspected shooter was in custody after a shooting Friday morning at Noblesville West Middle School.

Noblesville Police Department said the first call came in at 9:06 a.m. Two people were shot, a 13-year-old girl and a teacher.

The student has not been identified. She remains in critical condition as of Friday night.

The teacher is Jason Seaman. He was in good condition by the end of Friday.

"There is a male student at Noblesville West Middle School who has been detained," said Kevin Jowitt, Noblesville police chief. "We believe he is the involved suspect. We have no reason to believe that there is any kind of a threat connected to this anywhere else."

Authorities held a press conference at 2 p.m. Friday to provide an update on the shooting. They did not confirm the names of the victims or the suspected shooter at that time, they provided details on what led up to the shooting.

Jowitt said that a male student asked to be excused from a classroom, left and returned with two handguns. Jowitt said that classroom is where the shooting occurred and that the incident was resolved quickly.

"We don't know what happened in the classroom, so I can't make any comments but we do know what happened in that classroom resolved very quickly," Jowitt said.

"You never think they're going to happen in your hometown," is how Lt. Bruce Barnes, a public information officer with Noblesville Police Department, began his comments at the press conference.

Barnes said that a school resource officer assigned to the campus was inside the building and responded. He said the shooter "was apprehended in the classroom or thereabouts" and that authorities are still working to learn what that process looked like. He

also said that officials would be reviewing video from the school.

The teacher was shot while taking down the shooter and was taken to IU Health Methodist Hospital in Indianapolis. The girl was taken to Riley Hospital for Children at IU Health in Indianapolis.

Barnes said they had no reason to believe the suspect was injured.

Barnes also confirmed the school does not have metal detectors "as a regular basis of walking into the school."

Barnes said a number of search warrants had been issued, while another official said the investigation would have to be completed before they could determine if and what charges would be filed.

"We all train for this. When it comes down to it, we come to the realization of 'What do we do?'" Barnes said, speaking of the ongoing investigation. Noblesville Schools Superintendent Beth Niedermeyer said she had just visited with the families of the victims and asked that while cards and kind wishes were welcome, people stay away from the hospital to allow the families to have some peace.

Niedermeyer called the efforts of the school staff heroic and said, "They did exactly what they were trained to do. Please keep the thoughts and prayers coming. We're so grateful for the support we've had." Arrangements for students returning to school in the coming days were still in process, Barnes and Niedermeyer said.

In a statement, Barnes said, "It is from the very bottom of our hearts that we say 'thank you' to all of the local, county, state and federal emergency service agencies, Noblesville School Corporation, local, county, state and federal elected officials, community groups, local businesses, citizens and media outlets for their assistance, patience and outpouring of concern during this tragic incident."

**School lockdown**  
Shortly after the school shooting at Noblesville West Middle School, Noblesville High School was placed on lockdown after receiving a threat. Police officials indicated they did not find any credible evidence of a threat at NHS.

"You just never think it will happen in Noblesville, but it did. It is a sad day that we have to go through this in our community," Noblesville Mayor John Ditslear said.



"Here we go again and it is unfortunate; it's a cotton-picking sad day," stated Indiana State Police Superintendent Doug Carter during a press conference at Noblesville West Middle School.

## Wounded teacher makes heroic effort to save students

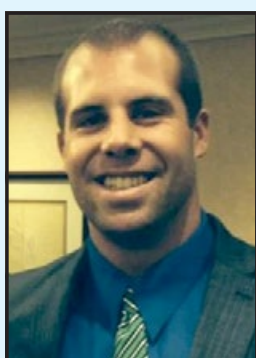
Jason Seaman, a science teacher at Noblesville West Middle School is being credited with a heroic effort in saving the lives of students.

On Friday, a student walked into Seaman's classroom and begin firing two handguns, striking a student and Seaman. Seaman was reportedly shot multiple times was able

to disarm and restrain the shooter while informing students to run from the classroom and call 911.

Seaman was transported to IU Methodist hospital. The student was transported to IU Riley Hospital.

Seaman has taught at Noblesville for approximately four years and is the seventh grade varsity football coach.

"First of all, thank you to the first responders from Noblesville and Fishers for their immediate action and care. I want to let everyone know that I was injured but am doing great. To all students, you are all wonderful and I thank you for your support. [You] are the reason I teach."

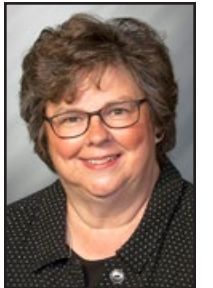

"The tragic events that took place at Noblesville West Middle School are a shock to the entire community, and I am saddened that some of our students have witnessed something so horrific firsthand. Thank you to every school official and first responder who acted bravely and quickly to secure the area. Noblesville is a strong community, and we will lean on each other in the coming days. Moving forward, I will work diligently with state and local leaders to review the situation to keep our students and community safe," Richardson said.

## Mayor John Ditslear's statement

Mayor John Ditslear has issued the following statement about Friday's shooting at Noblesville West Middle School:

"Words are hard to express about the event that occurred this morning at Noblesville West Middle School. School shootings are a tragedy regardless of the location, but having one unfold in your community is heartbreaking and shocking.

Our thoughts and prayers are with the two victims – a middle school student and a male teacher. I know we all send them our love and well wishes. We also keep the countless others who have been forever changed by this senseless act of violence close in our hearts.

Today was a harsh reminder that no matter how hard we try to keep our children safe, we must prepare for the worst conditions. The policies and procedures put in place by our public safety agencies and Noblesville Schools were proven to have worked. Lives were saved by the courageous actions of our first responders

and NWMS staff. Their training minimized the destruction and violence that could have occurred – and I could not have been prouder of their bravery.

Far too often, the importance of our first responders' lives and profession does not receive the proper gratitude it deserves. Today showcased the true bravery and vigilance they provide our city. I could not be prouder of the men and women that work for our police and fire departments. They continue setting an example for those who wear the badge and those for look for refuge in it.

On behalf of the City of Noblesville, I also want to thank everyone who quickly came to our aid to assist with this morning's tragic event – Fishers, Carmel, Cicero, Westfield, Lawrence, Whitestown and Elwood police departments; Hamilton County Sheriff's Office; Hamilton County Emergency Management Agency; Indiana

State Police; Hamilton County Health Department; Fishers, Carmel, Sheridan, Jackson Township, Cicero and Westfield fire departments; Federal Bureau of Investigation; Alcohol, Tobacco and Firearms; Homeland Security; Madison County Sheriff's Office; StatFlight; and St. Vincent, Riverview Health, Methodist, IU Health and Riley Children's hospitals.

Lastly, we had several local businesses that without asking, brought supplies and food to the American Red Cross to provide to students and personnel on the scene. I want to thank Chick-Fil-A, Kroger, Papa Johns, Pizza Hut and Logan's Roadhouse. You all are true community supporters and I know everyone was grateful for your donations.

Today, Noblesville was rocked at our foundation, but our response is one of hope and togetherness."

## Noblesville Schools Superintendent Dr. Beth Niedermeyer's statement

"I am still processing my emotions about today's terrible tragedy and I know you must all be as well.

I met this afternoon with the victims and their families and want you to know that Noblesville Schools is standing by to provide them support in whatever way we can. The families expressed to me that they appreciate the outpouring of love and support they have received today.

We have provided counseling support for West teachers this afternoon and have more counseling planned for this weekend.

On Saturday, May 26 and Monday, May 28, we will offer counseling for all district teachers/staff from 10 a.m. to 2 p.m. at NHS (Gate 1) and for all district parents/students from 1 to 3 p.m. at NHS (Gate 1).

Additionally, parents, staff and students can call a Hoosier crisis counseling hotline at 1-800-985-5990 or access counseling resources, including how to

discuss tragedy with children, at [i-cart.org/resources](http://i-cart.org/resources).

All events throughout the district have been canceled for this weekend. The baseball sectional championship will be moved to another location.

On Tuesday, May 29, school will resume as normal at all schools except West. West will be open 10 a.m. to 2 p.m. for counseling only and West students and families are encouraged to attend. Counselors will be on standby at all schools.

I want to express my sincere thanks and appreciation to our Noblesville West administrators, staff and students who stayed calm, showed courage and followed our safety protocols.

In addition, I would like to express my gratitude to the Noblesville Police Department, the Indiana State Police, the FBI,

SWAT team, Hamilton County Sheriff's Department, Noblesville Fire Department, County Emergency Preparedness and all first responders who answered the call, collaborated and responded quickly and calmly. They have helped tremendously in dealing with this terrible situation.

Our elected officials, community leaders, business leaders and parents have also been lending support today, and I'm so grateful for how we as a community have pulled together.

Thank you for your patience today as we worked to communicate information as quickly as we could in response to changing situations.

Please keep our injured school family members and their families in your thoughts and prayers.

# Non-profits seeking support from Fishers

Last year, the Fishers City Council decided to do a reset on how local nonprofit organizations would be financially supported. Before last year's budget process, only a few groups received

cash support from the city.

Previously, most of the funds went to The Fishers Freedom Festival and Conner Prairie, but the city began providing money to more organizations and even, at one point, considered using an independent, outside group to make these decisions, but decided in the end to keep everything in-house.

In 2017, the City Council formed a three-person committee of council members and established an application process for consideration of financial support. As a result of that process, the city decided to continue support for Conner Prairie, along with a number of other local groups. One organization that did not receive funding or in-kind support from the city in the 2018 budget was the Fishers Freedom Festival. The city is now organizing the Spark!Fish-

ers Festival in its place.

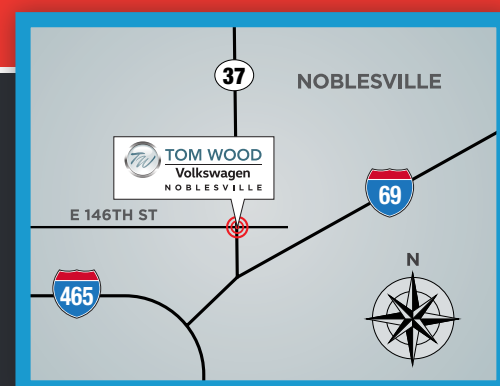

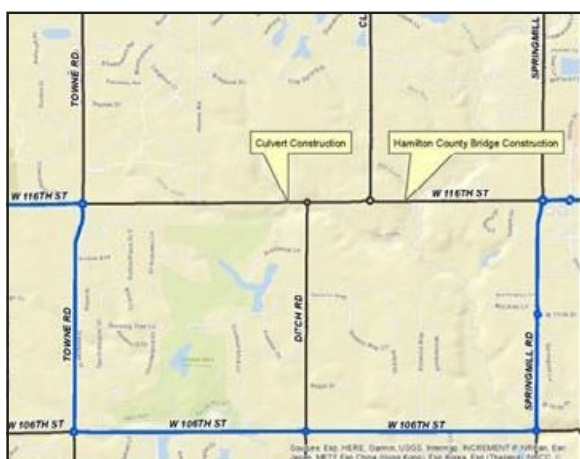
# 116<sup>th</sup> Street in Carmel to close for 65 days

On or after June 4, city contractors will close 116th Street between Towne Road and Spring Mill Road to all but local traffic for approximately 65 days.

This closure is necessary to complete two projects: The replacement of a bridge just east of Clay Center Road and a culvert over Williams Creek, just west of Ditch Road. The detour route uses 106th Street.

The anticipated completion date of these projects is Aug. 8, weather permitting.

# Learn basics about solar installation, investments

The City of Carmel is partnering with Carmel Green Initiative and other Hamilton County communities to co-host the Solarize Hamilton County 2018 Campaign. The goal of this community education program is to increase understanding of solar investments, simplify the solar installation process, enable access to program discounts and advance as many solar installations as possible.

Attendees will learn the basics about this new technology, how net metering affects return on investment and how to select a solar installer. All workshops are free and open to everyone. You do not have to be a resident of the community where the workshop is being held to attend.

In order to provide good product quality at a good price, campaign organizers have partnered with Solarize Indiana and selected three solar installers to provide participants with immediate access to pre-qualified, price-competitive solar installation firms. In addition, the participating installers will offer a group discount during the campaign.

To maximize the economic benefit of solar investments, installations must be completed by the Dec. 31, 2022 deadline.

A new state law passed in 2017 was designed to phase out net metering in Indiana – providing a credit

at the full retail rate for excess solar energy sent to the grid. The law requires that solar installations completed from 2018 to 2022 will qualify for full net metering rates until 2032. Net metering will no longer be available for installations completed after 2022.

tickets, ADA accessibility and much more.

Warm, humid conditions are forecasted for Sunday, so fans are encouraged to begin hydrating well before they arrive at the track and continue to drink as much water as possible at the track. Fans are permitted to bring coolers no larger than 18" x 14" x 14", with the reminder that no glass bottles are allowed.

"We want to make sure that everybody here is safe," IMS Director of Medical Services Dr. Geoffrey Billows said. "What we recommend is you make sure you hydrate. Don't wait till the day of the event. Start a day or so before. You want to keep your tank full."

"When you're here, make sure you're drinking plenty of water, some type of electrolyte solution, as well. When you come here, we recommend that you would wear very lightweight, light-colored clothing."

Five cooling buses will be stationed around the property on Race Day, with two near the IU Health Emergency Medical Center in the infield, one near the Snake Pit presented by Coors Light concert venue inside Turn 3 and one outside of Turn 4. Approximately 75 misting stations also are positioned around the property to help fans

beat the heat.

Gates at IMS open at 6 a.m. following the traditional cannon blast. From there, fans looking to beat traffic and avoid longer lines can take advantage of many fun opportunities, including:

•**IMS Museum:** The Museum, which opens at 6 a.m. on Race Day, features a special exhibit honoring the legendary Unser family this year. Learn more about the Museum's world-renowned attractions here: [www.indyracingmuseum.org](http://www.indyracingmuseum.org).

•**Fan Midway:** The IMS Midway, located in the infield, includes many new features this year for fans of all ages. Go karting and check out the virtual reality simulators, displays and more.

•**Shopping and Food:** A wide array of 102nd Running attire and collectibles will go fast, so don't miss out! Shop for family and friends while supplies last. All concessions and retailers will open at 6 a.m.

•**Borg-Warner Trophy March to the Bricks:** Back by popular demand, the Borg-Warner Trophy will begin an epic march to the iconic Yard of Bricks at 8 a.m. from the IMS Museum. Line up outside the west side of the Museum for a chance to see one of the most famous trophies in the world - escorted by the Indianapolis 500 Gordon

Pipers - begin its journey to Victory Podium.

•**IMS Red Carpet:** Many celebrities, including superstars Kelly Clarkson and Chris Hemsworth, will walk the IMS Red Carpet, located just north of Pagoda Plaza, from 9:30-10:30 a.m. The fans lining up in the viewing area earliest will have the best view of Race Day celebrities.

•**Epic Pre-Race! Be in your seat for it:** This year's pre-race ceremonies will serve as a fitting, stunning tribute to our nation's military heroes and continue as America's greatest Memorial Day Weekend sporting tradition. Be in your seat early to ensure you see every can't-miss moment.

•**Other Important Race Day Tips for Fans**

•**IMS App and Twitter:** Download the IMS app, available on both iPhone and Android. Also follow the IMS (@IMS), Town of Speedway Police (@SpeedwayPD) and Indiana State Police (@IndStatePolice) accounts on Twitter for the latest Race Day information.

•**Cooler, Backpack Restrictions:** No coolers larger than 18 inches by 14 inches by 14 inches can be brought into the facility, which will be strictly enforced. Fans will be allowed to bring one cooler and one standard backpack or book bag per person.

•**Smoke-Free Grandstands:** Smoking (including cigarettes, electronic cigarettes and vapes) will not be permitted in any IMS grandstands. Fans wishing to smoke will be asked to do so 20 feet away from buildings and seating entrances. Smoking will continue to be allowed in the IMS infield.

•**Parking:** All IMS exterior parking lots open at 5 a.m. on Race Morning, while interior lots open at 6 a.m. All IMS exterior and interior parking is sold out, including ADA parking.

•**Gate 2, Gate 10 Access:** Gate 2 and Gate 10 are not accessible via car on Race Day without a pre-paid parking pass. Fans with a pre-paid parking pass in Turn 3 must enter IMS through Gate 10, not Gate 2.

•**Road Closures:** To increase the safety and security of race patrons, the Speedway

Police Department will close Georgetown Road and 16th Street to all vehicular traffic during the running of the 102nd Running of the Indianapolis 500.

Georgetown Road will be closed south of 25th Street beginning at 7 a.m. After Georgetown Road is closed, no vehicular traffic, including placarded traffic, will be allowed to access the roadway. Race patrons with pre-paid parking passes who are accustomed to entering IMS Gate 7 must enter through Gate 2 (W. 16th Street) or Gate 10 (30th Street).

Upon completion of the race, Georgetown Road will remain closed to vehicular traffic until the vast majority of race pedestrian foot traffic clears from the roadway (approximately one hour after the race).

In addition, 16th Street will be closed between Olin Avenue on the east to the 16th Street roundabout on the west from approximately noon until the race ends. In addition, 16th Street will not be accessible from Polco Street, as it will be blocked at 10th Street.

Once 16th Street is closed, traffic traveling east on Crawfordsville Road from the west will be turned around at the 16th Street roundabout. Traffic traveling west on 16th Street from downtown will be diverted south on Olin Avenue.

•**Exiting the Facility:** Fans are encouraged to remember to be patient when leaving IMS after the race. There's no need to rush to your car, as parking lots are held until law enforcement deems the roads safe for vehicular traffic. This process takes slightly more time but keeps everyone safer when heading home.

•**More Traffic, Road Information:** Drivers can learn the locations of work zones and highway restrictions by calling INDOT's TrafficWise at 1-800-261-ROAD (7623) or viewing an online map at [pws.trafficwise.org](http://pws.trafficwise.org) or visiting @TrafficWise on Twitter. ISP will offer updates on traffic and parking on Twitter and Facebook.
