Noblesville continues to help No vote on Red Line expected this year

Two Noblesville business recently conducted fundraisers to aid Ella Whistler in her recovery from gunshot wounds received during the Noblesville West Middle School shooting.

Syd's Bar, a Noblesville landmark, raised a total of \$2,560 from T-shirt sales and cash donations. The money also included three staff members donating half of the tips they earned during the fundraising event.

A fundraiser conducted by Noblesville Culver's restaurant earned \$5,000 to be donated to the Noblesville Schools Education Foundation. Mary Collyer, Foundation President, stated the funds would be used to aid Ella Whistler and her family.

No vote on Red Line expected this year

The Red Line rapid transit bus system is now underway in Marion County, but earlier plans for the mass transportation line into Hamilton County is not part of the current plan. Originally the Red Line was proposed to extend from Indianapolis through Carmel and on to Westfield's Grand Park.

That plan has apparently been shelved for the time being. The Red Line in Indy will only extend from the University of Indianapolis to Broad Ripple. It is being financed largely by a \$75 million federal transportation grant which Marion County political leaders secured. The planned Hamilton County leg of the line failed to meet with great enthusiasm although supporters claim their surveys show it is a popular idea with many potential riders. To include Hamilton County in the Red Line route, the proposal, with a local income tax increase, would have to pass in a voter referendum in the townships which it would serve.

At the present time there are no plans to have the referendum on the general election ballot this year. County Commissioner Christine Altman, longtime advocate for public transportation, said recently that there is not enough time to do needed public education on the issue before November.

St. Vincent's drops controversial bid to build development in Carmel

St. Vincent's Health has notified the city of Carmel that it plans to withdraw a controversial bid to build a new facility in Carmel.

When the hospital group announced plans to build on undeveloped property at 96th Street and Spring Mill Road earlier this year, little was known about the group's plans for the site, but the possibility of a large hospital, one that might include a helipad, caused some Carmel residents to oppose the plans.

Residents showed up to protest at an informational meeting in April where the

property developer answered questions about what might be built on the site. But with little information to provide, residents left feeling frustrated and vowed to keep fighting the development.

St. Vincent's was set to ask the city's Plan Commission to change the zoning classification to allow St. Vincent's to build on the site, but strong opposition caused the proposal to be postponed several times before the city was notified on Tuesday of St. Vincent's plans to pull the zoning change request.

Here's the official update on St. Vincent's plans for the property at 96th Street and Spring Mill Road:

"As we reimagine healthcare, we are

continuously evaluating ways to best address our community's healthcare needs. As such, we are continuing on our pathway to purchase the land at 96th Street and Spring Mill Road. In working with the City of Carmel, project partners and considering the concerns of area neighbors, St. Vincent has decided to allow more time for additional planning and analysis and the creation of a more detailed vision. So, we are joining with our project partners to request a withdrawal of the previous rezoning request for that land. We look forward to refiling a comprehensive vision for this property - at a later date - that explores how we can create a space that's focused on improving our community's health and wellness."

"The nonprofit change is to increase the number of participants and help local groups raise awareness about their worthy organizations in a very fun way. We're also encouraging sports teams and school organizations to participate with the discount. The parade celebrates Noblesville along with our country so our goal is to make it as community-focused as possible," July 4 Planning Committee Co-Chairman Mike Hoffmeister said.

The Fireworks Festival is free of charge and will offer activities for kids, teens and adults, music, food vendors and more. The city is seeking organizations, businesses and individuals that would like to assist with inflatables or carnival games. Each organization is able to adopt as many stations as they believe can fill with volunteers from 6 to 10 p.m. Organizations can

wear matching T-shirts or volunteer vests.

"We will provide the games and prizes and organizations can adopt a game for the day, decorate your table/tent for your organization and provide handouts at the event. You are free to rotate through as many volunteers as needed to assist the event," said Kidszone Coordinator Nichole Haberin.

A hospitality tent will provide food and drinks for volunteers in addition to organizations earning in-kind trade or discounted rates for facility rentals. Organizations volunteering with at least 10 volunteers and reaching 20 hours of service can earn a free four-hour court or shelter rental. State lawmakers to review law after Noblesville shooting

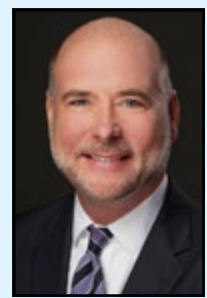

Indiana lawmakers will be reviewing state law as it pertains to juveniles being charged as adults.

Indiana House Speaker Brian Bosma (R-Indianapolis) made the announcement on Wednesday.

"In light of the Noblesville West Middle School incident and the recent charges brought against the shooter, we are reviewing current state law in regards to juveniles being charged as adults," Bosma said in a statement. "Given the heinous acts that led to a teacher and student being seriously harmed, I think it's important for us to take a thoughtful look at our criminal code and whether changes to the law are appropriate."

The announcement comes a day after Hamilton County Prosecutor D. Lee Buckingham announced a petition in juvenile court against the 13-year-old suspect in the May 25 shooting.

There was consideration of bringing the matter to a vote in 2016, but then dropped. The thought at the time was that it might be brought back this year. But, interest in the subject has not grown and advocates have not made further efforts to sell the idea. And, at the present time there

is no money secured for undertaking the expensive project.

The increase in local option income taxes, amounting to one quarter of one percent of individual income added to the current one percent, would not raise nearly enough money to cover initial construction costs.

The rapid transit line being built in Indianapolis involves special street lanes for new electric powered buses along with covered waiting stations at intervals along the route. That route from Broad Ripple south is to be located along College Avenue to the downtown area.



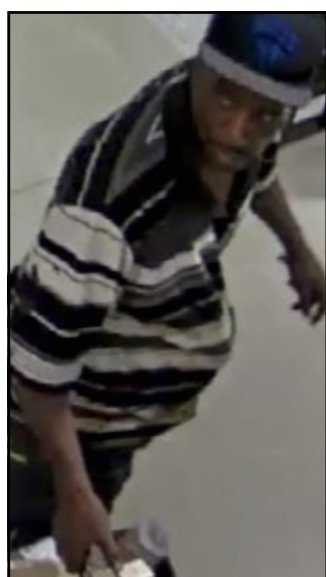

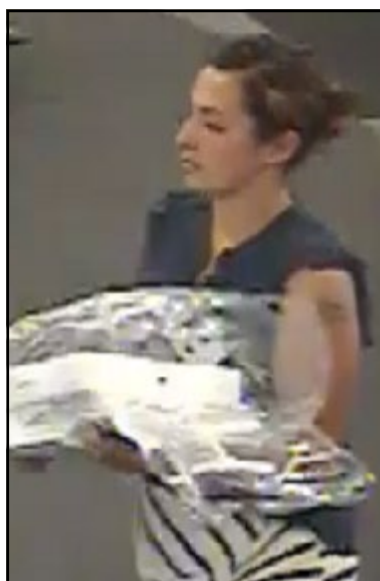


Zebra-clad identity thief on the loose

Affordable Carmel rental community almost ready to welcome residents

HAND Inc. will host a ribbon cutting and open house at its new Home Place Gardens development from 2 to 4 p.m. on Thursday, June 14. Located along 106th Street between College Avenue and the Monon Greenway, the 10-unit rental community is HAND's seventh property in Hamilton County and its first in Carmel.

The development includes eight one- and two-bedroom duplex apartments for seniors ages 55 and older and two three-bedroom detached homes for families who have survived violence. Residents are expected to begin moving in later this month.

The June 14 event is free and open to the public, thanks to sponsors American Structurepoint and Peterson Architecture. A ribbon-cutting ceremony is scheduled for 2:30 p.m., followed by self-guided tours of three rental units.

"All too often, when people hear 'affordable housing,' they conjure up visions of notorious public housing projects like Cabrini-Green in Chicago



or Brewster-Douglass in Detroit. The reality is very different," said HAND Executive Director Jennifer Miller. "We look forward to showing our neighbors how well affordable housing options can blend into our community."

Work on Home Place Gardens began last fall, with general contractor Meyer Najem overseeing construction. The Architecture Studio provided design services, and American Structurepoint handled site engineering.

Because on-site parking is limited and neighborhood streets are narrow, a free shuttle will be transporting guests to the June 14 event from nearby Orchard Park Presbyterian Church, 1605 E. 106th St. RSVP by June 11 here: bit.ly/HPG-RSVP.

The \$2.6 million project was funded with loans and grants from the Indiana Housing & Community Development Authority, Federal Home Loan Bank of Indianapolis, Hamilton County, Prevail Inc., Crosser Family Foundation and Woodforest National Bank.

Residents of Home Place Gardens must complete an income-verification process demonstrating they earn no more than 60 percent of area median in-

come. HAND has a waiting list of more than 250 individuals interested in one of its 106 affordable rental units in Hamilton County.

About HAND

Founded in 2003, HAND also has rental communities in Noblesville, Cicero and Sheridan, and it recently acquired 17 duplexes in Lebanon. Its mission is to be a leader in promoting prosperity and diversity by providing quality housing opportunities.

Baseball previews

Fishers, University ready for first semi-states

Two Hamilton County baseball teams will head into uncharted territory on Saturday: The IHSAA semi-state round.

Fishers is traveling north to Plymouth High School, where the Tigers will take on Chesterton in the Class 4A north semi-state. That game is the second of two games at Plymouth; the first one will be the 2A contest between Boone Grove and Lafayette Central Catholic. The first game is scheduled to start at 1 p.m., with the second game to follow, at approximately 3:30 p.m.

University doesn't have as far a drive, simply a short trip to Plainfield for the Trailblazers to face Tecumseh in the Class 1A south semi-state. That game is also set for a 1 p.m. first pitch. Winners of all the semi-state games will get a trip to the state finals, which are scheduled for June 15 and 16 at Victory Field in Indianapolis.

Fishers won its first-ever regional Saturday at Lafayette's Loeb Stadium. The Tigers held off Hoosier Crossroads Conference rival Zionsville 6-5 in the semi-finals, then stunned Fort Wayne Carroll with seven runs in the ninth inning to beat the Chargers 12-5 in the championship.

After such a long day on Saturday, Fishers had the day off on Monday. Tigers coach Matt Cherry said his team is "always loose," which he said is the team's personality, "and I believe what allows them to stay locked in under the pressure of some of these past few games."

On Tuesday, the Tigers went in for a light workout - "just to get the blood flowing again," said Cherry - then headed into the weight room. The coach said the team

"They came in today still as loose as they have been all season, but they are fully aware of their accomplishments and what it means for Fishers High School and our community," said Cherry. "We joked today about having a serious practice in June for the first time ever. They are locked in, but also staying loose and embracing the opportunity."

Chesterton cruised through its own sectional, taking care of Merrillville 17-0,

Hobart 11-0 and Valparaiso 7-0. The Trojans also had to sweat through a tense regional at La Porte, edging Lake Central 4-3 in a nine-inning semi-final, then beating Mishawaka 4-1 in the championship.

Because of the obvious distance, the Tigers and Chesterton have not played each other this season, nor do they have any common opponents.

"We have been working on learning as much as we can about Chesterton," said Cherry. "We have compiled a fairly complete scouting report that has been verified from different sources. They have a couple of good arms on the mound. They like to play small ball offensively with a couple of hitters who hit for power. It will be a competitive matchup. Anyone that has made it this far in the tournament will be a tough opponent."

The Trojans have a lineup of consistent hitters, including seven that have a .300 average in at least 50 at-bats. Chris VanEckeren is hitting .385, while Austin Peterson comes in with a .380 average. Peterson has the most hits on the Chesterton team with 27.

Tommy Benson hits at a .333 clip and leads the Trojans in runs batted in (29), runs scored (25), home runs (nine) and doubles (seven). Logan Lawson has the most triples with six.

Peterson is also one of the star pitchers for Chesterton. He holds a 6-1 record and a 0.58 earned-run average, also leading the team in strikeouts with 69. Chris Torres is unbeaten at 6-0 with a 1.79 ERA and 50 strikeouts.

The Trojans are 18-7 for the season, while Fishers is 27-7. While Saturday marked the Tigers' first-ever regional title, Chesterton has won three prior to this year, in 1985, 1988 and 1994.

Fishers' leading hitters are seniors Craig Yoho, with a .422 average, and Matt Wolff, who bats .400. Junior Kiel Brenzewski is next in line with a .378 average, and leads the teams in hits (45), RBIs (37), Brenzewski

wski and senior Grant Richardson both have two triples.

Junior JJ Woolwine has the most runs scored with 33, while Yoho and senior Alex Jamieson lead the doubles category with 13. Three Tigers each have hit five home runs: Yoho, Brenczewski and Jamieson.

Senior Luke Albright holds a 7-2 pitching record, with a 3.12 ERA and 83 strikeouts. Richardson is 5-0, with a 3.00 ERA and 72 strikeouts. Cherry said the Tigers are hoping to get through the game with just one pitcher, but since semi-state is only one game, "all hands will be on deck and all will be prepared to throw if needed," said the coach.

TECUMSEH NEXT FOR 'BLAZERS

University won the school's first baseball regional championship with a 9-4 semi-final win over Indianapolis Lutheran, then a 3-0 victory against Hauser in the title game at Morristown.

Next up for the Trailblazers is Tecumseh, a true powerhouse in 1A. The Braves won the Cannelton sectional by beating Springs Valley 15-7 and Northeast Dubois 5-4, then took the Jasper regional (moved from Loogootee) over Borden 1-0 and Barr-Reeve 7-0.

That regional victory was the ninth for Tecumseh, all of its titles having come in 1A since 2001. The Braves reached the state

finals in 2010, falling to Lafayette Central Catholic 4-2.

Tecumseh's best hitter is far and away senior Aaron Beard, who averages .546 for the season. Beard leads the Braves in almost every statistical category: Runs scored (46), hits (53), doubles (16) and home runs (nine). Junior Woody Brucken has the most RBIs with 29, while junior Steven Molinet has three triples.

Sophomore Chase Howell has hit a grand slam for Tecumseh during the season. He is also the Braves' leading pitcher, holding a 6-1 record with a 4.31 ERA and 27 strikeouts. Molinet has struck out 58 to lead in that category, while junior Spencer Buse has 46.

Tecumseh is 20-9 for the season, while University is 27-6. The 'Blazers have three hitters above the .400 mark: Freshman Tyler Galyean at .483, senior Garrett Hill at .473 and junior Dawson Estep at .421.

Hill leads the way for University in hits (52), RBIs (43), doubles (11) and home runs (10). Estep has the most runs scored with 48 and the most triples with four.

On the mound, senior Cade Carlson is 7-2 with a 2.33 ERA and 91 strikeouts. Junior Brock Moore is unbeaten at 7-0, with a 2.81 ERA and 66 strikeouts.
