Prime Life halts transportation service

Prime Life Enrichment, the countywide organization dedicated to assisting senior citizens, will end most of its transportation service on July 16. Needs for medical assistance in getting to a doctor's office or needed dialysis treatment will still be offered.

The Carmel based non-profit did not receive a vital grant this year which has greatly aided in financing the organization's fleet of vans and drivers. Prime Life will seek grants again next year to possibly renew its transportation service.

Prime Life, formerly known as Hamilton County Senior Services, has operated for more than 40 years

offering physical fitness programs and social entertainment for county seniors. Programs other than transportation will continue.

Hamilton County Express, a transportation service provided by Janus Developmental Services, will offer an alternative for anyone impacted by the termination of Prime Life transportation.

Schools can now request metal detectors

Gov. Eric Holcomb said Monday the state is giving metal detectors at no cost to Indiana schools that request them.

The governor describes the detectors as handheld wands. He said it will be up to local officials to decide how and when schools should use the devices.

"Unfortunately, we are living in a time when every school must prepare to respond to someone who might try to hurt them-

selves or others on school grounds," Holcomb said.

Schools can request one metal detector for every 250 students, meaning some schools could get multiple detectors.

State leaders said the program will cost up to \$550,000 and will be funded by the Indiana Department of Administration.

Jeff Crays is a former teacher in Marion County's Warren Township Schools.

"I think it's an important thing to at least have some option there

for those instances when (schools) feel like they need it," Crays said.

Crays said the schools he taught at had security tools and some schools will not need the detectors as much as others.

Schools can request the detectors at in.gov/idoa/3134.htm. The state will place the first orders for the devices on July 19 for delivery by mid-August. The program is open to public, charter and accredited nonpublic schools.

Fishers moving toward increase in stormwater fees to avoid 2019 deficit

Fishers has taken the first step toward increasing stormwater fees, following action Monday by the Board of Public Works and Safety. The board voted to send the recom-

Council Finance Committee. The full council could give final approval to the increase in September.

Rick Farnham, Director of Water Quality, an operation within the Fishers Department of Public Works, told the board that as a result of a study by Policy Analytics, he is recommending a stormwater fee increase on residential customers of \$1.71 per month. Since most Stormwater Utility residential users are billed annually, they would see an increase of \$15.40 in their yearly payment.

According to Farnham, if the city takes no action, the stormwater utility will be operating at a financial deficit in 2019.

Commercial users will see their rates increase between \$3,000 and \$63,000 a year, based on the size of their operations. Farnham told the board the Hamilton Southeastern Schools will be impacted by this increase.

Farnham told LarryInFishers that this is the first increase in the local stormwater fee in the last 10 years. Although this proposed residential fee increase is 35

percent, if you look at this on an annual basis, the increase comes out to about 3-4 percent per year over the past 10 years.

The fee increase proposal's next step is the City Council Finance Committee. That panel will vote on a recommendation that will go before the council for first reading at this month's council session. The second reading would be scheduled for August, which would set-up the fee increase to receive a final vote in September, as part of the annual city budget process.



Corbett criticizes city's handling of ITM

"Nearly all men can stand adversity but if you want to test a man's character, give him power."
— Abraham Lincoln

This quote comes to mind as I watch the drama unfold between the Indiana Transportation Museum and the City of Noblesville. We are in the final stages of ITM's eviction from Forest Park and I'd like to make a couple of comments on the way this episode has been handled. This is a real David and Goliath story. However, unlike in the Bible, Goliath will end up winning this battle despite David's efforts. The City has always held all the cards. It is the landlord, it has seats on the Hoosier Heritage Port Authority (which owns the tracks) and it has the deep pockets and formidable firepower of a taxing authority. The ITM is a non-profit that depends on donations and train fares to pay its bills and is run by volunteers. Still, it managed to successfully operate trains in Hamilton County for decades.

But ITM didn't have a chance

once the city decided it was time to go. Love of trains is no match for high powered lawyers and the heavy hand of government. The landlord exercised its right to eviction, placed an unreasonable timetable on the ITM and brought all available public resources to bear on the hapless non-profit. It's all perfectly legal but that doesn't mean it's right.

I've commented before on the injustice of a government entity throttling a private business for its own ends. I still maintain that our city overstepped its bounds by targeting ITM and doing everything necessary to ensure its demise.

But this letter is about character. When an organization the size of the city of Noblesville takes aim at one the size of ITM, I believe it's incumbent on the larger group to show a little mercy, negotiate a compromise and work in a spirit of cooperation to set things right. None of that happened here. The city, with all the power, created an ultimatum and is in the process of enforcing it. ITM had just months (now days) to

move dozens of train cars and engines, and can't even use the tracks to get the cars to safety because the city won't let it. It's shameful.

The ITM had its problems. Even its leaders will admit to some tough times in its history here. But you might expect that from a non-profit run by passionate people whose skills likely lean more toward mechanical engineering than non-profit management. Many non-profits struggle at times but they recover as long as they aren't targeted for eviction by their city leaders.

As Noblesville loses a treasured public asset, we need to consider whether our leaders did right by the ITM. Because, like it or not, they represent us and the decisions they make should reflect our values. I'm not proud of the way my city has treated the ITM. It's likely too late to salvage that relationship but I intend to do what I can to make sure this kind of thing doesn't happen again.

Two county residents sentenced in nursing home kickback scheme

A federal judge has sentenced two Hamilton County residents for their part in kickback schemes involving nursing homes.

Josh Burkhart, 42, Fishers, brother of the former American Senior Communities CEO who orchestrated the schemes, was sentenced to four

months in prison, two years of supervised release and \$420,000 in restitution.

American Senior Communities former CEO, James Burkhart, 51, Carmel, was sentenced in June to nearly 10 years for his role in the schemes that operated from January 2009 to September

2015. The company's former CFO also has been sentenced. American Senior Communities operates about 70 nursing homes.

Federal prosecutors have said those involved in the scheme have personally pocketed millions in kickbacks and fraudulent overcharges.



Rebecca E. Smith, 56, stationed at Sasebo Naval Base, Sasebo, Japan, passed away on June 18, 2017.

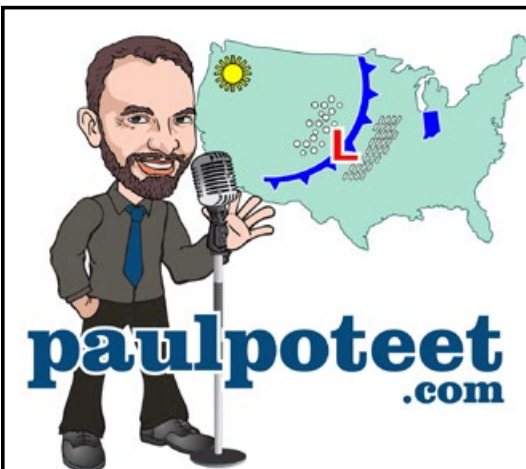

Golf at Prairie View...

Thomas Lewis in final group at Indiana Open

The best golfing talent in the state of Indiana has been demonstrating why it's the best this week at Prairie View Golf Club.

The club is hosting the Indiana Open Championship, which began Monday. Of the 74 players that made the cut after Tuesday's second round, 23 of them are below par. The tournament concludes today with the third round.

Thomas Lewis, a state champion for Westfield High School and a junior-to-be at Purdue, had an exceptional round on Tuesday, shooting a five-under par 67. That included six birdies. Lewis started the event with a one-under 71 on Monday, putting him at six under for the tournament and in a tie for second place.

Lewis is tied with Fort Wayne's Patrick Allgeier for second. Brian Maurer of Williamsburg is the leader: He followed up an even-par performance on Monday with a seven-under round on Tuesday. Maurer had seven birdies and made par on the other holes.

Lewis, Maurer and Allgeier will be the last group to tee off in today's final round, going off the first tee at 11:36 a.m.

Fishers' Andy Winings is tied for fifth place with a four-under par 140. Winings made six birdies in his Monday first round of 68, then shot even par on Tuesday.

Another Fishers golfer, Johnny Watts, is tied for 10th with a three-under 141. Watts, a 2014 Hamilton Southeastern and 2018 Ball State graduate, went under par both days, shooting 71 on Monday and 70 on Tuesday. Watts made an eagle on the 13th hole during the second round. He totaled five birdies in the first round and three in the second round.

Austin Vukovits and Brad Fellers both carded two-under par 142s. Vukovits, from Fishers, recently graduated from Cathedral and is committed to Mississippi State. He totaled four birdies in the first round and three in the second round. Fellers, a founder of the Golf School of Indiana and a PGA pro since 1997, also had four birdies on Monday, and three more on Tuesday.

Carmel's Jake Brown, who just completed his redshirt junior season at Indiana University, is at one-under par 143. Brown shot a 68 in his first round, with four birdies and the rest of the holes all par. Brown made two more birdies in the second round.

The third round begins at 8 a.m. today.
