HSE school board votes on timeline for K-8 redistricting

The Hamilton Southeastern school district is preparing to add another elementary building in August of 2019, which means there will be kindergarten through eighth grade redistricting on the way.

The school board voted Wednesday night to move forward on a recommendation by Dr. William Carnes on the timeline for developing new school district maps, with the board's final vote on redrawn maps set for Dec. 12, according to information posted to the school district website.



The timeline and general principles on moving forward with the process are in line with a discussion held earlier this month in a board work session.

Julia Church Kozicki announces candidacy for Noblesville mayor

Julia Church Kozicki announced Wednesday that she will be a candidate for Noblesville Mayor in the May 7, 2019 Republican primary.

"I am convinced that now is time for proven leadership in Noblesville with a fresh vision for our future and a respect for our city's history," she said. "I believe in a proactive approach to growth and a collaboration among community leaders, organizations and citizens to identify and provide the resources necessary to support a thriving community."

A native of Noblesville, Kozicki was elected to three terms (12 years) as a member of the Noblesville School Board of Trustees and has served in numerous leadership roles in the community, including Noblesville Tri Kappa, the Hamilton County Leadership Academy and First United Methodist Church. She has also served as a three-time chair of the Corporate Counsel Section of the Indiana State Bar Association and as the Region 5 Director of the Indiana School Board Association. She represented Noblesville precincts 1-20 at the 2018 Indiana State Republican Convention.

A graduate of Indiana University and

Loyola University Chicago School of Law, she is legal counsel for Sigma Kappa Sorority's national headquarters. She and her husband, Jeff, have two sons, one at Indiana University and one in his senior year at Noblesville High School, both of whom are Eagle Scouts.

Kozicki's platform includes:

- Establishing closer collaborative cooperation between schools, city and the community
- Reviewing current city ordinances with the goal of reducing unfair, unnecessary burdens of both time and cost
- Establishing a Neighborhood Roundtable to create open dialogue of issues and solutions between the city and its neighborhoods
- Supporting downtown business owners and residents and finally addressing the parking needs of a vibrant downtown
- Believing that on a long-term economic development and cultural/historic

HSE Superintendent's contract renewed through June 30, 2021

Hamilton Southeastern (HSE) Schools Superintendent Allen Bourff's contract has been extended through June 30, 2021, following action by the school board Wednesday night.

According to a posting on the

school district's website, Dr. Bourff will forgo a base pay increase and instead will have roughly \$4,000 added to his salary to utilize for health costs as he chooses. According to school board President Matt Burke, this amounts to about a 2 percent increase in Dr. Bourff's compensation and is less than he would be eligible to receive under his contract with

the school corporation.

The board's action approved Dr. Bourff's incentive pay for the period of July 1, 2017 to June 30, 2018 at \$11,530.89, in line with his contract.

According to the post, the vote to approve the action was unanimous. Two board members, Terry Tolle and Michelle Fullhart, did not attend the session.

Sobriety checkpoint coming this weekend

A sobriety checkpoint will be conducted on the night of Friday, Aug. 24 and the early hours of Saturday, Aug. 25.

Impaired driving is one of our nation's most frequently committed violent crimes. Just in Indiana in 2014, alcohol-related traffic crashes killed 101 people, accounting for approximately 13 percent of all fatal crashes, and injured another 1,880 people.

About 750 people are convicted of an impaired driving offense annually in Hamilton County alone, and nearly 100 of those are repeat offenders. In 2015 in Hamilton County, for example, the State filed 732 cases of operating while intoxicated. Of these, 106 drivers had prior convictions for operating while intoxicated within the last five years.

To combat this crime, the Hamilton County Traffic Safety Partnership will be setting up sobriety checkpoints around Hamilton County to aggressively deter, detect, and arrest those drivers who make the decision to drive impaired. Sobriety checkpoints have proven successful in both raising awareness of impaired driving and reducing the likelihood of a person driving after they have been drinking.

In order to raise awareness of the prevalence of impaired driving in our community and the efforts of the Partnership to combat the crime, the Partnership maintains a webpage at hamiltoncounty.in.gov/503.

At a sobriety checkpoint, law enforcement of-

ficers evaluate drivers for signs of alcohol or drug impairment at a specified point along the roadway, often depending upon the support of local property owners for the use of appropriate land. Checkpoint sites are selected based upon analysis of available crash and impaired driving arrest data and a consideration of officer safety.

Vehicles are stopped in a specific sequence, such as every other vehicle, every third vehicle, every fourth vehicle or by stopping three, four, or five cars in succession and allowing other traffic to proceed while checking the stopped vehicles. The planned sequence in which vehicles are stopped depends on the number of officers available to staff the checkpoint, traffic congestion, and other safety concerns.

Upon making contact with the driver, the officer advises them that they've been stopped at an HCTSP sobriety checkpoint and asks for the driver's license and the vehicle's registration. If, in the course of the contact, the officer detects that alcohol may be involved and that the driver may be impaired or if some other issue arises, then the vehicle is directed into a pull-off area for further investigation. Further investigation may involve the Standardized Field Sobriety Tests (SFSTs).

On the other hand, if all looks right during the initial contact, the driver is often on his or her way in less than two minutes.

Officers staffing the sobriety checkpoints work on an overtime basis paid by grant funds from the

National Highway Traffic Safety Administration through the Indiana Governor's Council on Impaired and Dangerous Driving.

Sobriety checkpoints are legal in 39 states, including Indiana, and the District of Columbia. In 1990, the U.S. Supreme Court ruled that, if conducted properly, sobriety checkpoints do not constitute an illegal search and seizure. In the 2002 case of *State v. Gerschoffer*, the Indiana Supreme Court found that sobriety checkpoints are constitutional when conducted properly. Members of the Hamilton County Prosecuting Attorney's Office work with the Partnership to ensure that each checkpoint meets constitutional requirements.

The Hamilton County Traffic Safety Partnership (HCTSP) is a consortium of law enforcement agencies in Hamilton County working to increase the usage of seatbelts, to combat aggressive driving, and to decrease impaired driving with the overall goal of creating a safer Hamilton County. The HCTSP is comprised of the Hamilton County Sheriff's Department, Fishers Police Department, Carmel Police Department, Noblesville Police Department, Westfield Police Department and Cicero Police Department, with the assistance of the Indiana State Police.



New electricity rate proposal approved by state regulators

Indiana utility regulators have approved an agreement between Duke Energy and consumer groups to lower customer electric rates using savings from the new federal tax law. The move will mean a 5.6 percent average rate reduction for Duke Energy Indiana customers by 2020, with most of the savings beginning in 2018.

Additional savings as a result of the federal tax act and the settlement will be reflected in future filings before state utility regulators. The amount of the tax savings will vary by customer class. Average residential customers using 1,000 kilowatt-hours a month will save \$7.33 on their monthly electric bills by 2020.

Duke Energy, the Indiana Office of Utility Consumer Counselor, the Indiana Industrial Group and Nucor Steel submitted the agreement to the Indiana Utility Regulatory Commission in late June. The agreement outlined how to pass along to customers the benefits of the Tax Cuts and Jobs Act, which federal lawmakers passed in late 2017.

"This is an important agreement, and the commission's approval allows us to begin passing along savings to customers immediately and ensure they see the benefit of the new federal tax law," said Duke Energy Indiana President Melody Birmingham-Byrd. "It's a unique opportunity to lower electric rates and help offset other costs."

Duke Energy began reflecting the lower federal tax rate in customer bills earlier in 2018 as it filed new electric bill riders with the state utility regulatory commission. In addition to the tax reductions in bill riders, the settlement agreement reduces base rates in September 2018 to reflect the lower tax rate. The agreement also includes refunds of accumulated deferred taxes in 2018 and 2020.

Positive energy leads Tigers to 4-0 record

If you go to a Fishers volleyball match, you will find a great amount of positive energy in the Tiger Den.

That was certainly on display Thursday night as Fishers played Zionsville to open Hoosier Crossroads Conference play. The Tigers came from behind to win the first set, took control of a see-saw second set, then cruised through the third set to sweep the Eagles, 25-22, 25-21, 25-17.

Thus Fishers began its HCC campaign with a win, and also improved its season record to 4-0.

"I'm almost speechless on how well they played because we've been putting so much emphasis on taking what we did in practice and doing it in matches, and working on our serve receive game and not getting too hyped, too amped up to the point where we can't execute and do what we need to do," said Tigers coach Steven Peek.

"It takes a large level of energy to play the game, but there's a point at which it's too much," said Peek. "So they did an amazing job of balancing their energy tonight and they did an amazing job of serve receiving, staying positive. This being my third season here, this is the most positive team I've coached in the three years here. They did a great job with that tonight."

That positive attitude carried the Tigers through the first set, a set in which Fishers trailed for most of the time. The Tigers were still down 20-17 at one point before running off eight of the next 10 points to win the set. Bryn Roberts hit three kills and joined Haley Soper for a block, Rose Duffy helped out with a kill, and Camryn Haworth spiked the set-winning kill.

Zionsville bolted out to a 4-1 lead in the second set, but Fishers immediately tied it up. Neither team led by more than a point for a long time, until a run of three consecutive points put Fishers up 21-19. The Tigers then finished the set with two straight points, as Camryn Haworth and Soper made a block, then Audrey Haworth put down a kill to put Fishers up 2-0 in sets.

The Tigers' big hitters powered through

the third set. Camryn Haworth hit an unbelievable five kills in an eight-point span midway through the set, helping Fishers to break out of an 8-8 tie and take a 14-11 lead. Jada Allen had three kills in the set, including a big hit to put Fishers up 15-11. From there, the Tigers worked their way to the finish line; Audrey Haworth's kill gave Fishers the match.

Camryn Haworth had 13 kills and 14 digs on the night.

"Cam is a dominator, for sure," said Peek. "That's what she wants to do. She's just built and made that way as an athlete and she's built herself to be that person."

Roberts had 12 kills, while Allen and Audrey Haworth both hit 10 kills.

"It takes a lot of pressure off, especially knowing that this is a really exciting game for everybody, so everybody's at their top and they're going over and beyond to just get the point," said Camryn Haworth.

Peek was thrilled with Allen's performance as well.

"We've got a great team and a great supporting cast around her and every single moment, we need somebody to be the star," said Peek. "Other teams, I think, make her out to be their No. 1 priority in stopping her, so she's got a target on her back all season from the get-go. People are going to want to try to stop her." The coach said for Allen to get 10 kills "means she absolutely earned it."

Duffy had an outstanding game with 43 assists, three blocks and 20 digs. Duffy had 20 dig attempts, which put her percentage at 100.

"For her to dig every ball, all 20 of them that came at her, is awesome," said Peek. "Like I said in regard to serve receive, one dig when it's 15-15 in the second and you had to come back in the first, that one dig just allows us to get a little bit of an edge and that confidence."

Emma Rosenberg had 18 digs and Soper made 1.5 blocks.
