# Carmel senior living center files for bankruptcy

One of Hamilton County's best known luxury retirement living centers, The Barrington, has filed for Chapter 11 bankruptcy. The Carmel facility, owned by Mayflower Communities, Inc., is a 271-unit facility located on Guilford Road a short distance north of 116th Street.

In late January, Mayflower filed in federal bankruptcy court in Texas claiming about \$152 million in liabilities and \$96 million in assets at its Carmel facility. The company owns five other retirement homes around the country.

The Barrington opened five years ago with considerable fanfare. New residents paid what are called "refundable entrance fees" of \$300,000 for an apartment plus a monthly maintenance fee and are guaranteed care for life.

Indications of serious financial problems became evident in November 2018 when the Barrington defaulted on municipal bond payments. Generally Chapter 11 bankruptcy is filed by corporations which ask the court to restructure their debts to make payment more possible or, in extreme cases, sell the assets.

Carmel city spokesman Dan McFeeley said Tuesday that the city is not held responsible in any way for paying off the bonds.

The original bond issue was for \$112 million.

The Barrington is listed as a non-profit organization which provides property tax exempt status. Despite its original financing through the City of Carmel's developer bonds and its tax exemption, the facility has still apparently experienced obligations far in excess of revenue.

The court action does not mean any immediate effect on residents. Normal operations are continuing.

# Heights earns 'Performance Qualified High School' status

Hamilton Heights High School (HHHS) was rated as an "A" school and has received the status of a "Performance Qualified High School" for the 2019-2020 school year by the Indiana Department of Education and the Office of School Accountability & Accreditation. This is the highest performance and improvement category by the Indiana Department of Education.

To be eligible for the Performance Qualified High School Program, a high school must receive an A for the previous school year. A high school remains designated as a Performance Qualified High School until it either receives a C or lower for one school year or receives a B or lower for two consecutive school years.

The purpose of establishing the Performance Qualified High Schools program is to provide flexibility to schools that meet the criteria. These high schools can then provide curriculum, instruction, programs and educational innovations

prepared for whatever challenges they may face."

Former Hamilton County Judge Steve Nation served as chairman of the event. In addition to Ditslear, Nation and Crossroads of America Council CEO Joseph Wiltrout speaking, Scouts of different ages talked about their experiences and the values that Scouting has taught them.

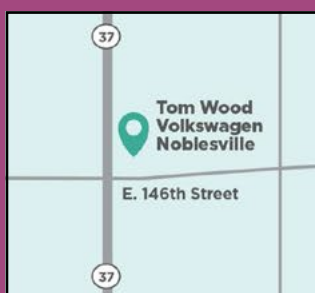

The Grand Junction Plaza will be that place where people can connect. It will anchor the east side allowing for a balanced approach to development. The Grand Junction Plaza will be a one-of-a-kind space that will attract people from far and wide and will give our citizen's a sense of pride."

There will be no tax increase for residential property taxpayers through the city's funding plan for the Grand Junction Plaza. The project will be funded with Local Income Tax revenues until that time when revenues from the Tax Increment Finance economic development area will be able to cover costs.

The Grand Junction Plaza was designed by renowned landscape architect David Rubin. The Grand Junction Task Group, a volunteer citizens group, included the Plaza as an integral part of its master plan designed over the last 10 years. The organization was instrumental in the concept development and design of the Grand Junction Plaza. Last October, the City announced the reconstruction of State Road 32, which was a fundamental element of the Task Group's master plan.

The Westfield City Council is expected to vote on the funding plan later this month. If financing is approved, Plaza construction will begin this summer and be complete in the summer of 2021.

designed to help engage students in greater ways than what is required of the schools.

One of the requirements of a Performance Qualified High School is that the instructional day consist of at least six hours of instructional time and 180 student instructional days. However, a school that is eligible for the Performance Qualified High School program may exercise some flexibility around these instructional time requirements if the total number of instructional minutes provided in a school year meets the required timeframe.

"I give a lot of the credit to our students and staff who have worked hard to earn this status," said Heights High School Principal Jarrod Mason. "This will allow us more flexibility in time requirements in the upcoming school year as we work to provide students with more opportunities to grow, learn and prepare for better, brighter futures!"

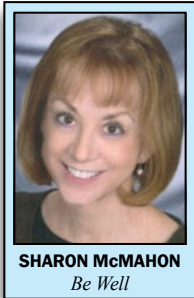
# Striving for gold standard in heart health

"I want to live, I want to give. I've been a miner for a heart of gold." – Neil Young, 1972

Most of you are very aware that February is "National Heart Health Month" as well as the "Go Red for Women" month. Fortunately there is much information available now about heart health, particularly as it relates to women. Few people are not surprised, thankfully, that heart disease is the *number one killer* of both men and women, surpassing all types of cancer and other diseases. In 2012, nearly 787,000 people in the U.S. succumbed to heart disease, with coronary heart disease being the most prevalent. Direct and indirect costs of heart disease total more than \$320.1 billion. That includes health expenditures and lost productivity.

While heart disease statistics have been available and research conducted for many years regarding heart disease and men, both research and information-gathering for women's heart issues are relatively recent. While only 1 in 5 American women believe that heart disease is her greatest health threat, heart disease causes 1 in 3 women's deaths each year, killing approximately one woman every minute. Ninety percent of women have one or more risk factors for developing heart disease. The symptoms of heart disease can be different in women and men, and are often misunderstood.

Thankfully, the information noted above, and much more, is readily available. I encourage everyone to talk frankly

with their health provider about their risk factors, review their dietary habits and make this a priority. My own viewpoint on the subject also incorporates getting adequate sleep, removing stress, "getting up from sofas and chairs" and making the necessary life changes which can alter those statistics.

Additionally, the effects of isolation and loneliness have been widely studied as it relates to heart disease. To learn more about the "Roseto" effect in which a close-knit community experiences a reduced rate of heart disease, a recent PBS special documentary revealed attributes of positive relationships which reflect on our heart health. Information is also available online for those who wish to search for more information. The effect is named for Roseto, Pa., and describes family and community interaction there and the healthy effect on the inhabitants.

My quote this week may seem a little odd, but I hope that as we close up the month of February you do take responsibility and become a "miner for a (healthy) heart of gold." Let's strive for the "gold standard" in heart health by consuming fewer trans fats, packaged foods high in sodium, refined carbs, fried foods and whole milk products. Working on establishing better family and working relationships, getting in those 10,000 steps each day and adequate rest will do your heart good!

# Carmel Redevelopment Director honored by IBJ's 'Forty Under 40'

Henry Mestetsky, the Executive Director of the Carmel Redevelopment Commission, has been honored by the Indianapolis Business Journal and its annual "Forty Under 40" feature that highlights entrepreneurs, doctors, government officials and executives considered by the news publication as a group of "Indy's rising stars."

# California-based real estate company purchases property in Carmel's Midtown

A revolutionary online real estate investing company recently added Allied Solutions' new headquarters in Carmel's growing Midtown redevelopment area as the newest asset in its portfolio. The purchase was announced last week.

On the campaign trail, I've been asked how I view (and would practice) the term that seems to have become all-too politically convenient to use. This is an important question all local leaders should answer.

To me, it's simple. Especially in the context of local government, to be fiscally conservative means to prioritize goals.

This past summer my wife and I renovated part of our house. It's a beautiful home on 9th Street built in the 1940s. It was well-loved prior to us and has a good core, but there are projects we need to accomplish to ensure it will last another 80 years. In fact, in the past eight years Noblesville has seen a nearly **19 percent increase in population growth**. From my perspective, we've maintained this rate of growth by ensuring that quality of life is high, housing is affordable and there is opportunity for upward mobility for the generation following us. These are all areas that should remain a focus going forward and by prioritizing our goals, we can ensure that Noblesville's best days are to come.

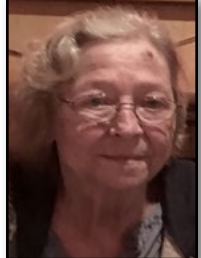

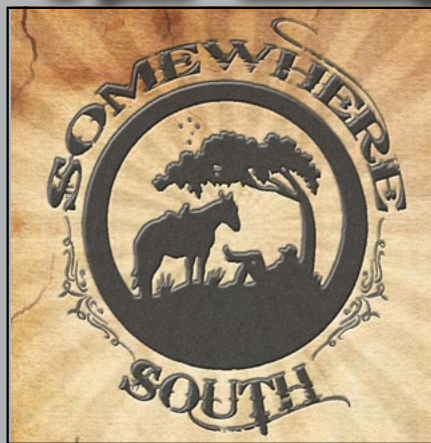

# Millers beat Golden Eagles for fourth win in a row

**NOBLESVILLE** - The Noblesville and Guerin Catholic boys basketball teams haven't played each other often, but when they do get together, it makes for some exciting games.

Tuesday's game between the two teams at The Mill was another good one. The Golden Eagles got off to a great start, then the Millers came back with an outstanding third quarter. Noblesville then held off a fourth quarter Guerin run to win 44-41, giving the Millers their fourth victory in a row.

"Everybody contributed and it was a huge, huge win for us, because Guerin Catholic's a very good team," said Noblesville coach Brian McCauley. "They've been in every game. They had a lead with 61 seconds to go against North Central, at North Central.

"It was a tough battle and we knew it would be," said McCauley.

The first quarter began with some early basket-trading, the Golden Eagles went on a 10-2 run that stretched into the start of the second quarter. Kian Sills hit a 3-pointer to open the run, with Matt Parenteau also contributing three points (a layin and a free throw). Eagan Keever-Hill's layin was the last score of the first period, but a basket by Bernie McGuinness put GC up 14-6 to begin the second quarter.

Jordan Schmidt hit a 3 for the Millers, and that was answered by Joseph Bobilya's 3 for the Golden Eagles. Noblesville scored five quick points to cut Guerin Catholic's lead to 17-14; Alex Hunt made a putback and Xavier Hines nailed a 3. But the Golden Eagles answered again: Matthew Gillis hit a layin and McGuinness drained a 3, putting Guerin Catholic up 22-14 at the break.

Following halftime, the Millers played what McCauley said was the best quarter of basketball his team had played all season. Noblesville outscored the Golden Eagles 17-2 in the third period.

"We were 8-of-8 from the field in the third quarter," said McCauley.

Zack Johnson made back-to-back layins, then Hunt took a steal in for a dunk. Hines' jumper tied the game, and Keever-Hill got the Millers on top with a layin. McGuinness made two free throws with 2:48 left for GC's only points of the third, but Noblesville promptly scored seven more points: Schmidt hit a jumper, Keever-Hill made a 3 and Johnson's layin put the Millers ahead 31-24.

"I think our guys battled for three of the four quarters," said GC coach Bobby Allen. "We obviously came out in the third quarter and we couldn't stop them."

Noblesville held the lead for the entire fourth quarter, twice going up by 11 points. Schmidt's two free throws gave the Millers a 39-28 advantage with 4:01 to play. The Golden Eagles started to chip away at that point, with Luke Godfrey hitting a 3-pointer, then McGuinness converted a traditional three-point play with 1:12 left to get GC within 41-38. But two free throws from Johnson with 21.6 seconds left gave Noblesville a 43-38 lead, and the Millers were able to hang on.

Schmidt and Johnson each scored 10 points, while Keever-Hill and Hunt both added nine points. Hines collected four rebounds.

"All in all, tremendous second half," said McCauley.

McGuinness scored 12 points for Guerin Catholic, with Sills adding 10, including two 3-pointers. McGuinness pulled six rebounds, with Sills grabbing five and also handing out four assists.

"Once they got that big lead on us, I'm proud of our guys for not giving up. We could've very easily given up and we battled back, had a chance to win it at the end," said Allen.

Noblesville is 12-8 and travels to Avon Friday to finish up Hoosier Crossroads Conference play. Guerin Catholic is 11-10 and will host Anderson next Tuesday.

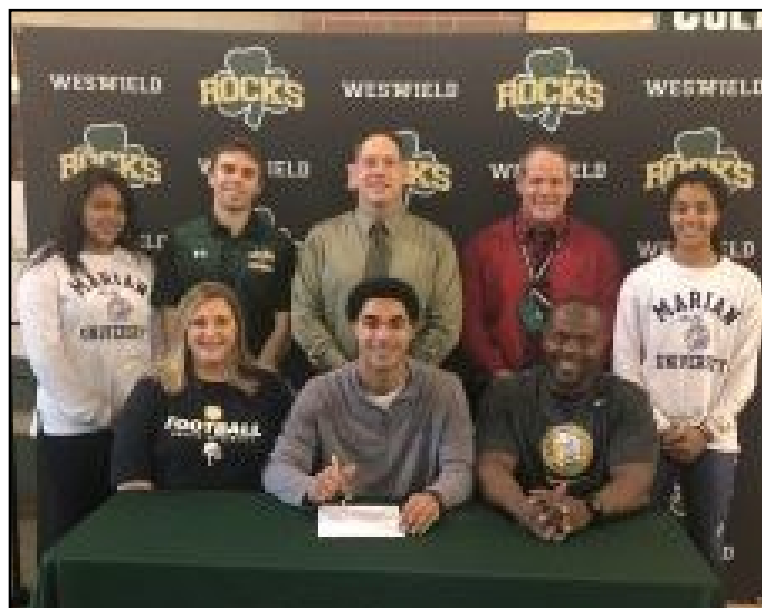

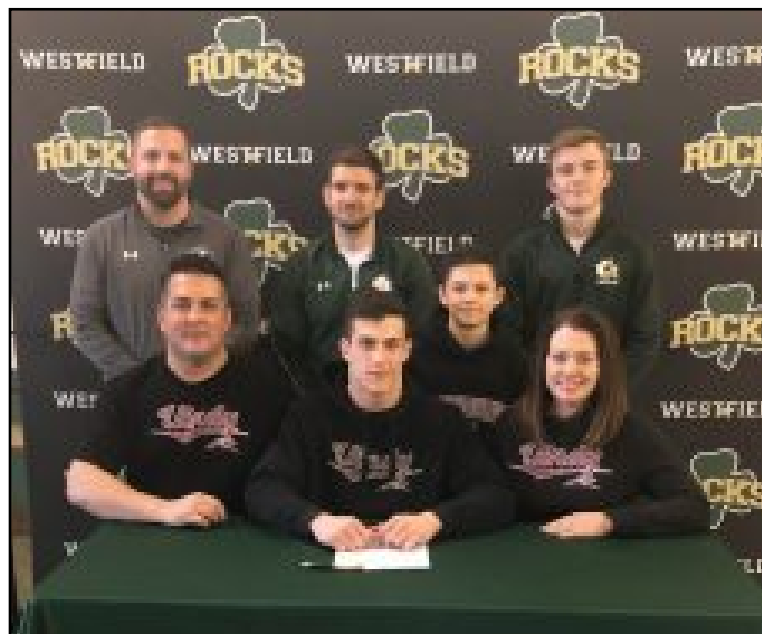
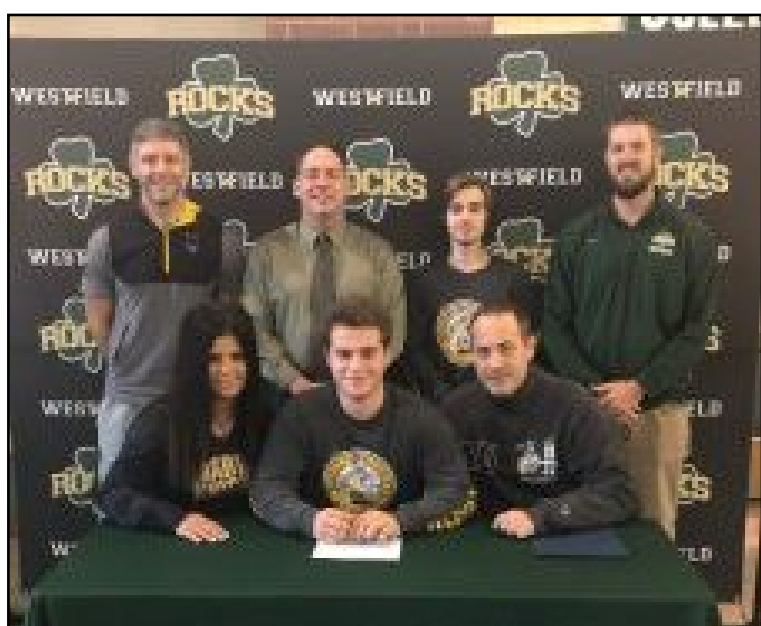
