## Fishers City Services Building opening today

As the City of Fishers has grown to a municipality containing an estimated 91,000-plus residents, the city staff has grown, and that has caused a space crunch at City Hall. With the police department exiting its longtime home in a building just north of City Hall and moving across the street to the new George Kehl Station, a number of city departments have been in the process of moving into the previous police station.

The City Services Building (CSB) is the name given to the former police headquarters, and the public will have access to the CSB as of Friday, March 1.

The Fishers City Court, which has been holding sessions in the City Council Chambers, will now be located inside the City Services Building, providing a secure and permanent location for court officials. Those visiting the CSB will be able to deal with permit and inspection processing, sewer and storm water bill payment, court payments, and traffic tickets. Parks and Recreation payments will be accessible at the City Services Building. This includes payments and registration for building and pavilion rentals, activities and programs and Special Event Permit Applications (SEPA). This new location can service residents in addition to Parks & Recreation's office at 11565 Brooks School Road.

Plenty of parking is available in the area of the CSB, with surface lots and a number

"In 2018, Hamilton County had 1,431

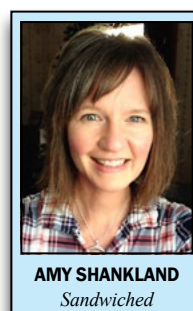

# Sheriff releases Home Place to Carmel Police Department

Effective today the Hamilton County Sheriff's Office relinquished primary law enforcement responsibility of the Home Place area to the Carmel Police Department.

This includes the areas in the southern portion of the county: old Home Place, Colledge Meadows of Lexington Farms generally bounded by 96th Street to the south, Westfield Boulevard on the east, 111th Street to the north, and Pennsylvania Avenue on the west.

The City of Carmel officially annexed the Home Place area in 2018 but the Sher-

iff's Office retained primary responsibility during the transition. Friday, March 1 marks the end of the transition so those residents affected by the annexation will see Carmel Police responding as the primary law enforcement agency for both emergency and non-emergency incidents.

"The Carmel Police Department is excited about Home Place and their residents becoming part of the City of Carmel community," said Carmel Police Chief Jim Barlow. "As we transi-

tion police services from the Hamilton County Sheriff's Department, we are prepared to provide dedicated and quality police response and protection. We look forward to building a great relationship with Home Place residents for years to come."

Requests for information and general assistance in the area should be addressed to the Carmel Police Department. As with all incorporated areas, the Sheriff's Office will maintain a presence.

I had to return to work the next week, but Mom

still had some miscellaneous needs. Fortunately, John's work slows down in the winter, so he once again came to the rescue. He hooked up Mom's little TV so she could have cable in her bedroom, bought and assembled a stand for it, and served as a general handyman that week for anything else that popped up. John also picked her up so they could both meet me for lunch that Wednesday – at Ginger's, of course.

He even purchased one of those "car canes" that fit

into the doorway so Mom could easily get in and out of his vehicle.

John continues to be my "back up" for various caregiving tasks for Mom, and I can't express my appreciation enough.

I never thought I could love my husband more, but in late 2016, I discovered that it truly was possible. Thank you, John, for all you do for Mom. And thank you to all spouses who do so much for their in-laws.

You are appreciated more than you know.

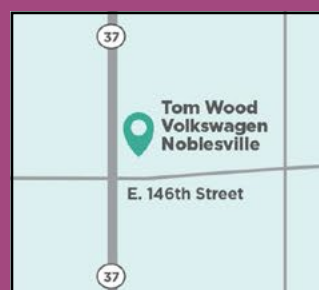

# Encourage respect for flag and nation



At the risk of sparking a controversy, I want to make a suggestion on a subject you could call 'respect.' The type of respect I'm talking about is respect for the American flag by practicing the time honored tradition of placing the right hand over the heart during the playing of the national anthem.

At a recent high school basketball game I could not help but notice

that members of the home team did not place their hands over the heart. Hundreds of fans likely observe team members during some part of the national anthem.

The U.S. Flag Code calls upon Americans to stand, face the flag and place their right hand over their heart during the playing of the anthem. There is no enforcement provision in the code. It's just a good recommend-

ed practice to follow. Of course there are many folks who don't follow the tradition.

But, members of sports teams are representatives of their schools and role models for fellow students and younger people who will often do what they see team members do.

Most of our sports team members follow rules of good behavior, get good grades and are on the road to

becoming successful, model citizens. So, it should not be difficult to incorporate this simple sign of respect into routine behavior.

Either in school or at home, you'd hope that youngsters would be taught this sign of respect for their flag and nation. If no one else encourages this simple but symbolic gesture, perhaps coaches should remind their team members of this practice.

# U.S. House passes bipartisan poison control bill to help combat opioid epidemic

The U.S. House of Representatives on Monday passed H.R. 501, the Poison Center Network Enhancement Act of 2019, legislation authored by Congressmembers Susan W. Brooks (R-Ind.-05), Eliot Engel (D-N.Y.), Diana DeGette (D-Colo.) and Jaime Herrera Beutler (R-Wash.) that will assist with potential poison exposures and help combat the national opioid epidemic.

Poison control centers are vital to preventing toxic exposure and poisoning injury and deaths, including opioid and other drug overdoses. This bill reauthorizes

funding for the Poison Center Network, including their national toll-free number: (800) 222-1222. It also clarifies that poison control centers can be called upon to assist with public health emergencies, responses and preparedness; and requests that enhanced communications capabilities like texting be established.

"There is no one-size-fits-all solution to put a stop to the deadly opioid crisis that is devastating Hoosiers and Americans across the country," said Brooks.

"However, this bill is a critical piece of the puzzle because it allows the national network of poison control centers to help people who are struggling with addiction by offering free, confidential and expert medical advice at all hours, every day of the year.

Their data is used to identify hot spots for opioid abuse and misuse, and with this reauthorization, will be able to continue combating the opioid epidemic and save lives."

"The nation's network of poison control centers help keep families safe by offering lifesaving assistance and helping prevent unnecessary poisoning deaths and injuries, including opioid overdoses. Not only are these centers often the first resource people seek after an opioid overdose occurs, but they also collect real time data to alert impacted communities about opioid abuse and misuse. We commend Rep. Brooks for her leadership on this bipartisan legislation, which will provide these vital centers with the tools they need in order to continue saving lives."

## AG Hill announces start of Wells Fargo consumer redress review program

On Dec. 28, 2018, Indiana Attorney General Curtis Hill announced that Wells Fargo Bank N.A. will pay \$575 million to resolve claims that the bank violated state consumer protection laws. As part of a settlement involving all 50 states and the District of Columbia, Indiana will receive \$5.2 million. (Click [here](#) to view the earlier release.)

On Thursday, Hill announced that Wells Fargo has begun a consumer redress review program through which consumers who have not yet been made whole through other remediation programs already in place can seek to have their inquiry or complaint reviewed by a Wells Fargo escalation team for possible relief.

"We must continue working tirelessly to hold companies accountable for engaging in blatant misconduct that harms consumers," Hill said. "This consumer redress review program announced today is another step toward restoring people who have suffered from such misconduct."

The consumer redress review program was a key component of the December 2018 settlement to resolve claims that the bank violated state consumer protection laws by (1) opening millions of unauthorized accounts and enrolling customers into online banking services without their knowledge or consent, (2) improperly referring customers for enrollment in third-party renters and life insurance policies, (3) improperly charging auto

loan customers for force-placed and unnecessary collateral protection insurance, (4) failing to ensure that customers received refunds of unearned premiums on certain optional auto finance guaranteed asset/auto protection ("GAP") products, and (5) incorrectly charging customers for mortgage rate lock extension fees.

As part of the program, Wells Fargo will maintain a website that contains information regarding consumers' eligibility for redress. Wells Fargo's website describes the issues covered by the settlement agreement and provides escalation phone numbers consumers may use to request review. In addition, Wells Fargo will provide periodic reports to the states about ongoing remediation efforts.

## County girls basketball players earn post-season awards

With the high school girls basketball season finished, the post-season awards are coming in.

Hamilton County is well-represented on these various lists, especially the teams from Class 4A state champion Hamilton Southeastern. Three Royals players were recognized on the Indiana Basketball Coaches Association's All-State lists, which were released earlier this week.

Amaya Hamilton was named to the IBCA/Subway Senior All-State "Supreme 15" list, which recognized the best seniors across the state. Hamilton, who is headed to Duquesne University, averaged 11.7 points and 6.6 rebounds per game for the Royals.

Four county seniors were named to the Honorable Mention list: Reagan Hune (Carmel), Malea Jackson (Hamilton Southeastern), Mallory Johnson (Noblesville) and Maddie Knight (Noblesville).

## Bogdanovic takes over in fourth, leads Pacers past Minnesota

With the game on the line, Indiana turned to a familiar source of offense: the hot hand of Bojan Bogdanovic.

In a tense fourth quarter against the visiting Timberwolves, Bogdanovic provided a steady hand, scoring seven straight Pacers points in crunch time to power Indiana to a 122-115 victory on Thursday night at Bankers Life Fieldhouse.

Bogdanovic, who finished with a team-high 37 points, played the role of hero for the Pacers (41-22), using his fourth-quarter showcase to overshadow a monster game from Timberwolves center Karl-Anthony Towns, who racked up 42 points and 17 rebounds.

"Karl-Anthony Towns hurt us in the first quarter," Bogdanovic explained. "We started to double him and started to play very aggressive defensively and we had a lot of easy points in the fast break."

The win snapped a brief two-game losing streak for the Pacers and opened up their three-game homestand with a gut-check win against a Timberwolves (29-33) team that is fighting to make the playoffs. Both teams were battling fatigue on the second night of a back-to-back, but it was the Pacers who had enough in the tank to make a final push, outscoring Minnesota 30-25 in the fourth quarter.

"I challenged the guys before the game," said Pacers head coach Nate McMillan. "All

we need is what we have in this room, to win games. We've got to bring that energy. We've got to bring that attitude, that focus, out there."

The Pacers showed that focus when the game was knotted at 107-107 and Thaddeus Young bulleted a pass to Bogdanovic, whose backdoor cut put the Pacers ahead by two with 3:31 remaining and started his game-winning streak of offense.

On their next offensive possession, it was Bogdanovic again, knocking down a 3-pointer to extend Indiana's lead to 112-107.

The Timberwolves quickly went to work on the other end, as Jeff Teague drew a foul and knocked down one of two at the line, getting the T-Wolves within four.

But on offense, Indiana's leading scorer Bogdanovic provided the answer again, with a deft up-and-under layup to push the advantage to 114-108.

Free throws from Taj Gibson following a loose ball foul on Indiana led to the Timberwolves once again narrowing the deficit, but the Pacers were able to close out the game with ease from there, ending the night with a seven-point win.

In the game's early moments, the Pacers struggled to contain the offense of Towns, as the All-Star center racked up 23 points and seven rebounds over the first 12 minutes of action. By the end of the quarter, the visiting Timberwolves led the Pacers 35-26 as Indiana searched for an answer to slow down Towns.

TJ Leaf, who finished with a career-high 18 points, set the pace for Indiana to begin the second, scoring the first seven points of the quarter for the Pacers.

"I'm a pretty confident guy," Leaf said after the game. "I don't really try and take what a lot of people say, good bad or ugly. I know what I can do out there, so I try to play my game, whatever that looks like on each given night."

Just as Indiana cut its deficit down to six on a Doug McDermott 3-pointer, the Timberwolves started a run, breaking off an 8-2 sprint that put them ahead 49-38.

It didn't take long, however, for the Pacers to answer right back, as Indiana opened up a barrage of long range shooting, knocking down six threes in a five-minute span to regain a 61-57 lead.

A late tip-in by Bogdanovic marked the final points of the half for the Pacers as Indiana entered the locker room leading 64-60 after outscoring the T-Wolves by 13 points in the second quarter.

The Pacers continued their impressive streak of scoring to open the second half, getting 3-pointers from Bogdanovic and Wesley Matthews to pull ahead 72-62.

It was then the offense hit a snag, as Towns and the Timberwolves embarked on a 14-2 run to wrest the lead back from the Pacers. During the run, Towns continued to be a force, at one point knocking down Thad Young on his way to the basket. While protesting the no-call, Pacers head coach

Nate McMillan was called for a technical foul, putting Towns at the line to add another point to his total.

Following a Pacers timeout, Indiana began to break out of its offensive funk, getting scores from Kyle O'Quinn and back-to-back buckets from Leaf to jump back ahead.

Despite a jumper from Timberwolves guard Tyus Jones to close the third quarter, Indiana remained in front, leading 92-90 entering the fourth.

Leaf continued his strong play to start the final quarter, converting on three shots to add to his career high in points. But the Timberwolves refused to fold up shop, cutting down their deficit to just two points when Jeff Teague dropped home a floater with 9:26 left in the game.

Over the next five minutes, the teams continued to trade baskets, with Thad Young tying things up at 107 and the Timberwolves calling for timeout with 4:22 remaining, setting up the exciting finish at the Fieldhouse.

"Win by any means necessary," said Darren Collison. "Right now, our backs are against the wall. We haven't been playing well, but tonight was an opportunity for us to get back on track. (We) understand that every game from here on out is important to us and, regardless of what the score was in the fourth, we were going to come out on top."
