# Reynolds Farm Equipment Christmas light show moving to Conner Prairie

In a move long-rumored around Fishers, the popular Reynolds Farm Equipment holiday light show will be moving to Conner Prairie. The move was announced in a joint news release issued by Reynolds and Conner Prairie.

Conner Prairie, Reynolds Farm Equipment, the Reynolds family and the festival title sponsor Conner Prairie Alliance surprised Central Indiana residents with an early Christmas gift this year by revealing a sparkling, new

addition to the previously announced A Merry Prairie Holiday festival arriving later this year. This new event promises to deliver endless opportunities for winter fun.

"Winter is always a special time at Conner Prairie thanks to our 40 year plus tradition of holiday festivities," said Conner Prairie President and CEO Norman Burns. "This year it will be even more so as we bring new experiences to the holiday season and carry on a time-honored family tradition by displaying the Reynolds Christmas lights donated by Gary Reynolds and his

family across the grounds as part of the new A Merry Prairie Holiday Festival."

The new A Merry Prairie Holiday festival at Conner Prairie debuts on Nov. 29 and runs through Dec. 31. A vast majority of 400

"Our Christmas light display was born out my father's love for Christmas and our community," said Gary Reynolds, owner and chairman of Reynolds Farm Equipment. "Transitioning our Christmas lights display to Conner Prairie ensures this tradition of celebrating Christmas with lights continue as part of Conner Prairie's new A Merry Prairie Holiday festival."

Founded in 1955 by farming husband and wife "Mac" and Arline Reynolds, Reynolds Farm

Equipment is a regional John Deere retailer serving farmers, homeowners, landscapers and golf course operators throughout the Midwest. Headquartered in Atlanta, Ind., the company operates seven retail locations in Indiana, Ohio and Kentucky.

## Carmel police K-9s get gift of Narcan

There's a new lifesaving device in the hands of police, one they hope they never have to use.

Officers say the Narcan sprayers could be the difference between life and death for K-9 officers. About two months ago, a K-9 in St. Louis needed Narcan to reverse the effects of an overdose.

Police in Carmel hope they never have to do the same. But since the epidemic really picked up, they're being extra cautious.

Officer Katy Malloy puts her own life on the line every time she gets out of the car; there's another tool in her uniform. "It is a big deal," she said.

She now carries a special pack of Narcan, not for her, but her K-9, Axl, who faces danger whenever he sticks his nose out.

"It could be the difference between life and death to get the necessary vet care we need," said

Malloy.

Axl worked fast in this training exercise Monday. His nose knows. That's what can be so dangerous – just a few grains of fentanyl is enough to make a person overdose. But a dog metabolizes it even faster.

"That type of exposure is so quick, it doesn't take much to cause death," said Malloy.

That's why about five years ago, she stopped having her K-9 go inside a vehicle to sniff out drugs, except in the most rare of circumstances. She said the danger of exposure to unknown substances is too great since fentanyl became more popular.

Axl is so good at his job he doesn't need to go inside to know there's something inside.

"If the dog does not have to put himself at further risk, then I'm not going to put him there," said Malloy.

The free gift of Narcan comes from a group called

An early Wednesday morning fire destroyed a home in the Shady Knoll subdivision in Fishers.

Fire officials say the residents were able to escape without injury due to the early warning of the home's smoke detectors.

"While a devastating loss for the family, the fact that everyone was able to get out of the home without injury is so important," said fire investigators.

Firefighters arrived around 2:30 a.m. and the home was completely involved in fire. Firefighters were able to prevent the surrounding homes from catching fire from the radiant heat. Homes on either side received minimal damage after firefighters battled the blaze for 40 minutes to bring it under control.

Firefighters encourage residents to check their

smoke alarms to make sure they are in working order and replace them every 10 years, sleep with your door closed to prevent smoke

from entering the bedroom, and know two ways out. The time it takes for a fire to spread is staggeringly quick.

The Fishers Fire Department was assisted by the Fishers Police Department and the American Red Cross.

## Solar power coming to more HSE Schools

You can sense the excitement in Bob Rice's voice as we walked

among the solar arrays, nearly completed just south of Hamilton Southeastern Intermediate/Junior High School (HIJH), at Cyntheanne Road and Southeastern Parkway. Rice, Energy Management Director for Hamilton Southeastern Schools, says the solar operation there will begin powering the HIJH school building in the next two to three weeks.

The next project will provide another array, delivering electricity for Sand Creek Elementary and Intermediate Schools.

The HSE School Corporation entered into a contract with Ameresco Inc. in January of this year to install the \$2.8 million solar project. The work is being financed by a four-year bond issue which is not expected to trigger a tax increase.

At the time the school board approved the plan, Rice projected the solar arrays will pay for themselves in 11 years through electricity cost savings.

Students will be able to use the solar arrays as part of

their science curriculum.

"Our partnership with Ameresco has already allowed us to invest in projects that directly benefit our students and create a more sustainable learning environment at our schools," said HSE Schools Superintendent Dr. Allen Bourff in an Ameresco news release. "The curriculum Ameresco provided will help our teachers educate their students about the latest innovations in renewable energy technology and the importance



of sustainability for the future of our environment."

Once the arrays at HIJH

and Sand Creek are completed, it will consist of 4,800 solar panels.

Vested Interest in K9s, a nonprofit from Massachusetts. Each pack comes with two sprayers because dogs need a double dose.


Since Axl is with Malloy all the time, both on-duty and off, she hopes she can be there for him. The reward at the end of a job well done should be a

chew toy, not Narcan.

"Something that we have that we hope we never have to use," said Malloy. "These are partners. These are animals we would do anything for. Having Narcan is just another way that we can care for them and make sure they are safe in the job that they're doing

for us."

If something were to happen to a K-9, it would be no small matter. They are highly trained and expensive to replace. Malloy said, at minimum, it's a \$12,000 price tag, which is why the free Narcan kits may not just lifesaving but money-saving tools, too.



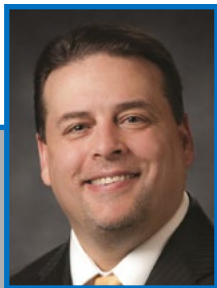

## Letter to the Editor

### Mike Corbett calls for “walkable, bikeable” downtown Noblesville

Dear Editor:  
It's great to see the City of Noblesville partnering with INDOT on road improvement projects, especially downtown. The roundabouts at the two intersections of SR32/38 and SR32/River Road are a much better idea than INDOT's plan from a few years ago, which sought to increase the speed of traffic between them by widening 32 and re-aligning the intersections. The goal, instead, should be to keep traffic flowing steadily but slowly through our downtown and this seems to head that direction.

The stretch of 32 between the hospital and the river also needs work. INDOT seems focused on a single goal: To move car traffic as quickly as possible through town. That often conflicts with the city's goal to maintain and grow a commercial district served by multiple modes of transportation. Our local representatives must advocate for the city on this. It does the city no good to have through-traffic whizzing by our stores and restaurants at high speeds.

As long as Noblesville's footing part of the bill, how about making sure these improvements include walkable and bikeable sidewalks and/or trails? The rendering doesn't seem to include those. I've heard more than one person suggest that it's easier and safer to get in your car and drive to Starbucks from the hospital than it is to cross the street on foot. That's just bad design and this new project gives us the opportunity to correct that.

We need to keep complete streets principles in mind as we improve the west side of the river. Ultimately our entire downtown ought to be walkable and bikeable. Currently walkability pretty much ends at the river. The Logan Street bridge walkway under construction is a good start but we have a long, long way to go and every improvement project needs to serve diverse modes of transportation.

# School districts can apply to participate in new senior/youth mentor pilot program

School districts across the state can now apply to participate in a new pilot program that aims to better connect students to older Hoosiers in their community.

This opportunity comes after State Rep. Chuck Goodrich (R-Noblesville) authored legislation creating the School Intergenerational Safety Pilot Project fostering positive relationships between students and older Hoosiers to help make schools safer.

"Some struggling students need a positive adult in their lives to give them sense of stability and hope," Goodrich said. "Unfortunately, there are kids across

the state who don't have an older figure in their lives to turn to when they need help. We have people who are willing to connect with these students and this program will help them do that."

According to the Indiana Department of Education, the three school districts selected for the program can have up to 16 volunteers who are at least 55 years old who could mentor troubled youth, patrol the school, report any threat to students or staff and provide guidance to teachers.

"This is a proactive

step to better ensure Hoosier children are safe at school," Goodrich said. "If there is a threat of violence, we want to know about it and address it."

To participate, volunteers must undergo a criminal background and a child protection index check. They must also commit to serving in their role for at least two years.

Goodrich said the Indiana Department of Education will choose a rural, urban and suburban school district to participate in the pilot program. School districts wanting to participate

should submit their letters of interest to the Indiana Department of Education by Aug. 15. Schools will then receive an application for the new program, with selections finalized by Aug. 23.

The three school districts selected will be eligible to receive \$75,000 to implement the pilot program.

# Carmel firefighters practice water rescue safety skills

The Carmel Fire Department is training for all the things that can go wrong on the water. Firefighters are brushing up on their water rescue safety skills to help keep people safe this summer.

Boating accidents aren't the only reason firefighters may use this training to come to your rescue.

"We also have a lot of retention ponds, and so people can get into those," said Tim Griffin with the Carmel Fire Department. "They can play in them or, like earlier in the spring when we had all of that water, we can have a lot of situations where we have a heavy rain come in and create flash flooding through a small creek and kids will be in there playing and the next thing you know it's become an emergency situation."

Firefighters spent time Tuesday at the Hamilton County Training Center reviewing how to operate a boat, how to get on and off it safely, how to save people who fall off boat and could be injured, all while protect-

ing themselves.

The department also uses a drone in cases where they need to drop a life-saving device to someone in distress.

"Whether it's a pond, whether it's a river, we can get it up into the air really fast. It moves 50 miles an hour," said Griffin. "We can check for patients, look for them, hopefully locate them faster than we would be able to locate them in the boat and then we can tell the crews where to go."

Firefighters say it's important for people in distress on the water to stay calm before help arrives.

"If you're going to be out fishing on the river or if you're going to be on a pond, make sure you know where you're at," said Griffin. "You tell somebody that you're going and so they know you're there. The other thing, never mix alcohol. Water and alcohol, they don't mix, so make sure you haven't mixed alcohol."

The Carmel Fire Department plans to do ice water rescue training in the winter.

# New community chorus gives people with dementia reasons to sing

People suffering from dementia may have trouble finding the right words or remembering the names of their closest relatives, but through music, they can remember and learn lyrics. More importantly, they can find joy.

That's the goal of a community chorus being formed in collaboration between CICOA Aging & In-Home Solutions and the Resonance Initiative, which works to change lives through storytelling and song in Indianapolis. Called SongShape, the chorus will consist entirely of people in the early to mid-stage of dementia and Alzheimer's and their caregivers.

It's long been thought that people with Alzheimer's lose their ability to learn new information. However, new research has found that people with dementia can learn music. That's because music stimulates activity in both sides of the brain.

When Rick Cobb learned about a community chorus in Minnesota called the Giving Voice Chorus, which is made up of about 140 people with dementia and their caregivers, he wanted to bring that opportunity to Indianapolis.

"The SongShape Chorus will use the power of group singing to encourage people with Alzheimer's and other forms of dementia – as well as their care partners – to create something unique, engage in community life and re-discover the fullness of what life with dementia and Alzheimer's can be," Cobb said.

He sought out CICOA

to help.

"Immediately, I wanted to find a way to make this happen," said Dustin Ziegler, CICOA's director of community programs. Ziegler also leads Dementia Friends Indiana, which works to break down stigmas about dementia. "The prevalence and complexity of dementia is so substantial that it literally takes a village to combat it. Not one organization can do it all, but together we can align in a way that makes a genuine difference."

CICOA and Resonance Initiative are looking for people interested in joining, volunteering and sponsoring the first SongShape Chorus. An introductory workshop will be held from 1 to 2:30 p.m. on Sept. 13 at PrimeLife Enrichment, 1078 3rd Ave. SW, Carmel, 46032.

The chorus is an eight-week commitment that brings together people who are living independently with Alzheimer's or dementia and their caregivers. Each weekly rehearsal will be hosted at PrimeLife Enrichment and will begin and end with a social time. There will be no auditions,

only a commitment to participate and the willingness to perform in a concert on Nov. 10, with the theme "Sing Your Story."

"This is an opportunity for people to come together in a stress-free environment," Cobb said. "Maybe they can't communicate with language, but they can communicate through this gift of music."

## AG Curtis Hill takes action against car sellers operating without dealer licenses even after orders to stop

Indiana Attorney General Curtis Hill filed lawsuits last week against two individuals who have ignored previous orders to stop operating as unlicensed car dealers.

Under state law, all motor vehicle dealers operating in the state of Indiana must obtain a dealer license from the Indiana Secretary of State. The law defines a dealer as a person who sells, offers to sell or advertises for sale at least 12 motor vehicles within a 12-month period.

"These laws exist to protect Hoosier consumers," Hill said, "and my office works daily to ensure that such laws are enforced."

Both defendants in the state's lawsuits, which were filed July 19, have conducted business primarily in the Indianapolis area.

**Scott Keen**, who has never held a dealer license with the Secretary of State, allegedly has advertised and sold hundreds of vehicles over the past year. He advertises the vehicles on Facebook and uses the slogan "Cash is Keen." He also seeks to buy used-vehicle inventory, offering cash for any running vehicle with a title. He then sells vehicles from his home.

On April 8, the Secretary of State issued a **cease-and-desist order** to Keen requiring him to cease advertising and selling vehicles. Since that time, he has stated in videos posted to Facebook that he intends to continue selling vehicles and maintains his actions

are legal. Since the Secretary of State issued the cease-and-desist order, Keen has posted advertisements for over 75 vehicles.

**Keith Williams** previously worked as the "VP of Sales" for Wheels of Fortune, an entity which had no dealer license despite selling hundreds of motor vehicles. At some subsequent point, Williams engaged in numerous unlicensed sales of his own under the assumed business name EZ Auto Sales. Williams was named as a defendant in the Attorney General's lawsuit against Wheels of Fortune (Cause No. 49D11-1809-PL-036568) for his actions at the business in addition to his separate individual vehicle sales.

On March 6, the Office of the Attorney General obtained a **judgment against Williams** prohibiting him from advertising or selling any vehicle that was not his personal vehicle titled in his own name. Since that date, Williams has advertised over 15 vehicles for sale on Facebook. The vehicles are being stored and sold off the premises of Brakes & Oil LLC. Brakes & Oil (also named as a defendant in this case) is a vehicle repair shop owned and operated by Williams. Other employees of Brakes & Oil have also posted several of Williams' vehicle advertisements on Facebook. Such vehicle advertisements and sales without a dealer license violate the terms of the injunction issued by the court and are deceptive acts and unfair practices under state law.

While there are benefits of choosing to purchase a vehicle from an individual rather than a dealer, consumers should be aware of the downsides as well. Specifically, a dealer is required to have a \$25,000 bond in place to obtain a license. In the event the

dealer does not comply with the law during a sale, that bond may be used to compensate a purchaser who incurs damages from those violations. Additionally, dealers are regulated by various state agencies while private sellers have no regulation. While these factors are seldom an issue when a consumer purchases an individual's personal used vehicle, a seller who engages in numerous unlicensed vehicle sales may also not be following other regulations designed to protect consumers.

Following are several tips for consumers regarding ways to ensure they are not doing business with unlicensed dealers:

- Consumers may see whether a dealer has an active dealer license by inquiring with the Indiana Secretary of State's Auto Dealers Services Division at [sos.in.gov](http://sos.in.gov).

- If the salesperson asks you to meet somewhere other than a dealership location, you are likely not communicating with a dealer.

- If you are dealing with an individual seller and the seller has numerous vehicles for sale at their home or lot, they may be acting as an unlicensed dealer.

- If you are purchasing a vehicle from an individual or dealer and receive a bill of sale from a different dealership, the seller is likely unlicensed and attempting to illegally run your transaction through a licensed dealership. In this case, you should not proceed with the sale.

Any consumers who have bought vehicles from either of these defendants may report these transactions to the Attorney General's Consumer Protection Division by calling 1-800-382-5516 or going online at [in.gov/attorneygeneral](http://in.gov/attorneygeneral) and clicking the "File a Complaint" box at the bottom of the page.

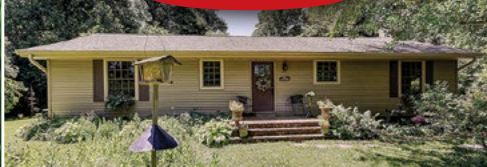

## Millers U13 team win USSSA National World Series

A couple weeks ago, a bunch of kids from Noblesville flew to Dallas.

For some, it was the first time they had ever flown on a plane. A week later, those kids returned home as national champion baseball players.

The Noblesville Millers 13U team won the AAA division of the USSSA National World Series, which took place July 11 to 17 in Dallas. Noblesville was one of around 30 teams from seven different states in the tournament.

The Millers cruised through the double-elimination tournament playing 10 games and finishing 8-1-1. Noblesville's final opponent was a team from Texas. Since the Millers came through the winner's bracket, the Texas team would have to beat them twice.

The Texans did win the first game 12-0, setting up a winner-take-all game for the championship. In that second game, the Millers were down 5-1 after the first inning, but roared back to win 24-15, thus claiming the championship.

"It was an absolute slugfest," said Noblesville coach Billy Finn. It was also downright hot – Finn estimated the temperature was 100 degrees, and on the turf it was 110. Such conditions would obviously favor a team from Texas, but the Millers came through.

"They're a group of fighters," said Finn. "They're just a group of fighters. Even after we lost the first game of the championship, we all talked about how we were going to forget about that." Indeed, the Millers kept themselves loose for the final game, and that resulted in victory.

"It was a really good experience," said Finn. "Before that we had played teams from Iowa, Oklahoma, a couple teams from Texas. Some really quality competition from the south."

The Millers actually made instant fans out of their opponents. The coaches of the

Iowa and Oklahoma teams gave Noblesville many compliments, telling the team "you guys play the game the right way."

"They respect the way we play," said Finn. "There's just a way the kids attack the game, even if it's 100 degrees. It's nice to get appreciated by other teams."

Two Noblesville players received awards for the tournament. Nolan Decker was named the MVP of the entire tournament, while Blake Widget was named the most outstanding offensive player for the tournament.

But of course, everyone on the team contributed to the win. In fact, Finn pointed out that the Millers were the only team

that batted its entire lineup of 12 people, which is unusual for that level of travel team ball.

"I think that gives us a little bit of an edge," said Finn. "Shows you what good teammates you have. We're a team that still believes in development, not just wins and losses, but you can still do that and win."

The USSSA World Series win was a culmination of a successful season for the Millers. The team won five tournaments and collected 30 wins in a 41-game schedule.

"That's pretty darn impressive for the tough schedule we played this year," said

Finn.

The trip to Dallas was one of many that the Noblesville team took this season. The weekend before the USSSA Nationals, the Millers won a 14U tournament at the Cincinnati Reds complex. "It was a really cool place," said Finn.

Noblesville also played at a tournament in Omaha, the site of the College World Series, another event that Finn called "a really cool experience for the kids and the families." They also got to visit the ESPN trailer at the College World Series as well. While in Dallas, the Millers got a chance to see a tour of the Dallas Cowboys facilities.
