Teachers' rally shutting down three county school districts

Three Hamilton County School districts have announced classes will be canceled on Tuesday, Nov. 19, allowing staff to attend a rally in support of "Red for Ed" Action Day at the Indiana Statehouse.

Sheridan, Hamilton Heights and Noblesville this week have informed parents of their plans not to conduct class.

In a statement to parents, Noblesville Schools said, "Because so many of our teachers plan to use a personal day in order to attend this rally, we have made the difficult decision to cancel school on November 19th. We cannot provide quality instruction or a safe school environment with such significantly reduced staffing."

Sheridan Community Schools stated, "It is important to understand the decision to make our presence known at the Statehouse rather than being present with our students is not an easy one. Our staff would much rather be at school teaching our students."

The Hamilton Heights School District on Wednesday issued a statement that in part said, "To help make its voice heard, Hamilton Heights School Corporation in cooperation with the Administration and the Hamilton Heights Classroom Teachers Association, has made the difficult decision to cancel classes on Tuesday, November 19."

Other school districts in Hamilton County have not yet canceled classes.

A spokesperson with the Carmel Clay School District said, "As of right now, yes, we will be in session.

A representative with Hamilton Southeastern Schools told the Reporter, "At this point in time we have not been given any information that we are going





Summary of Ordinance 39-09-19 Ordinance No. 39-09-19 proposes to amend the Noblesville parking ordinances

n the following manner. Section 70.50 of the Noblesville City Code (the "Code") will be amended to now include that for purposes of Title VII of the Code, a person who violates the traffic Code will be the driver of the vehicle at the time of the infraction. But if the driver cannot be identified at the time of the infraction, the owner of the vehicle will be

Section 70.99 of the Code will be amended to clarify that violators who do not vish to pay for a fine or penalty must file an appeal within 15 days of the date of the issuance of notice of the violation.

Section 72.17 will be added to the Code and require that all motor vehicles utilizing a parking space in Noblesville parking lots or parking garages shall park by pulling head first into the spot. Parking in these spots by backing your vehicle nto the spot is prohibited.

Section 72.90 of the Code will be amended to state that annual parking permits and meters on lots identified on the Downtown Parking Map (Exhibit 1 to Chapter 78) shall be: \$300 per year or \$25 per month for the Red Lot, Future Parking (to be the Levinson), and the Orange Lot; \$250 per year for the City Hall East Lot and designated spaces on Clinton Street; \$150 per year for the Purple Lot; and \$.25 per nour for all metered parking, plus surcharge for paying by credit card.

Section 72.93 of the Code will be amended to state that parking lots and garages

Section 72.94 of the Code will be deleted.

Schedule V of Chapter 78 of the Code will be amended to no longer prohibit parking on: N. 8th St., Logan to Conner, West side; Clinton St., two spaces east of 11th St., North side; Conner St., 8th St. to 6th St., North side; Logan St., 8th St. West to first alley, South side; Logan St., S.R. 19 to S.R. 38, both sides; and Maple Avenue, 8th to first alley East, North side. This Schedule will also been amended now prohibit parking at Clinton St., 8th to 9th St., North side and Maple Avenu 8th to 9th St., North side.

dentified in Exhibit 1 to Chapter 78 shall be enforced from 8:00 a.m. to 5:00 p.m.

Schedule VII of Chapter 78 will be amended to establish Downtown Square Parking at: 8th St., Clinton St. to Maple Ave.; 9th St., Clinton St. to Maple Ave.; Logan St., White River to 10th St.; and Conner St., 6th St. to 10th St. These parking spaces will be free for motor vehicles up to two consecutive hours each calendar day (excluding Saturday, Sundays, and City holidays) during the hours of 9:00 a.m. to 5:00 p.m. This two consecutive hour period will be limited where signage indicates that special parking duration limitations apply. This schedule will also amended to now only restrict parking in the same manner in the City outside of Downtown Square Parking in the following areas: N. 10th St., 100' North of Conner Street West side, 20 minutes; and Maple Ave., 9th St. ½ block West (South





Shaffer outlines "absurdity" of trying to get information from Carmel city government

Of the multitude of absurdities entire plan. It was not 48 pages, but 54. belched forth by Carmel propagandists, few reach the height (or, is it depth?) of this direct lift from carmel.in.gov:

"The City of Carmel takes very seriously its responsibility to be transparent and accountable regarding the business of the City. There are many ways that residents, businesses and others who may want to gather more information about upcoming, current or former projects and initiatives may access documents, video recordings, renderings or other materials that may be available."

If they can't spell "transparency," can they be transparent? And, how informative can a city be which speaks of "infor-

Here are a few examples from a fat file of responses received after submitting requests:

- 1. Finding Fire Department annual reports only as recent as 2015-2016, I requested 2017 and 2018 reports. The city attorney's office referred me to the city website address which, of course, was the 2015 and 2016 reports.
- 2. Requesting the fiscal plan repeatthe city had identified 48 pages of records but 47 of them had been "redacted." I got the one page, titled "Comprehensive Fiscal Plan & Capital Improvement Plan

(draft)." Unofficial sources retrieved the

- 3. When the city's Economic Development czarina failed to answer a request for the 2017 and 2018 totals of new businesses started in the city, I petitioned the City Attorney whose office "identified no records that are responsive to your request."
- 4. The City Attorney told me he found 85 pages responsive to my request for the Redevelopment Commission's final tax increment special purpose report. "However," he wrote on city letterhead, "these records constitute intra-agency advisory/deliberative material that are exempt from disclosure pursuant to . . . " Indiana statutes.
- 5. Several requests for engineering studies, fuel and time savings in roundabouts, purpose and results of junkets here and there by city employees, even a copy of the communications plan spokespersons follow – all met with silence.

6. Most recently, the mayor remained mute when asked (Oct. 29) for background on his time spent studying law in the United Kingdom where, the Minneapolis Star and Tribune reported, he "marveled at how efficiently traffic flowed through (roundabouts)."



Tigers cruise past Anderson, are 4-0

FISHERS - After four games, things have been going rather well for the Fishers girls basketball team.

The Tigers have won all four of their games, including an easy Wednesday victory over Anderson, 79-49 at the Tiger Den. Fishers' early-season success hasn't gone unnoticed, as the Tigers came into the ICGSA Class 4A rankings at No. 8 this week.

Greyhounds head to Homestead for regional

This Friday will mark the seventh consecutive year that the Carmel football team has played for a regional championship, and the Greyhounds will do so in a

familiar city. Carmel plays at Homestead Friday for the Regional 2 title. Kickoff will be at 7:30 p.m. This will be the fifth time in the past seven years that the 'Hounds will travel to a Fort Wavne school to play for a regional championship, having been the visitors against schools like Snider, Carroll and Homestead.

The Spartans have been a recent rival for Carmel. The two teams have played each other four times, each game in the regional round. Homestead won the first encounter back in 1998 27-3, but the Greyhounds have won the others, beating the Spartans in 2006, 2015 and 2016.

Homestead will come into the game

undefeated at 11-0. The Spartans were a perfect 9-0 during the regular season, with all of those games played against Summit Conference teams – thus Homestead is a conference champion as well.

The Spartans traveled to Noblesville for the Sectional 3 semi-finals, and came from behind to win 24-21 in overtime. Homestead hosted Carroll in the championship game and won 38-14 for the program's sixth sectional title.

"To begin, Homestead is 11-0 so they have proven that they know how to win football games in a variety of ways," said Carmel coach John Hebert. The coach said that the Spartans "have a number of very talented players," and that talent is everywhere - wide receiver, tight end, quarterback, linebacker, defensive backs.

"It's obvious to me that they are a very tight group that enjoys playing together and making plays," said Hebert. "It will be will be an exciting challenge to try to limit the production and effectiveness of their great players. No one else has been able to completely do it."

Junior Luke Goode is Homestead's quarterback, and he has had a spectacular season, throwing for 2,642 yards and 26 touchdowns, while rushing for two additional scores. Senior Jake Archbold leads in receptions with 37, 12 of them touchdowns. Senior Griffin Little and junior Jared Kistler have made 35 and 30 catches respectively, including six scores each.

The Spartans' running game is solid as well. Junior Braeden Hardwick has rushed for 957 yards and 15 TDs. On defense, junior Luke Palmer has 87 tackles, 13 for a loss, with senior Camden Rogers making 72 stops, 12 for a loss.

The Greyhounds will head to Homestead with an 8-3 record. Carmel won seventh consecutive sectional title (and 31st overall, a record) by beating Hamilton Southeastern 28-14 and Westfield 35-7. This was after a 6-3 regular season that saw the 'Hounds finish in a four-way tie for Metropolitan Conference champions.
