## Cook's bill to decouple teacher evaluations from test scores moves forward

#### The REPORTER

Rep. Tony Cook (R-Cicero) to permanently decouple teacher performance evaluations from student test scores passed out of the House Education Committee on Tuesday.

Cook said students' standardized exam results make up a significant portion of educators' annual performance evaluations. Cook, vice-chair of the House Education Committee and former school district superintendent and principal, said House Bill 1002 would allow school districts to determine how student exams are used when evaluating teachers.

"Local school administrators have a better grasp of educators' strengths in the classroom," Cook said. "Giving individual school districts the flexibility to cero) represents House District decide how to use test scores in evaluations will provide a more complete and accurate picture of teachers' overall performance."

These assessments are a factor in deciding whether a teacher is eligible for a pay raise, which is why Cook said Indiana needs to take a hard look at moving away from using standardized test scores in evaluations.

> "Teachers have a lot on the line when their performance is evaluated in the classroom," Cook said. "Our educators play a vital role in ensuring our young Hoosiers are set on a solid path to success."



## Noblesville opens Logan Street Bridge, river overlook

The City of Noblesville and Hamilton County officials came together on Monday to celebrate the completion of the Logan Street Bridge renovation.

The joint project, which began construction in July 2018, widened the bridge over the White River to accommodate sidewalks on the north and south sides and constructed a new bridge deck. A 150-foot river overlook was added along the south side of the bridge.

"The overlook will provide a nice gathering spot for special events," said Steve Dillinger, president of the Hamilton County Commissioners. "And the new sidewalks will give pedestrians much safer access across the river, especially those walking between downtown, Riverwalk and Federal Hill Commons."

The Logan Street Bridge project, which includes new lighting to the railings, provides a more scenic and secure east-west connection from the Hamilton County Courthouse and Riverwalk Trail to Federal Hill Commons.

'The bridge rehabilitation provides pedestrians and bicyclists the opportunity to travel to and from our downtown without using streets while emphasizing the beauty of the White River and downtown Noblesville," said Nobles-

## Fishers touts regional law enforcement approach in triple arrest

A showing of officials, including Fishers Mayor Scott Fadness, the Indianapolis Department (IMPD) Assistant Chief Chris Bailey and Fishers Chief of Police Ed

Gebhart, gathered to appear before the media Monday afternoon, revealing how two arrests in Fishers, related to the shooting death of Fishers police dog Harlej, led to arrests in an Indianapolis crime spree.

Police say the three arrests were related to two deaths and impacted the lives of 18 people in the Indianapolis area. A firearm recovered after the arrests related to the shooting of K9 Harlej was used to link that weapon with other crimes.

Those three individuals were charged

with the following:

• Richard Garrett: 23 counts, including two counts of murder, conspiracy to commit murder, six counts of criminal recklessness, pointing a firearm, seven counts of battery, aggravated battery, armed robbery, and four counts of carrying a handgun without a license.

• Delance Hatcher: 15 counts, including murder, conspiracy to commit murder, five counts of criminal recklessness, pointing a firearm, three counts of battery, armed robbery and three counts of carrying a handgun without a license.

• Rashaana Farrow: 15 counts, includ-Metropolitan Police ing murder, conspiracy to commit murder, four counts of criminal recklessness, five counts of battery and four counts of carrying a handgun without a license.

> According to Gebhart, just since March of 2019, 84 firearms somehow related to criminal activity have been taken off the streets of Fishers by his officers, and 56 of those weapons have been checked out and found to have been used in another crime. Gebhart told LarryInFishers a majority of those firearms were seized in activity near 96th Street, although the enhanced commercial activity along 116th Street has shown an increase in weapons seizures there lately.

> The main theme of the Monday news conference was collaboration among the many communities that make up the Indianapolis Metropolitan Area.

'Crime does not respect political boundaries," Fadness said. "It doesn't care whether you are a Republican or Democrat. All it cares about is causing chaos among the streets of our city as well as the streets of Indianapolis."





### AG Curtis Hill: State Egg Board lacks authority to regulate online 'farmers markets' as retailers

The Indiana State Egg Board has no authority to regulate as retailers third-party websites that facilitate transactions between buyers and sellers of eggs, Attorney General Curtis Hill said in an advisory **opinion** issued Tuesday.

Hill issued the opinion following an inquiry from the Indiana State Egg Board regarding an online business called Market Wagon that enables customers to connect with local agricul-

The vendor then and regulatory provisions were not designed to address e-commerce," Hill said. "For the board to regulate in this area, there would likely need to be legislative changes to extend the board's authority."

> Courts have held that websites that offer online marketplaces, such as Amazon and eBay, are not sellers of the products. The fact that a business such as Market Wagon collects money from the customer at the time of purchase does not make it a seller, Hill said, because its share of the money is collected as a fee for providing access to its online marketplace rather than for the eggs themselves.

The Indiana State Egg Board does retain regulatory oversight over the egg vendors who use Market Wagon's services, Hill said.







"We trusted our defense to drive them into the help," said Quaranta. "We took two charges, which we've been preaching in practice, but these are the first two, maybe two of three all season that we've


