couple teacher performance evaluations from student test scores passed out of the House Education Committee.

Cook said students' standardized exam results make up a signif-

icant portion of educators' annual performance evaluations. Cook, vice-chair of the House Education Committee and former school district superintendent and principal, said House Bill 1002 would allow school districts to determine how student exams are used when evaluating teachers.

"Local school administrators have a better grasp of educators' strengths in the classroom," Cook said. "Giving individual school

districts the flexibility to de-A bill authored by State cide how to use test scores cero) to permanently de- a more complete and ac-

curate picture of teachers' overall performance."

He said performance evaluations play a role in where an educator falls on the highly effective to ineffective scale. These

assessments are a factor in deciding whether a teacher is eligible for a pay raise, which is why Cook said Indiana needs to take a hard look at moving away from using standardized test scores in evaluations.

"Teachers have a lot on the line when their performance is evaluated in the classroom," Cook said. "Our educators play a vital role in ensuring our young Hoosiers are set on a solid path to success."


Several media outlets reported last Saturday that Kevin Wright will be joining the Indiana University football team's coaching staff as a tight ends coach.
