# Sheriff's office partners with Shepherd Center

The Hamilton County Sheriff's Office has announced its partnership with the Shepherd's Center of Hamilton County (SCĤC)

On April 9, deputies with the Sheriff's Office assisted SCHC by picking up necessary food and other items from the grocery store, decontaminating the items, and then helping to organize and deliver them to local senior citizens.

The coronavirus outbreak has caused the majority of all seniors in the county to shelter in place and forced SCHC to temporarily close the group programming, which allowed seniors to gather for food and fellowship. Therefore, SCHC is activating new ways to assist Hamilton County seniors by delivering food, cleaning supplies, and other needed items to their doors, along with regularly reaching out with a personal call to assess any needs and provide vital social connection.

The Sheriff's Office and SCHC will continue to work together every Thursday to help with grocery shopping, food decontamination, and food delivery.

# Carmel Clay Parks & Rec furloughs 471 employees

### The REPORTER

Since March 12, most of the programs and services provided by Carmel Clay Parks & Recreation (CCPR) have been mandated by an executive order from the Governor to temporarily cease operations, including the Monon Community Center and Extended School Enrichment. Because of these closures, CCPR no longer has incoming revenue from user fees and memberships crucial to help cover operating expenses, including payroll.

Due to these circumstances, CCPR has fur-

loughed 471 employees. A

total of 24 full-time posi-

tions and nearly all part-time positions are impacted by the decision. CCPR will continue to pay regular contributions toward health insurance for full-time staff impacted by the furlough to allow these crucial benefits to continue during this pandemic.

Indiana Election Commission sets final guidelines for primary

There have been many questions on what Primary Election will look Dav like this year, and much of that has now been determined by an order issued by the Indiana Election Commission.

Here in Indiana you will have many choices

when determining how you wish to vote for the candidates of your choice. By mail, in-person on Primary Election Day, or early voting at eight locations, the week prior gives you an opportunity to pick the best way for individually to cast your ballots. After the President de-

clared a national emergency on March 13 due to the coronavirus, the Governor announced that the May 5 primary would be postponed until June 2. At Eight locations could no lonthe same time, it was deter-

Voting by mail began on March 17 and continues every day until 11:59 p.m. on May 21. The Election Office staff and the Absentee Board has mailed out 9,279 ballots and there have been 2,952 returned as

Friday, April 17. Compare this to the 2016 primary where a total of 3,358 ballots were returned. With five weeks to go, nearly three times the number of total ballots have been processed as in 2016.

In addition to the ability to vote by mail, voters will be able to vote at their regular polling locations across Hamilton County on June 2. We have 124 of our 133 polling locations confirmed. ger host a polling place due will be open for early voters from May 26 to May 30 each day from 9 a.m. to 4 p.m. Those locations include:

· Hamilton County Government and Judicial Center and the Hamilton County Fairgrounds in Noblesville

· Coxhall Mansion and Mercy Road Church in Carmel





## Carmel firefighter beats COVID-19, now donating plasma to help others

### The REPORTER

City of Carmel firefighter Kevin Young – who contracted COVID-19, was hospitalized and has now fully recovered - has begun donating his plasma for potentially life-saving treatments for patients who are extremely ill with the virus.

According to the FDA, anyone who has fully recovered from COVID-19 may be able to help patients currently fighting the infection by donating their plasma. Because Young fought the infection, his plasma now contains COVID-19 antibodies and these antibodies (which helped his immune system fight the virus) may be able to help others, too.

Young, who is 40, made his first donation at Versiti blood donation center in Indianapolis, and he plans to make another donation this week. Versiti (formerly

the Indiana Blood Center) also has a Carmel location, but it currently only accepts donations of blood, not plasma.

"If my plasma donation can help save the lives of COVID-19 patients who are near death, then I will plan to do this as much as pos-

sible," said Young. "When I was sick, we had so many friends and neighbors who helped me and my family. This is my way of giving back.

Because Young's blood is type AB-negative, he is a "universal donor" of plasma, making his donations even more valuable to doctors treating a variety of COVID-19 patients.

Young said he does not know if his plasma donation will actually help others because it is too soon to tell. The FDA cautions that further investigation is still necessary to determine if convalescent plasma is safe and effective as a treatment for COVID-19. and whether it might shorten the duration of illness, reduce morbidity, or prevent death.



## The Noblesville-Notre Dame running connection Matt Sparks embraces 'humanistic' side of coaching

#### By RICHIE HALL

Early on during his coaching tenure at Notre Dame, Matt Sparks learned a lesson in how to be an effective leader: It's better if you don't try to do too much.

Sparks figured that out quickly, and is now using that knowledge as the Irish's Hatherly-Piane Director of Track & Field and Cross Country. The Noblesville native just finished his second year as director. Sparks has the direct responsibility of coaching the women's distance runners, then has the support of five assistant coaches who oversee the other divisions of the program. Sparks believes it's no different than being the head coach of other sports.

"In college football, you've got a head coach and they've got six to 10 position coaches," said Sparks. "I'm still intimately coaching 15 to 20 athletes, but I've got 100 athletes under my leadership.

Sparks said he gives 100 percent of the coaching control to his assistants over their event groups. He does have interaction with those athletes, but it's more of a "how was your day" discussion, or as Sparks puts it, the humanistic side of coaching.

I still have oversight of the throwers, but as the director I rely on the assistant coaches with the Xs and Os," said Sparks.

When he started at Notre Dame in 2014, Sparks was coaching both the men's and women's distance runners. While the Irish women were having a high level of success, cementing themselves as a top 10 team, the men were struggling to finish in the top five in their region.

What we learned at that time was, you can't coach 50 to 60 people and be on a national stage,' said Sparks. Another assistant coach took over the men's distance program, and Sparks could focus solely on coaching the women.

Šparks has known about running at a high level for over three decades. He was a multiple all-state honoree in both cross country and track at Noblesville High School, where he finished in the top five in the state cross country meet three times.

After a successful career at Indiana University, Sparks stayed with the Hoosiers for three years as an assistant coach, then was an assistant at Ohio State for two years. Sparks then spent 12 years as the cross country coach and assistant track coach at Southern Illinois, where he became the winningest cross country coach in history for the Salukis, winning several Missouri Valley Conference titles and coaching 51 conference winners along the way

Sparks found success at Notre Dame right away, as he coached a national champion in his very first season. Molly Seidel, then a junior, won nationals at the 2015 NCAA Outdoor Track and Field Championships in the 10,000-meter run, this after earning All-America honors at the Indoor Track and Field and Cross Country championships. Seidel would win the national cross country title in her senior year, then two national indoor

championships in the 3,000- and 5,000-meter runs.

More success has followed, including national championships in 2019 for the men's track team, with the Irish winning the indoor distance medley and Yared Nuguse placing first in the outdoor 1,500-meter run. Add this to the Atlantic Coast Conference (ACC) championships and high finishes by teams in the various NCAA national meets, and Notre Dame has established a high standard over the years.

Sparks said that managing the expectations of the incoming freshmen to Notre Dame is a challenge. Many of the student-athletes that enter the university are national-caliber athletes, "the best of the best across the board," said Sparks. And not just in athletics, but in academics as well. They're used to being highly successful, straight-A students in high school.

Of course, college is different.

You're not going to get straight As in college, and 95 percent of our athletes got straight As,<sup>2</sup> said Sparks. Thus, one of the things that he might have to help a student do is navigate the experience of getting that first B. Same goes for athletics, as Sparks said the majority of the athletes on the team were state champions.

'You're going to lose every day in practice,' said Sparks. "Learning how to be successful without winning is a challenge for athletes, because the majority of the athletes at the collegiate level were winners in high school."

"Getting comfortable with being a role player is something Notre Dame does well," said Sparks. With our Catholic tradition, everyone is conditioned to be more nurturing and caring. A little bit more of a humanistic side to campus life than other places I've worked. Where ever you finish, you're getting a hug from your teammates. You're getting a high five from your coaches.

Sparks said his coaching philosophy changes based on where he is. One difference he noted between Notre Dame and other schools at which he worked was that when students got to South Bend, they were ready for college.

They know how to matriculate their way through a university," said Sparks. "They're just falling in line with the family lineage.

Sparks said that the Xs and Os of coaching in any sport have become similar. Instead, it's the culture that makes the program.

"What you find when you dig deeper in the program is the passion and the feelings that people have for their program," said Sparks. "They have a circle of support that can't be broken.

That circle includes everyone: Coaches, parents, teammates and the university rallying behind a team

"We've got such a circle of support from everything to academic support services to the medical team, to the coaching staff," said Sparks. "Everybody's going to do what they need to do for you to be a successful person."

Life skills are a big part of what Sparks teach-

on life skills that they need to adhere to in order to be a successful college student, "then they can properly navigate the college athletic world.

Sparks said once an athlete gets past his or her freshman year and moves into sophomore year, that's when athletes start to see themselves develop. Freshmen usually rely on their high school experience, but at the same time they're dealing with all the big changes that happen when they get to college.

The anxiety of being away from home, your high school friends," said Sparks. "Dorm life is a challenge. Everything is a challenge and every-

es as well, saying that young people are educated thing is new." But once athletes get comfortable with their surroundings, that's when they being to grow as athletes, and then as people.

Sparks usually meets these young people when they are 17 and, he said, barely able to have conversation. But by the time they've had few years in college, "they're initiating the conversations with coaches," he said.

And of course, seeing a student-athlete years after his or her graduation is a gratifying experience for Sparks.

"Probably the biggest reward for me is reconnecting with them when they're 25 of 30," he said. "Seeing how much they can change in 10 years."

## *"I feel like she's my chief of staff" . . .* Kendra Foley making her mark as assistant coach

When Kendra Foley became an assistant cross country/track and field coach at Notre Dame in 2018, a circle that had started several years ago finally became full.

Back then, Foley was a standout runner at Noblesville High School, a four-time All State finisher at the IHS/ cross country meet. She was looking at colleges, and one of the coaches recruiting her was then-Southern Illinois University coach (and fellow NHS All-State runner) Matt Sparks. Foley wound up running at Grand Valley State University, and had four highly successful years there. But she and Sparks never lost that initial connection, and a couple years ago, they got back in touch. Now Foley and Sparks are coaching together and continuing the success and tradition of Notre Dame distance running. Sparks is now the director of track and field/cross country for the Irish. We joke a lot about where we came from," said Foley. She tells recruits that she and Sparks went to the same high school. "They always ask and say, 'The same year?" she said. Not quite. Sparks graduated from Noblesville in 1992, a couple years before Foley was born. She graduated from NHS in 2013, then went to Grand Valley State, where she was part of three NCAA Division II team cross country national championships, and twice won the NCAA Division II cross country individual championship. "Both of us have a lot of pride in that we came from the same area," said Foley. "And when I was being recruited, that's where we started our relationship and he tried to recruit me. It's kind of a funny start to where we are now." Foley was a volunteer assistant coach at Grand Valley State and was working at the university's summer camp when she got a call from Sparks. While Foley had some initial doubts about stepping into a coaching role at Notre Dame, once Sparks explained his vision for the role, she was intrigued and she went to the campus for an interview.



At the Atlantic Coast Conference (ACC) meet that year, the Notre Dame men won the championship, while the women were runners-up by one point. Foley said that was a tough day, but it motivated the Irish women for the rest of the season. They finished with a great meet at nationals.

"Being from South Bend, these girls are pretty gh and weathered," said Foley. "They took to that

Within two weeks after the interview, he offered me the job," said Foley. Soon after, she moved to South Bend.

"I called her back and said 'You don't have to do this. You're doing me a favor," said Sparks. That woke her up to what her passion was and what she really wanted to do. And she's been great at it since she got in."

week early for a little mini-camp before school got going. It was an opportunity for me to get to know everyone. I was learning along with the freshmen, how this team works, how this campus functions.

'Those first couple days were really great. I really got a chance to get to know them and get to know what my role could be for them. I sat down with the entire team and told them I was knew to this. I'm still fairly young.3

That youth allows Foley to relate to her runners, something which she thinks they appreciate. "They feel comfortable talking to me," she said. "I think it actually turns out to be an asset.3

"It's all pretty fresh in my head, I understand the frustrations," said Foley. "They feel comfortable talking to me about that kind of stuff."

Sparks said that Foley's biggest attribute is connecting to college-age women and sensing where they are in their development, be it training-wise, socially or emotionally.

"She's very perceptive to other people's needs," said Sparks.

"I feel like she's my chief of staff," said Sparks. "She gives me a list of things I have to do today." Sparks said he and Foley have worked so closely "for our two years now that I think we can finsihed each other's sentences."

During Foley's first season at Notre Dame, the Irish began their season with a four-team meet at Valparaiso, then hosted two meets on campus. Foley said that was "another great learning opportunity for me," as she got to see how a home cross country meet functioned.

"I got to help organize and prepare for that," she said. "I was more observing rather than really coaching. As the season progressed and as I got closer to more individuals, I was able to offer a little bit more advice and coaching."

day and took to the snow, the course and the mud, and ran hard and we ended up placing eighth, one of the highest in Notre Dame history. That was pretty special to be a part of."

The Irish then had a successful track and field season in distance, with three national qualifiers in the 10,000-meter run, one in the 5,000 and one in the 1500: Notre Dame had the most female distance runners at nationals for any school.

Foley said what makes post-season meets special is that's when coaches get to spend quality time with their athletes.

That's when the bonds are really made, spending the time and watching them progress through the season," said Foley.

During her second year with the Irish, Foley said she had more expectations for herself.

"I describe my job as making Coach Sparks' life easier, in whatever that may be," said Foley. "The small details. It's my job to make the girls' lives better. Somehow making their lives easier. I wanted to really build on the relationships I started to create and make sure they knew I was here no matter what.'

"As I have been her for longer, Coach Spark has entrusted me with a few more responsibilities," said Foley. "He trusts me with more of the little things.

The Notre Dame women had to deal with injuries during the season, but Foley said they still showed up at nationals "and ran very hard. We placed higher than we were expected to, which is always our goal. That was extremely special to be a part of."

The Irish were looking forward to the outdoor track and field season, but that got canceled, along with all other college athletics, due to the COVID-19 pandemic

"It's different for everyone, so my job right now is just to be there for them," said Foley. "It was a tough pill to swallow that their outdoor season got canceled.

The NCAA has allowed schools to provide those student-athletes who compete in spring sports to get an extra season of competition, a ruling which Foley said is fair.

None of them competed in the outdoor season, so they should all get their season back," she said.

## Shift in focus leads to Grand **Slam triumphs for Rajeev Ram**

A few years ago, Rajeev Ram shifted his focus from singles to doubles as continued his career on the ATP (men's professional tennis) tour.

Ram calls it a second career. He can also call himself a champion, as he started the decade by winning his first Grand Slam men's doubles title. The victory has established the 36-year-old from Carmel as one of the leading doubles players in the world, and Ram has no plans to stop now.

Ram and his partner, Great Britain's Joe Salisbury, won the Australian Open men's doubles title in January. The duo won six matches in the 64-player draw, dropping only one set along the way. In the championship match, Ram and Sailsbury beat the Australian pair of Max Purcell and Luke Saville 6-4, 6-2.

"It was a bit of a strange situation," said Ram. "The guys we were playing were wild cards.

They're Australian, so they got an exemption. They made it all the way to the finals.'

Ram and Salisbury were seeded 11th in the tournament, which made them obvious favorites. Ram said that made for a bit of pressure, and then there was the fact that he and Salisbury were playing an unknown team. But they went out and won easily

We went out and played a great match. I did my thing, my partner played amazing," said Ram. He was happy with how they handled the moment of being in such an important match.

'It could've been tough, it could've been tricky and I think we both did a really nice job of handling the moment well," said Ram.

Right after the Australian Open, Ram reached his career-high ranking of No. 5 on the ATP doubles ranking list. He is currently ranked ninth.

The 2020 Australian Open was the 58th time that Ram had played doubles in a Grand Slam, or major, tournament (Australian Open, French Open, Wimbledon and U.S. Open), and in fact, he has played doubles in every major since Wimbledon 2007. But Ram said that he didn't really focus on doubles until a few years ago, as he began to wind up his singles career.

Ram had a solid singles career, winning two titles at the grass-court event in Newport, R.I. in 2009 and 2015 and getting as high as No. 56 in the ATP rankings. But it was around 2016, he said, "when I really started to focus on my doubles. I almost feel like I started a second career then, or a shifted focus."

That change in focus has

paid off handsomely, as Ram has won 12 of his 20 career ATP doubles titles since 2016. At the end of that year, he even reached the championship match of the ATP World Tour Finals with his then-partner, South Africa's Raven Klaasen, where the two lost a third-set super tiebreak by a narrow 10-8 margin.

Ram struck up his current partnership with Salisbury in 2019. The duo won two tournaments that year and reached three other finals, also getting to the quarter-finals of the French Open. They also qualified for the Nitto ATP Finals.

"We played all of 2019, so we know each other pretty well." said Ram. "We played a lot of big matches. We were a level that could win."

Ram's 2020 Australian Open win was his second in a Grand Slam event. He won his first at the 2019 Australian Open, teaming up with the Czech Republic's Barbora Krejcikova to win the mixed doubles title, again beating an Australian team in the final. In 2016. Ram and fellow American CoCo Vandeweghe reached the U.S. Open mixed doubles final, but fell in straight sets.

"When you play at the end of a major in any capacity, it's special," said Ram. "It's a pretty special feeling. That experience really helped me going into this Australian Open final.'

Experience is something Ram can claim, as he has been a pro since 2004. But he's not the only 30-something playing at an

elite level: In the current top 10 doubles rankings, nine of those players, including Ram, are between the ages of 33 and 38. The only player under 30 in the top 10 is Salisbury, who is 27.

Ram said there's a couple of direct causes for players still performing at a high level into their 30s. First, "the game has gotten a lot more physical," he said, and young players don't have the physical capabilities to play at the highest level of the games.

"It takes a bit longer to develop that physicality," said Ram. The second reason is due to "huge advancements in the area of sports science," said Ram, such as nutrition, recovery and training. That allows players to keep their bodies performing at a high level so they can play tennis

at a high level for a longer period.

You're seeing players play into their 30s because their bodies allow them to do so," said Ram. He noted that when he started playing, recovery wasn't much thought of, now such things as ice baths and massages are the norm.

Another reason is that players are participating in less tournaments per year. Ram remembers that he once had a year where we played over 100 matches, but now he has cut back on his schedule in order to lengthen his career.

Of course, every pro tennis player's career is on hold as both the men's and women's tours are halted due to the COVID-19 pandemic. Ram said that right now sports are not the biggest con-

cern. The international nature of tennis makes it likely that it will be one of the last sports to start up again.

We're going to be the tail end of anything that comes back," said Ram. He also agrees with the postponement of the Olympics to 2021. Ram teamed with Venus Williams to win the silver medal in the mixed doubles event back in 2016.

"It's as global as it gets," said Ram. "I think they made the right move, unfortunate as it was."

Once he gets back on the tour, Ram doesn't see himself slowing down. He's still enjoying playing, is healthy and able to deal with the requirements of tennis.

"I'm definitely one of the fortunate ones," he said.
