Fishers establishes city health department

Dr. Indy Lane expected to be appointed Fishers Health Officer

Fishers Mayor Scott Fadness and the city council conducted an emergency meeting last Friday to take steps to further ensure the health and safety of Fishers residents is the highest priority of the city.

City officials acted on a resolution to establish a Fishers City Health Department.

Indiana statute provides for second-class cities to establish their own full-time health department.

The health department would be managed by a Fishers Board of Health.

The Board will have the powers and duties prescribed for all health boards in the state, which include, taking any action authorized by statute or

rule of the state department to control communicable diseases, make sanitary and health inspections, and investigating the existence of any contagious or infectious disease and adopting measures to arrest the progress of any contagious or infectious disease.

The health board will consist of seven members appointed by Fadness, not more than four members belonging to the same political party. At least three of the members must be licensed physicians. At least one of the members must be a licensed veterinarian. The initial members of the

Fishers for a four-year term.

board shall be appointed as follows: One will serve for a period of two years; two will serve for a period of three years; and four will serve for a term of four years.

A Health Officer will also be appointed by the council to serve as the executive officer for the Fishers City Health Department.

It is expected that Indy Lane, MD, FACOG will be appointed as the Fishers Health Officer. If approved Dr. Lane will serve as Health Officer for the City of

By establishing a health department and using

\$2,000,000 out of cash reserves testing will be available for any Fishers residents that need a COVID-19 test. Fadness indicated the Fishers Fire Department will perform the tests.

With the establishment of a health department, Fishers will partner with a software company to provide real-time data for residents and businesses.

"The ability to have real-time data analytics is critical. That data is information, and information is power," said Mayor Fadness.

Other city officials have agreed with Fadness' proactive approach to help the Fishers community with localized data, as it pertains to Fishers residents and businesses.

Fishers plans widespread testing, unveils recovery plan

Fishers Mayor Scott Fadness last Thursday announced his plan to support the health and economic recovery of the city in response to the COVID-19 global pandemic. The \$2.5 million Fishers Recovery Plan will launch COVID-19 testing for Fishers residents alongside a comprehensive tracing program and business recovery support programs.

"For far too long municipalities and mayors have only focused on the infrastructure, public safety, and economic development of their cities," said Fadness. "In today's economy, it is critical we add population health to this list. Fishers has benefited by the leadership of Governor Holcomb and State Health Commissioner Dr. Box in taking this pandemic seriously

from the outset. My hope is that our efforts announced today will further support their initiative while ensuring the health and safety of our residents in providing a roadmap toward health and economic recovery."

During the announcement, Fadness unveiled his six-part plan for ensuring the long-term health and safety of residents in response to the eventual lifting of statewide stay-at-home orders.

1. Establish Fishers Health Department
2. Provide free COVID-19 testing for residents
3. Provide testing access for businesses
4. Access real-time data analytics and contact tracing capabilities

Fishers city government dips into cash reserves to finance COVID-19 testing

"Today is a conversation about an action-oriented, comprehensive plan that will allow our city to be in a strong position as (Governor Eric Holcomb) and (Indiana State Health Commissioner Dr. Kristina Box) make their decisions

around recovery and reopening. Our City of Fishers will be ready."

That's how Mayor Scott Fadness opened his news conference announcing a plan to have Fishers set and ready once state officials gradually allow the business community to open up. The mayor says he will dip into the city's cash re-

serves to finance an aggressive COVID-19 testing program, allowing businesses the opportunity to reopen and remain open by combining public health with the city's economic health. The testing program, projected to provide 200 to 300 tests per day, will be financed with about \$2.5 million from cash reserves.

Detectives, coroner investigating homicide

At approximately 3:15 p.m. last Friday, Hamilton County Sheriff's Deputies responded to the 21500 block of Overdorf Road, northeast of Noblesville, on a death investigation.

Deputies located a white male approximately deceased in the ditch on the side of the road.

According to Hamilton County Sheriff Dennis Quakenbush, the deceased was identified through fingerprint records as David Michael Fouts, 50, of the 7400 block of South Woodrow Drive, Pendleton. Detectives also indicated Fouts also has ties to a residence in the 16500 block of

East 196th Street, Noblesville.

On Saturday, the Hamilton County Coroner's Office conducted an autopsy and the findings are pending as of press time.

Detectives, along with the Hamilton County Coroner's Office, are treating this investigation as a homicide and do not believe the victim died at this location.

Westfield projects \$85M in lost revenue due to COVID

The closing of Grand Park until at least June 1 is expected to cost the city of Westfield and central Indiana \$85 million in lost revenue.

The signs are almost everywhere around the park, two words with a crushing effect on the Central Indiana economy: Park Closed. Westfield Mayor Andy Cook is a champion for Grand Park.

"Its purpose in creating it was not to have an income from sports but to actually diversify our tax bases and build a tax base, and in this case, the tax base is tourism and youth sports," Cook said.

This would have been the

sixth full season for Grand Park and should have been a destination for 2.5 million people coming into the area.

The park has become an economic engine for this slice of Hamilton County.

The 400-acre park holds 26 baseball and softball diamonds, 31 soccer or multipurpose fields and has given life to dozens of hotels and restaurants that have sprung out of the fields surrounding the park. They all depend on the traffic generated by the park.

A special taxing district set up to finance the park generated just enough revenue last year to meet operational costs. But this

Help needed for election; 16-year-olds can work

This year's June 2 primary election is going to be like none experienced before. And, election officials are scrambling to line up enough poll workers to conduct election day voting.

Elections administrator Beth Sheller is encouraging absentee voting, which is available to any registered voter in Hamilton County. About 12,000 applications have already been received. Applications can be found online

at the election office website.

But, on Election Day, polls will be open and must be staffed with about 800 workers. Here is where the immediate problem lies as many older previous workers will not be working due to health concerns related to the pandemic.

Sheller said she is looking for teenagers and teachers who are out of school, and may want to be helpful and be paid for their work. Students as young as 16 are eligible to work. The pay ranges from \$225 for inspectors to \$105 for clerks and judges plus a \$20 food allowance.

The elections office may also need counters for absentee ballots. Pay is \$100 per day. In all cases applications for the positions can be found on the election office website or by calling the office at (317) 776-8476.

Due to the current health emergency, a few precinct voting places will be moved. Voters will be notified if their location is changed.

Early voting is another option being offered again this year from May 26 through May 30.

There will be two locations for early voting in Noblesville:

the County 4-H Fairgrounds Annex Building and the Government and Judicial Center.

In Carmel, early voting locations are the Mercy Road Church and the Coxhall Mansion at Coxhall Gardens, but at this location voting is available only through May 29.

In Westfield, the sites are City Hall and the Westfield Public Safety Building.

Fishers early voting sites will be found at City Hall and at Billericay Park.

Hours in all locations are 9 a.m. to 4 p.m.

Expansions at Noble Crossing, Hazel Dell elementary schools moving forward

The REPORTER

Noblesville Schools has announced that it is moving forward with expansions at Noble Crossing and Hazel Dell elementary schools.

These construction plans are in addition to several others the district has already announced previously, including an expansion at North Elementary, a new community center located off of Field Drive, a new multipurpose stadium, soccer shelter enhancements and a new district storage facility.

All projects will be funded through bonds and will not use referendum dollars or raise the tax rate.

Growth on Noblesville's west side has driven up enrollments in recent years at Noble Crossing and Hazel Dell, creating the need for expansions to maintain appropriate class sizes and services.

The Noble Crossing Elementary expansion will include:

- New southwest wing of six classrooms and teacher work room (May 2021)

- Expanded cafeteria dining area (December 2020)

The Hazel Dell Elementary expansion will include:

- Two new classrooms and two new teacher work rooms (August 2020)

- Renovations to office areas in media center, nurse clinic and front office (August 2020)

The district works with a professional demographer on an ongoing basis to analyze future growth predictions and trends. While all Noblesville schools are at or near capacity now, the predicted future needs do not warrant the expense of building additional schools at this time.

The district last rebalanced school boundary lines, including Noble Crossing's, in 2017 and will continue to use boundary management and the expansion of current schools, as needed, to manage growth.

Noblesville offering rain barrels at discounted price

Noblesville residents and business owners may purchase substantially discounted rain barrels while supplies last, thanks to the Noblesville Clean Storm Water Program. In order to qualify for this program, residents and business must pre-order their barrel on hamiltonswcd.org.

This program is open to Noblesville residents and business owners who receive a city sewer utility bill. There is a limit of one rain barrel per address and quantities are limited. The retail value of rain barrels is normally \$75 or higher but are available for \$30 courtesy of the Noblesville Clean Storm Water Program. Diverter systems for rain barrel installation also are available on

the online store for \$25.

A copy of your city sewer utility bill (not Indiana American Water bill) will be required at the barrel pick up event at the Hamilton County 4-H Fairgrounds, 2003 Pleasant St., Noblesville, between 11 a.m. and 6 p.m. on Friday, May 29.

A rain barrel collects and stores rain water that would otherwise be lost. It is designed to keep debris and insects out (including mosquitoes) and saves homeowners money.

County players make big impact as juniors for DePauw men's basketball

A group of freshmen college basketball players, including four kids from Hamilton County, came on to the DePauw University men's basketball team in the fall of 2017.

When they joined the Tigers, those freshmen were behind a roster of upperclassmen, waiting their turn to play. It wouldn't be long before their turn came: Two years later, those freshmen have completed their junior season, and have become solid contributors for DePauw, both in basketball and on the campus in general.

"That class is the heart and soul of our team," said Tigers coach Bill Fenlon. "They are pretty talented players, but also unbelievably good teammates. All of them are also really good students."

Fenlon said that the junior class are the poster boys of being DePauw athletes. "We're lucky to have those kids," he said.

There are seven men in that class, and the four Hamilton County players are all familiar names to local basketball fans: Nolan Ginther (Noblesville), Matthew Godfrey (Guerin Catholic), Caymn Lutz (Hamilton Heights) and Aaron Shank (Hamilton Southeastern). The other juniors in the class also came from Indiana schools: Nick Felke (Plymouth), Ken Decker (Crown Point) and Josh Hall (Bloomington South).

Ginther, Lutz and Shank played in all 26 of the Tigers' games this season. Unfortunately, Godfrey tore his ACL and was unable to play for the year; however, he stayed on as a student assistant and expects to be back on the court for DePauw next season.

"I've played against these guys ever since I was little growing up in AAU ball and in high school," said Godfrey. "I was actually on Caymn Lutz and Aaron Shank's travel team, so it was pretty exciting when we all decided to play for DePauw."

That county foursome could have been only a threesome had it not been for a last-minute change by Lutz, who was planning to attend Indiana University.

"Initially, I was just going to go to IU," he said. "Last-minute, my mom suggested I go visit DePauw, so I could have the option to play basketball."

Once Lutz visited, he quickly changed his mind.

"From the moment I stepped on campus, I had an amazing experience for the first time and I was just stoked

from that," he said.

Shank and Ginther both had similar feelings once they made their visits to Greencastle.

"I wanted a school that was academically challenging," said Shank. He already had decided to major in kinesiology, which is offered at DePauw, but not at some other schools.

"After visiting DePauw a few times it just seemed like the right fit for me," said Shank.

Ginther was in the same boat: He was looking for a school where he could either play basketball or major in actuarial science – "and DePauw offered both," he said.

The class spent its freshman year waiting their turn behind what was then a senior-heavy team. But the players made the most of their opportunities. Ginther played in 18 games, starting in one, and scored in double figures in three of those contests.

"It was a good experience," said Ginther. "We didn't have the best season that year, but it was good experience getting younger guys more playing time."

Meanwhile, they were also watching and learning from the upperclassmen.

"We got experience on the court and leadership that we needed," said Ginther.

Godfrey played in 11 games as a freshman, while Shank played in three and Lutz one. All of them were anxious to take the court, but they were also willing to do the work and wait their turn.

"Aaron and I were in the same position in that we knew we could go out there and compete," said Lutz. He said he "grew a lot" during his freshman year, and also played hard in practice.

"I learned a lot from it, it really expanded my game and knowledge of basketball," said Lutz.

Shank did the same thing, saying he "took that year to really work on my game, learn as much as I can, just try to compete every day and show coach that I was deserving of getting minutes." Meanwhile, the coaches were reminding both men that their opportunities were coming.

"He didn't play a lot, but got some experience on the practice floor," Fenlon said of Shank. The coach said Shank was a good contributor off the bench as a sophomore, leading him to a solid junior season.

It was the same for Lutz, as he found his way during his sophomore season

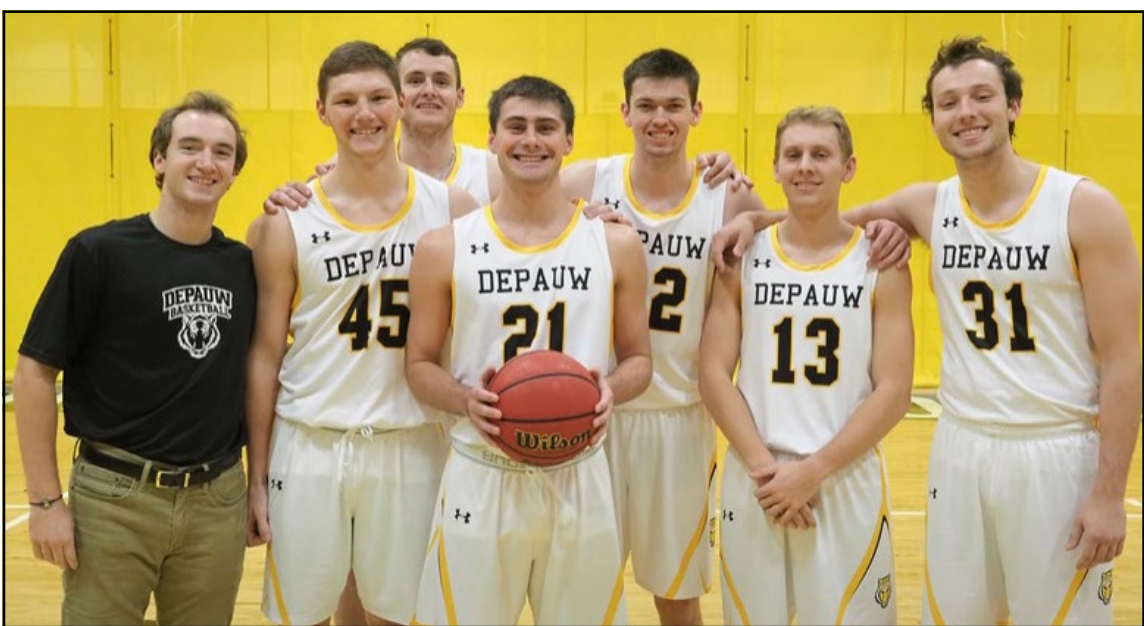

after having to make the big adjustment from high school to college basketball.

"He ended up the second half of his sophomore year becoming a solid positive contributor on the court for us," said Fenlon.

With the improvement, the opportunities came fairly quickly for the sophomore class. Shank played in all 27 of DePauw's games during his sophomore year, contributing 6.2 points per game, with Ginther becoming a regular starter, in 24 of the 26 games he played. He averaged 13.1 points and 4.8 rebounds, leading the team in both of those categories.

Godfrey played in 25 games, starting most of the second half of the season and averaging 50 percent from the 3-point arc. Lutz played in 21 games, adding 5.5 points per game and making 41.7 percent of his 3-point attempts. They helped the Tigers to a 17-10 record.

"As we became sophomores, we got a little more accustomed to the style of college basketball and we really started to gel a little more," said Godfrey.

"He's unbelievable," said Fenlon. "He's just an amazing kid. He's incredibly involved on campus."

While Godfrey had to sit out with an injury as a junior, the other three county juniors stepped up. Ginther continued as a regular starter, and was the leading scorer (14.7 points) and rebounder (6.5) and second with assists (2.5).

Ginther said he didn't expect to be the leading scorer, "it just happened to be that way," he said. The Tigers' offense runs through its post players, "so I get a lot of touches. It's something I've been working on."

In addition, Ginther has been named to the Tiger Pride Honor Roll all five semesters; that's given out to student-athletes with a 3.5 grade-point average or above.

"We're offered a lot of study tables," said Ginther. "At DePauw there's a lot of resources you can go to."

Ginther said that the professors are helpful with office hours and email, making it easy to talk with them about homework and tests.

"The campus environment is just very helpful in aiding your academic success," said Ginther.

Shank and Lutz also continued to improve. Shank was third on the team

in points, averaging 8.6 per game, and second with rebounds, pulling down 4.7 per game. He also made the Tiger Pride Honor Roll last semester. Lutz added 4.3 points per game, and was fourth on the team in assists (0.9) and fifth in rebounds (2.2).

"I think most of it is just confidence, just getting more minutes out there," said Shank. "I feel like I'm shooting the ball better. It just feels more natural to me."

Ginther was named to the All-North Coast Athletic Conference team this season; Fenlon calls him one of the "top five most competitive guys we've had in this program."

In addition to the Hamilton County players, Felke averages 14.0 points per game and Hall adds 11.2 points per game. With all of this talent back for a senior season, as well as the return of Godfrey, this class will be ready for next year.

"Our class keeps getting tighter and we have a lot of expectations for next year," said Godfrey. "Our goal is to win a conference championship, we haven't done that in a few years. That's definitely our aim for this upcoming season."

Hunter Ingle takes his own route to success in college

Hunter Ingle took his own college route, and it wound up working out pretty well for him.

The Noblesville graduate and cross country/track runner started at Vincennes University, and left with an associate's degree. Ingle headed south to Flagler College, located in St. Augustine, Fla., where he ran on the cross country and indoor track and field teams.

Ingle's path started at Vincennes, a junior college, although it wasn't something he relished at first.

"I remember not really being proud of what I was doing after high school, especially coming from Hamilton County," said Ingle. After all, this area is well-known for producing state champions and All-State runners, many of whom go to Division I schools.

"You tell people, it's not a very proud thing to state," said Ingle. "It's something you don't brag about."

But things worked out, both academically and athletically. He got good grades and completed an associate's degree in Advanced Manufacturing, "which was cool because I had something," he said. Now, Ingle is proud he went to Vincennes, because had he not gone that way, he would've never wound up at Flagler.

"I'm really happy I didn't settle," said Ingle.

Once it was time to start looking at his next steps, Ingle chose Flagler because it seemed like a good fit to him. It was also

in an area that he was familiar with: Ingle's grandparents lived in St. Augustine, which is about a half-hour south of Jacksonville, right on the Atlantic Ocean coast.

Ingle's grandparents owned a house and condominium at the time, so his family would stay with them whenever they came on vacation. Ingle noticed that the area around St. Augustine - which was founded in 1565, making it the oldest city in the contiguous United States – has

grown tremendously since Ingle was a kid.

"We have our quiet time every now and then," said Ingle. "There's a lot of people down here. Everyone learns about a really cool area, it makes all the magazines, everyone hardly remembers what it looked like before."

Something people associate with Florida, be it the northern, southern or inland part of the state, is humidity. High temperatures in St. Augustine average around 90 degrees during July, and the 80s linger as an average high into October. Ingle had to get used to that on a full-time basis once he arrived in Florida two-thirds of the way during the summer between his sophomore and junior years.

"You definitely feel the difference, especially at first," said Ingle. "The humidity makes it so hard to breathe. Definitely that first summer was a challenge and a lot to adjust to."

But after a full year, Ingle got used to the weather. He said working out in the Florida weather gives one an advantage, especially if he's racing against a team from the Midwest or the North. If those teams were to race in a southern climate, "it definitely gives you an edge, like kids that train at altitude," he said. "A lot runners call humidity the poor man's altitude. It's definitely something you have to adapt to."

Once at Flagler, Ingle delivered solid results for the cross country team. He started with a 30th-place finish at the 2018

Border Clash XC meet, which took place at nearby Valdosta State University, just over the border in Georgia. The Saints finished second out of nine teams at that meet.

The Border Clash XC Meet was unusual in that it was a 7,250-meter race. The next four races that Ingle competed in were all the more typical 8,000-meter (8K races). Ingle ran his career-best 8K time at the Royals Challenge, hosted by Queens College in Charlotte, N.C., clocking in at 26:42.0. He finished the 2018 season at the Peach Belt Conference championships, placing 54th. The Saints finished third as a team.

In his senior season, Ingle ran in two races, despite dealing with a stress fracture. He ran for the second time at the Peach Belt Conference championship, this time in Lumberton, N.C. Ingle placed 30th, helping the Flagler to a second-place finish. The Saints then competed at the NCAA Division II Southeastern Regional in Wingate, N.C., finishing in fourth. In the 10K race, Ingle placed 121st in a time of 36:56.0.

Ingle said he didn't notice many differences between junior college and a four-year school, "especially since I went Division II and I went to a smaller school." His decision to attend Flagler resulted in another athlete attending the school: Marcus Graham, a standout at Perry Central High School, also went the junior college route, running

Cam Lindley keeping sharp while waiting for Eleven season to resume

It was something that Cam Lindley and the Indy Eleven couldn't wait to do: Get a rising young player signed to the team and bring him back to his hometown.

Everything seemed to be working out when Lindley arrived in Indiana and joined the team. Then the COVID-19 pandemic hit and Lindley, like his new teammates and pretty much everyone involved in professional sports, got stuck in wait mode.

Even with the USL season suspended for now, Lindley is enjoying the fact that he's back with his home team.

"It's been good so far," he said.

The signing of Lindley with the Eleven happened rather quickly. Lindley said there was mutual interest between him and the team, so the signing process and Lindley's joining the team "honestly took probably a day."

"We drafted up a contract and I signed it as fast as I could," said Lindley.

Indeed, Lindley put his name on the contract and "was in the next day training," he said. He already knew a few of the players on the Eleven before he signed with the team.

"I trained with them his off-season," said Lindley. "So it was nice to already see some familiar faces when I walked in the door."

The Eleven sent out a news release about Lindley's signing

on Feb. 6. After that, he spent the next month with the team as they prepared for the season and played in pre-season games. The team got one regular-season contest in, playing its opener against Memphis 901 FC on March 7 at AutoZone Park in Memphis. The Eleven won 4-2, coming back from 2-0 down to win the game. Lindley played in the game as one of the subs.

But as the seriousness of the COVID-19 pandemic began to set in, the USL joined other professional sports leagues in halting its season. The USL announced on March 12 that it was temporarily suspending play.

"We were getting ready to leave for Kansas City, then they canceled that game," said Lindley.

Practices are also on hold, of course. But the Boys in Blue are keeping their skills sharp, and Lindley is no exception. He regularly posts "Skills of the Day" on his Twitter account (@cam_lindley), including several variations on "around the world." For that one, think of the soccer ball as a globe and Lindley's foot as a satellite orbiting the earth at a very high rate of speed. He even does one barefoot.

"We spend hours trying to learn new tricks, trying to learn different things," said Lindley. There are two reasons for that: It entertains them (and their fans), and it also makes them better soccer players.

"I'm trying to do different

challenges daily to get youth involved, to get them active,” said Lindley. “I get to interact with these people and they reach out to me and I get back to them,” making it a good way of connecting with people.

Lindley was already well-traveled by the time he signed with the Eleven. After graduating from Guerin Catholic High School in 2016, he played for two seasons at the University of North Carolina. He helped the Tar Heels to two appearances in the NCAA College Cup, back to back in 2016 and 2017. Lindley was named the ACC Midfielder of the Year and was a First Team All-ACC honoree as a sophomore, and enjoyed the college experience.

“Coach prepared me for the professional ranks very quickly,

and that’s why I felt like I was ready to leave after my sophomore season,” said Lindley. “We went to two Final Fours, so I was proud of that as well. My time there was something that I cherish and probably will for a very long time.”

Leaving college and turning pro is not something that an athlete takes likely. Lindley was no exception.

“It’s a scary decision,” he said. “It’s definitely scary because you’re leaving a place where you’re comfortable, you’re the best player. You’re taking a leap of faith and trusting yourself to make the jump to the next level and being able to perform.”

Lindley said that people don’t realize that the decision is harder on one’s mind than his

body.

“Very rarely do you see flawless transitions from college to pro,” said Lindley. “I don’t envy those who are going to be making those decisions anytime soon.”

But Lindley has made the transition well. He signed with Orlando City SC before the 2018 season and started three of the team’s four games. He then played at Memphis 901 FC in 2019, where he scored one goal and made seven assists.

“They were two great clubs,” said Lindley. “I really enjoyed playing for them and they definitely helped me develop as a person and a player.”

Now he’s back home, and hopefully will get to show that development to his family and friends. It wasn’t too long ago –

2015, in fact - that Lindley was part of Guerin Catholic’s state champion boys basketball team.

His highest finishes have come in relays; during his junior year, Ingle he joined the Saints’ 4x400 relay team for a fifth-place finish at the Gene Anderson Invitational at the University of North Carolina, then helped Flagler’s 4x400 team to take seventh at the JDL College Kickoff at Winston-Salem, N.C.

In his senior season, Ingle

placed 13th in the mile run at the Mondo College Invitational, then was part of the fifth-place 4x400 relay team at the JDL College Team Challenge; both meets were also at Winston-Salem.

Ingle is majoring in business, and said he realized “I wanted to something more along the lines of the business world,” and will be attending Flagler for a fifth year to finish up his degree.

“I decided to opt for the fifth year, especially since I saved so much money going to junior college,” he said.

And why not, since Ingle’s route wound up being the best route possible for him.

“Looking back on it, I chose Flagler, just because if I did walk on to a D-I school, I wouldn’t have been able to stay on the team,” he said. Instead, he has a strong bond with his teammates, is happy with the school itself, the academics, the location, and still be able to help out and be a volunteer assistant – “happiness here that I might not have been able to get at other schools,” said Ingle.

I was born and raised right here in Noblesville. I grew up in a home without domestic violence or assault – it wasn’t something I saw, or even heard about. But when I was introduced to Prevail of Central Indiana, I was shocked by the number of individuals who are affected by domestic violence.
