Five more Democrats file to run

Hamilton County Democrats, trying hard to fill their local ticket for the November election, have filed five more candidates for county office.

Democratic chairman Joe Weingarten last week filed the following candidates ahead of the July 6 deadline to fill the ticket as permitted when no one has filed for the party primary election.

Dan Montgomery, Westfield, will be on the ballot for County Commissioner in District 3 against incumbent Republican Mark Heirbrandt.

Mike Roberts, Fishers,

has filed for County Auditor against incumbent Robin Mills.

Jake Madone, Carmel, is the Democrat chosen to run against GOP candidate Susan Byer for County Treasurer.

Brad Beer, Wayne Township, will oppose incumbent Kenton Ward for County Surveyor.

And, Victor Schleich, Carmel, will run for one of three at-large seats on the County Council where Republican candidates are Brad Beaver, Sue Maki and Steve Nation.

One Democrat, Gardiner Bink, had already filed on the Democrat ticket in the primary.

"It is essential that we give the citizens of the county a choice instead of the usual people who are selected by one party only. All of our candidates are fully qualified and provide a choice for the voters. Too long we have had one-party rule and a lack of transparency and fairness for all taxpayers of Hamilton County."

Weingarten said in a memo to party workers that he hopes to find a candidate against County Commissioner Steve Dillinger as well as a third council candidate.

Democrats are not expected to challenge Republican judges on the ballot this year.

The party chairman also told his followers that he intends to challenge the City

of Fishers for not having the required number of Democrats on the city police and fire Merit Boards. **Read more on Page A5.**

For many years Democrats have not filled their general election ticket, and no Democrat has won countywide office for 62 years. The last was Charles Ardery, elected judge of the Circuit Court in 1958.

Humane Society breaks ground on new state-of-the-art facility in Fishers

The Humane Society for Hamilton County (HSHC) has launched its Building a Brighter Future for Hamilton County & Hoosier Animals Capital Campaign in November 2018.

Last Wednesday, the organization, along with local dignitaries, broke ground on the state-of-the-art 40,000 square-foot facility in Fishers. The new facility will allow the organization to save more lives, expand community outreach programs and provide a happier and healthier life for the animals of Hamilton County.

In attendance were Hamilton County public officials, HSHC staff, board members, lead volunteers, corporate sponsors, and key supporters and donors who have contributed to the capital campaign.

Remarks were made by Fishers Mayor Scott Fadness, Hamilton County Commissioner Mark Heirbrandt, a Meyer Najem representative, HSHC Board Chair Kim Ebert, HSHC President and CEO Rebecca Stevens, Hamilton County Council President Rick McKinney, Fishers Council President Cecilia Coble, and Steve Cage, the donor for whom the new facility will be named.

"Building this brighter future for the animals has been a decade-long, labor of love," said Stevens.

Hamilton County schools announce return plans

All Hamilton County schools will welcome students back for a new school year beginning later this summer, and the various districts have come together to share important information regarding the return to school.

Schools participating in this coordinated effort include Carmel Clay Schools, Hamilton Heights School Corporation, Hamilton Southeastern Schools, Noblesville Schools, Options Charter Schools, Sheridan Community Schools, St. Theodore Guerin High School and Westfield Washington Schools.

The safety of students, staff and families is top priority, and the districts say these decisions are based on guidance from the Centers for Disease Control (CDC), Indiana State Department of Health (ISDH), Indiana Department of Education (IDOE), Fishers Health Department and the Hamilton County Health Department.

All Hamilton County schools are following previously scheduled calendars and will start on the regularly scheduled start dates.

Schools will also:

- Provide flexible options to meet individual student needs, including both online and face-to-face learning.
- Implement daily screening/self-screening procedures for COVID-19 symptoms.
- Ask students and staff to wear masks, at times.
- Maximize facility space with respect to social distancing, including lunch tables spaced out to the greatest extent possible.
- Close water fountains and maintain water bottle fill stations.
- Require students and staff to stay home when ill and create separate spaces in school health clinics to address COVID-19 symptoms.
- Transport students with precautionary safety measures in place.
- Enhance student hygiene practices and building cleaning procedures.
- Restrict visitors.
- Train staff and students on COVID-19 safety measures.

Each school district will share additional, specific details with families in the coming weeks.

Carmel City Hall to gradually reopen to employees, public

Carmel City Hall will reopen to the public on Monday, July 6, with restrictions and measures designed to prevent the spread of the COVID-19 virus. A week earlier, on June 29, some city employees will return to their offices after working from home since March 17, giving them a week to assess the precautionary measures and adjust procedures in advance of the July 6 public opening.

Visitors and employees will have their temperatures taken as they enter City Hall and

will be required to wear masks, use hand sanitizer and practice physical distancing. The City will have a supply of disposable masks for those who enter the building without one. The public is encouraged to continue doing city business through emails and phone calls. Developers and others with construction and building projects should continue to submit plan documents through the new online portal. In-person meetings at City Hall will be only for city

Heights Youth Assistance Program continuing to serve local families during pandemic

The work of Hamilton Heights Youth Assistance Program never stops and is ongoing whether the school buildings are open or closed. The program, now in its sixth year at Heights, has been and continues to be a lifeline to services for district families in need.

Mary Ann Haymaker, Youth Assistance Early Intervention Advocate, spearheads the program at Heights and has become the "go to" for connecting Husky families to resources for food, clothing, financial assistance, mental health counseling, medication management, parenting support and a little bit of everything in between. She is supported by a vast network of

compassionate partners in every sector of the county. She works in tandem with other in-school advocates serving schools in Hamilton County.

"The harmful effects of this pandemic have not been distributed equally," Haymaker said. "The socio-economic impact and, in some cases, by mitigation measures, are resulting in additional hardships for families, many who are already struggling. The needs and our caseloads are increasing."

During this period of off-site instruction and physical distancing, Haymaker has been made it a point to reach out and keep in touch with the families to make sure they know this program services are not shuttered and to make sure they are doing OK. She also checks in regularly with program supporters.

"Our families are extremely grateful to continue their connection to the program and we are extremely grateful to our supporters who are there when we need them," Haymaker said. "Our County Youth Assistance team meets virtually each week to discuss the needs and progress of our communities to stay in close contact to make everyone

who needs assistance receives it."

Haymaker has been appreciative of the of the community's efforts to help to keep the shelves full at local food pantries to ensure local children get fed over the summer.

"Our community partners are some of our local heroes," Haymaker said. "They do so much and then find a way to do more. While our program is supported by many, I want to share my deep appreciation to our Hamilton County Sheriff's Department SROs, The Cicero Market, Delullo's, The Boat House, local food pantries, Jackson Township Trustee's and the Good Samaritan Network whose contributions, support, and involvement of late have helped ensure no one goes without. 

John R. Wimmer

1956 – June 24, 2020

John R. Wimmer, 63, program director in religion at Lilly Endowment, Inc., died on June 24, 2020, after he courageously fought a battle against a rare form of prostate cancer, and exceeded his life expectancy by almost two years. John received his cure when God brought him to heaven, and welcomed him with loving arms.

At his core, Wimmer was a man with a deep faith in God. He was a loving husband to his wife, Jan, and a devoted father to their son, David. He was a caring brother, uncle, pastor and friend. He was a scholar, a professor, a pastor, an author, an inspirational public speaker and a mentor. From his deep faith in God, all else flowed. John was genuine and honest, strong and gentle, generous and kind. John listened, he cared, and above all, he was a servant of God.

Wimmer joined the Lilly Endowment staff in 2002, and in his role as program officer in the religion division, Wimmer was responsible for nearly \$550,000 million in grants that supported religious institutions across the wide spectrum of Christian traditions. These grants strategically helped congregations and pastors, denominations, and theological schools, as well as church-related agencies and other religious non-profits strengthen their capacities to serve their communities and the world. Two large initiatives he directed (Sustaining Pastoral Excellence and Addressing Economic Challenges Facing Pastor Leaders) involved at least 30,000 parishes, or approximately one-tenth of all congregations nationwide.

Prior to joining the Endowment staff, Wimmer served as founding director of the Endowment-funded Indianapolis Center for Congregations. The Center for Congregations now has five regional locations in Indiana and provides consulting services, educational programs, and grants to nearly 4,000 Indiana congregations each year.

A graduate of University of Indianapolis, Duke University Divinity School (M. Div.), and University of Chicago (Ph.D.), Wimmer was a professor at the University of Indianapolis and taught courses in religion (1989-1996). He also served as Special Assistant to the President at the University of Indianapolis, where he helped to develop a comprehensive campus restructuring plan, launch the school for adult learning, and co-ordinate programming for the Christel DeHaan Fine Arts Center.

An ordained minister in the United Methodist Church for 40 years, Wimmer was pastor of churches in North Carolina, as well as churches in West Lafayette, Lafayette and Lebanon. John was known for his inspiring sermons, his sense of humor, his ability to communicate profound truths clearly, and his genuine personal care for the members of his congregations.

Author of three books and numerous articles, Wimmer was an acclaimed authority on the changing religious landscape in America. In his most recent book, Blessed Endurance, Wimmer testified to an enduring trust in God despite profound experiences of suffering. In 2018, he was awarded the Medallion of Merit by the Texas Methodist Foundation for his contributions to congregational life and leadership.

Wimmer is survived by his wife of 42 years, Janilee (Jan) S. Blaising, and their beloved son, David M. Blaising-Wimmer (Zionsville); his sisters Ann (Randy) Tilton (Ocoee, Fla.) and Carol (David) VanHoose (Waco, Texas); his brother-in-law, Stephen (Terri) Blaising (Indianapolis), and sister-in-law, Anne (Todd) Bidelman (Lutz, Fla.), and his eight nieces and nephews, Ryan and Stephen Tilton, Michael VanHoose, Megan and Nick Blaising, and Taylor, Erica and Charlie Bidelman, as well as his father-in-law, Adolf Hansen. John's daughter, Kathryn (Katie) E. Blaising-Wimmer, preceded him to Heaven (also on June 24), as did his loving parents, John and Dorothy Wimmer, and his loving father-in-law and mother-in-law, Rev. Mark and Nona Blaising.

The four 2020 parade grand marshals include:

Noblesville Schools: Jill Maynard
Maynard, a second to fifth grade special education resource teacher at Noble Crossing Elementary, was named the 2020 Noblesville Schools Teacher of the Year at the overall district level and

the elementary level. Her primary role is supporting students’ social and emotional development while helping them achieve academic success. She recently completed her seventh year of teaching at Noble Crossing. Prior to becoming a resource teacher Maynard taught third and fourth grade.

Riverview Health: Joyce Wood

Joyce Wood began her career as a staff nurse at Riverview Health in 1990, and currently serves as the chief nursing officer and vice president of Organizational Improvement. Wood is responsible for overseeing both strategic and operational initiatives that impact nursing practice to

ensure patients receive safe, compassionate, high-quality care. She also provides leadership on risk management and regulatory compliance.

Noblesville Fire Department: Division Chief James Macky

Macky is a 20-year veteran of the Noblesville Fire Department, who supervises the 91 EMT’s and 37 paramedics that work for the NFD. Deadline for penalty waiver on property taxes approaching

Property taxes were due for residents in the State of Indiana on Monday, May 11. However, an executive order issued by Governor Eric Holcomb gave folks who needed extra time in making those payments an extra 60 days without penalty.

The deadline for that payment is Friday, July 10.

The executive order issued March 19 asks counties to waive penalties for delinquent non-escrow property taxes – both real and personal – paid for up to 60 days.

“Property taxes are more critical now

more than ever,” Hamilton County Treasurer Jennifer Templeton said. “These taxes are distributed to our police and fire departments, schools, and trustees – services that are critical to our COVID-19 recovery efforts. Paying your property taxes ensures no disruption to these services.”

Taxpayers have several options for making their payments including the following:

Democrats say Fishers police, fire commissions lack political balance as required by state law

Indiana law requires many locally appointed bodies to have a political balance, and Hamilton County Democratic Party Chairman Joe Weingarten says Fishers Mayor Scott Fadness has not been following that law. City Attorney Chris Greisl has sent a response.

Specifically, Weingarten says the Fishers Police Merit and Fire Commissions cannot have three members of the same political party serving on those panels, yet he claims election records show four of the five Police Commission members are Republicans and all five on the Fire Commission are Republicans.

The police and fire commissions are responsible for handling issues of discipline for those serving in those city departments.

According to Weingarten, Bryan Babb is listed on both Commissions’ websites as a Democrat, though his voting records indicate that, while he voted Democrat in the 2016 primary, he voted Republican in the 2011 and 2014 primaries.

Weingarten also points to Mr. Gary Bolenbaugh, listed with no political affiliation on the Commission’s website, while voting records indicate he voted Republican in the 2016, 2018 and 2019 primary elections. The Democratic Party Chair says based on their voting records, both Babb and Bolenbaugh should be listed as Republicans, resulting in a politically imbalanced Commission.

On the Fire Merit Commission, Mike Peterson does not show party affiliation but voting records indicate he voted Republican, based on Weingarten’s letter to Fishers Mayor Scott Fadness. William Stuart, per the same letter, has a primary election voting record showing he voted Republican. This results in all five members not meeting the intent of the Indiana Code, according to Democrats.

Although how one votes is a secret ballot, under Indiana law, in a primary election, a voter generally asks for a Republican or Democratic ballot. Which ballot you choose is a matter of public record.

City Attorney Chris Greisl, in responding to Weingarten’s letter, cites Indiana’s code as saying Gary Bolenbaugh serving on the police and Mike Peterson with the fire commission are appointees by the city council and, per the statute, are not subject to the political affiliation rules.

As to Babb and Stuart, Greisl says “claimed status within the Democratic party. We are happy to further review any information you provide that would otherwise disqualify members of your party from serving on our local boards and commissions.”

When asked to comment on Greisl’s response to his letter, the Democratic County Chair told LarryInFishers he is not satisfied. “Instead of an excuse and side stepping the questions it would be nice if they followed the law,” Weingarten said in an email message.

“Fairness when it comes to our police and fire departments and the administration of justice to its members is critical to the safety of Fishers residents,” Joe Weingarten said in a Democratic Party news release. “Now more than ever, we must ensure that decisions pertaining to department member discipline, including suspension, demotion and termination, are balanced and made in the best interest of the community.”

Below is the text of the letter sent by Weingarten to Mayor Scott Fadness, followed by attorney Greisl’s response.

Dear Mayor Fadness;

It has come to my attention that both the City of Fishers Police Merit Commission and Fire Merit Commission are not constituted to meet the requirements of Indiana Code § 36-8-3.5-6.

The current Police board as listed on the cities website lists Mr. Bryan Babb as a Democrat and under the code the “political affiliation shall be determined through the voters’ registration records of the three (3) most recent primary elections” in which each Commissioner voted. Mr. Babb voting record shows that he voted Democrat in 2016 and Republican in 2011 and 2014 primaries and thus cannot be listed as a Democrat. This would result in four of the five members of the Commission to be listed as Republican. Again, under the code no more than three members can be from the same party.

Mr. Gary Bolenbaugh, does not show party affiliation on the website, but voting records show that he has voted Republican in the last three primaries (2016, 2018 and 2019).

On the Fire Merit Commission Mr. Babb is also a member and listed as a Democrat.

Mr. Mike Peterson, does not show party affiliation on the website, but voting records show that he has voted Republican in the last three primaries (2016, 2018 and 2019). Mr. William Stuart is listed as a Democrat but voting records show that he has voted Democratic in the past three primaries (2014 R, 2016 D and 2018 D). Therefore he can’t be listed as a Democratic member of the Commission. This results in all five members listed with none being valid members of the Democratic Party.

Please inform me when you will take action to replace one on the Police and two on Fire of the Republicans on the Commis-

sions with a Democrat(s).

Mr. Weingarten:

I am in receipt of your June 18, 2020, letter to Mayor Scott Fadness regarding appointments to the City’s Police and Fire Merit Commissions. In general, whenever a law requires that an appointment to a board be conditioned upon the political affiliation of the appointee, or that the membership of a board not exceed a stated number of members from the same political party, at the time of an appointment, one (1) of the following much apply to the appointee:

(1) The most recent primary election in Indiana in which the appointee voted was a primary election held by the party with which the appointee claims affiliation.

(2) If the appointee has never voted in a primary election in Indiana, the appointee is certified as a member of that party by the party’s county chair for the county in which the appointee resides.

Ind. Code §36-1-8-10(b). Because many Democrats often vote in Republican primaries in Hamilton County, the City annually reviews its boards and commissions to ensure compliance with Indiana law.

Moreover, under Indiana law, Merit Commissions consist of five (5) commissioners to be established as follows:

(1) two (2) persons, who must be of different political parties, appointed by the unit’s executive;

(2) one (1) person appointed by the unit’s legislative body; and

(3) two (2) persons, who must be of different political parties, elected by the active members of the department.

Notwithstanding Ind. Code §36-1-8-10, political affiliation shall be determined through the voters’ registration records of the three (3) most recent primary elections. Ind. Code §36-8-3.5-6.

Please note that both Gary Bolenbaugh (police) and Mike Peterson (fire) have dutifully served the City as council appointments to their respective commissions, and as such, no political affiliation is required. Both Mr. Babb and Mr. Stuart have claimed status within the Democratic party. We are happy to further review any information you provide that would otherwise disqualify members of your party from serving on our local boards and commissions.

The Commissioners serving both the Police and Fire Merit Commission deal with some of the most sensitive issues that face our City. These public servants will continue to lead and be guided by the only principle that matters – serving the best interest of the City and its residents (not politics).

business and limited to 10 or fewer people.

“We have taken unprecedented steps to safeguard our employees since the virus became known in central Indiana, while continuing to provide all city services. We have had our employees work remotely, when possible, made available COVID-19 testing, antibody testing, contact tracing and extensive educational outreach,” said Mayor Jim Brainard. “As we reopen City Hall, we plan to be diligent in following the guidelines issued by the CDC and other federal, state and local health and safety authorities. We want employees and the public to feel safe as they conduct business.”

The mayor plans to continue diligent tracking of hospitalization rates and the availability of ICU beds and ventilators in the Carmel area, looking for signs of increases as the state of Indiana continues to reopen different sectors of the economy.

City Hall will be thoroughly cleaned and disinfected daily. Employee work spaces and daily routines have been modified to minimize the risk of spreading viruses to other employees and visitors. All employees are required to be tested for COVID-19 before they return to City Hall. Where possible, contactless options have been installed to turn on lights and faucets and to open doors. Additional hand sanitizer stations have been placed throughout the building.

The re-opening for employees will be gradual, with each department identifying which employees will return and when. Those decisions will be based on the needs of the department, the possibility of continuing to work remotely and personal considerations of each employee who may be at-risk or are caregivers for children.

Public access to City Hall will be limited to the south doors, located off the city parking lot. As you enter, you should use the southeast door (near the reception desk) and as you exit, you should use the southwest door (closest to the elevators) in order to maintain physical distancing. The north doors will be locked, although they can be used to exit the building. Drinking fountains inside City Hall will remain shut off except for the “bottle filling” function.

All Carmel City Court hearing dates, originally set during the time City Hall was closed, have been rescheduled for a later date. Defendants have been notified of their new hearing dates, either by email (if an email address was provided) or by regular mail to the address on file with the Court. Anyone who had an original hearing date during the shutdown, but did not receive a notice, should call the Carmel City Clerk’s office at (317) 571-2440 to get their new hearing date.

In July, most hearings will be done remotely. In subsequent months, the court will resume in-person hearings with appropriate measures to limit the number of people coming into the courtroom. Anyone entering the building for court will be screened by officers providing court security. The screener will ask the questions for screening of COVID-19. Temperature will be taken by a touchless forehead thermometer. Masks will be required and provided.

If you need to pay a fine, the Clerk’s Office will reopen on July 6. All payment of fines and costs are made to the City Clerk and can be done in any of the following ways:

- Online at GovPayNow.com
- By phone: 1-888-604-7888, enter payment code #5988
- In Person: with cash, money order or cashier’s check at the Clerk’s payment window on the second floor of City Hall.
- By mail: With cashier’s check or money order to Carmel City Clerk, 1 Civic Square, Carmel, IN 46032.

Operations Scott French said. "We're excited to join with Indiana Nitro to not only 'compete,' but to come together for a cause greater than wins or championships."



Tod Windlan hired as Sheridan boys basketball head coach

A familiar coach is back in Hamilton County, one with a remarkable record of success.

And he's ready to bring some of that success to Larry Hobbs Hall.

Tod Windlan was hired as the new boys basketball head coach at Sheridan High School last Thursday. After the afternoon school board meeting, Windlan was introduced at a presentation at the SHS cafeteria, where he addressed the crowd, then met the returning basketball players and their families, one by one.

"I just think it's a great opportunity for me," said Windlan. "I've spent 16 years in girls basketball, coaching the biggest games you could coach, the Hall

of Fame, the state final games, sectional, regional, semi-states. I think this is a time in my career where it's time for the move to go to boys. I had a son that played, successful player, won a state championship at Carmel."

Windlan's son Karsten was part of the Greyhounds' 2019 Class 4A state championship team.

"I'm just blessed to be here and have the opportunity to do it and I look forward to working with the feeder program and getting it done," said Tod Windlan.

Six of Windlan's 16 years in girls basketball were spent in Hamilton County. First, Windlan coached the Hamilton Heights girls team for two seasons. In 2011-12, he

guided the Huskies to a sectional championship and a 21-5 record. Then in 2012-13, Heights was the Class 3A state runner-up, finishing with a 23-3 record.

After one season at Warren Central, Windlan returned to coach the Carmel girls for four seasons, 2014-18. During that time, the Greyhounds were 87-20, won three sectional championships, the 2017 Hall of Fame Classic, and had the 2018 Miss Basketball in Amy Dilk, who is now a star for the University of Michigan.

"We wanted somebody that was local," said Sheridan athletic director Beth DeVinney. "We wanted somebody that was committed to building a pro-

gram, building a feeder program. Obviously, Tod's had great success everywhere he's been. We want to win now. We want somebody to come in and infuse passion and some life into our boys basketball program, and that's exactly what he's going to do."

Windlan noted that the whole hiring process happened rather quickly.

"Once the process started, it was really swift," said Windlan. "It was a late-night call, got in here the next morning. By that afternoon I was chosen. It was a very quick, swift process, but one that I am really looking forward to. Sheridan's a sleeping giant in all sports, because I think Hamilton County's growing this way. I think the school's going to grow by enrollment. I think you're going to see kids coming in here."

The players that come out for Windlan's team will need to be prepared to run. Windlan likes to play a fast tempo with everyone running up and down the floor. Look for the scoreboard operator to be busy as well: In Windlan's 2017-18 season at Carmel, the Greyhounds averaged 69.2 points per game.

"That's just how I'm programmed," said Windlan. "We may have to tweak some things based on what the kids can and can't do. They're going to be in shape, they're going to play hard and we're going to be a fun team to watch."

"They're not used to playing that way based on some of the game film I've watched," said Windlan. "It's just all about changing the culture here and getting back to trying to create a program like the football team. It's successful and the kids want to come and

play and be a part of it. That's what we want here in basketball as well."

Being a smaller school, Sheridan will have several multi-sport student-athletes on their teams, something that Windlan will encourage his players to continue.

"I think that's wonderful, because anytime you get multi-sport kids playing, when they're out of season, they're still competing," said Windlan. "And I don't think there's any substitute for competing. Too many kids play one sport. They don't play the other sports, so they're really not competing when they're doing workouts and stuff like that. Competition breeds success. I want my kids playing."

With activities at Indiana schools shut down for a couple more weeks, the Sheridan players and their new coach won't be able to get into the gym until July 6. Windlan said the first order of business is to get the middle school players (grades 6-8) in the gym first, then the high school athletes will be joining their open gym. During that time, Windlan plans to "work on skill breakdown, fundamentals of the game, and then start teaching them our offensive and defensive scheme."

"When the fall rolls around and we're ready to start practicing for real, then they'll have a good knowledge of what we're going to be about," said Windlan.

Derrick Dean looks back at playing and coaching Heights boys soccer

For over 25 years, Derrick Dean has been involved with the Hamilton Heights boys soccer team.

First he was a player, then he spent a couple years as an assistant coach before becoming the long-time Huskies head coach. Now after 17 years, Dean has announced that he is stepping down from that position.

Dean is taking a job at Rieth-Riley, a construction company – “They deal with asphalt, concrete, basically infrastructure stuff,” he said. This also means Dean is retiring from his teaching position at Heights, which he has held since graduating from Purdue University in 2001.

“It was kind of a last-minute thing,” said Dean. He called the events and timing of moving out of teaching and into the Rieth-Riley position “a perfect storm.” Dean taught technology and pre-engineering at Heights, and also advanced manufacturing.

“I’ll miss all the teaching stuff, the hands-on projects and real-world applications, all the certifications,” said Dean. “Same thing with the soccer side, I’ll miss all the memories we’ve had over the past 17 years. It was a tough decision, but it was a perfect storm. Everything seemed to line up and it made sense.”

Dean’s involvement with the Huskies soccer team began when he started high school at Heights. He was part of a big freshman class that came in and played on the team all the way through its senior year, winning a couple of conference championships along the way. Dean graduated from Heights in 1997.

“It was nice because our team never really changed from freshman year all the way to senior year,” said Dean. “Everybody just stayed together. It was very competitive. We were very good for quite a while.”

After that, it was off to Purdue, where Dean majored in Technology Education and played three years of club soccer. After graduation, he returned to Hamilton Heights to begin his teaching and coaching career.

Dean started as the assistant coach for the Huskies in 2001, after talking with Keith Thomes, the coach at the time.

“He approached me and wanted me to help him out,” said Dean.

Two years later, in 2003, Dean moved into the head coaching position when

Thomes retired. He led the Huskies to a run of sustained success, including sectional titles in 2013 and 2014, as well as a couple of conference championships.

“We had some very competitive seasons,” said Dean. He always tried to challenge the team with a tough schedule, which was designed to prepare the Huskies for tough sectional opponents.

In the single-class era, Heights had to take on teams from bigger schools, such as Noblesville and Pendleton Heights. When the two-class system began in 2011, the Huskies were a Class 1A team; the three-

class system started in 2017, and Heights was a 2A team.

“They loved the challenge,” said Dean. “I’ve tried to make our schedule stronger and stronger, always adding new opponents that would challenge us. I always told them I don’t care what their record was. If you’re not playing challenging games, it’ll never get you anywhere in the end.” Dean said the Huskies could’ve scheduled easy teams and had winning records and undefeated seasons, but again, it wouldn’t have gotten them anywhere.

Speaking of not going anywhere, Dean

said that he will be staying involved with the Heights program, even if he’s no longer the head coach.

“I’m not going anywhere,” said Dean. “I’ll be volunteering, I’ll come to what I can. I told (athletic director) Kurt (Ogden) I wanted to be a volunteer assistant.

“I’d be willing to help out in the interview process,” said Dean. “I have offered my assistance if they need it. Everyone knows when you coach, it’s year-round. I will communicate to the parents, I’ll send things out. I can still communicate and help out with what I can.”

Luke Melloh already making an impact as DePauw assistant coach

From Noblesville to Greencastle, and at all points in between, everyone that has ever met Luke Melloh knows he has a passion for football.

That love of the game led Melloh to success as a quarterback for the Millers, then for two years at DePauw University. But after a medical diagnosis led him to stop playing, Melloh switched his focus to coaching and has already proven himself successful at it - even though he was still a student when he began.

Melloh’s transition from player to coach happened during the summer between his sophomore and junior years at DePauw. He was diagnosed with cystic fibrosis, a lung condition.

“I wasn’t told that I couldn’t play, but it was a strong suggestion that I stop,” said Melloh.

Melloh and then-head coach Bill Lynch had a conversation afterwards, and Lynch suggested Melloh move into coaching.

“I hadn’t really considered it, but it was an opportunity,” said Melloh. “So, I did that for my junior and senior season and it went really well. I think I want to pursue this coaching thing long-term.”

And what better place to do that than right at his alma mater? Melloh graduated from DePauw this spring with a communications degree. He was also hired by Brett Dietz, who became the Tigers’ head coach in January, to come on board “and coach in a full-time role,” said Melloh.

“I was the quarterback coach, and he was a quarterback,” said Dietz. “I’ve known Luke for a long time.”

As a student-coach, Melloh had a variety of responsibilities during his junior and senior years.

“I was working with the quarterbacks and receivers, mainly receivers I would say,” said Melloh. He did a good amount of film work, charted plays and coverage of the defense during his junior year and also oversaw weight room workouts. Melloh also helped relay play calls; the offensive coordinator at the time would be in the press box, and would tell Melloh through the head set the play, which Melloh signaled to the players.

Melloh said that even though he was a student-coach, he was doing everything a full-time coach would do – he just also was in class.

“I got more responsibility in my second year doing it than I did my very first year, but I was doing a lot as a junior,” said Melloh.

“You can see Luke’s confidence grow,” said Dietz. “He started off playing quarterback and really just had that personality about him that you really just fall in love with the kid.”

Melloh also made quite an impact, which is why Dietz asked him to stay on the coaching staff after he graduated. He noted that Melloh has an “infectious personality,” and said “he’s got the energy you need to be a very effective coach. He has the respect of former classmates.”

“I think they can see his passion and genuine love for the game, and that makes him somebody you want to follow,” said Dietz.

“I had several players come up and ask me if Melloh was going to stay on coaching,” said Dietz. “In terms of what he will bring to the coaching staff, he’s going to bring energy, for sure. He brings a willingness that he wants to learn.”

Melloh has already learned quite a bit, and his new role helped enhance the life lessons that football teaches.

“I’ve always known as a player how much football can teach you about life both on and off the field,” said Melloh. “But I think once I transitioned to the coaching role, you see that play itself out even more so.”

“It’s a different relationship, player to player versus player to coach,” said Melloh. “Even though I was the same age as the players I coached, they respected me and looked at me as more of a coach than as a peer.”

“You just realize how important playing the game of football is,” said Melloh. That statement doesn’t apply to just the game itself, but also with what one does after his football-playing days are over.

“I want to make sure that I don’t miss an opportunity to impact these kids not just an athlete, but also people,” said Melloh. “This game is an unbelievable teacher

of life, and what a way to bring people together in a pursuit of one goal.”

Melloh’s coaching career is just beginning, but for now he’s happy where he is. He said his goal is to be a head football coach, and he’s open to coaching in college or high school.

“I’m not going to pigeon-hole myself to any one level,” said Melloh. “College coaching’s going to be what I do right now. As long as the common denominator is the same, which is coaching football, I’m in for it. Having the opportunity to go back to my alma mater is something I

couldn’t pass up.”

Dietz believes there is a bright future for Melloh in the coaching world. He noted that there are “a couple of guys I know that have made it up to the Division I level, and both of them have a very, very similar personality to Coach Melloh, where it’s that energy. It’s somebody that the kids want to play for.”

“I want everyone to be excited to be out there, I want our players to be excited,” said Dietz. “When there’s energy, then we’re going to get real work done. He has that ‘it’ factor.”



