The 60th Hamilton County 4-H Queen Pageant was a bit different than any that had come before. Host Adam Goode called it an "unusual year" as social distancing protocols prevented the public from attending the event.

Last Friday afternoon, judges interviewed each contestant individually. By the end of the night, they named 19-year-old Rachel Read of Noblesville (Giddy Up Gang) as your 2020 Hamilton County 4-H Queen. Rachel is the daughter of Ryan and Jennifer Read. She has completed 37 projects during her time in 4-H. She is a sophomore at Butler University.

First Runner-up is 17-year-old Laura Vaughan of Noblesville (Lucky Robots). Laura is the daughter of George and Lisa Vaughan. She has completed 119 projects during her time with 4-H. Laura is a homeschooled senior.

Second Runner-up is 17-year-old Anneliese Jessee of Noblesville (Heartland 4-H'ers). Anneliese is the daughter of Anthony and Kimberly Jessee. She has completed 45 projects during her time with 4-H. Anneliese is a senior at Noblesville High School.

Third Runner-up is 18-year-old Caitlin Hartwick of Cicero (Husky 4-H'ers). Caitlin is the daughter of Chad and Cheri Hartwick. She has completed 44 projects during her time with 4-H. Caitlin is a freshman at Indiana Wesleyan University.

Fourth Runner-up is 16-year-old Delaney Howard of Noblesville (Stringtown Pikers). Delaney is the daughter of Brad and Pam Howard. She has completed 22 projects during her time with 4-H. Delaney is a junior at Noblesville High School.

The award of Miss Congeniality is voted on by the queen pageant contestants, rather than the judges.

Miss Congeniality is 17-year-old Alexandra Matthews of Noblesville (Llama Trekkers). Alexandra is the daughter of Rick and Stacy Matthews. She has completed 40 projects during her time with 4-H. Alexandra is a senior at Hamilton Heights High School. She was given the award because she is known for being friendly, helpful, cheerful and enthusiastic.

HSE school board issues statement on racism

As the Hamilton Southeastern (HSE) school board began its July 8 session, Board President Michelle Fullhart read a statement on behalf of the entire board about racism. She cited an Instagram account, Black at HSE, which features a series of anonymous posts about what the writers describe as racist incidents during their experience as a student at HSE Schools.



"Student voice is a powerful thing," the statement says. "We applaud our students who will not tolerate discrimination of any sort in our schools and are using the platform to advocate for change."

The statement also refers to a petition submitted and signed by over 1,000 local residents asking that school officials "openly address the issue" of racism and "implement real change."

The entire statement read at the school board meeting is below:

On behalf of the board, I would like to address recent discussions that have taken place nationwide, as well as in our community and on social media concerning racism. An Instagram account was created recently called Black at HSE where current students and alumni are anonymously sharing their experiences of racism they've felt while being in our schools. Student voice is a powerful thing, and we applaud our students who will not tolerate discrimination of any sort in our schools and are using the platform to advocate for change.

We had students speak to the board about racism during the non-discrimination policy discussion last year and have had quite a bit of feedback on the topic, as

Portillo's receives recommendation from Westfield Plan Commission

Editor's note: The Westfield Advisory Planning Commission reviewed several projects that area residents will see in the near future. Commission member Victor McCarty shared his comments and highlights from the board's most recent meeting, which you can read below.

Portillo's

After a few months delay, Portillo's was back in front of us tonight for recommendation. The project was given a favorable recommendation, 7-2. I had several concerns when it was first presented, but most of them were addressed, which is why I voted favorably. As iron

sharpened iron, when two entities work together a better project is the result. I look forward to hearing the City Council's thoughts and the possibility of Portillo's coming to Westfield on the corner of Wheeler Road and State Road 32 (next to the Monon bridge). Some changes made include:

- Upgrade to 56 percent brick from 35 percent
- Added safety to the parking lot

- Raised the loft four feet and added additional screening to the roof
- Turned trash into a compactor so that it is always covered
- Personal touches of local aesthetics

Consent agenda

We approved the Harmony Shoppes next to CVS at Ditch Road and 146th Street; Belle Tire, who went above and beyond to up-

grade their building at Austrian Pine Way and State Road 32; and an addition to Thrive Church on Towne Road.

Public hearings

There were three public hearings, one of which was a new Culver's at Gray Road and 146th Street. Thoughts shared concern the necessity of a fast food restaurant in the area, but overall there was a positive reception.

Understanding details of county government budgeting process

While we hear more about the federal and state governments for the laws they pass and policy decisions they make, it is the local governments that are responsible for public education, law enforcement, road maintenance, parks, public health programs and more. One good way for people to get a solid understanding of the county government's activities is to look at its budget.

"There are a lot of different elements to the county budget, and it might be difficult to understand if you don't have a back-

ground in governmental accounting and a familiarity with organizational budgeting,"

Auditor Robin Mills said. "Development of the annual budget in the public sector is more than just simple number crunching. The budget reflects a strategic plan that considers the needs and priorities of all stakeholders, from government administrators and employees to citizens and business leaders."

Each department of county government has a line-item budget to track

Carmel Clay Public Library secures temporary location

The Carmel Clay Public Library will lease space in the Merchants' Square shopping center while its Main Library facility undergoes a two-year expansion and renovation project.

The Merchants' Square site, which was formerly home to Marsh Supermarket, will serve as the library's primary facility while construction is underway at 55

4th Ave. SE. Library service will shift to the temporary location in September.

Key areas of the Main Library project include the following:

- A parking garage and improved traffic flow on the south side of the facility
- Increased capacity for events and programs
- Expanded space for teens
- Increased seating

and meeting space for study and tutoring

- Moving the Digital Media Lab from its current offsite location into the Main Library
- Outdoor spaces for additional program opportunities

CCPL's locations were visited by over 600,000 people last year, and over 72,000 people attended programs and events offered by the library.

every dollar spent on personnel, supplies, operating and equipment costs. The county has operating budgets and capital budgets. An operating budget is a plan of current spending and the means to pay for it (taxes, fees, grants, etc.). A capital budget contains long-term spending objectives and acquisition of assets along with the means to pay for them including, borrowing and/or bonding.

In each of these budget categories, Hamilton County has multiple funds, or budgets, that keep the designated public funding organized and transparent. Without a comprehensive understanding of governmental accounting and an in-depth knowledge of the county, the annual budget process can be confusing and complex.

"As auditor, I work with the other elected officials and department heads to develop the annual budget," Mills said. "During the development of the budget we

use information from the current year and previous years, current revenues and expenditure, cash-flow, debt service commitments, financial reports and capital plans. We need to comply with Department of Local Government Finance (DLGF) regulations and meet State Board of Accounts standards."

The county budget is also at the mercy of economic and development realities that are often beyond county officials' control and changes that may take place over the course of several years. And while county officials may be able to anticipate some of the impacts, they will also have to be ready to adjust the budget to react to them.

The county establishes its priorities by setting the funding levels and allocating the spending within the different programs.

"The budget also shows how the policy commitments are constrained by available re-

sources," Mills said. "Because the county is limited in how we raise revenues – legally through tax limits and politically by tax and fee levels that are acceptable to the voters – we are constantly working to balance the demands of different programs and services. Ultimately, the county does not have sufficient resources to fund everything to the extent users of government services want."

The county conducts an appraisal of the monetary value of property and tax is assessed in proportion to that value. While the budget numbers change every year, the overall budgeting process does not.

In May, the county departments receive budget instructions from the Auditor's Office. Contained within those budget instructions is a budget worksheet that the departments fill out, based on the budget instructions. The departments have until June to get the budget

worksheets back to the Auditor's Office where they are entered into the county financial system.

The Chief Deputy Auditor prepares the countywide budget book and in August, the departments present their individual budgets to the council at the budget hearings. The County Council then makes cuts to the departmental budgets and holds a public hearing on the official countywide budget in September. Final adoption occurs 10 days after the public hearing. Before it becomes final, the budget has to be uploaded to the State, where the DLGF must certify it.

"Budgeting for Hamilton County is about more than finance," Mills explained. "The annual operating budget serves as the county's most significant policy document and operating plan. As county officials, we must be sure that the decisions we make financially, are going to continue to help the county be sustainable for many years to come."

NOTICE OF A PUBLIC HEARING ON PROPOSED RATES AND CHARGES

Property owners, ratepayers and other interested parties in or served or to be served by the sewage works of the City of Noblesville are hereby notified that Ordinance No. 18-07-20, amending the rates and charges for services to be rendered for trash services, was introduced at a meeting of the Common Council held on July 14, 2020. At a meeting of the Common Council to be held at 7:00 p.m. on July 28, 2020, in the Noblesville City Hall Council Chambers, 16 South 10th Street, there will be a public hearing on the matter of the rates and charges, and consideration of adoption of Ordinance No. 18-07-20 which provides in part the following rates:

§ 91.06 FEES FOR TRASH COLLECTION AND RECYCLING FOR RESIDENTIAL CUSTOMERS WITHIN THE CITY.

(A) For purposes of this section, the term "ELIGIBLE RESIDENTIAL DWELLING UNIT" means a structure located within the city which includes a room or series of rooms located within a building or mobile home and forming a single habitable unit with facilities, which are used, or are intended to be used for living, cooking, eating and sleeping, and are either:

- (1) A single-family residential dwelling unit, defined as a residential dwelling unit separated from any other dwelling unit by open space, and designed for occupancy for one person or family;
- (2) A multi-family residential dwelling unit, defined as a building or related group of buildings not to exceed four units located on the same lot, tract, or parcel of real estate, with each dwelling unit being independent of the other; or
- (3) A Condominium, defined as any multi-family residential unit where the owner pays separately assessed property taxes.

(B) Beginning September 1, 2020 until September 1, 2024, there is hereby imposed a monthly trash collection fee per Eligible Residential Dwelling Unit in the amount of \$13.85.

(C) After the above dates, the monthly trash collection costs shall be re-established by an amendment to this section.

(D) (1) Any owner-occupant of an eligible residential dwelling unit who has filed, and been granted one of the following deductions from real property taxes and may request a credit against the fee imposed by this section:

- (a) A claim for an over age 65 deduction for property taxes pursuant to I.C. 6-1.1-12-9, or I.C. 6-1.1-20-6-8.5;
- (b) A claim for a blind or disabled deduction for Property taxes under I.C. 6-1.1-12-11; or
- (c) A claim for a disabled veteran or surviving spouse deduction for property taxes pursuant to I.C. 6-1.1-12-13;

Any owner-occupant eligible for any of the above credits is eligible for a 50% per month credit from the fees approved in subsection (D) of this section. A residential parcel may receive only one credit even though the owner-occupant may be eligible under more than one statute.

(2) Any request for a credit under this section shall be made to the City Wastewater Department by the person eligible for the credit. The credit shall be granted by the Wastewater Department if the owner-occupant of the Single Family Residential Dwelling has been granted a credit described in subsection (D)(1)(a) through (c) of this section.

(3) The property owner shall not be eligible for the credit until the first billing cycle after the request for the credit to the Wastewater Department. No credits will apply retroactively before the first month after the request by the owner-occupant.

(4) The Common Council shall annually appropriate into the Trash Collection Fund an amount equal to the total amount of the credits ("the Credit Amount") granted by this division.

(E) Any owner-occupant of an eligible residential dwelling unit who meets the criteria established in this subsection is eligible for special circumstances economic hardship credit ("hardship credit") from the fee established in subsection B of this section. Owner-occupants of eligible residential dwelling unit may apply for this credit beginning on September 1, 2020. This subsection shall expire on March 31, 2021.

(1) The hardship credit may be initially granted during a public health emergency or during a year in which a public health emergency has been declared.

(2) To be granted a hardship credit, an owner-occupant of an eligible residential dwelling unit must provide documentation to the Wastewater Department that shows proof that the owner-occupant has filed for any of the following:

- (a) Unemployment with the state Department of Workforce Development;
- (b) Hardship accommodation with the Indiana Department of Revenue;
- (c) Financial assistance with the township trustee; or
- (d) Energy assistance through the Low Income Home Energy Assistance Program;

and must affirm under penalties of perjury that the filing related to economic conditions caused in part by the public health emergency.

(3) Owner-occupants satisfying the requirements of this subsection will receive a 50% per month hardship credit, for a period of up to six (6) months. All hardship credits under this subsection will expire on March 31, 2021.

(4) Credits provided under this subsection may be granted up to a maximum of \$115.345.

(5) The Common Council shall annually appropriate into the Trash Collection Fund an amount equal to the total amount of the credits ("the Credit Amount") granted by this subsection.

(G) The fees payable under this section for any eligible residential dwelling shall be billed to the person or entity which receives the wastewater bill for the service to the eligible residential dwelling unit. If the monthly wastewater bill is for service to more than one (1) eligible residential dwelling unit, the monthly fee shall equal the number of eligible residential dwelling units included in the wastewater bill, times the monthly fee established by this section.

(H) The owner of any parcel of real estate containing an eligible residential dwelling unit which does not receive wastewater services from the city, but receives trash collection services from the city, shall be billed a monthly trash fee pursuant to this section, and any unpaid fees for the trash collection service shall be subject to the same remedies against the owner of the real estate, or recipient of the bill, which are included in subsection (J) of this section.

(I) The rate imposed by this section shall be in addition to the rates charged by the city to operate its municipal sewage works pursuant to I.C. §36-9-23-1 et seq., and any Ordinance establishing rates for the collection and treatment of wastewater by the city's wastewater utility.

(J) All unpaid fees imposed by this Ordinance are subject to the same delinquency fees, penalties, and interest authorized for delinquent sewer bills and may be collected by any lawful means including the filing of liens as authorized by Indiana Code 36-9-23.

(K) The City Controller shall cause the monthly charges collected pursuant to this section to be paid into a segregated fund (the Trash Collection Fund). The Trash Collection Fund shall be separated from the balance of the revenues of the Wastewater Utility, and to be used solely for the purpose of paying the city's trash collection cost.

At a meeting of the Common Council to be held at 7:00 p.m. on July 28, 2020, in the Noblesville City Hall Council Chambers, 16 South 10th Street, there will be a public hearing on the matter of the rates and charges, and consideration of adoption of Ordinance No. 17-07-20 which provides in part the following rates:

§ 51.03 RATE SCHEDULE.

This section shall impose a monthly fee for the use and the services rendered by the sewage works. Rates and charges shall be collected from the owners of each and every lot, parcel of real estate or building that is connected with the city sewage system or otherwise discharges sanitary sewage, industrial wastes, water or other liquids, either directly or indirectly, into the sewage system of the city. Such rates and charges include user charges, debt service costs, excessive strength surcharges and other service charges, which rates and charges shall be payable as hereinafter provided and shall be in an amount determinable as follows:

(A) (1) There is hereby established a flat, monthly fee of \$46.13 for each single-family residence and residential duplexes with separate meters ("residential parcels"), beginning September 1, 2020, until September 1, 2024.

(2) Any owner-occupant who is eligible for, and has filed:

- (a) A claim for an over age 65 deduction for property taxes pursuant to I.C. 6-1.1-12-9;
- (b) A claim for a blind and disabled deduction for property taxes under I.C. 6-1.1-12-11; or
- (c) A claim for a disabled veteran or surviving spouse deduction for property taxes pursuant to I.C. 6-1.1-12-13;

is eligible for a \$10 per month credit from the above amounts. Beginning September 1, 2020, the credit shall adjust to \$12 per month for eligible owner-occupants. A residential parcel may receive only one credit under this subsection, even though the owner-occupant may be eligible under more than one statute.

(d) Any claims for the above credit shall continue to be in effect as long as the rate payer meets the criteria above.

(e) Future claims must be filed with the Hamilton County Auditor. The property owner shall not be eligible for the credit until the first billing cycle after the claim is filed. Any owner-occupant who has filed a claim, but does not receive the credit on the wastewater bill, must file a file-marked copy of the owner's affidavit requesting one of the above deductions.

(3) Any owner-occupant of a residential parcel who meets the criteria established in this subsection is eligible for special circumstances economic hardship credit ("hardship credit") from the residential parcel monthly fee. Owners-occupants of residential parcels may apply for this credit beginning on September 1, 2020, and the credit shall be applied to the first billing cycle after the credit is approved by the City. This subsection shall expire on February 28, 2021.

(a) The hardship credit may be initially granted during a public health emergency or during a year in which a public health emergency has been declared.

(b) To be granted a hardship credit, an owner-occupant of a residential parcel must provide documentation to the Wastewater Department that shows proof that the owner-occupant has filed for any of the following:

1. Unemployment with the state Department of Workforce Development;
2. Hardship accommodation with the Indiana Department of Revenue;
3. Financial assistance with the township trustee; or
4. Energy assistance through the Low Income Home Energy Assistance Program;

and must affirm under penalties of perjury that the filing related to economic conditions caused in part by the public health emergency.

(c) Owners-occupants of residential parcels satisfying the requirements of this subsection will receive a \$15 per month hardship credit, for a period of up to six (6) months, beginning the next billing cycle after documentation is provided under subsection 3(b). All hardship credits under this subsection shall terminate on February 28, 2021. The hardship credit shall not be applied retroactively.

(d) If the owner-occupant receiving the hardship credit moves to another residential parcel, the owner-occupant shall supply the documentation required under 3(b) and may continue to receive the hardship credit on their new residential parcel amount.

(e) Credits provided under this subsection may be granted up to a maximum amount of \$250.000.

(B) The schedule of rates for all other users of the city's sewage works shall be determined as follows: The sewage rates and charges shall be based on the quantity of water used on or in the property or premises subject to such rates and charges, as the same is measured by the water meter there in use, plus a base charge based on the size of the water meter installed. For the purpose of billing and collecting the charges for the sewage service, the water meters shall be read monthly or based on the average monthly usage for the preceding seven months ending in May based on actual readings. These readings shall be averaged and the users shall be billed monthly (or a period equaling a month). All new customers of the wastewater utility shall have service commenced at the monthly rate based on meter size plus the family residential rate. Upon receiving at least three readings, the new customer's rate shall be adjusted accordingly.

(C) (1) The rates for the sewage works not included in subsection (A) above are as follows:

5/8-3/4 inch	\$16.32
1 inch	\$36.38
1- 1/4 inch	\$56.51
1-1/2 inch	\$80.68
2 inch	\$136.77
3 inch	\$310.88
4 inch	\$538.55
6 inch	\$1,221.38
PLUS a monthly flow charge (per 1,000 gallons)	\$5.05

(2) Unmetered non-residential parcels shall be charged a rate to be determined by the city on an individual basis by applying the above metered rates to estimated usage and meter size.

(D) There is established a surcharge rate for certain excessive strength surcharges based on effluent strength as follows:

Excessive Strength Surcharges	Monthly Per Pound
(Based on Effluent Strength)	Beginning September 1, 2020
B.O.D. in excess of 250 mg/l	\$0.17/lb
S.S. in excess of 250 mg/l	\$0.10/lb
Phosphorus between 4.0 – 6.99 mg/l	\$1.76/lb
Phosphorus in excess of 7 mg/l	\$10.11/lb

(E) Upon receiving notice that the water meter has become active from any of the water companies currently serving customers in the city, billing shall commence immediately. In the event a new customer uses the sewer system prior to notification to the utility, the utility may bill the new user retroactively, based upon either: the date a certificate of occupancy is issued for a new building or residence; or, for existing buildings, the date of transfer of the real estate, based on the deed recorded in the Office of the Hamilton County Recorder.

(F) For the service rendered to the city, the city shall be subject to the same rates and charges hereinabove provided, or to charges and rates established in harmony therewith.

(G) In order to recover the cost of monitoring industrial wastes, the city shall charge the user the actual costs of monitoring, but no less than \$65 per sampling event. This charge reimburses the City for the cost of administration of the sampling.

(H) No adjustment to the monthly rate charged to non-residential parcels shall be applied retroactively for more than three monthly billing cycles. Any appeal for an adjustment to the monthly rate more than three months prior to the request for an adjustment is deemed waived.

Fishers junior-to-be Dominic Oliverio committed to play baseball at Indiana State University last week.



With Indiana high schools finally able to open their doors, student-athletes are preparing for their seasons.

That includes football players, who are six weeks away from their first game of the 2020 season. The schedules are ready to go, and five Hamilton County teams have at least one new team on their line-up.

Former Sheridan hoopsters welcome new coach to town

In all his years crisscrossing the state of Indiana as an athlete, coach and father supporting his two daughters and son in their athletic endeavors, it seems Tod Windlan had never been to Downtown Sheridan.

That changed Tuesday evening when the town's new high school boys basketball coach found his way to Main Street – needing directions, of course – and met up with three former Blackhawk at the town's blossoming Historical Society Museum.

It was a meet and greet for Windlan and Jim Godby, David Sanders and John Holmes, members of Sheridan's 1960 Carmel Sectional championship team, which had stunned highly-rated Noblesville on its way to the title.

It was a game that still makes old Noblesville fans snarl, and some old Sheridan fans still claim it the greatest win in any sport in Sheridan's athletic history.

The highlight of the evening was touring the museum's vintage basketball history display that features legendary Hall of Fame coach Larry Hobbs. Whether the new coach, who took Hamilton Heights' girls to a state championship game, can duplicate the same success remains to be seen. But the three former players seemed impressed with the new coach's attitude.

"I believe a team is a reflection of its coach and I'm going to bring that drive every day," he told them. "You're going to see that from my players."

"I'm bringing my team here to see this," he said as he gazed at numerous photos and displays of Sheridan's basketball glory days from the late 1940s to 1960. "This is all about winning and they need to see this."

Windlan is well aware of where the high school gymnasium is, and he's met most of his players. There have been some workouts, too. "The attitudes have been good," he said.

"They're open to what we're trying to do. Right now, they're exhausted."

Godby, Sanders and Holmes expressed concern that football might still dominate the

small school, but Windlan promised to make basketball relevant again.

"In 49 states basketball's just a game, but this is Indiana," he smiled.

The Tigers are scheduled to open the regular season with a home game Aug. 23 against North Central.
