# Bank robbery in Sheridan

First Farmers Bank & Trust, 2400 State Road 38, Sheridan, was robbed at approximately 9:45 a.m. Wednesday morning.

The suspect pictured gave a note to the teller implying he had a weapon, but no weapon was displayed during the robbery. The suspect got away with an undisclosed amount of money. The suspect is a white male who appears to be in his 30s with tattoos on both arms.

The Hamilton County Sheriff's Office Investigations Division is currently assisting Sheridan Police Department with a bank robbery investigation.

According to the Sheriff's Department, both employees and citizens were inside the bank when the robbery took place.

Because of the nature of this crime, the FBI is assisting local law enforcement with this case.

The suspect was last seen wearing jeans, a striped short-sleeve shirt and glasses, and he possibly left in an older, white, four-door vehicle with all black rims.

According to the Reporter's sources, the last bank robbery in Sheridan was at The Farmers Bank in 2014.

# Student-athlete at Heights high school tests positive for COVID

A student athlete at Hamilton Heights High School has tested positive for COVID-19. The student has not attended school.

The school district contacted the Hamilton County Health Department, and per the health department's guidance, the student will quarantine at home for 14 days. Through contact tracing, any player the student touched must be quarantined

for 14 days as well.

As a precautionary measure, a staff member and 13 student athletes will also quarantine for the next 14 days.

Protocols and procedures related to this scenario can be found on pages 5-7 of Heights' [Re-Entry Plan](#). Heights administrators encourage families to remain diligent, take personal responsibility, and follow the recommendations by local and state public health partners to

mitigate risk of exposure and transmission on and off school grounds.

As a reminder, if you or anyone in your family is experiencing symptoms in line with COVID-19, contact your healthcare provider for further guidance. Families are encouraged to self-monitor for symptoms of the coronavirus virus including fever, dry cough, body aches, and shortness of breath.

A statement issued by the school district said, "We appreciate your continued confidence and support as we prioritize the health and safety of our students and staff while accelerating learning opportunities for all students during this pandemic. Thank you for doing your part to be good neighbors and show kindness and empathy as we move forward through these challenging times together."

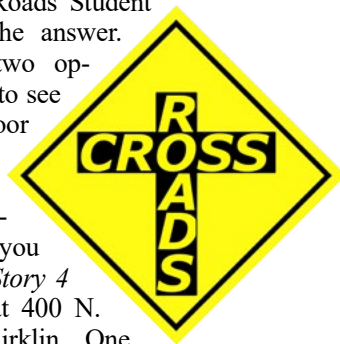
According to Pastor Chris Brooks, there is no cost for these family-friendly events.

# Water main flushing begins next week in downtown Noblesville

Indiana American Water will conduct water main flushing in the Noblesville service area beginning overnight on Sunday, Aug. 16 and continuing through Monday, Aug. 17 in the downtown area from 10 p.m. to 6 a.m.

Flushing of the remaining areas outside of downtown Noblesville will start on Wednesday, Aug. 19 and run through Friday, Oct. 23 from 8 a.m. to 4 p.m., Monday through Friday.

The company conducts the annual maintenance program to assure high-quality water service and to ensure fire hydrants are operational.

According to Noblesville Superintendent Josh Cox, "Water main and fire hydrant flushing is an important part of a regular maintenance program for water distribution systems. Indiana American Water consistently meets or exceeds all drinking water standards."

No interruptions in water service are anticipated as a result of the work. Customers may experience a slight drop in water pressure or temporary water discoloration while this program is underway. Customers should refrain from doing laundry during the time of day the flushing program is taking place in or near their neighborhood.

If tap water is discolored, Indiana American Water recommends allowing several cold-water faucets to run for a short time until the water runs clear. Using more than one faucet allows the water to clear more quickly.

Customers who have questions regarding hydrant flushing may call the Indiana American Water Customer Service Center at 1-800-492-8373.

The water main flushing will be performed by Indiana American Water crews. They will be working out of trucks identified with the company logo. All employees will also have photo ID badges.

residency and from this experience came the inspiration for this series of over 30 pieces.” Janosky, who is a juried artist member of Indiana Artisan and the Indiana Artists Club, hopes “that viewers considering these paintings will feel a connection with the Indiana Dunes landscape and appreciate the many interesting aspects of the dunes environment.”

Nickel Plate Arts Executive Director Ailithir McGill sees this as an excellent way to feature established area artists.

“Hub & Spoke offers an opportunity for artists to connect and collaborate with new audiences,” McGill said. “Hub & Spoke gathers together designers, fabricators, tradespeople and creative entrepreneurs in one amazing space.”

Hub & Spoke, a 94,000 square-foot master-planned mixed-use development, offers a design center with retail showrooms open to the public, a coworking space, and a state-of-the-art makerspace.

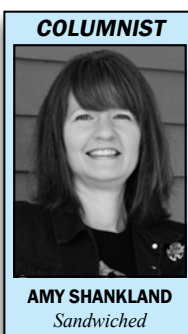

I wish I could say that one of us moved or that we simply drifted apart, but sadly, the end of our friendship came about because of a stupid fight – one that I can barely remember the details of. This fight not only tore us apart, but our families as well.

is not uncommon. I grew up never getting to know an uncle and his family because of an argument over, of all things, a bracelet. It seems like every person I've talked to since Amy died has had a similar

story.

People, we've got to do better. Why do we let a beautiful relationship, filled with years of kindness and goodness flowing both ways, suddenly stop over ONE stupid, bad thing? I'm not talking about something heinous, just thoughtless.

When I taught the Dale Carnegie course years ago, we discussed that it's human nature to focus on the one bad thing. For example, when a student is do-

ing a worksheet with 20 math problems but gets one wrong, we're quick to jump on them and point it out. We often ignore the 19 correct ones. We need to remember the hard work and effort they gave to those and praise and focus on them first.

I think we need to apply this concept to our relationships. Yes, people do hurt us, but if we think about it, we've hurt others as well. I look back on those I've hurt with my thoughtlessness and my heart just aches. I wish I could take back my actions. While I've apologized or tried to make it up them, I know all I can do now is pray that they have truly forgiven me and that they are happy and doing well.

Amy and I were lucky. My niece Melissa became friends with her sister Car-

oline in high school and they worked on a project together that brought them to Indianapolis. Our families gradually started talking to one another. Soon Amy and I had lunch at Olive Garden in Mishawaka and shared apologies and old stories. My mom and her grandmother Rita became friends again as well.

While I've been sad to have lost her these past few weeks, I would have been utterly devastated had we not patched things up all those years ago. I'll be attending her celebration of life in South Bend at the end of this month and will be among friends vs. enemies. I've thanked God every day that we reunited when we did. She became an incredible woman who touched the lives of many and I'm proud to have called her my friend.

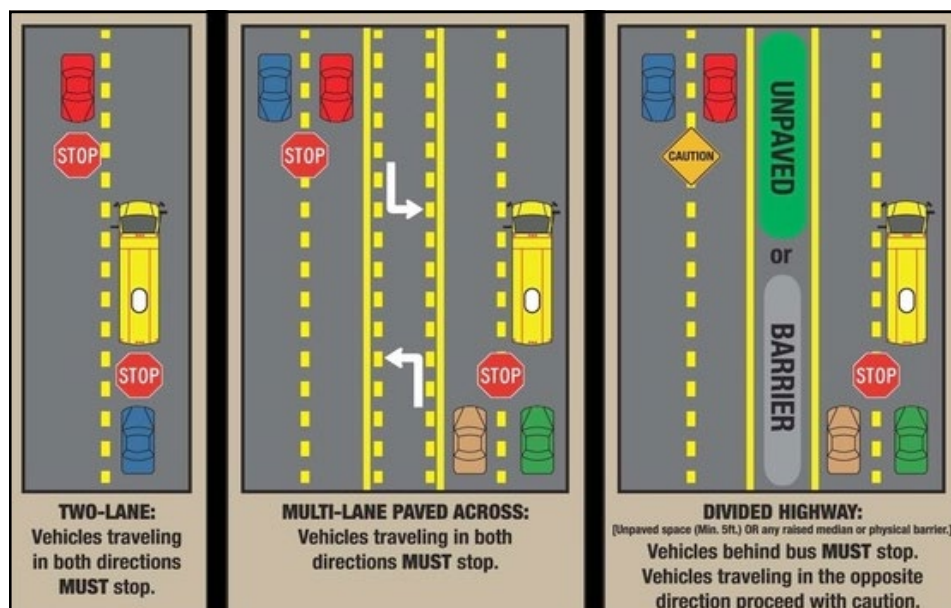
## State Police focusing on school bus safety, school zone speed limits

As the extended summer break comes to an end, students across Central Indiana are starting their return to school.

With that return, motorists should expect an increased amount of school bus and pedestrian traffic during the morning and afternoon commutes, and therefore need to plan those commutes accordingly to allow for extended travel time. Also to be expected, troopers with the Indiana State Police will be hitting the roads to watch for school bus stop arm violations. High visibility enforcement will be used to encourage motorists to stop for school buses, and enforcement action will be taken against those who don't.

Motorists should also be cognizant of school zone speed limits. The speed limit in a school zone is often reduced significantly during school hours or when children are present. Law enforcement officers will be increasing patrols in school

zones throughout Indiana.

The Indiana State Police would like to remind all motorists of the Indiana law concerning school buses, flashing lights and stop arms.

When approaching a school bus from any direction, which is stopped and has its red lights flashing and stop arm extended, motorists are required to **STOP**, even on multiple lane highways where there

is no barrier or median separating lanes of traffic.

Motorists who are on a highway that is divided by a barrier, such as cable barrier, concrete wall, or grassy median, are required to stop only if they are traveling in the same direction as the school bus.

Always be prepared to stop for a school bus and watch for children. Children are unpredictable. Not only

is disregarding a school bus stop arm dangerous, it is a serious offense.

Prepare for increased pedestrian traffic in the morning and afternoon hours, and be aware of children standing along the roadway at a bus stop.

The Indiana State Police is committed to the safety of children and keeping Indiana's roadways safe through enforcement and education.

# AG Curtis Hill urges Congress to pass legislation to protect seniors who have been victims of fraud

Indiana Attorney General Curtis Hill is urging Congress to pass legislation known as Edith's Bill, designed to assist seniors victimized by fraud, as part of the nation's efforts to provide relief to those most impacted by COVID-19.

This bipartisan legislation would amend the Victims of Crime Act of 1984 (VOCA) to include victims of senior fraud as eligible for reimbursement through the Crime Victims Fund in states that provide compensation to victims. Indiana is one of those states.

Realizing that seniors are especially at risk from COVID-19, scam artists are targeting older people who are isolated at home, separated from families and detached from typical support networks.

"Scammers are well known to prey especially upon our older citizens," Hill said. "We must work together across local, state and federal jurisdictions to do everything possible to protect seniors from criminal predators. Further, we must also do our best to make seniors whole when they do fall victim to these unsavory schemes."

Hill is one of 44 attorneys general to sign a **letter to congressional leaders** advocating for the legislation. The bipartisan coalition is led by Louisiana Attorney

General Jeff Landry, a Republican, and Wisconsin Attorney General Josh Kaul, a Democrat.

Edith's Bill – or the Edith Shorougan Senior Victims of Fraud Compensation Act – would also amend VOCA so that penalties and fines from deferred prosecution and non-prosecution agreements are deposited into the Crime Victims Fund. This bill is named after a Wisconsin woman who was scammed out of more than \$80,000 in retirement savings.

Across all states, there has been a surge in COVID-19 scams targeting vulnerable seniors. The U.S. Department of Health and Human Services Office of Inspector General **has warned** that fraudsters "are offering COVID-19 tests to Medicare beneficiaries in exchange for personal details, including Medicare information." This is just one of many COVID-19 scams targeting seniors.

Even after the pandemic, fraudsters will continue focusing their schemes on seniors. By using this legislation to add senior fraud as an eligible reimbursement expense under VOCA, states can help victims obtain the financial relief they deserve. States would be incentivized but not mandated by this legislation to provide compensation to victims of senior fraud.

# Scott Dixon climbs to top of Indy 500 speed chart

Scott Dixon just keeps on rolling. NTT INDYCAR SERIES points leader Dixon jumped to the top of the speed chart Thursday on the second day of practice for the 104th Indianapolis 500 presented by Gainbridge with a top lap of 39.8050 seconds, 226.102 mph in the No. 9 PNC Bank Chip Ganassi Racing Honda. His fast lap came with the benefit of an aerodynamic tow, as drivers continued to refine race setups in traffic.

Dixon, who opened the 2020 season with three straight victories, rose to the No. 1 spot on the 2.5-mile oval after recording the third-fastest speed Wednesday on Opening Day at 224.047. He looks to be a prime contender for both pole position during Armed Forces Qualifying Weekend this Saturday and Sunday and for his second Indy 500 victory on Race Day, Sunday, Aug. 23.

"Today, we made some minor changes and tried to figure out some different balances," Dixon said. "We're also focusing on how the car feels. The No. 8 car had some changes yesterday that (teammate

Marcus Ericsson) liked and we tried them, but I'm on the fence. We're just running through those variations and trying to run in as much traffic as possible and get the car as comfortable as possible for the race.

"We're really just working hard on race setup. We've had a lot of options to work through, and we also wanted to run some of the things the other two cars have tried. We also worked on finding traffic today to see how the car would respond."

Takuma Sato was second overall Thursday at 225.693 in the No. 30 Panasonic/PeopleReady Honda, with Marco Andretti third at 225.249 in the No. 98 U.S. Concrete/Curb Honda.

Conor Daly was the fastest Chevrolet-powered driver, fourth overall at 225.106 in the No. 47 United States Air Force entry. Rookie Alex Palou rounded out the top five and another strong day for Honda-powered teams at 224.971 in the No. 55 Dale Coyne Racing with Team Goh Honda.

Jack Harvey was the fastest driver without an aerodynamic tow, with a top

solo lap of 222.124 in the No. 60 AutoNation/SiriusXM Honda.

The first incident over two days of practice came at 4:40 p.m. – 50 minutes before the end of practice – when two-time Formula One World Champion Fernando Alonso was unhurt in an accident. Alonso made right-side contact with the SAFER Barrier exiting Turn 4 after clipping the concrete apron in Turn 4 with his left front wheel, with his No. 66 Ruoff Arrow McLaren SP Chevrolet then doing a half-spin to the left at pit entry and sliding into the inside pit wall, making secondary right-front contact. The car suffered moderate damage.

Alonso, who also crashed in practice last year, was eighth fastest today at 224.363 before his accident.

"It was the car, the grip of the car," Alonso said. "This place, the walls are coming very close. This is the way it is. Unfortunately, it happened again today. Hopefully it happens today instead of
