# Health Dept. orders new safety restrictions

Stricter guidelines go into effect today, restrictions based on state's weekly color metric

Due to the ongoing COVID-19 pandemic and the recent surge of new cases and related hospitalizations in Hamilton County, Dr. Charles Harris, Health Officer for the Hamilton County Health Department, has issued a public health order to complement Governor Eric Holcomb's Executive Order 20-48 issued on Nov. 13.

"The Governor's orders identify minimum levels for high exposure settings like social gatherings or events," Dr. Harris explained. "This order establishes stricter limits for our county based on the state's color-coding metrics for each county."

As of press time on Tuesday night, Hamilton County was **ORANGE** under the state's color-coded metrics. The Indiana State Department of Health updates the coronavirus dashboard at noon each Wednesday, after which a county's color code could change. The following local restrictions for Hamilton County take effect at midnight on Wednesday, Nov. 25:

Social gatherings

If Hamilton County is under **ORANGE** (moderate to high transmission level):

- The Hamilton County Health Department will not approve any safety plans for social gatherings of more than 250 people.

- Organizers of social gatherings and events at venues with multiple, clearly separate areas, such as banquet rooms, conference rooms, or multiple sports fields, must submit a safety plan for each separate area up to a maximum of 250 individuals per gathering or event.

If Hamilton County is under **RED** (very high transmission level):

- The Hamilton County Health Department will not approve any safety plans for social gatherings of more than 100 people.

- Organizers of social gatherings and events at venues with multiple, clearly separate areas, such as banquet rooms, conference rooms, or multiple sports fields, must submit a safety plan for each separate area up to a maximum of 100 individuals per

## Cicero town officials announce COVID public health measures

The Town of Cicero is re-activating health and safety measures to keep town employees and the community safe by restricting public access to all town-owned buildings, with exception to the Red Bridge Community Building.

"Public health and safety continue to be our top priorities, and with the increase in the spread of COVID-19 within the community, we determined it was best to once again restrict public access to many of our town

owned buildings and Departments," said Cicero Town Council President Dan Strong.

The Town of Cicero has put the following procedures in place. Town officials will continue to monitor community spread and will re-evaluate risk exposure to determine the date to end these procedures.

- The Town of Cicero is restricting public access to all town buildings, with

## County secures health incident trailer

Mobile unit will allow for COVID-19 testing in hot spots

The Hamilton County Health Department has purchased a health incident trailer to help in responding to the increase in COVID-19 cases. With specialized features like solar charging, UV disinfectant lights, and ADA accessibility, the trailer has the ability to help with testing, vaccinations, PPE distribution, and incident command.

"This trailer gives us the ability to be anywhere in the county we are needed," said Christian Walker, emergency preparedness

coordinator for the Hamilton County Health Department. "As a self-contained unit, we can provide COVID-19 testing in Mid-Town Carmel and vaccinations in downtown Sheridan within just a few hours' notice."

The trailer was designed by JHB Group, Inc., a firefighter owned and operated small business in the Chicago suburbs. JHB is in the process of making at least 30 more trailers for health

"We purchased the trailer to respond to the pandemic, but it will be a great resource for our community many years from now," Walker said. "We have already talked with the Noblesville Fire Department about using it as a

The Hamilton County Health Department will use the trailer as a fourth COVID-19 testing facility starting Monday, Nov. 30. It will be located in the Health Department's north parking lot at 18030A Foundation Drive, Noblesville. Hours will be 8 a.m. to 4 p.m.

## Westfield launches rapid COVID-19 field testing for acutely ill patients

Westfield launched Central Indiana's first COVID-19 field testing program on Tuesday in an effort to reduce community spread and strain on local hospitals.

The city will dispatch paramedics trained to conduct rapid antigen tests when "acutely ill" residents with COVID-19 symptoms request an ambulance. Test results will be available on-site within 15 minutes.

The Abbott test kits, provided by the County Health Department, use nasal swabs similar to the polymerase chain reaction (PCR) tests recommended by CDC.

Swab samples are combined with a reagent solution and inserted in the test card.

One or two lines will appear in the result window, indicating whether the test detected the presence of SARS-CoV-2 proteins. The "gold-standard" PCR test detects the virus's genetic material.

"I think some people

are fearful of going to the hospital because of the second surge, so this gives us an option to hopefully address some of those patients' concerns [and] get them some answers," said Patrick Hutchison, the Westfield Fire Department's EMS division chief.

Residents who test positive will either be given resources to manage symptoms while quarantining at home or transported to a hospital for further treatment.

The rapid field testing program is not for asymptomatic individuals or people reporting mild symptoms, Hutchison emphasized.

"We don't want people to call 911 and have us replace a walk-up test site or a drive-by test site," he said.

Approximately 80 percent of the city's EMS calls are COVID-related. Officials cautioned against flooding the dispatch line with test requests for non-acute cases.

The lights were turned on for the first time at 6 p.m. on Monday. Due to COVID-19 precautions,

the typical celebration was replaced with a smaller gathering of the mayor, members of the Noblesville Common Council, Noblesville Parks Director Brandon Bennett, Duke Energy's Mark LaBarr and Sandy Stewart of the Noblesville Preservation Alliance.

"Seminary Park is a cherished asset in Noblesville, and it is wonderful to shine a spotlight on it this time each year," Jensen said. "The event gives our community a chance to get outside and create memories together this holiday season. It's also an ideal nearby addition to the Holidays at the Hill activities we have at Federal Hill Commons."

This is the third year for Lights Over Seminary, which is free to attend and available 5 to 11 p.m. nightly through Jan. 3, 2021.

In addition, the use of electronic ticketing methods is strongly recommended to aid in managing capacity, identifying patron seating location, and contact tracing. The organizer or host of a community recreational sports league or tournament must also maintain a list of event attendees and their phone numbers for up to 21 days following the social gathering for contact tracing purposes.

### Restaurants and bars

If Hamilton County is under **RED** (very high transmission level):

- Restaurants, bars, taverns, nightclubs and other establishments providing in-person food and drink service must limit capacity to 50 percent of indoor capacity.
- Restaurants, bars, taverns, nightclubs and other establishments providing in-person food and drink service must be closed and cleared of customers between the hours of midnight and 5 a.m. to perform enhanced cleaning and disinfecting protocols.
- Restaurants, bars, taverns, nightclubs and other establishments providing in-person food and drink service will only be allowed to seat customers at tables. Bar seating will be closed.

In addition, table seating must be limited to six people per table and tables must be spaced at least six feet away from one another. Also, self-service food stations (buffets, salad bars, etc.) will be banned unless a staff member serves patrons. Finally, outdoor tent seating will only be permitted if the tent has at least two open-air sides for ventilation.

### All other businesses

If Hamilton County is under **RED** (very high transmission level):

- Gyms, exercise, and fitness centers (including yoga studios, dance studios, karate studios, martial arts studios, and other similar fitness centers) must limit capacity to 50 percent.
- Cultural, entertainment, and tourism sites (including museums, music venues, auction venues, flea market, and parks) must limit capacity to 50 percent.
- All other non-essential entertainment businesses (including movie theaters, bowling alleys, trampoline parks, boating and marina facilities, and rock wall climbing facilities) must limit capacity to 50 percent.
- Personal service businesses (including salons, barber shops, nail salons, spas, microblading and tattoo parlors) may remain by appointment. Face coverings may be removed for beard trimming or as required to complete the service.

### Schools

K-12 schools will be allowed to manage and implement their own plans for maintaining education services, so long as they utilize effective and appropriate measures to prevent the transmission of COVID-19.

### What you should do

Residents of Hamilton County are also strongly encouraged to quarantine for 14 days after traveling to or from another country, state, or county. All residents are asked to wear a mask outside of the home and to maintain at least six feet of social distance while out in public.

exception to the Red Bridge Community Building. Each department will remain open and will be able to address questions and concerns. However, buildings will be closed for public access.

- Payments to the Town of Cicero for utilities or transactions made through the Clerk-Treasurer's office should be made using the drop payment box located at the Town Municipal Building, located at 331 E. Jackson St. Questions can be sent to the Clerk-Treasurer's office at (317) 984-4900.
- All town parks and shelters will remain open to be used by the public at your discretion.

- The Community Building at Red Bridge Park will remain open to be used for meetings and events with approval by the Cicero Parks Department. To discuss meeting and event plans, please contact the Cicero Parks Department at (317) 984-3475.
- Building permit applications can be submitted online at [ciceroinc.org](http://ciceroinc.org), or you can email Cicero/Jackson Township Plan Commission Director C.J. Taylor at [ctaylor@townofcicero.in.gov](mailto:ctaylor@townofcicero.in.gov), or you may call the Plan Commission office directly.

- All town-provided utilities such as trash, recycling, water, and sewer, as well as maintenance of streets and sidewalks, will continue to be provided. However, the Cicero Street and Utilities Office at 1159 Stringtown Pike will be closed to the public. If you have questions, you may contact the Street and Utilities Department at (317) 984-4833.
- The Town of Cicero Police Department and the Town of Cicero Fire Department will continue to operate as usual and will continue to provide for the safety needs of our community. Public Access to these buildings will be restricted.







# Fishers police officers make 3 arrests in 2 burglary probes

The Fishers Police Department expressed thanks to local residents willing to report suspicious activity in their neighborhoods quickly, because that led to three arrests connected to two burglary investigations.

The first occurred at The Hamilton Apartments (Hamilton Pass and Hoosier Road). A resident notified police after observing a suspicious car driving thru the apartment complex.

While officers were searching the area, they observed a suspect inside a screened-in porch. The suspect refused commands from the officers and ran. Police chased the suspect and took him into custody. The suspect was later identified as Dwayne Chaney, 54, Indianapolis.

The second incident occurred in the 9700 block of April Rose Drive (96th Street and Cyntheanne Road). Like the prior incident, a resident immediately called 911 to report a

suspicious person at their front door. As officers arrived, they observed the two suspects fleeing the area in a Honda passenger car. Officers pursued the suspects for a short distance before the Honda became disabled. The suspects were later identified as Gregory Gardner, 30, and Emily Parrish, 23, both of North Vernon.

The three suspects were taken into custody and transported to the Hamilton County Jail. All three face several charges.

# Carmel hazardous waste site remains closed to the public

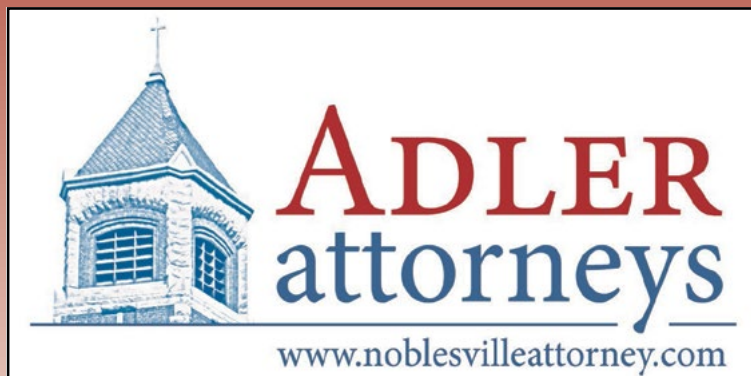

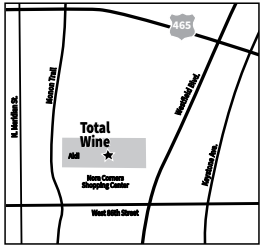

# Pokagon opening toboggan run on Friday

Get ready to ride, Hoosiers—Pokagon State Park's toboggan run opens Friday, Nov. 27. Tobogganers will notice some changes due to COVID-19 but can still enjoy this thrilling ride that drops 90 feet over the distance of a quarter-mile.

While hours and fees remain the same as in previous years, only one track will be open. This change allows guests and staff members to stay socially distant inside the tower. This means that fewer than one-half of the normal number of toboggans will be available to rent, which may mean longer wait times. Riders will also be required to wear masks and gloves and to socially distance themselves while in line.

The registration process has also been modified. Upon arriving at the park gate, nature center, or Potawatomi Inn front desk, riders will receive details for reserving a sled using a mobile alert system. When a sled is ready, guests will receive a text asking a member of their party to go to the rental room to fill out

a registration card. One rider from the group will then take that card and a driver's license to the checkout window to receive their sled. Users will return sleds outside the rental room at the end of the rental period. Sleds will be sanitized before use by a new group of riders.

Warming Center restrooms will be open; however, concessions, indoor and outdoor seating, and the bonfire area will be closed. Carry-in meals and tailgating are prohibited in the toboggan run area and in both the upper and lower toboggan parking lots.

Pokagon staff will provide monitoring to ensure that riders follow the park's guidance and have the opportunity for a great outdoor

experience.

"The toboggan run has been a tradition at Pokagon for generations and will continue to help our guests make memories naturally, this year and into the future," said interpretive naturalist Nicky Ball. "We look forward to seeing many happy riders this winter."

## Balanced Tigers storm past Ben Davis

**FISHERS** - The Fishers boys basketball team already has its identity set for the 2020-21 season, and it can be boiled down to three things: Depth, balance and unselfishness.

The Tigers put all of those on display in its season-opening game Tuesday at the Tiger Den, when they overwhelmed Ben Davis 75-49. It was an impressive opener for Fishers, which is ranked No. 20 in the IBCA's one-class pre-season poll.

The Tigers were playing their first game under new head coach Garrett Winegar, who was the head coach at Warren Central last season and had spent a few years there as an assistant. When discussing the game afterwards, Winegar brought up something then-head coach Criss Beyers said during the Warriors' undefeated state championship season in 2017-18.

"When I was at Warren with Coach Byers the year we won state, we had six players averaging between 8 and 12 points a game," said Winegar. "He always just preached to them, like, 'We don't care who gets the shot, we just want the best shot.' And I think this group, I think we see that they're playing unselfish, they're willing to pass up a good shot to get a great shot, and that's exciting."

That attitude was in effect for the Tigers on Tuesday. Fishers had four players reach double figures in scoring, chipping in between 11 and 17 points. Of the nine Tigers who took to the floor, eight of them scored at least one point.

"I think that's our strength," said Winegar. "We don't have one guy who's probably going to go get 30, but we have six guys who can probably go get 15. Our depth and our balance and our unselfishness has to be something that is our strength. We're probably never going to be the most athletic or most talented team on the floor when we play, so we have to be the most unselfish and we have to be well-rounded."

Fishers never trailed in the game, and the score was only tied twice, early in the game at 2-2, then 4-4. Junior Charlie Smith broke that second tie with a 3-pointer, then the Tigers finished the first quarter on a 6-0 run to lead 15-7. Junior Bryce Williams got the first five points (including a 3), then junior Matt Brewer made a free throw.

The run continued at the start of the second period, with sophomore Myles Stringer hitting a couple free throws to push Fishers ahead 17-7. The Giants cut that lead to 17-12 as KJ Windham, a talented freshman, made a 3-pointer and a layin.

But the Tigers darted ahead again with a 6-0 run; senior Lucas Prewitt, Smith and senior Drew Turner each made baskets. That made the score 23-12, and Fishers maintained that lead through halftime, where it led 31-23.

The Tigers took total control in the third quarter, outscoring Ben Davis 27-8. Fishers scored the first 15 points of the period, with Williams pouring in eight points (including another 3). Turner scored seven in the middle of the quarter (also including a 3), then junior Sean Millsaps hit two 3s on his way to

eight third-period points. Fishers had eight total 3-pointers in the game.

"I think the third quarter, we showed how good we possibly could be on defense," said Winegar.

The fourth period was a little more even, but Ben Davis was never able to make a dent into the Tigers' lead. Prewitt and Millsaps each made a 3-pointer in the quarter.

Williams finished with 17 points, followed by Turner with 16, Millsaps with 13 and Smith with 11. Fishers was playing without Jeffrey Simmons, still recovering from an injury.

"We got a long way to go to be where we want to be, offensively and defensively, but if they play with the kind of effort and energy and togetherness that they've been playing with, this group has a chance to surprise some people," said Winegar.

Fishers plays another home game next Tuesday, taking on Muncie Central.
