# Hamilton County among nation's healthiest counties

Hamilton County has been recognized as the 16th healthiest county in America by U.S. News & World Report in collaboration with the Aetna Foundation.

"Our ranking reflects the long-term investments made by the county and our cities and towns in parks, recreation, and open spaces as well as readily available quality health Altman care," County Commissioner Christine Altman said. "Hamilton County both attracts and retains active and engaged residents of all ages." Accompanied by news, analysis and in-depth reporting, Healthiest Communi-LeMaster ties features rankings drawn from an examination of nearly 3,000 counties on 84 health and health-related metrics in 10 categories. Population health and equity are the most highly weighted factors in the methodology, followed closely by education and economy. Data were gathered and analyzed by the University of Missouri Center for Applied Research and Engagement Systems (CARES). This year's rankings also include data relevant to the pandemic, such as county-level information on coronavirus cases,

# Ongoing renovations at Noblesville, Fishers libraries focus on improved access, better indoor, outdoor spaces

If you have visited or driven by the Fishers and Noblesville libraries lately, you probably have noticed renovation work.

Construction at both libraries will focus on preparing for the future by improving access and expanding possibilities in the use of indoor and outdoor spaces. When completed, Fishers and Noblesville residents will notice more pedestrian-friendly access and gathering spaces, additional parking, improved traffic flow, plus more experiential learning opportunities.

The Noblesville library renovation will focus on improved traffic flow and expanded parking, increasing access to green spaces, creating outdoor amenities for all ages, plus an updated front façade. The Indiana Room is being expanded with more experiential learning opportunities and, improving second-floor access.

The Fishers library renovation will focus on more pedestrian-friendly access and gathering spaces, improved traffic flow and expanded parking, integration of the south entrance with the Nickel Plate trail, redesigning the north entrance to become the new main entrance, and expanding the north side parking. Currently the North and East parking lots are under construction. Library and Ignite Studio visitors can park in the li-



# Westfield CrossRoads Church helps 26 families across county

What can 250 people do to impact Hamilton County communities in one week in a significant way? Home repairs for 26 families!

A total of 250 people from around the country, mostly high schoolers, gathered in Westfield last week and completed repairs on 26 homes in northern Hamilton County. In conjunction with Group Mission Trips of Ft. Collins, Colo., Cross-Roads Church at Westfield (ForOurNeighbor.Life) invited church high schoolers and their adult leaders from eight states from as far away as Nebraska, New Hampshire, and New Jersey to participate. In groups of five to seven people, each day they spent their days with a homeowner doing significant home repairs, including mobile home skirting, building wheelchair ramps, constructing decks, and doing exterior painting.

All of the repairs were free for the residents. The construction repair material costs are being paid for by CrossRoads Church, by the participants, and through a local Central Indiana Community Foundation grant. Senior adults, veterans, and families who are struggling with home needs were the primary recipients.

Ruth Griepentrog, whose 18-month-old daughter has physical challenges, said, "Our family had an amazing week. A team from Ashland, Ohio, spent five days working in our yard and giving us a

### Theodore Louis Alexander Rowland June 23, 1940 – June 28, 2021

Theodore Louis Alexander Rowland has left the place he loved for



a place he loves more. Born into a German immigrant family in Indianapolis on June 23, 1940, his destiny was to make a difference in the place he was to call

home, and he did just that throughout his life. His mother was Blanche Pauline Schmidgall Alexander, and his father was Theodore Louis Alexander. Around the age of 12, Ted moved to Noblesville with his mother and new father, James L. Rowland. The remainder of his life was in Noblesville, where he started his family, his business and found his happiness. Noblesville Senior High School (Class of '58) became the place that taught his lifelong work. In high school, he met a young girl that later would become his wife for 59 years, and both shared in the hard work and the best of times.

After graduation, Ted joined the Navy and served aboard the USS Alamo and the USS Ester AGC 12 as a Lithographer (Printer) while advancing his talent and skills. Lithography was an area that Ted excelled in. As shop manager in high school, specialty training in the Navy, he began a 50-plus year career in the printing industry. After finishing his tour of duty in the Navy, he married Mary Sue Staton Rowland, starting his own printing company in 1972 in downtown Noblesville in the historic Union Traction Terminal Station just one block off the Courthouse Square, known as Image Builders Rowland Printing. Ted worked in Chicago, Anderson and Indianapolis WFBM Time Life Radio and Television Station as the implant printing department manager. He met many people who became friends and customers for his new young business.

Ted was known for his generosity and support of community. Retiring in 2017, he continued to enjoy discussing printing with his sons Dane Vincent Rowland and Dean Vance Rowland, both continuing the tradition their father started. Ted's grandchildren were his greatest joy: Vincent Theodore Rowland and Vivian Michelle Rowland, children of Dane Rowland. They loved Grandpa too.

Ted was creative, generous, and a risk taker who had thousands of ideas, most of which became a reality, when others were not so sure. That included the idea of starting his business on a shoestring. The one thing others did not understand was that Ted had "luck' on his side. Ted truly lived life to the fullest. If you knew Ted, you would agree he was unique. He did "it" his way, always. He was hard to keep up with but left behind a million memories for all of us to enjoy and share for years to come. When asking Ted about his most favorite accomplishments, he would narrow a long list to three.

First and foremost, was the time he spent in high school working nights at Hudler Press in Noblesville, printing the weekly paper and getting it out on the street the following early morning before returning to class after an "all nightery." He was not the only printing student who worked at the paper and some lifelong friends were developed during those years. After serving in the Navy, Ted returned to Hudler Press to open a new offset printing department for the long-time business. Some 30 years later, Ted returned to Hudler Press again, upon its closing, to purchase the paper he printed as a student. Continuing production of the weekly "Noblesville Times" tradition without missing an issue was perhaps the most fun Ted had. He focused on the community and those people who made it great. He asked people with special talent to write articles for the paper and placed hundreds of pictures into each edition taken by him personally. After serving as the editor of the paper he once printed



The second accomplishment most important to Ted was the production of many historic bound books of Hamilton County towns and cities. He also published his own history book along with a team of well-known artists, writers, designers, and his own production company. The history book is called "Remembrances" and the year was 1976. Ted's Hamilton County History book sits today in the National Library of Congress, the State Library and local library.

Ted's mother had three brothers that were favorites. All three served in World War II in different branches of service at the same time. All three brothers serving during the war, catching the interest of many. Uncle Oscar became a talented chef like his father after the war, Uncle Julis also became a chef, and Uncle Henry, who was in the cavalry during the war, become a printer. Henry lived to 94 years and his wife Marie lived to almost 99 years. During the war, Henry received the Purple Heart along with Theatre Ribbons, including four Bronze Stars and an Accommodation for the Liberation of France.

The time, as always, flew by. But fortunately, Melissa is staying with Mike near South Bend for a few more weeks this summer and will be back for more Wednesdays in July.



# World-class goalkeeper tells her tale Carmel woman earns place in Canadian Soccer Hall of Fame

Canadian soccer is celebrating a big anniversary this year: It was 35 years ago when it fielded its first-ever women's international team.

featured a goalkeeper from Ontario named Carla Chin. She would be with the team for nine years, culminating in a trip to Canada's first-ever Women's World Cup in 1995.

Twenty-five years later, Carla Chin Baker and seven of her teammates have a permanent place in Canadian soccer history, as they have been inducted into the Canada Soccer Hall of Fame. The induction honors the eight players who were part of that original Women's National Team. Chin Baker, who lives in Carmel, got a chance to reconnect with her teammates when they were presented to played three more games the country in a Zoom meeting in April.

"It was fantastic, because some of them I hadn't seen since '95," said Chin Baker.

Chin Baker started playing soccer at age 12, playing in a coed league. When she got to high school, a friend asked her to try out for a club team.

"That's when I got exposure to travel soccer," said Chin Baker. She continued to play and by 1986, when she was at university, she its provincial championship. When that was successful,

"They were in a village probably about 10 miles away, but we couldn't really venture too far from our congregation." said Chin Baker.

# If this football season feels like déjà vu, it's because of a COVID-19 do-over

Here's a welcome thought after what had been a turbulent 2020 season in high school football: Not much is changing in terms of schedules in Hamilton County.

Five of the county's eight football-playing schools have no new teams on their 2021 schedule, nor do they have any moving around of opponents. From Week 1 to Week 9, everyone's lineup will be the same this season as it was (or was supposed to be) last season.

Of the three schools that have changes, each one only has one new opponent. Carmel has replaced its Week 2 game, with Detroit King replacing Cathedral.
