

Historically, elected officials in our county are chosen in the Republican primary. Democrats have little success in the November general election, and thus the winners of the GOP primary are almost certain to become our next elected leaders.

Election watchers can usually predict when a big or small election day turnout is likely. For example, this year only about 1,800 citizens have voted early. Hamilton County has more than 200,000 registered voters on the rolls. Candidates can also get a feel for voter interest as they travel the county, and most see something less than great enthusiasm this year.





Fishers road construction updates, week of May 2

All left-turn lanes are currently restricted on SR 37 and on 146th Street with traffic moved to the interior lanes. Thru traffic and right turns on SR 37 and

The 143rd roundabout at Range Line Road and 116th Street began construction on Monday, May 2.

The roundabout at 116th Street will be constructed one half at a time with east/west connectivity maintained for the duration of the approximately 110 days of work.

Portion of 266th Street closed

casual joke that I was helping a local candidate so that I could be appointed administrator of Riverview Hospital. Pushback came within days from those who took it as a serious statement.


