Hear Abigail Ko play with Carmel Symphony Orchestra next weekend

On Saturday, May 14, Carmel High School Senior Violinist Abigail Ko will perform with the Carmel Symphony Orchestra (CSO). As of Thursday, May 5, Ko has accepted an offer to attend The Julliard School this fall.

When The Reporter spoke to Ko last Friday afternoon, one day after she decided to attend Julliard, she said the idea did not yet feel real to her.

"It's actually kind of surreal," Ko said. "If you'd asked me maybe three years ago if I'd be going to music school or not, I probably would have laughed at you. I feel like it's pretty

representative of how far I've come not only as a musician but as a person just opening up and realizing my own potential. Really, it's just so surreal."

Ko began playing violin at six years old and said most violinists she knows started even earlier.

"I have a friend whose mother is a violin/beginner piano teacher," Ko said. "I would go to this friend's house a lot and I would see her mom giving violin lessons pretty often. That's when I realized I wanted to start."

Ko said she was not pushed into violin by her parents, but it was a thing she chose herself and something even though it was her own decision.

Five grassroots historic preservation organizations have been selected to participate in Indiana Landmarks' inaugural Affiliate Advancement Program, a year-long training initiative aimed at strengthening volunteer-driven local groups.

Through workshops conducted by leading professionals, participating organizations will learn strategies to help improve fundraising and planning efforts, develop new opportunities for community engagement, and communicate historic preservation's role in creating vibrant, resilient communities.

Organizations selected to participate in 2022 include Cornerstone Society of Madison; Historic Fall Creek, Pendleton Settlement; Noblesville Preservation Alliance; Save Our Stories in Marion; and Vincennes Knox Preservation Foundation.

Imagine standing on a stage, lights beaming down, seats filled with people, castmates by your side – and the next day it all disappears because of a global pandemic.
