



# HSE senior recognized at 29<sup>th</sup> Youth Service Awards ceremony

## — Laksmhi Pendela awarded \$1,000 scholarship —

Hamilton Southeastern High School senior Laksmhi Pendela was presented with the 29th annual Hamilton County Youth Service Award on May 9. The ceremony is sponsored by the Hamilton County Commissioners and the Hamilton County Council on Alcohol and Other Drugs (HCCOAO). Pendela was given a \$1,000 scholarship.

Pendela is a youth blogger for the National Suicide Prevention's You Matter Council, a student board member for the Hamilton Southeastern Education Foundation, secretary for the Key Club, and co-captain of her school's Speech and Debate Team. She also volunteers for

Buddy Help, her local COVID-19 vaccine clinic, and ENGIN, where she teaches English to Ukrainian children.

"Drug and alcohol problems are common in Ukraine," Pendela said. "So, in addition to teaching English, I talk to the kids about the value of good mental health and the harmful effects of using drugs and alcohol. My ultimate goal is to one day become a pediatric psychiatrist and start a telehealth platform to accurately assess an individual's overall health."

Six other students were nominated for the Youth Service Award by their school's

# Carmel begins new sister-city partnership with Jelgava, Latvia

Mayor Jim Brainard of Carmel, along with the Honorary Consul for the Republic of Latvia to the State of Indiana, Andris Berzins, have announced that Carmel will soon formalize a sister-city partnership with Jelgava, Latvia. This will be Carmel's first sister-city in Europe and Jelgava's first sister-city in the United States.

The agreement between Mayor Brainard and Mayor Andris Ravins of Jelgava was facilitated by the Latvian Ambassador to the United States, Maris Selga, during his visit to Carmel in October 2021. The mayors will explore opportunities to establish closer ties between the cities in such areas as education, culture, business, and public services. There will also be official visits between city delegations as well as special ceremonies in both Carmel and Jelgava to commemorate the signing of the formal agreements.

At the request of Mayor Brainard, Andris Berzins will serve as the Chairperson for the Carmel-Jelgava Sister-City committee, and he will work in collaboration with his counterpart, Anna Zerina, Jelgava's External and Foreign Relations officer, as the process moves forward.

This partnership also comes at a very important and pivotal time in history where the support for freedom and democracy in the world is under siege. International relationship building, such as the sister-city program, is a key to mutual understanding and peace throughout the world and for generations to come.

# Two roundabouts coming to SR 32 in Noblesville

Many readers have been asking about the construction project in Noblesville along State Road 32 from River Road to State Road 38.

The ongoing work is part of a larger project to replace the signals at both intersections with roundabouts. Work over the past several weeks has involved moving utilities in preparation for the construction of the first roundabout at SR32/SR38, which the city expects will begin this year. Construction of the roundabout at SR32/River Road is anticipated to begin in 2023.

In addition, a median will be placed between the two roundabouts, which will only allow for right-in/right-out movement at the entrances between the intersections.

At an estimated cost of \$6.5 million, the project is being financed by a matching partnership between the city and the Indiana Department of Transportation.

# Winners give milk at Gleaners Food Bank

You may have heard of the gallon challenge, but Gleaners Food Bank of Indiana is taking the million-gallon challenge.

Gleaners, the largest food bank in the state, just launched its third annual No One Runs on Empty campaign during the months of May and June to raise awareness of food insecurity. This year, the campaign centers on the idea of "Winners Give Milk" – looking to have people donate money towards buying gallons of milk to reach Gleaners' goal of 1 million milk gallons in 2022. The

goal for May is to fund 16,500 gallons of milk, equal to 500 gallons per driver in the Indy 500.

The Reporter spoke with Gleaners CEO John Elliott about the milk drive and the need behind it.

"Food insecure household are typically getting the food they need from multiple sources," Elliot told The Reporter. "First, earned income – they just don't earn enough to feed the family for the whole month. Then many times they are on a program like SNAP or WIC or kids are in the school meal program. But that still may not be enough for a family."

Two weeks ago, I was taking clothes out of the dryer and hanging them up or folding them. I began to hum a song that had been going through my head. Suddenly, I stopped.

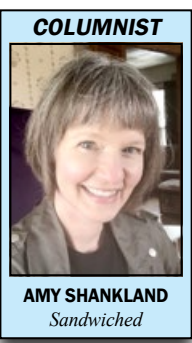
I realized that I was in ... a good mood.

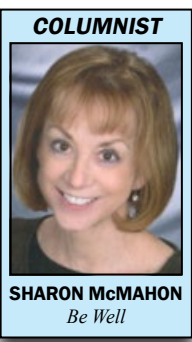
Give trees a chance

"They took all the trees, put 'em in a tree museum / And they charged the people a dollar and a half just to see 'em / Don't it always seem to go that you don't know what you've got till it's gone / They paved paradise, put up a parking lot" – Joni Mitchell, Ladies of the Canyon album, 1970

Okay, Readers – you may wonder about this selected quote as my submissions for my "Be Well" series are focused on fitness and nutrition. Well ...you may also recall that my last column, "Give bees a chance", addressed the importance of bees and other pollinators in our health, and frankly, in our very existence.

The same can be said for trees, which are essential for our well-being. There is a reason trees are often called "the lungs of the world." A tree has the ability to provide an essential of life for all living things on our planet: Oxygen, and the power to remove harmful gases like carbon dioxide, making the air we breathe healthier. You may be thinking ... yes, yes, I sat through biology class and understand the concept of photosynthesis, etc., etc. Me too! (*Mr. Wesley Abel, Noblesville High School, 1964/65*)

According to the U.S. Department of Agriculture and the U.S. Forest Service, in one year a mature tree will absorb more than 48 pounds of carbon dioxide from the atmosphere and release oxygen in exchange. It is proposed that one large tree can provide a day's supply of oxygen for up to four people. What is the cost of this essential, life-giving gift? The

cost is recognition of the importance of trees and our mission to make certain that these God-given resources provided for our well-being are preserved.

A human breathes about 9.5 tons of air in a

year, but oxygen only makes up about 23 percent of that air, by mass, and we only extract a little over a third of the oxygen from each breath. That works out to a total of about 740 kilograms of oxygen per year. This is about seven or eight trees' worth.<sup>1</sup>

We tend to hear/read/repeat the word "wellness" often these days, and good for us that we recognize the importance of care of our bodies and our psyches. However, wellness is much more than an exercise program, nutrition-focused eating, and mindful pursuits – all of which are vitally important. The pollinators, the trees and other plants, our waterways, and our atmosphere are equally important.

I was 20 years old when Joni Mitchell recorded "Big Yellow Taxi" from which the above lyrics were taken. At that time the concept of a "tree museum" seemed rather science fiction-oriented. Let us hope we never see that option come to fruition. So please, give trees a chance! The next time you take a deep breath of air, give credit to a tree!

Modifying the public-school system

I have been diagnosed with ADHD and sometimes school and some teaching styles can become overwhelming and difficult for me to manage. I think it would help me, and others, if the material was more in-depth or more personalized.

Another way schools

could improve is by changing the learning environment. The classroom I feel the safest and most comfortable in is my accelerated English teacher, Mrs. Williams' room. There are four lamps that shine a muted yellow light that replaces the bright LED overhead lights. There are colorful posters and pictures and the whole back wall is covered in calm-looking tapestries. Mrs. Williams also has various flexible seating options. Her classroom is a prime example of how future classrooms should look.

Alternative seating is a great way to change the environment of classrooms and make students feel more engaged. According to a 2018 study by the University of Mississippi, alternative seating is recommended in place of a seated desk, because a seated desk prohibits natural body movements that are linked to increased learning abilities. There are many types of alternative seating such as beanbags, yoga balls, couches, standing desks, and low tables for floor seating. Alternative seating gives students a chance to move around and fidget while being engaged in class.

The last recommendation I have for schools is to expand the patience and teaching style of teachers. I am not saying teachers need to change their whole curriculum, but rather become more patient, more loving, and more kind. A prime example of this type of teacher at Sheridan High School is my chemistry teacher, Mr. Olsan, who makes chemistry a lot easier to understand and learn. He is very patient and is willing to re-explain anything we do. He is also a very funny guy who shows that he cares when he engages in conversations – with me personally, and with the whole class. Most days when the bell rings to start my fifth-period class, we talk about some sort of food, sport, or something completely random like arsonists.

I think that this type of fun, casual conversation at the start of class helps us engage in the lesson more. I know school would be more enjoyable for many students if the system was improved.

I hope schools across the U.S. can take this article into consideration and better change the lives of public high school students.

# Baby boxes are saving lives

Indiana has a strong history of defending the lives of our most vulnerable, and it’s critical we continue this important work.

Part of defending the lives of newborn Hoosiers is encouraging communities to have resources for expectant and new mothers who may find themselves facing difficult decisions. Through our Safe Haven Law and the use of Safe Haven Baby Boxes, we’re saving newborns and giving them an opportunity at life.

Indiana’s Safe Haven Law enables a parent in crisis to safely and anonymously surrender an infant fewer than 30 days old to any hospital emergency room, fire station, police station or Safe Haven Baby Box within the state without fear of prosecution. Baby boxes, which are installed in exterior walls of designated fire and police stations and hospitals are temperature-controlled incubators with a silent alarm system that is triggered when a child is placed inside. First responders are immediately alerted and are able to rescue the baby and provide critical care.

In April, a baby girl and boy were safely surrendered at a Safe Haven Baby Box in Carmel. In both local instances, firefighters responded to the infants within minutes, ensuring the health and safety of these precious babies who will be placed with loving families. Since the first baby box was installed in Indiana, 18 Hoosier infants have been saved and 81 of these life-saving devices have been placed across

the state, which is four times as many as all other states combined.

In 2021, I supported a bill helping communities install baby boxes at a volunteer fire station or a facility staffed 24/7 by professional emergency medical service providers. Hamilton County currently has two Safe Haven Baby Boxes – one in Carmel and one in Westfield – and I hope more communities consider installing their own baby box.

The National Safe Haven Baby Boxes Crisis Hotline, which can be reached at 1-866-99BABY1, is an additional resource connecting mothers in crisis to counselors who can help them make the right choice for themselves and their infant. Through this service, more than 100 surrenders have been made across the country.

These devices are proven to work and save lives, and I remain committed to spreading the word about Indiana’s Safe Haven Law and baby boxes. For more information about baby boxes or to donate toward installing one, visit [shbb.org](http://shbb.org).

# Memories of my grandfather

Do you have memories of your grandfather?

Mother was the youngest of a family of nine, and I was grandfather’s next to last grandchild. He was 84 when my youngest sister was born.

He often told stories that happened along life’s way. One such story took place on a wintery December day in 1899. He went with his fiancée’s father from his home near Wingate to Crawfordsville to obtain his marriage license. A short distance from his father-in-law’s farm, a band of gypsies were camped near the road. As grandpa and his soon-to-be father-in-law approached, a slender lad began asking them for money. For a small sum he offered to dance by

the roadside.

When there was no immediate response, he became insistent and declared, “I must make a living for my wife!” This plea elicited a coin. After a brief nimble performance, the dancing “bread-winner” returned to camp. It was a traveled custom for gypsy parents to arrange marriages for their children, giving the child’s consent when he or she reached the age of 12. The lad claimed to be almost 13.

When they proceeded on their way, my grandfather’s prospective father-in-law said, “That young man must keep on dancing the rest of his days.” The remarks seemed humorous at the time to Grandpa, but he later surmised it may have been

intended to convey a double meaning, which included Grandpa as well.

On another occasion, Grandpa went to the Otter Creek Church, west of Brazil, but an epidemic of measles prevented services from being held. He stayed over the weekend with a family living near Fontanet where he accompanied them to Sunday evening church. Reverend Deeter was the pastor, and he cordially invited Grandpa to take part in the meeting.

Consequently, his position on the rostrum enabled him to see the young couple that came in late and occupied a rear seat near the door. Their rude behavior attracted the attention of the congregation. The minister continued speaking, apparently oblivious of this disorder, when, suddenly, digressing from his subject, he asked permission to tell a story. He began, “Once upon a time when Dr. Wilde was

addressing a large audience, a young man in the assembly created a disturbance. He rebuked the offender, but without effect. A little later, a member of the congregation informed the speaker that the young man was an idiot. Ever after, Dr. Wilde was careful not to rebuke an idiot.”

The shame-faced couple was very quiet during the remaining service and hastened out of the door immediately following the benediction.

I was so very blessed to learn from the stories of my grandfather. Few things in life are more valuable than the advice from a long life well lived. Thus, it is not wise to argue with a fool or to rebuke an idiot, but do keep dancing.

# MILK DRIVE

That’s where the charitable sector enters. We close that last gap. When you shrink the other two pieces – if household incomes drop or the federal programs drop – that grows the gap that the charitable sector like Gleaners needs to fill. We are expecting another spike in need as the school year ends and the federal programs reduce.”

Milk is an expensive product. It is a loss-leader for most retailers. Gleaners negotiated a discounted price to wholesale, but the organization is not in the same position as retailers who can absorb the difference. That makes this drive a multi-million-dollar cost to Gleaners.

“There is a long,

multi-decade history of the amount of milk in food-insecure households hovering around 5 percent of the USDA recommended amount. In other words, two gallons a year instead of 52 gallons a year is what most food-insecure households have seen,” Elliot said. “We have been stuck at that level for decade after decade. So, this is also about changing that and raising the quantity of milk to affect not just hunger, but chronic health conditions that are affected so much by the mix of foods that people eat or, in many cases, the food they don’t eat. There is a lot to be said not only about the quantity of food available to neighbors in need, but the right nutritious mix and variety.”

The need for volunteers will likely increase in the weeks and months to come because of the spike in people at the food lines that started in December is now up 40 to 50 percent since then due to inflation.

“The next wave – the next significant increase is coming as school feeding programs stop for the summer and those kids need to be fed in some other way, but also the drop off in federal feeding programs,” Elliot said. “I assume you know that with SNAP and other programs, the allotments per household had been increased in response to the pandemic. Indiana made a decision legislatively with a date to end that in April. Where many states waited

for the end of the presidentially declared emergency as their date to stop this program, Indiana preemptively stopped earlier. They allow for a wind-down month, which is May. That means in June SNAP benefits will drop off substantially, and so will some other federal feeding programs.”

Key land acquisition by Hamilton County Parks means more recreation, restoration, preservation

In an effort to address the statistically alarming lack of dedicated public park space in Hamilton County, steps were taken recently by the County Parks and Recreation Department (HCPD) to acquire an ecologically significant parcel of property.

With unanimous approval provided by the department's park board, and supported by the Hamilton County Council and Commissioners, 107 acres of land in Hamilton County, located near the intersection of 216th Street and Hinkle Road, were purchased with the intent of adding the acreage to the county's park system.

The acquired property, referred to as HC Farms, brings the total amount of land owned and maintained by the county park department to slightly more than 1,800 acres – which remains less than 23 percent of the space needed for parks in the county, as recommended by the Indiana Department of Natural Resources.

According to HCPD Superintendent of Natural Resources and Education Amanda Smith, the HC Farms property represents the most significant opportunity that the park department has encountered in 20 years.

"Aside from the large list of plant and animal species currently found in the area," Smith said, "this property's environmental characteristics would be most enjoyed by passive recreation users who would appreciate the plant and animal diversity, scenic views, and relatively rugged terrain."

As surrounding proper-

ties in both Noblesville and Westfield are being developed for commercial and residential use at such a rapid pace, county officials and park leadership felt it was imperative to secure the property, knowing it holds the potential to provide Hamilton County citizens and visitors with a park experience unlike any other available within the county park department. HCPD is currently seeking funds available through DNR programs – the In Lieu Fee and the Land and Water Conservation Fund – to acquire land previously impacted by development and agricultural activity, which has the potential to be restored and preserved as critical wildlife and aquatic habitat.

"Hamilton County Parks, with invaluable support provided by Indiana DNR, feels blessed to be able to procure this ecological asset on behalf of our county and community," said Parks Director Chris Stice on the importance of the land acquisition. "The department's intent is to restore the land's wetlands and stream corridor and expand the existing prairie. Appropriate reforestation measures will also be taken. We are looking to strategically develop and maintain trails on the property, as well."

No specific timeline has been established for the park department's planned efforts at the HC Farms property.

# Super-close relay finish gives Royals girls county meet championship

**WESTFIELD** - There seems to be something about the 4x400 relay and the Hamilton Southeastern girls track and field team that brings the excitement, and the winning of close finishes.

Four years ago the Royals claimed a state title in the 4x400, winning the race in .04 seconds - an "exclamation point," said coach Julie Alano, on winning a team state championship.

Now, let's head back to the present day, or last Tuesday, when Southeastern was competing in the 2022 Hamilton County girls track and field meet at Westfield's Riverview Health Stadium. The Royals were battling Noblesville for third place in the 4x400, and managed to nose out the Millers by .02 seconds.

With that finish, Southeastern clinched the county championship, getting the points it needed to win the trophy. The Royals finished with 137 points, followed by runner-up Carmel's 136 and Noblesville's third-place 135. The difference between first and third was those .02 seconds.

"Yeah, every point mattered," said Alano. The coach said her team was "just really focused on trying some things to make sure we had our sectional lineup determined," as that lineup is due today. So, the county meet was more about tweaking things for the upcoming sectional, which Southeastern hosts Tuesday (May 17). The sectional will consist of all the county teams, plus Lebanon and Western Boone.

"It was just really good for us to pull it out when I didn't even really expect us to," said Alano. "But I think it's good for us to see where other teams fall and how next week will play out. We

really value this competition for next week. If we can win, that's great, but we're not always that concerned about winning."

The Royals did their share of winning in the individual events, taking four of them. Ally Elsbury had two victories, claiming the 100 hurdles in 14.72 seconds and the long jump in 18 feet, 4.25 inches, both of which are new county meet records.

Elia Blackmore was first in the 300 hurdles, clocking in at 45.68 seconds; Alano said that time was .01 seconds off the record Carmel's Mary Steffel set in the year 2000. Rosiebella Fiabema was the shot put winner, with a best throw of 42 feet, 0.5 inches.

That put Fiabema back above the 42-foot mark, as she threw 42 feet, 11.5 inches at the Royal Relays early in the season, "so it was really relieving to do it again," she said. Fiabema also placed third in the discus and was happy with her results.

"I worked really hard this week and I'm super excited for next week's sectionals," said Fiabema.

Carmel jumped into contention for the team championship with consistent results all the way around, including four event wins. The Greyhounds started the meet with a win in the 4x800 relay, and finished the meet by running away with the 4x400 relay. Carmel then picked up a pair of 1-2 finishes on the track in between. In the 400 dash, Olivia Cebalo won that race with Campbell Wansley second, then later in the 3200 run, Alivia Romaniuk cruised to a victory with Olivia Mundt the runner-up.

Noblesville joined the battle by also taking four individual events. The Millers got a 1-2

high jump finish from champion Malina Miller and runner-up Rylee Hassan, while Laina Lillge triumphed in the pole vault. Hannah Alexander won the discus and took second in the shot put. Paige Hazelrigg was the 1600 run winner.

Fishers finished fourth as a team with 86.5 points. The Tigers won two events: Ella Scally was first in the 200 dash, and was also part of the Tigers' winning 4x100 relay. Scally won the high point scoring award at the conclusion of the meet. Scally also placed second in the long jump and third in the 100 dash.

"This is actually my first meet doing all my normal

events," said Scally, who had foot surgery in December. Scally said the meet got her prepared for next week's sectional.

Westfield scored 52.5 points to finish fifth as a team. The Shamrocks had an event champion in Princess Campbell, who won the 100 dash in 12.48 seconds.

"I think I ran great," said Campbell. "Facing great competition." Campbell also said that the race makes her "a lot more confident" in her 100 abilities.

Guerin Catholic's Bridget Gallagher delivered a win for the Golden Eagles in the 800 run; the team finished with 26 points. Kelsey Smith placed

third in the high jump to lead Hamilton Heights, while Abby Hannon took fourth for University in the shot put.

# HSE boys also win close county meet

**FISHERS** - Two days after the Hamilton Southeastern girls track and field team won an ultra-close county meet, the boys team was hoping to get a Royals county sweep.

Southeastern hosted the Hamilton County boys track and field meet last Thursday and did achieve the goal of winning the championship. Just like the girls, the Royals boys won the meet in dramatic fashion.

It came down to the 4x400 relay, where HSE finished in third place by 0.37 seconds. That gave the Royals enough points to claim the trophy, totaling 152 points to the Greyhounds' 150. Fishers placed third with 117.5 points.

Southeastern and Carmel were close to each other for the entire meet. It looked as if the Royals were starting to pull away after they got a 1-3 finish in the 800 run; Nolan Satterfield won the event in 1 minute, 55.37 seconds, with Bennett DuBois placing third.

But the Greyhounds answered right back. James Philpott and Camren Avant went 1-2 in the 200 run, scoring 18 points and getting Carmel back within single digits. A 2-3 finish in the shot put helped the 'Hounds stay close.

Carmel placed second in the 4x400, but the Royals clinched the trophy by placing third; Southeastern coach Garrett Lawton said he knew his team would "need to keep it pretty level with Carmel heading into that 4x4" to have a chance to win.

Lawton said his team had "a lot of strong performances" at the meet. "A couple of people I think weren't necessarily quite where they wanted to be. But overall, I feel pretty good about where everyone's at heading into the sectional."

Satterfield's 800 victory was one of three for the Royals at the meet. Manraj Grewal won the high jump with a winning leap of 6 feet, 4 inches, while Michael Griffith had an outstanding long jump today, with a best jump of 22 feet, 11.25 inches.

The Greyhounds had five individual wins at the meet. Philpott's 200 victory (in 21.93 seconds) was his second of the evening, as he had already claimed the 100 dash in 10.86 seconds. Philpott scored 20 points at the meet and was a co-winner of the high point award.

Joseph Franklin picked up a discus win (161 feet, 1 inch). Carmel then had two relay victories, in the 4x800 (7:46.88) and the 4x100 (42.30 seconds).

Fishers also got five individ-

ual victories. Tyler Tarter was his usual dominant self in the hurdles, easily taking the 110 hurdles (14.93 seconds) and 300 hurdles (39.10 seconds), thus scoring 20 team points. As a result, Tarter was the other co-winner of the high point award.

Keefer Soehngen also turned some heads with his performance in the 400 dash. Soehngen ran the

race in 48.44 seconds, establishing a new county meet record. He was also part of the Tigers' 4x400 relay win (3:18.82).

Soehngen said he thought he ran "pretty well" at the meet. "And today it was really nice having good competition," he said. Shout out to the HSE 400 runner. He's got a great future." (The Royals' Jaylon Cooper

placed second in 50.23 seconds.)

And Soehngen is also looking forward to the post-season, starting with the sectional, which takes place Thursday (May 19) at Carmel.

"I think it's going to be exciting, going into these races with some good competition," said Soehngen. "I think I can definitely push past 48."

Josh Forbes provided excitement in the pole vault, which he won with a best vault of 15 feet, 6 inches. Forbes started at 13 feet, then didn't miss all the way through 15-6.

Noblesville took fourth place as a team with 63 points. Joel Mumaw got a victory for the Millers, making a big kick at the end to win the 1600 run in 4:15.12.

Westfield placed fifth with 55 points. The Shamrocks had two runner-up finishes: Kai Connor in the 1600 (4:17.69) and Colin Lakomek in the 800 run (1:55.90).

Hamilton Heights scored 31.5 points. The Huskies got a record-breaking performance from its star thrower, Colin Wilson. The junior won the shot put by over 10 feet, with his best throw of 62 feet, 5.5 inches setting a new county meet record.

"I think I threw pretty good," said Wilson. "My first three were my best throws, the qualifying rounds, but the last three I got

a little tired. I think I can come back at a later meet."

Wilson said that today's record was an outdoor personal best, but he's thrown further during indoor meets.

"I think I'm going to be able to toss some even further throws at the sectional meet," said Wilson. "And I got the motivation from this."

Peyton McQuinn had a good pole vault, placing second with a best vault of 14 feet, 4 inches.

Guerin Catholic scored 26 team points and had an event winner. Ethan Hines ran a strong 3200 race, resulting in a first-place finish (9:40.87). Jack Weber placed third in the 1600 run.

University scored five points. Steven Scott placed seventh in the long jump and 400 dash, and eighth in the 200 dash.

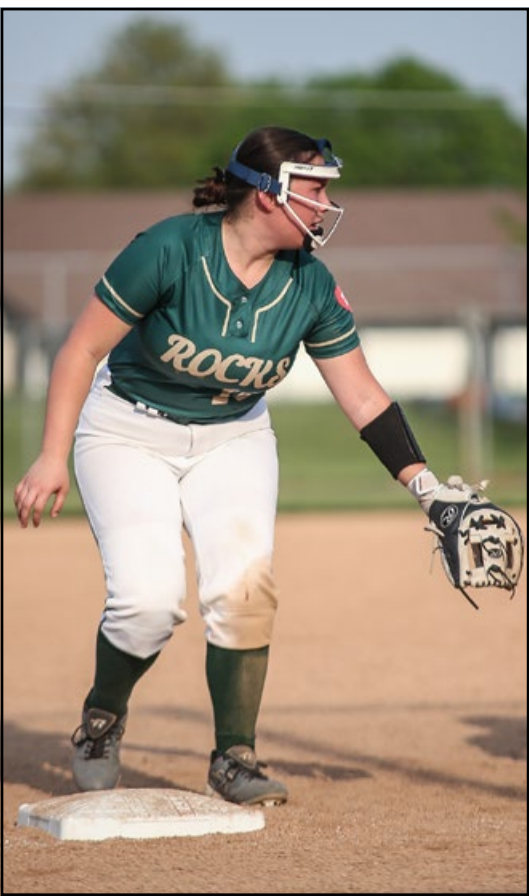
Neiling hit 3-for-3. Alayna Baber pitched a complete game, striking out six.
