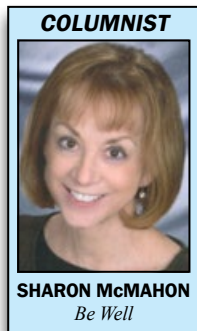

## Good posture critical at all stages of life

"Stand up straight."  
— My mom, mid-1950s to 60s

Yes, this is something I heard "a time or two" as they say, and many of you probably have as well. I was not particularly tall but did have my full height by 12 years of age — 5' 5 1/2" — and I felt rather tall and awkward compared to some of my petite friends! (Unfortunately, I am now 5' 5" as that half inch is gone!) Later in my teen years I felt more "average" and due to a mild case of scoliosis found that holding my body upright was actually more comfortable.

As a fitness instructor I often share important information about the importance of good posture. It is something we all know, but most people do not know the reasons that good posture is critical for our health and wellbeing. Currently, according to Amir Mahajer, D.O. and a dual-certified physiatrist and the head of interventional spine care at Mount Sinai West's new Spine Center in New York, many children and millennials are developing kyphosis, or curvature of the thoracic spine. Sitting for prolonged periods of time, according to Dr. Mahajer, in a "shrimp position" while stooped over cell phones and computers puts undue pressure on the spine and can lead to disc herniation and early onset osteoarthritis.

## Legislature overrides gubernatorial veto

Trans student athlete bill will become law without governor's signature

### The REPORTER

From the beginning, a four-page bill to ban transgender girls from participating in K-12 girls sports teams in Indiana schools proved controversial, even prompting the threat of a lawsuit from the American Civil Liberties Union.

After initially signaling his support of the bill earlier this year, Governor Eric Holcomb ultimately vetoed the bill, saying the legislation presumed a lack of fairness already existed in school sports and that the supposed problem wasn't being dealt with accordingly.

"After thorough review, I find no evidence to support either claim even if I support the overall goal," Holcomb wrote in his veto message.

House Speaker Todd Huston (R-Fishers) quickly responded that Republicans would work to override the governor's veto when it reconvened at a special one-day session on Tuesday, May 24.

On Tuesday, the GOP did just that.

The override votes were nearly along party lines, with a 32-15 vote in the Senate and a 67-28 vote in the House. Four GOP senators joined all Democratic senators in voting to uphold the veto. In the House, three Republicans voted to sustain the veto, while one Democrat supported overriding it.

## State Reps. Chris Jeter & Tony Cook: Overriding veto will protect girls sports

### The REPORTER

State Reps. Tony Cook (R-Cicero) and Chris Jeter (R-Fishers) on Tuesday joined the majority of Indiana's lawmakers in successfully overriding the governor's veto of legislation protecting the integrity of girls' sports.

House and Senate legislators voted on Tuesday at the Statehouse to override the governor's veto of House Enrolled Act 1041, which prohibits biological males from competing in K-12 girls' sports in Indiana.

Jeter, who co-authored the bill, said the vote came as part

of technical corrections day, where lawmakers can take up any vetoes and fix technical errors in laws passed during the prior session.

"My young daughters, and all Hoosier girls, deserve a fair and level playing field in sports," Jeter said.

"I strongly believe this is a much-needed step to protect female athletes and their opportunities to compete, earn spots on teams and obtain scholarships."

Indiana will join at least 16 other states that have similar laws on the books supporters say will protect female sports. Jeter said concerned parents reached out after an increasing number of biological males have dominated the national spotlight in girls athletic events across the nation.

Following the legislature's Tuesday override of Governor Holcomb's veto of House Enrolled Act 1041, Alliance Defending Freedom Senior Counsel Christina Kiefer released the following statement:

"Women and girls deserve to compete on a level playing field. We are grateful to the Indiana Legislature for responding to the nationwide threat to fairness in women's sports by overriding Gov. Holcomb's

misguided veto of HB 1041. While more work must be done to protect Indiana's female athletes in college, overriding this veto is an important step towards ensuring fairness in women's sports. Indiana now joins a growing coalition of states that have acted to preserve fair competition for female athletes, ensuring Indiana's girls will not face the losses that come with allowing males to compete in women's sports. We commend the Indiana legislators who took

a stand for female athletes by overriding this veto, and we are hopeful they will act quickly to extend these protections to collegiate athletes, especially since the NCAA has failed in its duty to preserve fair and equal opportunity for women."

Helping to make dedication day even more special:

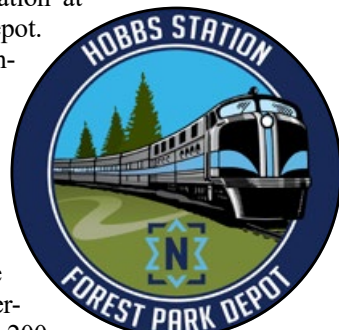
• Custard Dog food truck will be onsite selling a variety of lunch items and sweet treats.

VETO

There are certain biological differences that give males an unfair advantage over females in sports, like greater muscle mass, bone density and cardio capacity. Cook said the vote Tuesday was especially important as June marks the 50th anniversary of Title IX, which ensures women have an equal

opportunity to play and compete in sports.

"Nearly 50 years ago, we federally passed Title IX to give women the right to equal opportunity in sports. Now, we're seeing those rights are being threatened across the country," Cook said. "This override indicates that Indiana stands with our female

athletes, and this new law will protect their athletic opportunities now and in the future."

In Indiana, a gubernatorial veto can be overridden with a constitutional majority vote in both chambers, and the bill becomes a law without the governor's signature.

The law will take effect on July 1, 2022.

GOOD POSTURE

We have all seen the “little old ladies” with curved spines whose shoulders, neck and head are projected forward. Many of these folks also have osteoporosis, a condition of mine as well. While we all like to sit in a comfortable chair, in my humble opinion human beings were not created to sit on their bottoms on a soft seat, which beckons slouching. Not only do your vertebrae and muscles fail to do their intended work, but think of your internal organs calling out to you – “help, we’re all crowded in here together; give us some space to do our work!” Yes, slouching can affect the efficiency of our internal organs to do their important jobs such as digestion.

Remember that your C vertebrae in your neck become weaker as we age; it happens. However, the vertebrae in your neck and upper spine must still hold up your head, which is about the size/weight of a bowling ball. When the

neck becomes weaker, we compensate by bringing the shoulders forward and the chin down, exacerbating the problem. Combining the aging factor with poor posture habits complicates the issues which can result.

The key to good posture is the position of your spine. Your spine has three natural curves – at your neck, mid back, and low back. Correct posture should maintain these curves, but not increase them. **Your head should be above your shoulders, and the top of your shoulder should be over the hips.** There are fitness programs which can address and benefit posture issues, among them Pilates and some Yoga poses. Of course, maintaining a strong skeletal framework is essential. As I have mentioned in previous articles, if you are working with a fitness trainer, make sure that they have proper credentials to address your needs. Begin with a physical check-up from your physician and his or her recommendations

for a program.

Readers, this is a topic “near and dear” to me because the benefits of good posture can keep you from losing your balance, falling, and subsequent injury. As we age in particular, a fall can have devastating effects. There is much information on the health benefits of good posture for you to do your own research, and please do so. Remember when seated with your electronic devices to stand up frequently, pull your shoulders back, your chin up, and practice your deep breathing and stretching. Your ability to maintain your energy, wellness, and possibly eventually your independence may depend on it.

# Carmel cuts ribbon today on Midtown Plaza AED station

## The REPORTER

Today at 1 p.m., the City of Carmel, the Carmel Fire Department and Carmel Clay Parks and Recreation will cut the ribbon on a new automated external defibrillator (AED) station.

An AED is used to help those experiencing cardiac arrest; this will be the first of many to come to the Carmel trails network and Carmel Clay Parks facilities and grounds. An AED is a complex but easy-to-use medical device that can analyze the heart's rhythm and, if necessary, deliver an electrical shock, or defibrillation, to help the heart re-establish an effective rhythm.

Annually, about 1,700 lives are saved by good Samaritans using AEDs. Cardiac arrest victims who are administered a shock from a bystander have 2.62 times higher odds of survival and 2.73 times more favorable outcomes as compared to people who first received an AED shock by emergency

responders. The AED units have audible instructions to assist the user and a QR Code on the station will have an associated video. In addition to the AED, Bleed Kits will also be available in the

AED station to assist in the case of a bleeding-related injury. A video with directions on how to use the Bleed Kit can also be found on the

AED station.

The first AED in this growing program will be installed at Midtown Plaza while four additional AEDs will be installed over the next several months along the Monon Greenway at Central Park, near City Hall on Gradle Drive, near the new public restrooms across from Carter Green and where Main Street crosses the Monon Greenway. Eventually, there will be more AED stations installed along Carmel's trail network and at all Carmel Clay Parks locations.

The first installation was funded by a donation from

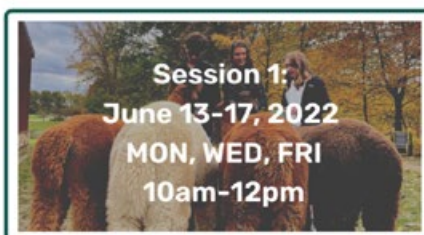

# Millers defend regional championship

Last year at this time, the Noblesville girls track and field team made history by winning its first-ever Lafayette Jefferson regional championship.

History repeated itself on Tuesday, as the Millers defended their regional title. Noblesville scored 96 points, winning three events along the way and qualifying 10 events to next weekend's state tournament at Indiana University.

Kiana Siefert picked up a victory for Noblesville in the 300 hurdles (44.46 seconds), while Summer Rempe won the 800 run in 2 minutes, 13.34 seconds, improving her time by one second from last week's sectional meet. Malina Miller triumphed in the high jump, with a big leap of 5 feet, 7 inches.

Siefert also qualified for state in the 100 hurdles and long jump. Hannah Alexander earned places at state in both the discus and shot put. Rylee Hassan qualified in the high jump, while Paige Hazelrigg advanced in the 1600 run, as did the Millers' 4x800 relay.

Carmel placed second with 84 points and advanced seven to state. That included all three relays; the Greyhounds won the 4x400 and 4x800, while taking fourth in the 4x100 but doing so in a state standard time of 48.41 seconds, thus qualifying them for state.

Taylor Reagor triumphed in the discus event with a throw of 138 feet. Olivia Cebalo took second in the 400 dash in a new best time of 55.61 seconds, while Cambell Wamsley finished fourth, but her time of 56.80 seconds beat the state standard. Alivia Romaniuk also qualified in the 3200 run.

Hamilton Southeastern finished third by scoring 75 points. The Royals qualified nine events to state, with Ally Elsbury advancing in three. Elsbury won the 100 hurdles race (14.61 seconds), then qualified in the 300 hurdles and long jump.

Southeastern also advanced Maggie Powers in the 3200 run, Elia Blackmore in the 300 hurdles, Rosiebella Fiabema in the

discus and all three relays.

Fishers placed sixth as a team with 41 points. Ella Scally advanced to state in three events, the 100 dash, 200 dash and the long jump.

Guerin Catholic's Bridget Gallagher qualified for state by winning the 3200 run (11:04.48) and taking second in the 1600 dash. Hamilton Heights' Kelsey Smith was second in the high jump, also advancing to state.

A handful of performances may be good

enough to earn callbacks to state; those will be determined today.

# Second-half surge sends Guerin Catholic to Sectional 2 championship

**NOBLESVILLE** - The Guerin Catholic girls lacrosse team has had an incredible season, and it got even better on Tuesday.

The Golden Eagles hosted the Class 2A Sectional 2 championship, taking on county opponent Hamilton Southeastern. It was an exciting game, with both teams scoring in bunches as well as playing tough defense. The Royals had Guerin Catholic down at halftime before the Golden Eagles rallied in the second half to win 7-5 and qualify for the state tournament.

Guerin quickly got out to a 2-0 lead with goals from Caitlin Carter and Alex Soucie. Southeastern came back just as fast, tying the game in the sixth minute; Jessie Lyons and Sam Borgert scored goals within 32 seconds of each other.

Ellie Fitzpatrick scored with 16:52 left to put the Royals in front for the first time, then Lyons and Sydney Schena added goals to give Southeastern a 5-2 lead. The Golden Eagles began a comeback during the last two minutes of the first half: Claire Alic scored at the 1:45 mark, then Ella Bellflower put in a goal with 14 seconds left. That made the halftime score 5-4, HSE.

"It seems like every we've ever played has been ebbs and flows," said GC coach Brian Billand. "It's just who can control the ball at the end of the game. Our team started pulling together. We had a lot of turnovers in the first half, just a ton of turnovers. We just pulled it all together and played our type of lacrosse. But they're a tough team to beat. They're a high-quality team."

The second half was pretty much de-

fense all the way. Neither team scored until the 20:26 mark, when Soucie tied the game with her second goal. Eight minutes later, Soucie delivered the go-ahead score, giving her three goals for the game and putting Guerin Catholic up 6-5.

"We did what we needed to do on the draw circle in the first half," said Royals coach Rex Holliday. "We controlled the ball, we controlled the clock and for the most part, controlled the score in the first half and it completely flipped on us."

Alic finished the game with her second goal of the night with 4:52 left, and the Golden Eagles' defense held on from there. With the win, Guerin Catholic kept its record undefeated for the season at 18-0.

"We had a lot of tough games," said Billand. "We had to go through Cathedral and Carmel and Bishop Chatard. They're tough teams to beat." The Golden Eagles also traveled to Pittsburgh to play two tough teams in that area, and won there as well.

Guerin Catholic will play Bishop Chatard, the Sectional 3 champion, at next week's semi-state. The other semi-state features Carmel and Evansville Memorial; sites and times will be determined soon.

In the Class 1A tournament, Westfield is back in the semi-state, having beaten Harrison and Brownsburg to win Sectional 6. The Shamrocks will play Heritage Christian in one semi-final, with Chesterton and Evansville Central playing the other game.

# Baseball sectional preview: 4A Sectional 8 at Noblesville

The 2022 Class 4A baseball Sectional 8 will be held at Dunker Field in Noblesville. Just as it usually is, the six-team field will be a loaded one. Noblesville, Westfield, Fishers, Hamilton Southeastern, Carmel and Zionsville make up the six teams that will duke it out for this year's sectional crown and they all have a chance to win.

The Fishers Tigers are the defending champions of the 2021 sectional and look to be labeled as the favorite, being the only ranked team in the half dozen, sitting ranked fourth in the final regular season poll by the IHSBCA, the title is out there for the taking.

Five of the six teams in this sectional post a .500 record or better and even the one team that's sub .500, the Hamilton Southeastern Royals, can be considered a hard out.

In the last seven seasons (not including 2020, which was canceled due to Covid-19), four teams that have won this sectional have made their way to a state finals appearance, with three of those hoisting state championship trophy for the first in each school history.

Noblesville started the trend in 2014, becoming the first school from Hamilton

County to win a baseball state title. Four years later in 2018, Fishers nabbed its first state championship, and then the Tigers' school district neighbors Hamilton Southeastern won the 2019 crown.

Fishers had inched close to advancing beyond the Regional, but was derailed by Zionsville in 2017. The year before that in 2016, Carmel lost in a Regional title of the Hamilton and Boone county border schools, dropping that Elite Eight game to Zionsville.

Throw into the mix what Zionsville was able to do when it spent a few years up in Sectional 7 and made their presence known. The Eagles were able to beat Carmel for the Lafayette Jeff Regional championship. They wound up losing the 2016 state championship to Roncalli on a controversial ending, 3-2 in 9 innings. The 2017 season saw Zionsville lose in the Kokomo Semi-State to Penn and then a 2018 Regional semifinal loss to Fishers. And not to mention Westfield, who had two 4A state runner-up teams in 2009 and 1998.

This just goes to show that this is the toughest sectional in the state of Indiana. This year's draw will keep the crowd at Dunker Field compelled for five extremely

competitive games.

**Game 1 - Zionsville at Noblesville:  
Wednesday, 5:30 p.m.**

**Zionsville Eagles 17-11 (7-7 HCC)**

The Zionsville Eagles have won three in a row and nine of their final 11 games heading into sectional play. They have a rematch with Noblesville, whom they swept both games from the Millers less than a week ago, 16-4 and 4-2.

The Eagles had key wins this season in their opener over Carmel (1-0), Cathedral (4-1) and also was able to sweep Westfield (6-1 and 3-2), who was ranked a majority of the season until recently. Zionsville posts an 11-6 record on the road and boasts a 7-2 mark against Sectional 8. They have also been able to score 4.5 runs per game and give up 3.2.

Head coach Jered Moore is in his ninth season at Zionsville and has gone 160-84 in that span.

**Noblesville Millers 14-14 (7-7 HCC)**

Noblesville went 3-3 heading into sectional and has only been able to string together one three-game winning streak this season.

The Millers have gone 6-6 in the month of May and have had their ups and downs trying to find their groove. They get the chance to redeem their two losses last week to their first round opponent in the Zionsville Eagles.

They had some pretty key wins this season with what is one of the toughest schedules in the state. Beating then top-ranked Fishers on their home field in mid April, shutout perennial power Cathedral (4-0), won at Westfield and also had a dominating home win over 3A second-ranked Western (9-1).

The Millers went just 7-6 at home and are just 4-5 against the other five in the sectional. They averaged 4.4 runs per game and gave up 4.1.

Noblesville is looking for their first sectional title since winning the 2014 state championship. Head coach Justin Keever is now in his 18th season, compiling a record of 314-211 leading the Millers.

**Game 2 - Westfield vs. Hamilton  
Southeastern: Wednesday, 8:00 p.m.**

**Westfield Shamrocks 18-8 (8-6 HCC)**

The Westfield Shamrocks have hit a hot streak leading up to their first round matchup with Hamilton Southeastern, winning six straight and 9 of their last 14.

The 'Rocks and the Royals split their regular season HCC series games, losing at HSE 5-3 and taking their home game 2-1 just two weeks ago.

Westfield's key victories were sweeping Brownsburg in the HCC, 5-4 and 16-7, and also routed Carmel 19-1 at home. The Shamrocks also carry 8-3 road and 3-0 neutral records into sectional.

They have been able to score runs in bunches, averaging 7.1 per game and giving up only 3.2, but they are just 3-6 against Sectional 8 competition.

Westfield hasn't won a sectional since 2011 and couldn't be more hungry for a title with the talent they have. Ryan Bunnell has been head coach for the Shamrocks, going 288-221-1 in that 20 season time frame.

**Hamilton Southeastern Royals 10-17  
(3-11 HCC)**

The Royals have come into sectional ac-

tion winning two in a row and have gone 4-3 in their last seven

They've had some key wins as they have improved in the latter portion of the regular season. HSE won at fourth-ranked Fishers, at home versus Westfield and swept Franklin Central to end the season on a high note.

Southeastern was just 5-7 on the road and 0-1 in neutral site games, while averaging 4.4 runs, they give up 4.9.

Hamilton Southeastern is just 2-8 when playing against Sectional 8. Its last sectional championship was in 2019 in Jeremy Sassenella's first season, when the Royals won their first baseball state championship. Sassenella is now in his fourth season, going 45-41-1.

**Semifinal #1:**

This matchup will pit the winner of Game 1 between Zionsville and Noblesville against the Westfield and Hamilton Southeastern winner from Game 2.

**Semifinal #2 - Fishers vs. Carmel:**

**Fishers Tigers 21-7 (12-2 HCC)**

The Fishers Tigers head into their semifinal game against Carmel also playing well. They had won seven in a row before losing two of three to end the regular season.

The Tigers have pretty quality wins by sweeping their two-game HCC set against Zionsville, also taking both HCC games from Westfield and a statement 11-0 win over potential Regional opponent Homestead. A more key win was beating the Greyhounds 6-4.

Fishers was a perfect 10-0 on the road and 2-1 on neutral fields, while averaging 7 runs a game and yielding 4.2. They have the best record against the sectional lineup, being 8-2 in those games.

The Tigers took the 2021 sectional and took a state tournament run all the way to Victory Field, before dropping the state championship to Jasper, 3-1.

Matthew Cherry is in his 16th season as Fishers' head coach, going 243-200-1.

**Carmel Greyhounds 18-8**

The Greyhounds too have won four consecutive, but had lost four of five prior. One significant thing for Carmel is that this is their first baseball season as an independent, since defecting from the Metropolitan Interscholastic Conference. A good side note is that while keeping their MIC opponents on the schedule, the Greyhounds went 7-1 in those games.

The 'Hounds were able to beat a really good Lawrence North squad, edged 1A third-ranked Lafayette Central Catholic 1-0, won at number-eight Jasper (7-6), bested top-ranked Center Grove in extras, 5-4 and topped 10th-ranked Columbus North, 2-1.

They posted a 9-3 road record and lost their only neutral field game and averaged 7.6 runs and gave up 4.3 per game.

Being the only non-HCC school, they have just a 2-3 mark against the sectional field.

Carmel has not won a sectional crown since 2016. That season, the 'Hounds lost the Regional title game to Zionsville, 8-4.

Since then, Matt Buczkowski has been the head coach for the Greyhounds for the last six seasons with a record of 98-38-1.

To say that the sectional is wide open is an understatement. This is why it's the toughest sectional in the state, year after year.

## Sky escape with home win against Fever

The Chicago Sky defeated the Indiana Fever, 95-90, in a high-scoring Commissioner's Cup matchup at Wintrust Arena on Tuesday night. Eleven players total finished in double figures in the first of three matchups between the eastern conference foes this season. The win for the Sky comes on the same night as their championship ring ceremony and banner unveiling after winning the first WNBA title in franchise history in 2021.

Chicago moves to 4-2 on the season, while Indiana dropped to 2-7.

Chicago got out to an early 11-2 lead in the first quarter, but a quick timeout by Indiana paused Chicago's momentum in the opening minutes. Fever forward Emily Engstler's work on the glass — who tied a career-high with four offensive rebounds in the first quarter — aided the Fever in making the score 28-22 after one quarter of play.

Indiana played stifling defense in the second quarter, holding Chicago to 5-of-23 shooting in the quarter alone. This allowed the Fever to close the half on a 10-3 run and lead by seven at halftime. Indiana's 49 points in the first half were also the most points scored in a first half by the Fever this season.

Chicago began the second half similar to the first, quickly erasing the deficit with an 11-4 run to tie the game at 53 at the 7:03 mark. Despite shooting 5-of-22 in the third quarter, Indiana only trailed 70-65 heading into the fourth quarter against the defending champions.

After only scoring 10 points through the first three quarters, Kelsey Mitchell began to take the game into her own hands. Led by Mitchell, the Fever would go on a 12-3 run in more than two minutes of game action and took a 77-74 lead with 6:43 left in the game. Chicago secured the lead again on a Candace Parker layup with 5:07 left in regulation, and would never trail for the rest of the game. The Sky shot 11-of-16 from the free throw line in the final quarter.

Mitchell finished with 25 points, scoring 15 points on 5-of-6 shooting and 4-of-4 from the free throw line in the fourth quarter. Mitchell now has five games this season and 39 career games with at least 20 points. Victoria Vivians scored 17 points and had her third game this season with at least three made field goals from beyond the arc. The fourth-year guard has now scored at least 15 points in five of her last six games.

Engstler recorded her first career double-double at 11 points and 13 rebounds and set a new career-high in offensive rebounds with seven. Queen Egbo ended with 10 points and 8 rebounds, with Destanni Henderson also contributing 13 points off the bench.

The Fever scored 42 points in the paint and outrebounded the Sky 40-38.

For Chicago, Parker led the team with 16 points, as well as seven assists and six rebounds. Allie Quigley had 12 points and set a new WNBA record for consecutive free throws made at 69 before missing her first attempt in more than two seasons at the 0:37 mark of the fourth quarter. The Sky ended the night with season highs in points (95) and total rebounds (39).

The Fever head back to Indiana Farmers Coliseum for the next nine home games of the regular season, beginning on Friday at 7 p.m. against the LA Sparks.
