Noblesville Schools names Dan Hile new superintendent mills in Carmel

Northeastern Indiana's Superintendent of the Year will start July 1

Noblesville Schools announced Wednesday that Dr. Daniel Hile has been named the district's new superintendent, replacing Dr. Beth Niedermeyer who is retiring at the end of this month. The Noblesville Schools Board of Trustees unanimously voted to approve the hiring of Hile at a special session held Wednesday evening. His contract begins July 1.

Hile, who was named the 2022 Northeastern Indiana Superintendent of the Year, takes on the top Noblesville role from his current position as superintendent of Smith-Green Community Schools in Churubusco, Ind. Located approximately 15 miles northwest of Fort Wayne, Hile also served previously as a principal, assistant principal, and teacher in Churubusco.

"The Noblesville community told us they wanted a trustworthy, approachable school leader with strong communication and problem-solving skills," said Dr. Joe Forgey, president of the Noblesville Schools Board of Trustees.

Aasen says "no" to puppy, kitten

Changes to city code would make Carmel the largest city in the state of Indiana to prohibit the sale of cats or dogs in pet stores.

Proposed amendments to city ordinance, sponsored by City Councilor Adam Aasen, would still allow responsible, licensed breeders to sell animals directly to consumers within city limits. The new policy would not prevent pet



stores from collaborating with animal care facilities or rescue organizations to offer space to showcase adoptable cats or dogs.

Aasen said this change is needed because many pet stores who sell cats and dogs obtain their inventory from unlicensed puppy mills, many of which are out of state. One study from PAWS, an animal nonprofit, estimates 90 percent of dogs and cats sold at pet stores are obtained from puppy mills.

'The Carmel City Council has already prohibited puppy mills from operating in our city limits and we already prohibited pet stores from sourcing their animals from puppy mills," Aasen said. "This simple change takes the next step to protect animals and discourage abuse and mistreatment. This law would be actually easier for our city to enforce because we wouldn't have to track down where the animals are obtained from, which can often be out of state."

The Sheridan Historical Society has begun offering Saturday open hours for the George Boxley Cabin up on the hill in Veterans Park. Society docents will be available to offer a tour of the cabin and its environs to the public from 11 a.m. to 3 p.m. on Saturdays through Labor Day weekend.



Fr. Michael Kettron October 13, 1930 – June 14, 2022

Fr. Kettron was born in Anderson, Ind., on October 13, 1930, at St. John Hickey Memorial Hospital to Lydia Catherine (Doerflein) and Richard Leo Kettron, and was raised with sisters Mary Angela Kraus and Carolyn Wiehe. Fr. Kettron now joins them in the kingdom of our Lord. He met our

Savior on Tuesday, June 14, 2022. He is survived by many nieces, nephews, and cousins.

From grade school through high school, Fr. Kettron attended St. Mary's parochial Catholic school in Anderson and then went on to Our Lady of the Lakes Preparatory Seminary in Syracuse, Ind. (Lake Wawasee). He continued his education for priesthood at St. Meinrad Seminary and School of Theology to receive degrees in Philosophy and Theology. He was ordained on May 25, 1957.

Fr. Kettron's life journey and 60 years of priestly service touched countless lives and carried him around the world, taking the self-described "hick-boy Hoosier" from Anderson to Great Britain, France, Spain, Rome, the Holy Land, Egypt, South Africa, Vietnam and multiple religious shrines.

Fr. Kettron's first assignment was as an associate at the Cathedral of St. Mary of the Immaculate Conception under the pastorate of Bishop Carberry for three years during which time he was also assigned to the Chancery office. At age 30, he was sent to Rome to earn a doctorate in Canon Law. He attended the Pontifical North American College where he lived in residence at the Casa Santa Maria on the Via Del'Umilta, a property which the Holy Father had given to the bishops of America. After three years of study and with his doctorate in the Chancery Office in Lafayette as pro-Chancellor and later as Chancellor. He was assigned to serve as pastor of St. Joseph parish in Delphi, Ind., in 1967 where he took on a five-year task of remodeling the church. In 1972 he became pastor of Our Lady of Mt. Carmel parish in Carmel and later at Sacred Heart of Jesus in Cicero in 1987. Fr. Kettron lived his last few years at the Hermitage in Beech Grove, Ind. He was cared for by the Benedictine sisters and their staff.

In fulfilling his pastoral mission, Fr. Kettron found great spiritual satisfaction and long-lasting friendships during his priesthood participating in Catholic movements – Cursillo, Christ Renews His Parish, Parish Encounter and Priest Encounter. Fr. Kettron will be missed by so many people; his family, friends and parishioners. His life has been recounted by our children, parents, grandparents and great-grandparents and our religion. 



AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF NOBLESVILLE, HAMILTON COUNTY, INDIANA
Noblesville Schools Tennis Facility Super-Voluntary Annexation
WHEREAS, the City of Noblesville, Hamilton County, Indiana received a petition requesting that certain territory generally located along the north side of Field Drive

and approximately one-quarter mile east of North Tenth Street with a common address of 1610 Field Drive, as herein after described (Annexation Territory"), be annexed

WHEREAS, the petition has been signed by the sole owner (i.e. 100%) of the property within the Annexation Territory; and WHEREAS, in accordance with Indiana Code §36-4-3-5.1 (e), on or around May 24, 2022, the City Council held a duly noticed public hearing regarding the

WHEREAS, in accordance with Indiana Code §36-4-3-1.5, the Common Council has determined that the Annexation Territory is contiguous at least by one-eight (1/8) of the aggregate external boundaries of the Annexation Territory and coincides with the boundaries of the City.

WHEREAS, the written fiscal plan and definite policy adopted by resolution provides for the provision of services of a non-capital nature (including police protection, fire protection, street and road maintenance and other non-capital services normally provided within the corporate boundaries of the City) to the Annexation Territory within one (1) year after the effective date of this annexation in a manner equivalent in standard and scope to those non-capital services provided to areas within the

within one (1) year after the effective date of this annexation in a manner equivalent in standard and scope to those non-capital services provided to areas within the current corporate boundaries, regardless of similar topography, patterns of land use, and population density; and

WHEREAS, the written fiscal plan and definite policy adopted by resolution provides for the provision of services of a capital nature (including but not limited to street construction, sewer facilities, and storm water drainage facilities) to the Annexation Territory within three (3) years after the effective date of this annexation in a manner equivalent in standard and scope to those capital services provided to areas within the current corporate boundaries, regardless of similar topography, patterns of land use, and population density; and in a manner consistent with federal, state and local laws, procedures, and planning criteria; and

WHEREAS, the Common Council now desires to annex the Annexation Territory generally known as the Noblesville Schools Tennis Complex.

NOW, THEREFORE BE IT ORDAINED by the Common Council of the City of Noblesville, Hamilton County, Indiana as follows:

Section 1. Contiguity. The petition requesting voluntary annexation for the Annexation Territory, further described in Exhibit A, attached hereto and incorporated herein and graphically depicted in Exhibit A. and graphically depicted in Exhibit A. and graphically depicted in Exhibit A.



AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF NOBLESVILLE, HAMILTON COUNTY, INDIANA Stony Bluffs Super-Voluntary Annexation

WHEREAS, the City of Noblesville, Hamilton County, Indiana received a petition requesting that certain territory generally located along the north side of East 166th Street and approximately 700-feet east of Union Chapel Road with a common address of 11002 East 166th Street, as herein after described (Annexation Territory"), be annexed by Noblesville; and

WHEREAS, the petition has been signed by the sole owner (i.e. 100%) of the property within the Annexation Territory; and WHEREAS, in accordance with Indiana Code §36-4-3-5.1 (e), on or around May 24, 2022, the City Council held a duly noticed public hearing regarding the Annexation Territory;

WHEREAS, in accordance with Indiana Code §36-4-3-1.5, the Common Council has determined that the Annexation Territory is contiguous at least by one-eight (1/8)

of the aggregate external boundaries of the Annexation Territory and coincides with the boundaries of the City.

WHEREAS, the written fiscal plan and definite policy adopted by resolution provides for the provision of services of a non-capital nature (including police protection, ire protection, street and road maintenance and other non-capital services normally provided within the corporate boundaries of the City) to the Annexation Territory within one (1) year after the effective date of this annexation in a manner equivalent in standard and scope to those non-capital services provided to areas within the

current corporate boundaries, regardless of similar topography, patterns of land use, and population density; and
WHEREAS, the written fiscal plan and definite policy adopted by resolution provides for the provision of services of a capital nature (including but not limited to street construction, sewer facilities, and storm water drainage facilities) to the Annexation Territory within three (3) years after the effective date of this annexation in a manner equivalent in standard and scope to those capital services provided to areas within the current corporate boundaries, regardless of similar topography, patterns of land use and population density; and in a manner consistent with federal, state and local laws, procedures, and planning criteria; and WHEREAS, the Common Council now desires to annex the Annexation Territory generally known as "Stony Bluffs".

NOW, THEREFORE BE IT ORDAINED by the Common Council of the City of Noblesville, Hamilton County, Indiana as follows:

Section 1. Contiguity. The petition requesting voluntary annexation for the Annexation Territory, further described in Exhibit A, attached hereto and incorporated herein and graphically depicted in Exhibit B. attached hereto and incorporated herein.

Section 2. Annexation Territory. The real estate containing approximately 7.63 acres, more or less legally described in Exhibit A, and graphically depicted in Exhibit B, both attached thereto and incorporated herein, and generally known as the Stony Bluffs, is hereby annexed to and declared to be a part of the City of Noblesville,

Section 3. Council District. The above described real estate is hereby assigned to City Council District 6 and shall become a part thereof immediately upon the effective

Section 4. All prior Ordinances or parts thereof that may be inconsistent with any provision of this Ordinance are hereby superseded. The paragraphs, sentences, words, and Annexation Territory of this Ordinance are separable, and if a court of competent jurisdiction thereof declares any portion of this Ordinance or the Annexation Territory unconstitutional, invalid, or unenforceable for any reason, such declaration shall not affect the remaining portions of the Annexation Territory or this Ordinance. Section 5. The effective date of this annexation shall be as soon as allowed by law following its adoption, execution, and publication as required by law.



Surviving the awkward years

of my adoption didn't come up very often between my parents and me after that revealing Sunday. I do remember being a preteen brat once and claiming that they had said they regretted get-



brought on a lot of tears and sadness for all three of us.

Mom and Dad reassured me that they never had such a thought.

My admiration for my parents grew thanks to learning all this information. I couldn't imagine the pain they endured losing a child at such a young age. And I found out that my mom had some incredible courage and strength.

At one point she was getting ready to have one of the final interviews with Catholic Social Services in order to adopt me. The day before this occasion, she was hanging a mirror with my grandfather in the living room. I remember this mirror – it had to have been at least four feet wide and three feet tall. It was large, with an ornate, gold-plated frame. It fell off the wall and right on to the last three toes of Mom's left foot. Needless to say, she broke all of them, and they still didn't look

But Mom refused to walk into that office using crutches or wearing any special shoes. She didn't want the adoption agency to think there was anything wrong with the potential family I was going to be placed with. So the next morning, my grandma dropped Mom off. She walked into the building, had the interview, walked back out, and burst into tears upon climbing back into Grandma's car due to the pain.

Yeah. My mom was kind of a badass.

I went on with my life, going through the typical tough years of adolescence, which included not only braces for my teeth and acne, but glasses and a back brace for scoliosis. If you looked up the word "awkward" in the dictionary back then, you would have seen my picture. I even went through a time where I was tempted to take my own life, but thinking of what that would do to my parents

stopped me right away. Thankfully, most of us survive our teen years and hopefully escape that awkwardness. By the time I went away to Indiana University in Bloomington, both types

of braces were COLUMNIST gone along with my zits. And after encouragement from good old Dr. Erickson, my glasses were replaced with contact lenses. course, he never got to see my new look because ev-

ting me during a fight. That ery time I saw him I was sick and didn't feel like putting in the contacts. That irritated Mom to no end.

> During delightful dinner out over IU's Parents Weekend, I broached the subject of my adoption once again. I remember we were at a beautiful candlelit restaurant in Columbus, Ind., and I had just tasted duck for the first time in my life. I asked my parents if they knew anything about my biological mother and father. Once again, Mom was the one who responded.

> "We were only told three things," she said. "That they were college students, they wore glasses, and had allergies."

I thought that was really strange because at the time I wasn't allergic to anything that I knew of. But the glasses part made sense, since my vision was terrible, and I was a college student after all. So I at least had two things in common with my birth parents.

We had an interesting talk about how easily I had just fit into our family over the years. I also found out that one friend of the family was not so accepting of me. She would often ask my grandmother, who died when I was 10, about my brother and sister, but never about me. It was as if she had some sort of prejudice against me because I was adopted. I never found out who this woman was. But I am amazed that there were, and probably still are, people in the world who have these kinds of feelings.

WHEREAS, the petition has been signed by the property owners (i.e. 100%) of the property within the Annexation Territory; and WHEREAS, the City of Noblesville had code §36-4-3-5.1 (e), on or around May 24, 2022, the City Council held a duly noticed public hearing regarding the Nonexation Territory.

WHEREAS, in accordance with Indiana Code §36-4-3-1.5, the Common Council has determined that the Annexation Territory is contiguous at least by one-eight (1/8)

of the aggregate external boundaries of the Annexation Territory and coincides with the boundaries of the City.

WHEREAS, the written fiscal plan and definite policy adopted by resolution provides for the provision of services of a non-capital nature (including police protection, fire protection, street and road maintenance and other non-capital services normally provided within the corporate boundaries of the City) to the Annexation Territory within one (1) year after the effective date of this annexation in a manner equivalent in standard and scope to those non-capital services provided to areas within the

urrent corporate boundaries, regardless of similar topography, patterns of land use, and population density; and
WHEREAS, the written fiscal plan and definite policy adopted by resolution provides for the provision of services of a capital nature (including but not limited to street

construction, sewer facilities, and storm water drainage facilities) to the Annexation Territory within three (3) years after the effective date of this annexation in a manner equivalent in standard and scope to those capital services provided to areas within the current corporate boundaries, regardless of similar topography, patterns of land use, and population density; and in a manner consistent with federal, state and local laws, procedures, and planning criteria; and WHEREAS, the Common Council now desires to annex the Annexation Territory generally known as "Silo Ridge".

NOW, THEREFORE BE IT ORDAINED by the Common Council of the City of Noblesville, Hamilton County, Indiana as follows:

Section 4. All prior Ordinances or parts thereof that may be inconsistent with any provision of this Ordinance are hereby superseded. The paragraphs, sentences, words, The proof of this Ordinances of parts thereof that may be inconsistent with any provision of this Ordinance are nereoly supersected. The paragraphs, sentences, words, and Annexation Territory of this Ordinance are separable, and if a court of competent jurisdiction thereof declares any portion of this Ordinance or the Annexation Territory unconstitutional, invalid, or unenforceable for any reason, such declaration shall not affect the remaining portions of the Annexation Territory or this Ordinance.

Section 5. The effective date of this annexation shall be as soon as allowed by law following its adoption, execution, and publication as required by law.



The City of Westfield held a public hearing in January 2022 for a proposed reconstruction project located along State Road (SR) 32 in Westfield, Hamilton County. This public hearing was held as part of the environmental analysis phase. as required per the State Environmental Policy Act (SEPA). Public involvement is n important element of a comprehensive decision-making process. The purpose of the proposed project is to improve corridor mobility along SR 32 through the downtown Westfield area for both motorists and pedestrians alike.

The Preferred Alternative consists of widening and reconstructing SR 32 from ust east of the Poplar Street roundabout to just east of Timberbrook Run. Outside of the boundaries of the Stultz-Stanley House (209 W Main Street) and the Westfield Historic District (NR-2521), the existing 2-lane section of SR 32 will be econstructed to consist of four, 11-to-12-foot wide travel lanes (two westbound, wo eastbound), with a raised 13-foot wide center median, curb and gutter, and 8-foot wide sidewalks separated by 6-foot wide grass buffers on both sides of the roadway. Along SR 32 left turns will be restricted with left turn movements only available at Westlea Drive/Mill Street and Union Street. This reconstruction vill result in widening the roadway to the south by approximately 25-feet. Additionally, new pedestrian crosswalks with refuge islands will be constructed along SR 32 in three locations: just east of Westlea Drive/Mill Street, just west of Walnut Street, and just west of Cherry Street. Rectangular Rapid Flashing Beacons (RRFBs) will be installed at these pedestrian crossings to increase driver wareness of pedestrians.

In front of the Stultz-Stanley House (209 W Main Street), SR 32 will be shifted north by approximately 34-feet, and the typical section of SR 32 will remain the same with the exception of no 6-foot wide grass buffer along the south side of the roadway between the sidewalk and roadway. Within the boundaries of the Westfield Historic District (NR-2521), SR 32 will be reconstructed to consist of four, 11-to-12-foot wide travel lanes, an 11-foot wide turn lane, a 2-foot wide aised center curb with 1-foot wide curb offset, curb and gutter, and 8-foot wide idewalks separated by 6-foot wide buffers on both sides of the roadway. This will result in widening SR 32 to the south by approximately 25-feet and result in the removal of four buildings from the Westfield Historic District: 101 S. Union Street, 102 S. Union Street, 103 S. Union Street and 111 E. Main Street.

Moving east outside of the district, the intersection of SR 32 and East Street vill be reconstructed to a two-lane roundabout with 11-to-12-foot wide travel anes (two westbound, two eastbound) with 8-foot wide sidewalks separated by -foot wide grass buffers on all sides. North of the roundabout, East Street will be reconstructed to consist of two 11-foot wide travel lanes (one northbound, one southbound) with 6-foot wide sidewalks adjacent to the curb and gutter on the west side of the roadway. East Street will be realigned to provide the appropriate ransition into the roundabout as well as to straighten out the existing S-curve along East Street, north of Penn Street. East of the roundabout and extending to east of Timberbrook Run, SR 32 will be reconstructed to consist of four 11-to 2-foot wide travel lanes (two westbound, two eastbound).

Overall, the project will result in the elocation of thirteen buildings.

Guerin basks in glory of first win

County teams dominate top three spots in golf state championship

CARMEL – With two birdie putts, the Guerin Catholic boys golf team earned some redemption – and a state championship.

The Golden Eagles had been battling with Westfield for all 36 holes of a hot IH-SAA state championship last week at Prairie View Golf Club in Carmel. The tournament finished last Wednesday afternoon in dramatic fashion, with the Shamrocks leading Guerin Catholic by one stroke with two groups left to play.

But thanks to those birdies from Connor McNeely and Jacob Modleski, the Golden Eagles overcame that deficit to finish first. Guerin totaled a two-day team score of 602, just ahead of Westfield's 603. It's the first-ever boys golf state championship for the Golden Eagles, and also brought Guerin Catholic full circle after last season's state finals – where it finished second to Center Grove by one stroke.

"There's a lot of pressure going down the last hole," said GC coach Mark Mathews. "Last swing is a tough one to make and those were pretty good swings. I'm just almost speechless, which for me is impossible."

McNeely went first, making his birdie to bring the Golden Eagles up to a tie with the Shamrocks. The senior held the lead after Tuesday's first round, but struggled during the sec-

"I ended on a high note," said McNeely. "State championship as a team, that's all that matters, so I'm happy as can be right now."

DON'T TELL ME

Modleski came up next, and after a perfect wedge shot - "probably the best wedge shot of the two days," he said – quickly put the ball in the hole for the birdie. While everyone around him was aware of how important his putt was, Modleski kept himself intentionally unaware of the score.

"I actually had no idea," said Modleski. "I told Coach Mathews not to tell me, unless we needed some sort of heroics on 18."

Coach Mathews can confirm this.

"It's pretty cool," said all intention to tell Jacob what he needed to do, and the first thing when I walk up is, he said 'I don't want to know anything, just help me with the shot. Don't need to know anything, just

help me with the shot.' He's a smart kid, so he knew that if I walked out there, that I was probably going to tell him what he needed to do."

Modleski and McNeely both finished the tournament with two birdies, and Modleski would also earn an individual medal as well, tying for fifth place with a two-day score of 145. Modleski went under par for his second round, a one-under 71.

Leo Wessel tied for 10th individually, scoring a 148. Wessel drained four birdies. all on the front nine, during his second round, in which he totaled an even-par 72. Everyone on the Golden Eagles team made at least one birdie, with Zach Thieme collecting two and Scotty Smith one.

Modleski and Wessel were both named to the All-State team at the conclusion of the meet. In addition to being Guerin Catholic's first-ever boys golf state title, it's the fifth IHSAA state title in school history for the Golden Eagles, following two each in boys basketball and boys soccer.

While it was a tough way for the meet to finish, the Shamrocks still had an outstanding state tournament. This was the first time a Westfield team had made it to state since 2017, and it did so with a young cast.

Junior Jake Cesare was part of the three-way tie for 10th place, scoring a 148 and making three birdies along the way. All five Westfield players drained at least one ond round before getting birdie, including three for it together on the last hole, freshman Alec Cesare and which he called his "four two for Will Harvey, another freshman. Nolan Hall collected two and Cam Kooi made one. Jake Cesare was also named to the All-State team.




