The prosecutor of Hamilton County must be focused at all times on the protection of our citizens.

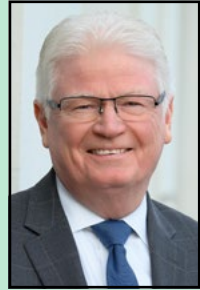
