# Hamilton County Emergency Management assists Johnson County after Friday tornadoes

Last Friday night, the National Weather Service placed much of central Indiana under a tornado watch, meaning conditions were likely.

Hamilton County Emergency Management volunteers and staff activated Storm Operations in the county's Emergency Operation Center (EOC). Trained personnel stand ready to coordinate information, activate the outdoor warning sirens, and support municipalities and the county's unincorporated areas.

When a tornado warning was issued for the county's northwest corner, the outdoor warning sirens were sounded for Sheridan and Atlanta. After several thunderstorm warnings, Hamilton County had only a few reports of downed trees and power lines.

The EOC monitored reports of the tornado in Sullivan, Ind., but the line of storms had yet to pass through Hamilton County. As it did, reports came in from Johnson County of multiple injuries, homes destroyed, and countless damages to outbuildings and vehicles, especially in Whiteland. Due to large amounts of debris, Interstate 65 was also closed in both directions near the town.

IN THE GARDEN

Following the Last Supper, Jesus was betrayed, as He knew He would, by Judas. Later that evening, Jesus went to the Garden of Gethsemane. This is such a poignant moment in the Bible. It is a time where we see Jesus as a man in agony.

Jesus is overwhelmed with burden and grief as He knows His death is imminent. He prays. It is easy to only think of Jesus in the Divine sense, but He was also Man. That Thursday evening, He was a vulnerable man weeping in a garden to His Father. He had the sins of the world on His shoulders,

and He knew what was going to happen on Friday. Jesus told His Father, “*Not my will, but yours be done.*”

The three coming days, known as the Triduum, consisting of Holy Thursday, Good Friday, and Holy Saturday ultimately lead us to Easter Sunday. Much like Good Friday, winter can be harsh and challenging. We hold on to the fact that we know just like Sunday is nearing, so too, is Spring. Spring is a time of rebirth and resurrection. Jesus washed the feet of His disciples, broke bread, and wept on Thursday. He was killed on Friday,

but what happened Sunday? Resurrection. Spring came, the Heavens opened, and the tomb was empty. “He was not there, for He had risen.” Matthew 28:6.

I often have wondered about the Garden that evening that Jesus went to talk to His Father. What was blooming? What did it look like? What did it smell like? Were there animals nearby that heard Him weeping? Did the tears that Jesus cried that night fall to the ground and land on any flowers? What must it have been like to be Jesus knowing that you were to be put to death

tomorrow? Did He focus on Sunday or was He overcome with anguish about Friday?

I often think about one of the greatest lines from one of my favorite novels, *The Secret Garden*, “Is the spring coming?” “What is it like?” “It is the sun shining on the rain and the rain falling on the sunshine, and things pushing up and working under the earth.”

Some believe it rained on Good Friday. I don’t know if it is known for certain, but whether it rained from the sky or not, the blood of Jesus poured down. Friday was a dark day. Jesus looked at His mother on His way to be crucified, carrying His own cross that he was eventually nailed to. What was Mary thinking that day? She saw her only child fall and struggle as he carried this heavy cross. The cross that is weighed down by the sins of mankind. What a heavy burden to carry. What must it have been like to see your baby boy on His death march? Would you have wiped His face like Veronica?

As Jesus died, the Earth shook. Just as described in *The Secret Garden*, rain falls upon rain, but soon will come the sunshine. Sunday will come. The sun will shine again. And just as the Earth shook on Friday and the blood of Jesus poured out, the same Earth is working on new life and resurrection. He went from weeping in the garden on Thursday to rising from the dead and an empty tomb on Sunday.

May these coming days be a time of holiness for all of us. May we remember the ultimate sacrifice that He paid for all of us. May we never forget Friday. We will mourn on Friday and weep just with Mary as she stood looking at her only Son, but we must never forget the tomb will be empty on Sunday. Death could not hold Him.

For very soon He will be risen indeed.

Hamilton County is still looking for Republican Inspectors. These people are in charge of the precinct and must attend a training session on one of the following days: April 25 at 6 p.m., April 27 at 6 p.m., or April 29 at 9 a.m. or 11 a.m. Other obligations include picking up supplies on April 29, setting up the polling place on May 1, and working on Election Day. The job pays \$200, plus \$25 for training and \$20 for meals.

The county is also in need of Republican and Democratic judges. This position requires online training. These individuals will

help set up the polling place on May 1 and run the polling place on May 2. These jobs pay \$105, plus \$15 for training, and \$20 for meals. The Democratic judge will be paid an extra \$15 to return election results to the Judicial Center in Noblesville with the Republican Inspector after the polls close.

Finally, the county is in need of Republican and Democratic Clerks to run the electronic polling pads. This position requires online training. The job pays \$105, plus \$15 for training and \$20 for meals.

“When we knew the threat to Hamilton County had passed, we reached out to Johnson County offering support,” said Shane Booker, Executive Director of Hamilton County Emergency Management.

Hamilton and Johnson counties are in the same homeland security district to leverage resources and support. The team who worked in the EOC transitioned to a response task force with light towers, side-by-side ATVs, a mobile command center, and enhanced satellite communications.

Johnson County quickly accepted Hamilton County’s offer.

When the team arrived, the response was well organized, with an established command post to help coordinate activities. Hamilton County was assigned the role of logistics.

“The team did a great job setting up the command center, deploying to the hardest hit areas, assisting with lighting and donations at the high school, and helping the fire departments by transporting families out of the damaged areas with our ATVs,” Booker said. “We are grateful to the Hamilton County Board of Commissioners and the Emergency Management Advisory Council for providing us the latitude to help others quickly.”

The team supported Johnson County for a few hours and was released to return home early Saturday morning.

Hamilton County Emergency Management is a county public safety department with nine staff and 150 volunteers who are ready to provide support and coordination in Hamilton County. Learn more at [hamilton-county.in.gov/em](#).

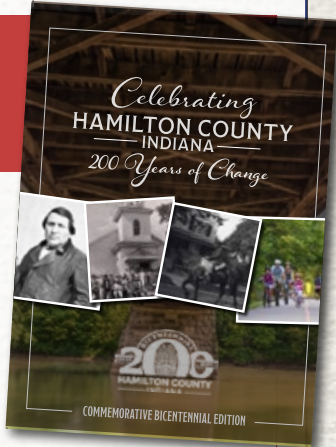

or do we want?

Early voting now underway  
Deadline nearing to apply for absentee ballot by mail

At a school board meeting in April 2022, Noblesville residents were presented with an expansion plan for the high school.

The first phase of that expansion was the creation of a multi-purpose athletic area. That expansion meant we had to take on a \$17.4 million bond with an estimated \$5.5 million in interest. The school board approved that bond and construction is underway.

The second phase of the expansion was to be another \$17.4 million bond plus interest for the construction of five STEM classes, renovation of choral and jazz facilities, band practice rooms, orchestra pit, auditorium stage, additional music practice area, storage, and classrooms. All those additions were to be accomplished within the existing structure and estimated at over 12,000 square feet. Public comments made by Noblesville residents affirmed the NEED for this second phase.

Here we are less than a year later, and what was supposed to be a \$17.4 million expansion has now turned into seeking approval for a \$39 million expansion. The interest on that bond is more like \$22 million. The proposed expansion for the high school has gone from 12,000 to 70,000 square feet. What has changed?

We are moving away from sending our students to J. Everitt Light career center for CTE classes and instead having those classes in Hamilton County under the umbrella of the Pursuit Institute. Also, approximately six teachers are sharing classrooms or rotating through the building working out of moving carts. We must support our students by adding more CTE classes, and teachers and students are not well served by having to share classrooms. Moreover, we should increase the classroom size for the STEM classes to have space for future demand. We can also re-route some of the congestion at the current cafeteria by providing a café

space where students can gather and have a light lunch or snack.

When the five STEM classes, the CTE class, the café area, and the six additional classrooms for teachers are added up we arrive at approximately 25,000 square feet of needed space. In a demographic study, presented to the board at the November 2022 meeting, the projected enrollment forecast for grades 9 through 12 for the next 10 years was zero or slightly below current.

Do we need 70,000 square feet when enrollment projections are almost flat? Do we need an additional 22 classrooms when we have only identified the need for 11 (five plus six)? The additional space amounts to a WANT – or wish list. We certainly do not need a budget that has almost tripled in less than one year. Assertions have been made that the school corporation can afford to take this debt on. Do you believe that just because we can that we should?

Our taxes are indeed capped at 1 percent of property value, but we are facing an increase in property assessments which could significantly increase the dollar amount we pay in property taxes. The board has the final say on how the school budget is spent. They will have to differentiate between what is needed and what is wanted.

Noblesville residents NEED a school board that is a good steward of our tax dollars. There is still time to go back to the drawing board and make modifications.

Two public meetings will be held before the school board votes on this expenditure. The first meeting is scheduled for 10 a.m. on Thursday, April 13 in the Board Room at the Educational Services Center, 18025 River Road, Noblesville. The second public meeting will be held during the April School Board meeting at 7 p.m. on Tuesday, April 18.

The final public meeting schedule will be posted in *The Reporter* at a future date.

Previewing Jackson Township's "Lantern Walk"

The Hamilton Heights High School theater students will hold a "Lantern Walk" through Cicero Cemetery from 7 to 9 p.m. on Saturday, April 22. The walk will include 12 stops at the gravesites of important folks in the history of Jackson Township.

The Reporter will publish a short biography of each of the 12 individuals in our online editions from Wednesday to Saturday for three weeks, concluding April 15. Hansel Roberts is featured in today's edition.

Note: Peter Roberts, pictured above, is Hansel's first cousin once removed. No known likeness of Hansel Roberts exists.

"I am Hansel Roberts, an African-American pioneer. We were people of mixed African, Native American, and European descent, raised in eastern North Carolina, an area where our families had lived as modest, well-respected, free landowners for at least a generation before the American Revolution. We migrated to Indi-

ana's frontier in large measure because our freedom seemed in jeopardy. In July 1835, I journeyed to the federal government's land office in Indianapolis to purchase homesteads in northern Hamilton County. The claims had been intentionally chosen to be within several miles of Quakers, a group known to be accepting and supportive of free blacks. In October 1835, we brought our families to our wilderness claims and settled permanently, establishing a farm community later known as Roberts Settlement. By 1840 the neighborhood included about 10 families and 900 acres of land. In the mid-1920s, growing self-awareness of Roberts Settlement's special heritage led former residents to organize annual homecoming reunions, establishing a Fourth of July tradition that has continued to the present day. My final resting place is the Roberts Chapel Cemetery."



## Dream Hou\$e invites you to explore beyond surface-level family drama

*A Seat on the Aisle*

*House Hunters*, *Fixer Upper*, *Property Brothers*, *Trading Spaces* ... most of us have binge-watched an HGTV series while sick on the couch, or eagerly awaited the next episode of a favorite show. This commonality makes the HGTV setting of *Dream Hou\$e* a brilliant choice, but playwright Eliana Pipes uses that jumping-off point to plumb much greater depths.

On one level, it’s a family drama, as so many of our great plays seem to be. Two Latina sisters have just lost their mother, and the time has come to dispose of the home that has been in their family for generations. Perhaps unsurprisingly, the siblings cannot agree on the best course of action. On a deeper level, the play wrestles with the question of whether gentrification is always wrong. Is it still opportunistic if it presents the singular chance in a hardworking life to make a profit?

As Patricia, the sister who wants to sell the family home, Yolanda Valdivia gives a sparkling and energetic performance. The character is driven and can come across as too aggressive, but that’s only because she wants a better life for herself, her sister, and the baby her sister is carrying. As Julia, the sister opposed to the sale, Lexes Rubio provides a foil that is more centered and down-to-earth, although she could have shown more variance in her performance.

Things get really interesting when we learn that Patricia has signed them up to be participants in an HGTV show, *Flip It and List It!* As Tessa, the host of the show, Jean Arnold is a force to be reckoned with. The on-stage energy shoots up even higher as soon as she enters and remains that way for the rest of the play. Her performance is over-the-top in the way of all the most mesmer-

izing television hosts.

As is only fitting for a piece on this subject, the set is an additional star of the show. Bernard Killian’s set design is perfectly evocative and lends itself well to being staged and even partially demolished at certain points in the play. The quirky details of the props add an extra layer, especially when they’re being switched by crew members from actual family heirlooms to fake ones that may play better on television.

This heartwarming, thought-provoking piece, ably directed by Jordan

Flores Schwartz, seems a perfect fit for the mission of the Fonseca Theatre Company. The light number of audience members was a disappointment and perhaps had something to do with the unusual curtain time of 4 p.m. on a Saturday.

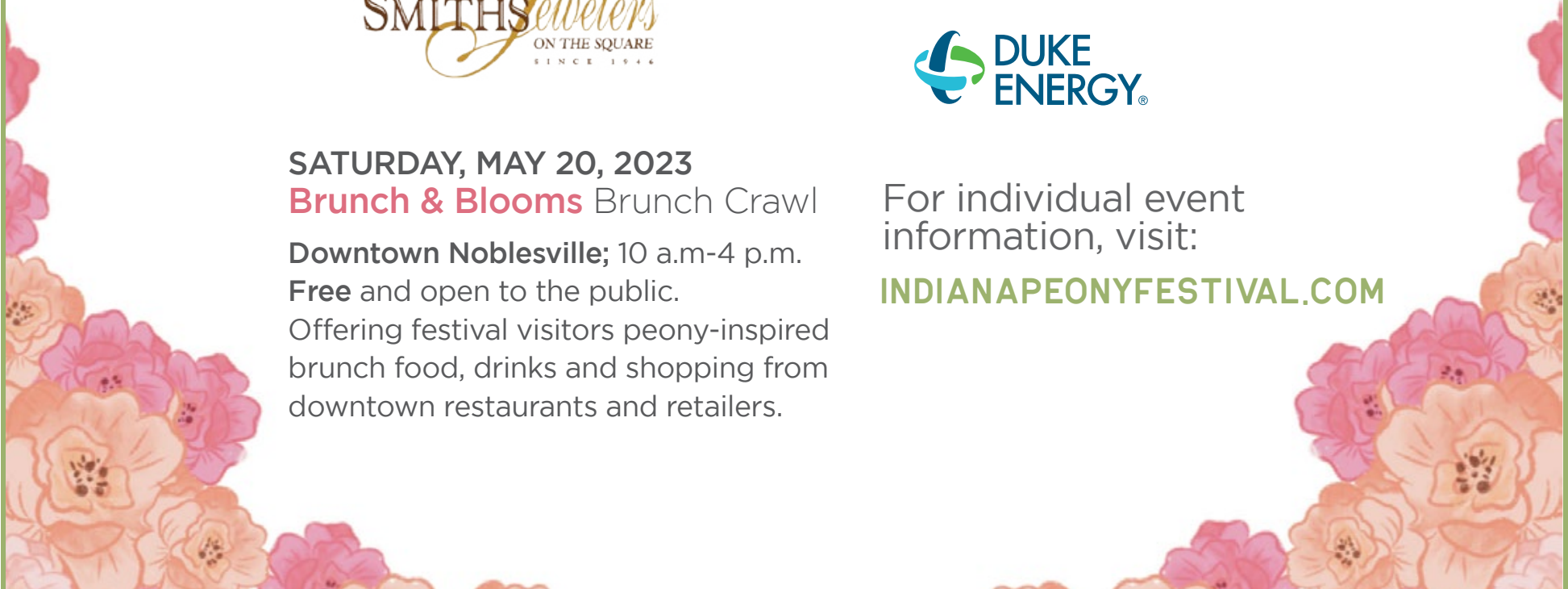

# Two of county's best players earn spots on Indiana Boys All-Stars team

## The REPORTER

Noblesville's Luke Almodovar and Carmel's Sam Orme are among the 13 players selected for the 2023 IndyStar Indiana Boys All-Stars, All-Stars game director Mike Broughton announced Tuesday.

Those chosen to the team will play three games in June – one exhibition game against the Indiana Junior All-Stars as well as home-and-home contests against the Kentucky All-Stars.

The other players chosen the 2023 Indiana Boys All-Stars, listed alphabetically, are Xavier Booker of Indianapolis Cathedral, Markus Burton of Penn, Myles Colvin of Heritage Christian, Zane Doughty of Ben Davis, Joey Hart of Linton-Stockton, Logan Imes of Zionsville, Mason Jones of Valparaiso, A.J. Lux of Crown Point, Ian Raasch of NorthWood, JaQualon Roberts of Bloomington North and Sheridan Sharp of Ben

Davis.

The 2023 IndyStar Indiana Mr. Basketball winner will come from among this group of 13 players. The 2023 Mr. Basketball winner is expected to be announced as part of the IndyStar Indiana High School Sports Awards program on April 19 at Butler University's Clowes Hall in Indianapolis.

This year's boys' All-Star team features five players who have been a part of state championship teams in Doughty and Sharpe of Ben Davis (2023 4A), Raasch of NorthWood (2023 3A), Booker of Cathedral (2022 4A) and Orme of Carmel (2021 4A). The squad also includes an IBCA first-team Academic All-State selection in Raasch plus two IBCA honorable mention Academic All-State picks in Doughty and Imes.

Don Carlisle of Ben Davis has been named the head coach of the 2023 All-Stars. He will be assisted by Brent

Brobston of Frankton and Shane Burkhart of Evansville Bosse.

Carlisle is 144-66 in eight seasons as an Indiana varsity coach. That includes a 98-41 mark in five seasons at Ben Davis -- with a 33-0 ledger and the Class 4A state title in 2022-23 -- and a 46-25 slate in three seasons at Indianapolis Arlington. Brobston is 239-136 in 15 seasons at Frankton. Burkhart is 250-132 in 15 seasons at Evansville Bosse.

The Junior-Senior exhibition game is set for June 7 at a site to be announced. The first game against Kentucky will be June 9 at the Owensboro Sportscenter in Owensboro, Ky. The final game against Kentucky will be June 19 at Gainbridge Fieldhouse in Indianapolis.

All three dates will be doubleheaders with the IndyStar Indiana Girls All-Stars, whose roster was announced March 14. The roster for the Indiana girls

Junior All-Stars was announced March 8. The roster for the Indiana boys Junior All-Stars was announced March 31.

The Indiana Junior All-Stars will play two girl-boy doubleheaders this year -- June 4 against the Kentucky Junior All-Stars at Jeffersonville and June 7 against the Indiana seniors at a site to be announced.

The Indiana All-Stars program was founded in 1939 when the Indiana Boys All-Stars played the state champion Frankfort Hot Dogs. The series with Kentucky began in 1940, and the girls' portion of the All-Stars was added in 1976. The Junior All-Stars, boys and girls, were added in 1996. The All-Star senior girls have played Kentucky every year since 1976, except 2020 because of the COVID-19 pandemic. The All-Star senior boys have played Kentucky in all but three years since 1940 -- 1943 (World

War II), 1944 (World War II) and 2020 (COVID-19 pandemic).

The Indiana Senior boys lead 103-44 in their series with Kentucky. The Indiana Senior boys lead 41-10 in games against the Indiana Junior boys. The Indiana Junior boys lead 7-4 in their series with Kentucky. The Indiana Senior girls lead 52-40 in their series with Kentucky. The Indiana Senior girls lead 41-10 in games against the Indiana Junior girls. The Indiana Junior girls lead 10-1 in their series with Kentucky.

The June 10 date also will include the inaugural IndyStar Indiana All-Star "Futures Games." The Futures Games will be a girls-boys doubleheader at Gainbridge Fieldhouse with Indiana-only squads of juniors, sophomores and freshmen in a North vs. South format. The girls' Futures Games lineups were announced Feb. 16. The boys' Futures Games

lineups were announced March 21.

The Indiana portion of the All-Star Games is organized and produced by the Indiana Basketball Coaches Association. The Indianapolis Star, with its IndyStar brand, is a title sponsor.

Mr. Basketball is selected through a balloting process of coaches and media overseen by game organizers from the IBCA. The remainder of the team is finalized by Broughton after observing numerous games and events throughout the season, conferring with coaches, school officials and media across the state. Broughton also reviews votes submitted by coaches and media who each could recommend up to 10 players.

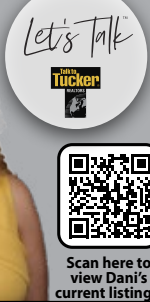
