# Arcadia gets new waterworks

#### The REPORTER

After years of planning and hard work, Arcadia is getting major upgrades to its waterworks and sewage systems. A ceremonial groundbreaking was held on Wednesday to kick off the project.

# **April County Council meeting:** the excitement of the mundane

I struggled to put together the ideas and information I wanted to share from our meeting. April As we all know, sometimes life is less than exciting, and in politics that is sometimes a good thing - es-

pecially in an election year. April's meeting was mundane and dominated by an in-depth conversation about funding an overrun for a sewer project at the White River Campground. Other topics discussed included the approval of a one-time interlocal agreement regarding the distribution of public safety LIT funds, updates on several highway projects and a review of a request from the new Director of Administration, Lee Buckingham. Most of this was standard, so I will use this space to discuss only a few topics and close the loop on the County Fairgrounds.

We have had several meetings pass with a tabled request to appropriate \$2.5 million for affordable housing. This money makes up the second half of the ARPA committee's request to Council. The Council is fully in favor of an initiative to support attainable/affordable housing but is waiting for the plan to be presented before funding the second half of this request. These dollars have restrictions on use and need to be appropriated and spent within a designated time frame.

# Go see Mud Creek Players put on a memorable production of Agatha Christie's The Mousetrap

Agatha Christie's The Mousetrap opened on London's West End in 1952 and ran continuously until mid-March 2020, when COVID-19 considerations caused a 14-month stoppage. Returning

# Fishers road construction updates, week of April 24

#### The REPORTER State Road 37 & 141st Street

A pre-construction phase at SR 37 and 141st Street is currently in place. During this phase, 141st Street will be transitioned to a Right-In-Right-Out (RIRO) traffic configuration.

This is not the permanent configuration. This will allow for traffic to flow more freely along SR 37 until the next phases of construction can be activated. This will eliminate all backups along SR 37 that have caused dangerous stops to the free flow traffic and backups on the 146th Street interchange. Again, this is not the permanent configuration for 141st Street.

The full timeline for the 141st Street interchange will be provided after project bids are accepted in the summer of 2023. View detour routes here.

#### I-465 & I-69

Drivers will see an increase in construction along the Interstate 69 corridor in the coming months. This work will focus on reconfiguring the interchange at I-465 and I-69. New ramps will provide direct movements from eastbound I-465 and northbound I-465 to northbound I-69.

Binford Boulevard will also be reconstructed to separate local traffic from traffic entering and exiting I-69 and I-465. Access to I-69 from Binford Boulevard will remain open. Drivers can expect to see significant activity on I-69 at the 82nd Street interchange.



# Advocate: Indiana hospital pricing measure could cut bills by half

Hospitals on Thursday warned an Indiana hospital pricing measure could potentially force some to cut services.

Negotiations began late Thursday afternoon on a measure that would forbid hospitals from charging additional hospital fees at doctors' offices and clinics that are affiliated with them but are not physically a part of their main hospital facility. The measure would only apply to hospitals that reported at least \$2 billion in net patient service revenue in 2021. That category includes Ascension, Community Health, Franciscan Health, and IU Health.

The bill is the centerpiece of a Republican effort to crack down on health care costs. A study last year by the RAND Corp. found Indiana had the sixth-highest cost for outpatient hospital care in the country.

Gloria Sachdev, president and chief executive officer of Employers' Forum of Indiana, has been one of the leading advocates for the health care bill. She said eliminating the extra fees could cut typical doctors' bills from 30 percent to 50 percent.

"Many of us have seen that where we get two separate bills and that's really not the governor's desk.

By GARRETT BERGQUIST fair," Sachdev said. "Those aren't hospitals, they're not open 24/7, and we shouldn't be paying hospital facility fees for that."

Brian Tabor, president of Indiana Hospital Association, said the legislation unfairly targets a small group of hospitals. He said lawmakers have done nothing to address the state's Medicaid reimbursement rates, which he said haven't changed in 30 years and are among the lowest nationally, nor have they gone after pharmaceutical companies for high drug costs. Tabor said if the legislation becomes law, depending on the impact to hospital fees, it could force some chains to cut back on services.

"We want to be at the table and have conversations about how we can reduce costs and achieve affordability," Tabor said, "but we need to make sure that insurance companies are paying our doctors fairly, which doesn't happen today.'

The legislation has passed both chambers by wide margins. Once a legislative conference committee finishes working out the differences between the versions each chamber passed, the House and Senate will still have to hold final upor-down votes. Lawmakers have until the end of next week to send legislation to

**ELWOOD** – The stage was set for a sixth-straight win Friday night.


Elwood stranded 11 base runners. Seven were in scoring position.
