### Bipartisan bill offers better answer to prevent unwanted pregnancies

Now more than ever, it is imperative to prevent unwanted, unintended pregnancies. Considering Indiana's new abortion statute, women should have increased access to birth control measures. Preventing an unwanted pregnancy is far more desirable than address-



poteet

ing the pregnancy after it occurs.

Indiana HB 1568 would allow pharmacists to prescribe self-administered hormonal birth control to women 18 years and older in the form of pills, rings, and patches. The bill contains many safeguards including required training of participating pharmacists and a patient screening protocol and other rulemaking developed in conjunction with the state health commissioner, medical expert consultation, and the Indiana Pharmacy and Medical Licensing Boards.

Pharmacist participation is voluntary, and they cannot be forced to prescribe based on moral, ethical, or religious objections. The medication must not be an abortifacient; pharmacists who prescribe for the purposes of abortion would face felony charges.

Additionally, the bipartisan bill's authors Reps. Rowray, Negele, Vermilion, and Fleming, recognized the importance of the involvement of the patient's physician or other provider to assure continuity and quality medical care. The bill includes requirements that the patient be referred to her provider when the hormonal birth control is prescribed, that a written record of the product be given to the patient with the advice to consult with her provider, that the pharmacist's prescription is limited to six months, and that the patient must see her provider within 12 months of the original prescription. I anticipate that additional safeguards will be added in the rulemaking process. HB 1568 easily passed in the House. But in the Senate, it entered rough waters. In the Senate Health Committee, although most

The legislation eventually passed with Committee Chairman Charbonneau not accepting any proposed amendments. HB 1568 was then recommitted to the Appropriations Committee where it also faced continued criticism but also earned committee passage. To my surprise, the bill passed in the full Senate unamended.

Opposition was based on refuting the fact that there is a physician (or other women's health provider) shortage, and that pharmacist participation will not actually increase access. Opposition also contended that self-administered hormonal contraception is not very effective in preventing unplanned pregnancy and doesn't necessarily impact infant and maternal mortality or abortion rates. the bill is on its way to the that hormonal birth control is extremely dangerous, and that this prescribing is best left to physicians. Their objections are unfounded.

> In reality? Indiana has one of highest maternal (third highest) and infant mortality (ninth highest) rates in the country. It has been clearly demonstrated in the public health literature that unplanned/unintended pregnancies are related to increased maternal and infant mortality. When easily available, self-administered hormonal contraception significantly prevents unintended pregnancy. Onethird of Indiana counties are federally designated as physician shortage areas and that "maternity deserts" are widespread. The high

prevalence of pharmacies in underserved areas will increase access.

I do not generally support pharmacists providing medical services unless the rationale for doing so is compelling. Providing immunizations and smoking cessation medications are two previous successful examples.

Pharmacists prescribing birth control has been demonstrated in 24 states as very safe when the legislation is thoughtfully written and contains the types of safeguards contained in this bill.



# From humble beginnings – a journey

My story is one of hope & faith, an abundance of gratitude, forgiveness - and above all, honesty.

Since emigrating from Iran in 1977 at the age of 16 with little resources of my own, I've enjoyed turning challenges into opportunities. Today I am a businessman, entrepreneur and philanthropist who never gets tired of giving back to my community. As a candidate for District 5 on Noblesville's City Council, I hope to be able to achieve better than I've been able to previously.

Initially landing in Bowling Green, Kentucky, I graduated with honors from Bowling Green High, then entered Western Kentucky University to complete my undergraduate work. After earning a multi-major degree in chemistry, animal science agriculture, and computer network engineering, I attended Medical School in the Dominican Republic. Upon graduating I returned to the States as a citizen, moving to Indiana in 1985. While my wife attended law school, I was busy building my first business as a computer consultant.

In 1990, I was a happily married 29-yearold with a two-year-old son. With both my construction company and my computer consulting firm's success – along with my wife joining a reputable firm, we thought that we had it made. And we did, that is until my wife's glioblastoma cancer diagnosis only six months after moving to Noblesville. It was during this time that I found Christ. Two weeks post-diagnosis, she underwent brain surgery and was subsequently placed in a coma for an extended period. Our amazing community rallied around us even though we were newcomers. For over eight months, our wonderful neighbors helped to keep lunch and dinner on the table, daily. They were able to lend an ear or a hand whenever we needed one. Everyone suffers from a low point in their lives. Mine was during this period. Through paying for her treatments, we were quickly losing everything that we had built through our hard work and fortitude. Looking back, I can still distinctly remember the night that she was placed in a coma. It was that very night that I made an oath to Christ. I promised to dedicate my life to paying it forward if he would just deliver me from my internal pain and angst. Almost immediately, I began to feel a sense of relief. Despite all our efforts, my wife passed away 16 months after her diagnosis. Our son, Abrahim, was now four years old.

#### **Building From the Rubble**

The Fall of 1992. I became employed with a local accounting firm, working 80 to 90 hours a week. Having all our savings swallowed up by medical bills, I was doing everything that I could to ensure that the financial woes that I was experiencing would never happen to me - or my family – again. With the help of an amazing person, Terri Zeigler, I was able to work as much as I could and help build us back up to where we needed to be. Terri, also being a believer in Christ, helped me learn how to walk closer with Him.

For the next three years, I could rely on Terri to help me in caring for and raising my son. Throughout the next few years, Abe and Terri formed an unbreakable bond. This led to love blossoming between Terri and I. We were married in 1996 and would spend the next eight years fervently attempting to expand our family. When all routes had been exhausted, we were overjoyed to adopt our newborn daughter, Ava, welcoming her home in June 2004. Terri has been my rock and I am forever grateful for her support, patience, love, and her understanding.

Up until the early 2000s, my main goal wisely, ensuring my family's future. With four love of architecture, history, and its preservation. Being involved in this project let me build on my love of historic buildings, but I was now hungry for more. In 2001, I purchased the Model Mill building. After a three-year renovation project that included refinishing floors, replacing windows, carving out new spaces, adding modern fixtures, and so much more, I was able to quickly fill the space with tenants. Peterson Architecture was the building's architect and first tenant.

cess, I became more engaged with the public, substance abuse and dependence. I wanted and enjoyed getting to know them better. As the community and I grew to know and respect each other, I began to celebrate their successes, while also helping them identify their needs.

Early 2006, I helped form the SW Quad Neighborhood Association – promoting homeownership, as well as providing beautification opportunities, community events and neighborly camaraderie to those living in the SW Quad. We started neighborhood cleanup initiatives, along with beginning our annual SWQ Proud Heritage Picnic tradition. One of the historic homes from the 2005 move is now located on the corner of 8th & Walnut Streets. Not only was I, and still am, heavily involved with the residents that make up the Quad, I enjoy knowing that I've helped provide food for area residents in need, through my sponsorship of the Community Garden located there.

### **Learning to Adapt**

The stock market crash of 2008 affected several of my companies, my business tenants and my plans - greatly. As tenants moved from the newly renovated Model Mill building, I was eager to find a more fulfilling purpose for the space. In 2010, the Mill Top Banquet & Conference Center opened for business. In 2013, I felt that I needed to do more for my community. God was calling me to make an even bigger impact. It was then that I decided to start giving others second chances. I began accepting applications from and interviewing those who had been offenders. They were model employees, who were eager to do a great job and were humbled to be employed when all others had turned them away. I've always believed that "Your past is your past. Learn from it, then leave it where it belongs ... in your past." I feel good, knowing that I have been able to change the lives of several of my employees. Sometimes, they just need someone to believe in them, so that they can really shine as a person.

more for my neighbors. I felt that this issue needed some attention. This is when Hope & Recovery Centers, Inc was conceptualized. The plan was to create a faith-based ministry, serving those with addiction. I spent the following years networking with other service providers, observing the processes, analyzing the risks, and learning all that I could about how I could help address this need.

Through obtaining this knowledge, I worked with leaders in the field to create a program that addressed the needs of possible recovery center residents, helping to tackle their issues at the source. This faith-based program was broken down into several steps, being carried out over a two-year period. In the Spring of 2016, I purchased a church property at 2140 Greenfield Avenue. In doing so, I funded and managed an existing children's ministry located in that church. The building was leased to Legacy Church, who occupied it for the next five years. When their lease ended in 2021, the church relocated, and I was ready to carry out my next 'Act of Love' for Noblesville. It was then that I began the process of meeting with Miller Care Group, a local provider spejumped on board, along with Step Up Staffing. Step Up is not quick to turn offenders away, letting their employees' work ethic speak for itself. Step Up, like I, had also learned that sometimes good people make bad choices, and just needed someone to give them a second chance. I feel that our plans for a facility and the resulting positive impact have so much to offer. After careful studies, I have placed the building on Greenfield Avenue up for sale to raise funds and am currently looking in Marion County for a facility to purchase. Although the facility would not be in Noblesville, the effect will be felt in surrounding areas. I feel compelled to keep reaching out to the community – in any capacity.




#### **Keeping My Promises**

I was ready and able to start paying it forward on a larger scale than I had been able to previously. Now a thriving business owner, I wanted to do more in the community that my family and I loved so much. In 2005, through a partnership with Noblesville City Hall, I acquired three historic homes. I concentrated on having them relocated and preserving their histories. The 2005 'Parade of Homes' was a memorable day for many Noblesville Residents. 
#### **Continued Efforts**





Health departments are are not high-paying," said often given an infusion of federal dollars after a public health crisis such as COVID-19, but those dollars eventually dry up. The Center for Disease Control and Prevention is awarding grants to help local health departments build up infrastructure, but that only benefits larger departments.

"Our other health departments are missing out on that funding," Dearth said. "The state does have a plan to try and help some of the local health departments."

For several years, Indiana has ranked far below other states in per-capita funding for public health. Public health workers are the ones who inspect gro-

cery stores and restaurants. They also test air and water quality after an environmental disaster.

'Summer is coming up soon," Dearth said. "We have those back-to-school clinics happening with local health departments to make sure the kids are fully vaccinated, measles, mumps, and rubella. Not just COVID. Health departments do lots of things outside COVID."

Dearth is hoping the legislature will pass Senate **Bill 4**, which, among other things, allows local health departments to enter into contracts or approve grants for core health services.

She also says student loan forgiveness for health workers entering the workforce may help them stay in the profession longer.



# Be alert for post-disaster fraud

After disasters, con-artists and criminals may try to get money or steal personal information through fraud or identity theft. In some cases, thieves try to apply for FEMA assistance using names, addresses and Social Security numbers they have stolen from survivors. Indiana residents recovering from the March 31 and April 1 severe storms and tornadoes need to pay attention for these risks and protect themselves.

### Fraudulent applications

If a FEMA inspector comes to your home and you did not submit a FEMA application, your information may have been used without your knowledge to create a FEMA application. If this happens, inform the inspector that you did not apply for FEMA assistance, so they can submit a request to stop further processing of the application.

If you did not apply for assistance but receive a letter from FEMA, please call the FEMA Helpline at 800-621-3362. The Helpline will submit a request to stop any further processing of that application.

If you wish to apply for FEMA assistance after stopping an application made in your name without your knowledge, the FEMA ing information to a person Helpline will assist you in creating a new application. Other disaster-related

FEMA Disaster Survivor Assistance teams, housing inspectors and other officials will be working in areas impacted by the March 31 and April 1 severe storms and tornadoes. They have official identification badges with photo IDs. FEMA and U.S. Small Business Administration representatives never charge applicants for disaster assistance, inspections, or **consumer.com**.

help in filling out applications. Don't believe anyone who promises a disaster

grant in return for payment. Be careful of unexpected phone calls or visits to your home from people claiming to be FEMA housing inspectors or people claiming they work for FEMA. FEMA inspectors will have your FEMA application number.

Don't give your bankclaiming to be a FEMA housing inspector. FEMA inspectors are never authorized to collect your personal financial information.

#### Take action

If you believe you are the victim of a scam, report it immediately to your local police or sheriff's department. Consumers may also report charity or disaster scams to the Consumer Protection Division of the Office of Indiana Attorney General online at indiana-

Keith also loved flying. He learned to fly when he was 14 and helped ferry military planes in northern Indiana during World War II. Later he owned his own planes and was able to go flying on his 90th birthday.
