See what it takes to run Westfield schools with Shamrock Academy

With the motto "Educate, Experience, Engage," Shamrock Academy offers parents and community members in the Westfield Washington School (WWS) district an up-close, behind-thescenes look at what it takes to run a successful school district.

In the glove compartment, I found an Indiana Certificate of Vehicle Registration. It included my current address. It displayed the Seal of the State of Indiana. It was approved by the State Board of Accounts. Clearly, the document would be OK'd by a state-run license branch.

I re-entered the BMV, excitedly waving the Holy Grail of home address proof, then I handed it to her. She waved it off. Again, the headshake.

"We don't accept that."

"You're kidding?"

She shrugged.

"But it's a vehicle registration approved by the State."

"I'm sorry," she said.



Rowland developed a plan to help the Old Southside Neighborhood recover after flooding and had a fire station built at Herriman Boulevard and Greenfield Avenue. She also led the restoration of downtown and created a community Thanksgiving dinner.

Rowland was given a Sagamore of the Wabash by Governor Evan Bayh and served on the Noblesville Common Council following her time as mayor.

Dennis R. Redick (1996-2003)

Prior to becoming mayor, Redick served 20 years as a firefighter. He revived the Fourth of July Fireworks Festival. Redick served on the executive committee of the Indiana Association of Cities and Towns. He also created a corporate campus for 146th Street on the city's southeast side.

During his tenure, Redick supported additional facilities, equipment, and salaries for public safety.

John Ditslear (2004-2019)

A veteran of the U.S. Navy, Ditslear moved to Noblesville in 1966 and was an active civic and community leader before becoming mayor.

Ditslear led the addition of several quality-of-life initiatives within the city, including Hamilton Town Center and the conservation of green space. The city expanded its trails system and added Dr. James A. Dillon Park, Federal Hill Commons, and purchased 200 acres for Finch Creek Park.

Ditslear oversaw the improvement and expansion of roadways throughout the city, including the introduction of roundabout intersections and the construction of 146th Street across Noblesville. Additionally, Ditslear improved the ability for residents to volunteer and has increased community engagement. He currently serves on the Board of Public Works & Safety.

David Moss briefly served in a mayoral role when Noblesville was incorporated as a town in 1851. The first mayor of Noblesville was Edgar C. Wilson in 1887. Since him, 21 other men and two women (Patricia Logan and Rowland) have served as mayors.

The annual Fourth of July Parade through downtown Noblesville kicks off the city's July 4th festivities at 4 p.m. Participants are encouraged to incorporate the city's bicentennial theme into their parade entry. Registration to participate in the parade is \$25 (501(c)(3))nonprofits are not charged) and entries must be submitted by Wednesday, June 28. Forms are available at NoblesvilleFireworksFestival.com.

The parade kicks off the city's Independence Day celebration. The free Fireworks Festival will take place at Forest Park from 6 to 10 p.m. with The Flying Toasters performing on the main stage. The day will culminate with the annual fireworks show at 10 p.m.







Shepherd's Center & United Way "Go All IN" for local senior citizens

Shepherd's Center of Hamilton County (SCHC), 1250 Conner St., Noblesville, has partnered with United Way of Central Indiana to "Go All IN" to meet the needs of Hamilton County senior citizens.

Thirty volunteers from Allied Solutions, Trans America, and Ivy Tech recently packed 60 care packages valued at \$35 each and delivered them to Hamilton County's financially fragile seniors. Care packages include personal care items that seniors are unable to get at a food pantry. They consist of toilet paper, soap, shampoo, paper towels, and other household items.

SCHC collects personal care items throughout the year and delivers them to low-income seniors each quarter. If you, your family, or your organization would like to donate care package supplies or participate in care package assembly or delivery, please contact SCHC Programs Director Lisa Albano at lisa@scofhc.org.

In addition to care packages, SCHC provides free resources to help Hamilton County seniors aged 55 and over to age in place with the dignity they deserve, as long as safely possible. SCHC facilitates this through five signature programs: Together Today, Reaching Resources, Community Caring, Counseling, and Guardianship. 
Rep. Spartz also met with the government of Sweden and issued the following statement upon her

This exaggerated posturing ignores the apology and is an absurd bullying of a group which calls itself


I'm not a member of the Moms group, being a non-mom myself. But I write because I dislike minor league politicians trying to score points as Ford is doing.

This weekend is a big one for high school basketball in Indiana, as the Indiana Basketball Coaches Association and the IHSAA are conducting the 18th annual Boys Team Showcase in Memory of Charlie Hughes.

A total of 159 teams from across Indiana are participating in the tournament, and Hamilton County is hosting all of them. Six different sites are being used for the event: Carmel High School, Carmel Middle School, Clay Middle School, Carmel Dad's Club, Westfield High School and Westfield Intermediate School.

Games began on Friday, with two Hamilton County teams playing in two contests. Fishers was at Carmel High School's Eric Clark Activity Center, and won both of its games easily. The Tigers defeated Plainfield 79-48 and Chesterton 76-41.

Meanwhile, Guerin Catholic played at Westfield High School's Fieldhouse, and won both of its games as well. The Golden Eagles, last season's Class 3A state runner-up, beat Fort Wayne Carroll 56-51 and Scottsburg 62-54.

Six more Hamilton County teams will begin playing games today, while Fishers and Guerin Catholic will finish out their schedules of games. A schedule for each school is listed below.

Noblesville's Ava Bramblett named 2022-23 Gatorade Indiana Girls Soccer Player of the Year
