

# Community First Bank give \$25K to Westfield Library Foundation

Donation will fund playhouse & seed library at new building

Community First Bank (CFB) of Indiana has donated \$25,000 to the Westfield Library Foundation to support the library's new building set to open next year. \$15,000 will be dedicated to creating a playhouse in the Children's Department, while \$10,000 will be used to establish a new seed library for gardening enthusiasts.

CFB's generous donation will fund one of three playhouses in the new library that are part of a larger mock town. The seed library will provide a space

We're continuing our series on reducing our mental labor. For the next couple of weeks, we'll focus on shopping and meal planning.

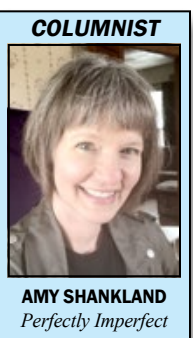
Groceries. Personal hygiene items. Pet food. Prescriptions. Clothing. These items are necessary for most households, but they don't magically appear when we need them. (Damn it!)

For groceries and most personal items, you can always go the delivery or pick-up route.

In central Indiana, I've used Shipt, a service that delivers things from local stores. Of course, there are other options, but this is the one I'm most familiar with.

With Shipt, you simply select what you need online using an app or visiting their website. You pay an annual fee of \$99 or \$10.99 a month. Prices on some items are slightly higher than what you would find in the store, although they have many things on sale each week. And you should tip your shopper.

This all may sound too expensive, but if you are often guilty of making impulse buys, you could come out even. I know I'm not the only one who runs to Target to buy a few things and ends up coming home with 20!

# AG Rokita makes statement after Supreme Court's public reprimand

In September, the Indiana Supreme Court Disciplinary Commission filed a complaint against Indiana Attorney General Todd Rokita, claiming three counts of professional misconduct regarding his handling of the case of Dr. Caitlin Bernard – the doctor who performed an abortion last year for the 10-year-old rape victim from Ohio.

The case drew national attention after Dr. Bernard shared the story with *The Indianapolis Star*. The complaint sought disciplinary action against Rokita.

The Indiana Supreme Court Disciplinary Commission reprimanded Rokita on Thursday. The reprimand came with no sanctions, no suspension of his license to practice law, and no fines. He will, however, have to pay \$250 in court fees.

Grocery pick-up services are also convenient and not as costly. I use Kroger's free grocery pick up (for orders \$35 or over). Other stores charge around \$5 per order or a little more for expedited pick up. Most of these services are similar. You place your order online and select a future pick-up time. Then at that designated time you pull into the parking lot and slip into one of the marked spots. From what I've seen, you are not expected to tip these shoppers.

I think these services are brilliant for many situations. When you're sick, it's wonderful to be able to stay home and rest, or at least

just drive up to the store and sit inside your vehicle versus dragging your nearly lifeless body inside the grocery. And your fellow shoppers are probably grateful that you're not sharing your icky germs.

If either of these services had been available when my kids were little, I would've taken advantage of them! My nephew's wife had a baby right before Christmas years ago. She posted on Facebook about how relieved she was to be able to use Shipt and not worry about exposing her precious little girl to a bunch of germs. I hadn't thought of this benefit, but

it sure made sense.

Once again, I know many people might be reluctant to try this service. When I first started to use Shipt, some of my friends wondered if the shoppers would be as particular about selections as I would be. Wouldn't they also make some errors? But I've found that most shoppers are as picky as I am, especially with produce. And if they ever are in doubt about something, they typically text me.

They do make mistakes occasionally. I'll never forget the time I ordered a five-pound bag of rice and ended up with a 20-pound one. At least we didn't run out of rice for six months! But shoppers are human and most of these errors are not the end of the world.

Despite the failed attempt to derail our work – which could have disenfranchised nearly 2 million voters, the largest amount in Indiana history for any state office candidate – it all boiled down to a truthful 16-word answer I gave over a year ago during an international media storm caused by an abortionist who put her interests above her patient's. I received a 'public reprimand' for saying that "...we have this abortion activist acting as a doctor – with a history of failing to report."

The media, medical establishment and cancel culture, all on cue, supported – and then attempted to vindicate – the abortionist who intentionally exposed personal health information at a political rally all in furtherance of their shared ideological and business interests.

These liberal activists would like to cancel your vote because they hate the fact I stand up for liberty. In the healthcare space alone, I stopped the vaccine mandate, publicly contested severely flawed Covid data, significantly curtailed Indiana's abortion business and fined hospitals and healthcare providers for not putting patients' privacy first.

Having evidence and explanation for everything I said, I could have fought over those 16 words, but ending their campaign now will save a lot of taxpayer money and distraction, which is also very important to me. In order to resolve this, I was required to sign an affidavit

without any modifications.

Now, I will focus even more resources on successfully defending Indiana's laws, including our pro-life laws, and fighting the mob that silences parents, employees, conservative students, law enforcement, Believers of all faiths, American patriots and free enterprise itself.

As I said at the time, my words are factual. The IU Health physician who caused the international media spectacle at the expense of her patient's privacy is by her own actions an outspoken abortion activist.

Many know that she openly discussed with a reporter, and caused to be identified, a 10-year-old rape victim at a political rally. She also used this opportunity to wedge herself into various media outlets, including MSNBC and CBS News. In the end, she had the attention of the entire country, including the pro-abortion President and Vice President.

Less well-known is that for years she has appeared as the keynote speaker at pro-abortion rallies and has roamed the hallways of the legislature in a white lab coat attempting to influence lawmakers. Then, in 2019, the doctor unsuccessfully brought litigation against the people of Indiana to legalize a brutal abortion procedure where the living child is extracted piece by piece. She also poses and is interviewed regularly in media outlets and her full-time patient

practice focuses exclusively on performing abortions.

Bernard also claims a tattoo – an image of a coat hanger – that she displays and openly discusses with the national media. Whether you think this behavior is good or bad, I challenge any objective Hoosier to conclude that she isn't an "abortion activist," as I stated.

Also, according to media accounts and complainant press releases, it was in fact publicly alleged well before my TV interview that the abortionist had failed to properly report her work to the state's department of health.

Privacy must exist between doctor and patient in order for trust to exist so that healthcare can advance. So, we work hard to protect personal health information – like a little girl's identity and medical trauma – from publication by their caregivers. This is why Bernard's own peers fined her the maximum allowed by law.

By the way, the Office of Attorney General has nearly two dozen patient privacy cases pending at any time, debunking any claims of a vendetta against Bernard.

Had the cancel culture establishment been successful disenfranchising us, they also would have stifled other elected officials from keeping voters, citizens, and taxpayers informed – especially when uncomfortable facts fall outside a preferred narrative.

I thank Hoosiers for their continued support as we fight for our values.

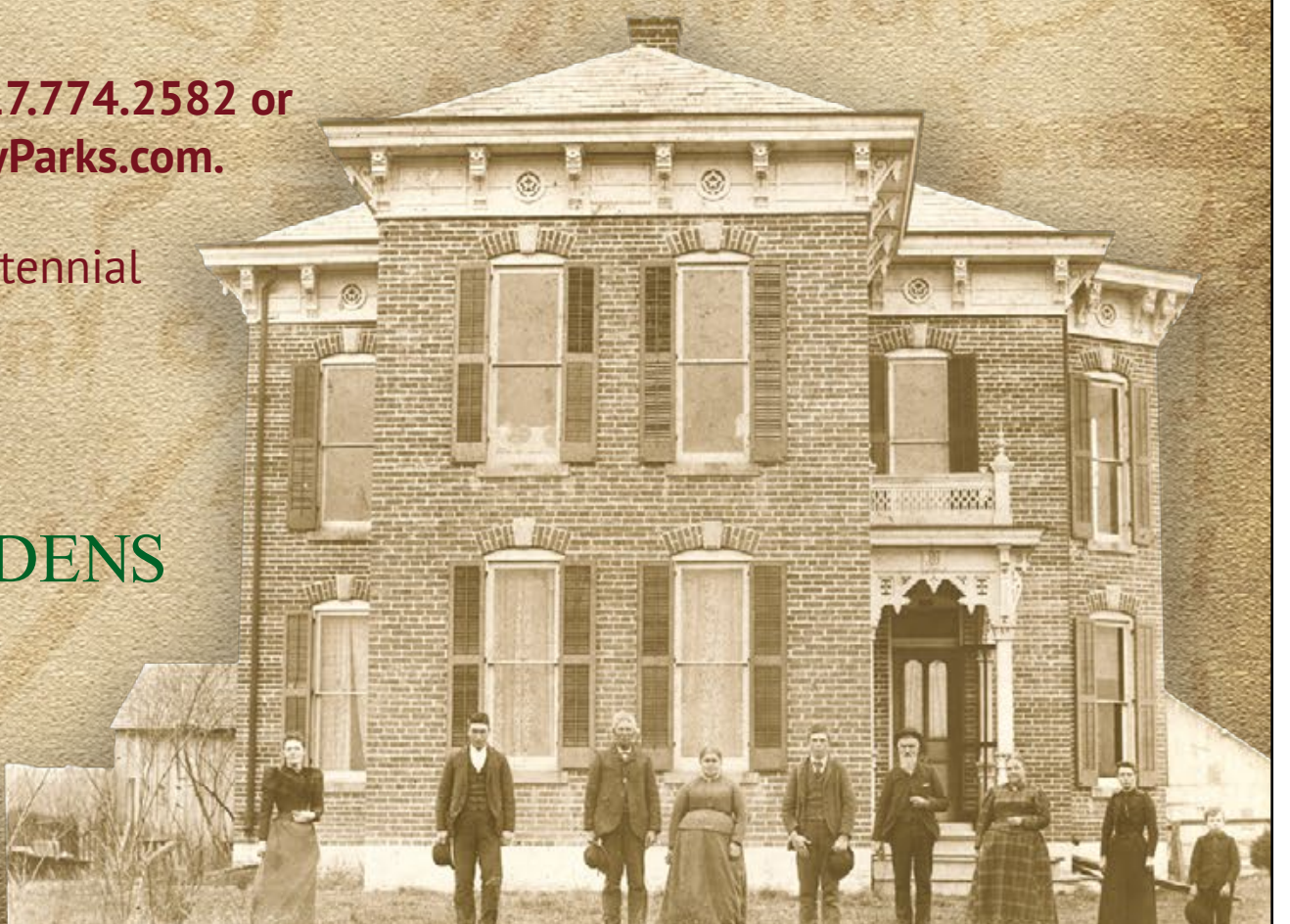

## Study: Carmel economy sees big boost from arts & cultural activities

Nonprofit arts and cultural activities in Carmel generated \$42.7 million in economic activity last year, according to the latest [Arts & Economic Prosperity study](#) conducted by Americans for the Arts.

The total includes \$17 million in spending by arts and culture organizations and \$25.7 million in event-related spending by their audiences. Nearly 49 percent of the people attending local arts and cultural events in 2022 came from outside Hamilton Coun-

ty, according to the study, for which the Center for the Performing Arts and its Resident Companies assisted in gathering data. All that activity supported the equivalent of 981 jobs and generated \$10 million in local, state, and federal government revenue.

Notably, more than 77 percent of the responding attendees agreed with this statement: "I would feel a great sense of loss if this activity or venue were no longer available."

# Eighth Street reopening date, new townhomes, budget details & more in Noblesville

October was action-packed in the City of Noblesville. We approved a budget, shared the State of our City, and so much more. Before we jump in, a few things I wanted to be sure you knew:

- The Nickel Plate Trail is open. **It looks great** and you should give it a look.
- Costco is headed to Noblesville – and it’s opening soon. You’ll be able to shop there later this month.
- We have some pretty incredible employees in our Police and Fire Departments. We recently celebrated those with milestones. **Take a look at those folks here.**

Without further ado, here’s the latest happening in the ninth-largest city in the State of Indiana:

- 1. We passed a budget.**  
In last month’s email, I did a deep dive into the budget. If you’d like to see the specifics of that message, **click here**. There are lots of important programs within the budget, but here are five that I think are important for you to know you are helping to fund:
  - **Protecting Brick Streets**
  - **Assessing next steps for an additional fire station in Noblesville**
  - **Expanding Boden and Olio roads**
  - **Building sidewalks in**

**Old Town**  
• **Preparing for a new (and much-needed!) public safety building**  
Have any questions on the budget? I’m happy to field them.

**2. The State of Our City is Strong.**

Chris Jensen took Noblesville’s story on the road on Tuesday, sharing the latest projects with more than 600 people at the Chamber’s State of the City. I was grateful to introduce him on behalf of the Council.

A few notes that I hit on in my remarks:

- Working alongside Mayor Chris Jensen, we have paved roads on the west side, built roundabouts on the east side, and preserved brick streets downtown.
- We’ve doubled down on the people of Noblesville – talking openly about mental health and advocating for those with disabilities.
- We’ve made our city safer with record investment in the men and women who serve and protect us each and every day.
- And we’ve seen more than \$1.5 billion worth of private investment in our city.

We’ve bet on Noblesville in the past four years – and I know we are just getting started.

**3. Eighth Street is (almost) open!**  
Over the last few months, the team has made strong progress on Pleasant Street extension. I’m excited to share that 8th Street is set to reopen NEXT WEEK! The bridge over the White River remains under construction – look to completion on that portion of the project next year.

Project Overview: As a reminder, the Pleasant Street project is a multi-year initiative to improve east-west connectivity in Noblesville. The project will be completed in three phases, the first of which is currently underway.

- Phase One: River Road to 10th Street
- Phase Two: 10th Street to State Road 37
- Phase Three: River Road to State Road 32

**4. New townhomes proposed at Moontown Road & SR 32**

Last month, Lennar proposed 50 front facing, three-story townhomes which will have rear entry garages accessed via alleys. The proposed project is just north of Moontown and SR 32.

In the past, I’ve voted no on townhome proposals simply because I felt they didn’t meet the bar for our community. These brick townhomes on the west side will be a great addition to Noblesville. I hope to see more like them down the road.

The **Indianapolis Business Journal** picked the sto-

ry up and shared a quote of mine from the project’s introduction at Council: “This is a really strong town home product and really elevates the game,” City Councilor Aaron Smith said. ‘I would like to show something like this to other developers that are coming in that are looking at creating those type of products.’”

**5. Reimagining Development: Cuyahoga County, Ohio**  
As Noblesville grows, development will play a key role in building the vision the city sets for its future. Each month, I try to share some of the examples of new development I’ve seen that I believe we should look to as inspiration down the road.

Cuyahoga County launched a search for a new or renovated home for its courts and the market responded with seven options. One of them was presented by DMD Development Group. It proposes to demolish the entire Justice Center complex and replace it with eight lower-slung buildings, each of them evoking or replicating a historic structure that once stood in downtown Cleveland.

# Statewide mental health initiative to receive support of legislature next year

Noblesville Mayor Chris Jensen has announced the Indiana Community Cares Initiative, a statewide program that would enable communities to invest in proactive and sustainable paramedicine resources designed to rehabilitate at-risk Hoosiers while reducing public safety expenses across the state of Indiana.

“Indiana has been a leader throughout the nation in helping to erase the stigma around mental health. It is now time to put words into actions,” Jensen said. “Communities across Indiana are starting to make serious investments in mental health resources. These resources are showing signs of improving our state’s overall health and wellness, but a more holistic approach is needed for all Hoosiers.”

The Indiana Community Cares grant program will allow cities and towns that have invested in a paramedicine program or a mobile integrated healthcare program to apply for an annual \$150,000 grant to be used to fund the critical human infrastructure needed for the paramedicine program.

For example, in many communities, the missing component to a more holistic set of services has been

access to a licensed clinical social worker to collaborate with first responders on response and intervention strategies. Jensen said this grant will be applied for annually, with a three-year sunset provision.

“The goal is to incentivize municipalities to invest in paramedicine programs that will enhance lives and ultimately be a cost-saving measure for our state,” Jensen said. “In addition, the program will seek to explore incentives for those individuals seeking mental health accreditation or degrees to stay in Indiana to continue to build a Hoosier talent pipeline to meet demand.”

In 2020, Noblesville launched the NobleACT program, a proactive paramedicine program aimed at strengthening community-based responses through a partnership with the city’s police and fire departments and area service providers. Since its inception, the NobleACT program has responded to more than 6,000 calls for help to appropriately address issues

the help of therapy dogs Luna, Carbon, and Sadie.

“This investment has shown great success in giving a hand-up to our at-risk citizens and helping ease the burden on our public safety department, which makes up 50.1 percent of our annual operating budget,” Jensen said. “Localities in Indiana and throughout the country have been in communication with Noblesville to attempt to implement similar programs in their communities.”

Noblesville and Hamilton County worked with the legislature in 2021 to support House Enrolled Act 1118, which allowed for more effective information sharing of individualized mental health safety plans between first responders and healthcare providers to improve treatment outcomes and decrease instances of repeat mental health crisis calls for service.

Sen. Scott Baldwin (R-Noblesville) will champion legislation authoriz-

ing the program during the 2024 legislative session and continue to work with executive branch agencies and other stakeholders to implement best practices.

“As a retired police officer, I’ve seen firsthand the challenges of untreated mental health in our communities,” Baldwin said. “The success of Noblesville’s NobleACT program underscores the need for proactive approaches like the Indiana Community Cares Initiative. I’m committed to advancing this vital initiative, enabling Indiana to partner with communities in an effort to ensure every Hoosier receives the support they deserve.”

Mayor Jensen, who serves as chair of the Accelerate Indiana Municipalities Legislative Committee, has prioritized mental health and wellbeing initiatives throughout his time in office. His administration has also worked to increase access to wellbeing and treatment resources for public safety and city employees and their dependents. He also worked with Noblesville Schools to launch the Noblesville Wellbeing Coalition and hosts “Mental Health Mondays” on Facebook Live with a local licensed mental health therapist.

# Using voice search? Use caution when asking for auto dial from a smart device

Tell Alexa to play your favorite song. Ask Siri about the weather. Use Google Assistant to turn down the air conditioner. But don’t ask your smart device to look up a phone number, because it could accidentally point you to a scam.

**How the scam works**

You need the phone number for a company, so you ask your home’s smart device, which might be Google Home, Siri, or Alexa, to find and dial it for you. But when the company’s “representative” answers, you start to notice some red flags. This representative may insist they can only help you if you make a payment by wire transfer or prepaid debit cards. Other times, they demand remote access to your computer or point you to a scam website.

One recent victim reported to **BBB Scam Tracker**: “I used Siri to

look up the United Airlines customer service line. Somehow, the call was connected to a different company ... The agent pretended to be a United Airlines agent and said he could help me cancel my flight. The fee was \$125. I was convinced it was United Airlines, but the next day I realized my mistake. They said they would refund my money, but only after I threatened to call the police. I’m still waiting for a refund.”

In another version of this scam, a consumer tried using voice search to contact Roku with a question about setting up their device. Instead, someone pretending to represent Roku charged them an \$80 “activation fee” for a service that doesn’t exist.

In all versions of this scam, the “representative” isn’t from the company you were searching for at all. Instead, scammers created a fake customer service number and bumped it to the top of the search results. These

bad actors hope that when consumers do a voice search using Siri, Alexa, or another device, the algorithm will accidentally pick their scam number and an unsuspecting victim will contact them directly.


**Tips to avoid this scam**

- **Be careful when searching for support phone numbers.** Rather than doing an online search or letting your smart device look up a number, use the contact information on the business’s website (always **double check the URL**) on your bill, receipt, or in your confirmation email.
- **Beware of fake ads.** Scammers **create bad ads** with fake customer service numbers. Using voice search to find a number can make it harder to tell a phony listing from the real one. Get your information from the official company website or official correspondence.
- **Go straight to the source.** For example, if you need to get in touch with Amazon, use the Amazon

mobile app or website. This goes whether you’re seeking customer service, tech support, or when looking to make changes to your account. Visit the Message Center on Amazon.com or on the official app to review authentic emails from Amazon. Remember that reputable companies like Amazon will never ask you to provide payment information for products or services over the phone.

- **Make payments with your credit card.** It’s easier to dispute a credit card payment. Paying by wire transfer or pre-paid debit card is like using cash. There is almost nothing you can do to get the money back.



# Royals vs. Knights: who will be crowned state champion?

*Southeastern takes on Castle with 4A trophy & perfect season on the line*

The Hamilton Southeastern volleyball team has an opportunity to join some exclusive clubs on Saturday evening.

The Royals travel to Ball State University that night to play in the Class 4A state championship match. Top-ranked Southeastern will take on No. 5 Castle in the 4A final, which is scheduled to start at 7 p.m., following the state title matches in the other three classes.

The Royals won the 4A state title last year, beating Yorktown in four hard-fought sets. Southeastern is unbeaten for the year at 32-0, so the Royals will attempt to be the third school to go undefeated for a season. Yorktown did it twice in 2018 and 2020, while Cathedral was perfect in 2015.

Southeastern is also trying to become the first school to win back-to-back 4A state titles since Avon did so in 2012 and 2013. (New Castle won back-to-back 3A championships in 2017 and 2018, then moved up to 4A in 2019 and won state in that class.)

The last team left standing between the Royals and their goals is Castle. The Knights are 34-3 for the season and are making their seventh appearance at state. Castle was the 2021 4A state runner-up.

The Knights' only losses have been to 3A state finalist Providence, Glenbard West (Ill.) and Terre Haute South. They cruised through the Jasper sectional, taking care of Evansville Central, Evansville Harrison and Evansville North in straight sets for their state-record 41st sectional championship. Castle holds the record for most consecutive sectional titles, winning 26 in a row between 1994 and 2019.

The Knights advanced to the Bloomington North regional, where they swept Franklin Community and No. 8 Center Grove to claim the program's 10th title. Castle then played No. 3 Roncalli in the Jasper semi-state, winning in four sets.

Senior Katie Kopshever is the offensive leader for the Knights with 413 kills, averaging 11.2 per match. Sophomore Emma Bruggenschmidt has 251 kills. Castle has two capable setters in senior Megan Harpenau (535 assists) and junior Maya Joska (524 assists).

Kopshever also leads in digs with 278 for the season, with Bruggenschmidt getting 243 digs and Harpenau 241. Six-foot-two Junior Addison Gallentine is the top blocker with 166, followed by 6-foot junior Emma Watson with 121 blocks.

Meanwhile, Southeastern is riding a 66-match win

streak dating back to the second match of its 2022 season. The Royals have been dominant this year, only dropping four sets over their 32 matches. Only Yorktown and Cathedral took a set off HSE during the regular season.

Southeastern won the Zionsville sectional with sweeps of the host Eagles in the semifinals and No. 10 Noblesville in the championship. At the Homestead regional, the Royals swept Harrison in the semis, then battled with the host Spartans before prevailing in five sets. Southeastern then swept La Porte in the Frankfort semi-state to punch its ticket back to state.

The Royals' offense is led by 6-foot-3 senior Lauren Harden, a Florida commit, who has put down 358 kills this season. Junior Lindsey Mangelson, at 6-foot-2, has 339 kills this year. Senior Macy Hinshaw, headed to Santa Clara, has 595 assists, while junior Ava Hunter has dished out 495 assists.

# Millers ready to hit the court

Noblesville girls basketball coach Donna Buckley said that after "three weeks of practice, I am sure my kids are extremely excited to play a game on Saturday."

The Millers have many reasons to be excited about this season. Noblesville returns its top three scorers from last season, a good nucleus of players with varsity experience, plus some newcomers as well.

"Practices have been good," said Buckley. "We have a nice mix of experience and youth. The young kids are leaning on the older kids to help them find their way."

Those top three scorers are part of a Millers program that has set high expectations: Noblesville has totaled at least 21 wins over the past three seasons, which includes last season's mark of 21-4.

Leading the way is junior Meredith Tippner, who is the top returning scorer (17.6 points per game) and rebounder (9.2) for Noblesville. Tippner is fresh off a soccer state championship.

Right behind her is senior Reagan Wilson. The Iowa State commit averaged 16.9 points last year and led the Millers in assists (4.0) and steals (3.4). Senior Ava

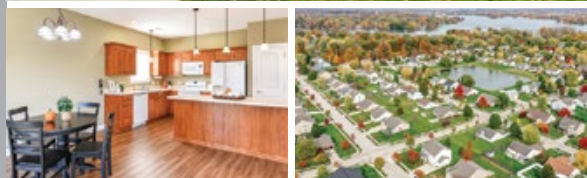

Southeastern starts season Saturday

This year’s Hamilton Southeastern girls basketball team will be young, but the Royals are set to have a very strong season.

Southeastern has one of the top juniors in the state, plus two sophomores who already have multiple Division I offers. Add to that a handful of returning letter winners, and there is quite a bit of potential with this year’s Royals team.

“We are eager to see what this team can accomplish,” said HSE coach Brian Satterfield.

Leading the way is Maya Makalusky. The junior brings back 15.4 points and 3.9 rebounds per game from her sophomore season, second only to her older sister Riley Makalusky, who is now playing at Butler University. Maya is also going the D-I route, as she has committed to Indiana University.

The two sophomores returning are Kennedy Holman and Kayla Stidham. Holman averaged 6.1 points, 4.0 rebounds and 2.8 assists from last season, while Stidham brings back 2.8 points per game.

The three other returning letter winners are juniors Maine Hooks, Kayla Brinley and Addison Van Hoesen. Hooks played in all but one game for Southeastern last year, while Brinley and Van Hoesen saw action in 10 games. The Royals were 21-3 last season.

“It will be interesting to see how the entire group handles the lights being turned on,” said Satterfield. “We as a staff feel they are progressing and getting ready for the challenge, but it is hard to tell until you really get out there to see them in live action. Our scrimmage went well, so we hope that is a good indication as to how our team will perform moving forward.”

Other varsity players for the Royals this year are juniors Abby Brown, Tommi Burton, Abi Clayton and Kenley Johnson, sophomore Antonnette Green and freshman Abby Orme.

“We have had some good team bonding experiences this fall,” said Satterfield. “Our group volunteered at AgriPark in Fishers for an event where kids could play on rides and carve pumpkins. We had them get into two teams and compete at the Escape Room. We hope these team bonding experiences helps to gel this group as we start to get into the

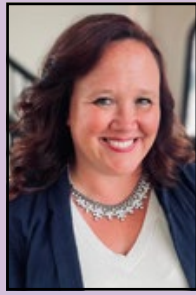
