Remembering Larry Stork and his lifetime of service

On Tuesday, the City of Noblesville honored and remembered the life of Larry Stork on his 88th birthday with the dedication of a park bench. Mayor Chris Jensen also proclaimed July 16, 2024, as Larry Stork Day.

Stork served 35 years on the Noblesville Board of Works and Public Safety and was reappointed by four different mayors. He also served on the Noblesville Common Council from 1980 to 1984.

He proudly served his country in the Army National Guard from 1958 to 1964. He moved to Noblesville in 1962, before Firestone Industrial Products sent him to Canada from 1966 to 1968, but returned to the city in 1968 and lived here until his death on Nov. 19, 2019.

Larry's wife, Sally, and daughters, Erica and Cara, were joined by current Board of Works members John Elmer, Rick Taylor, Laurie Dyer, Jack Martin, and John Ditslear for the bench dedication in Forest Park.

Community First Bank of Indiana (CFB) will hold two Free Shred Days in Hamilton County open to the community.

The Westfield event will be held from 11 a.m. to 1 p.m. on Thursday, July 25 at its branch located at 707 E. State Road 32. Freewill donations will be welcome to support Student Impact of Westfield.

The Noblesville event will be held from 11 a.m. to 1 p.m. on Tuesday, Sept. 24 at its branch located at 17661 Village Center Drive in Noblesville. Freewill donations will be welcome to support Family Promise of Hamilton County.

For both events, all are welcome to drive through the branch parking lot to drop off boxes of documents to be securely shredded with PROSHRED Security. There is a limit of five boxes to be shredded per vehicle, and the event will end once the shred truck is full. All documents will be shredded on-site and 100 percent of the paper is recycled and eventually made into other paper products. Three-ring binders cannot be shredded.

Over time, unused documents like medical records,

credit card statements, and bills can build up in a home or office and pose a security threat. Ensuring that all these items are properly disposed of by using document shredding can prevent this personal information from falling into the wrong hands. Armed carjacking leads to police chase, two arrested in Noblesville

An armed carjacking on Monday afternoon led officers on a chase that resulted in a crash and the arrest of two people, including a juvenile, in Noblesville.

Officials from the Hamilton County Sheriff's Office said the incident originated in Marion in Grant County with a report of an armed carjacking. A police chase ensued along State Road 37 and ended in a crash at SR 32/37 intersection in Noblesville.

Both suspects got out of the vehicle and fled on foot.

Officials at the scene told News 8 that one suspect, identified as a juvenile, went into a Hardee's restaurant parking lot and was arrested. The second suspect fled behind the Hamilton East Public Library, where they entered the building and were arrested inside.

The library is expected to be closed until 10 a.m. Tuesday so that officers can do an "evidentiary sweep" of the building.

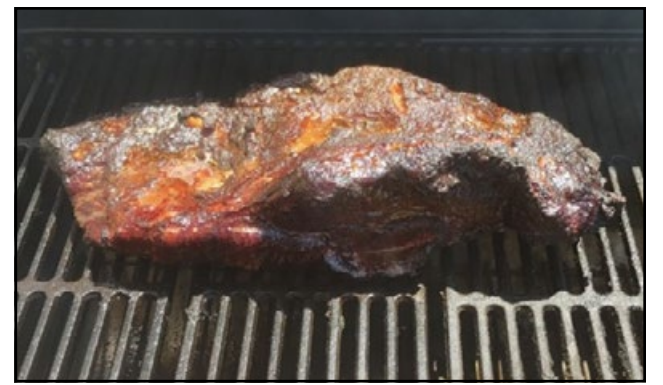

When asked about the involvement of a minor in this crime, Bryan Melton, public information officer for Hamilton County Sheriff's Department, expressed disappointment.

"It's a very unfortunate situation," Melton said. "A lot of us are fathers and mothers that work at our agency and it's tough when you see things like that. I just hope that things get better for them."

Officials say it was a bit shocking for this type of incident to happen midday like this in Noblesville.

"Law enforcement is never shocking because it's something different every day. But for this to happen midday like this, we were very fortunate to have all the law enforcement response that we had, you know, if

you're going to pick a location to do it," Melton said. "This is optimal. The Sheriff's Department is right here, Noblesville is right here. Fishers were coming up 37, we had the Westfield unit to help us out. Indiana State Police helped us out, and we even had an Elwood Police Department vehicle here that happened to go up 37 and saw what was going on."

Police did not say if a firearm or any weapons were located.

No word on the relation between the two suspects.

No additional information was immediately available.

Office of Utility calls for cutting Duke Energy rate hike by more than 60 percent

The Indiana Office of Utility is recommending Duke Energy cut down on its pending rate request by more than 60 percent.

According to a release, Duke Energy requests a \$491.5 million base rate increase from the Indiana

Utility Regulatory Commission. An analysis from the OUCC shows that an increase of \$184.7 million (6.1 percent) is warranted.

Ten OUCC witnesses this week filed testimony with the IURC. In the testimony notes, the most of the increase requested is due to capital projects that received IURC preapproval,

and are now being included in rates as is provided by state law.

"The significant reduction we recommend to Duke Energy's request is based on a thorough analysis by our attorneys and technical staff, and it balances the need for reliable service with the affordability concerns raised by our

staff and by the hundreds of customers who have spoken out on the request," said Indiana Utility Consumer Counselor Bill Fine.

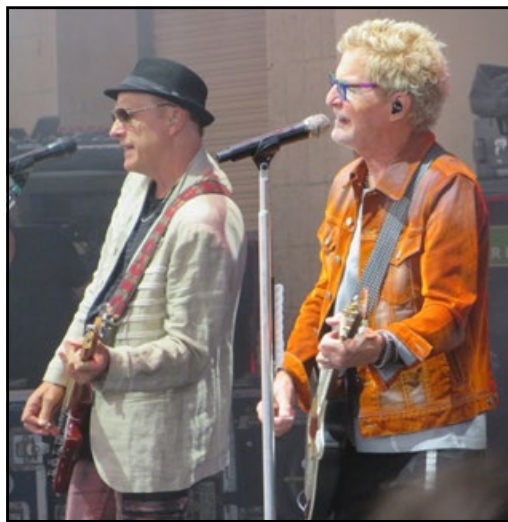

Oakmont resident questions Noblesville's tree removal plan as only solution to fix neighborhood sidewalks

Dear Editor: Recently, residents of Oakmont chatted with the cities of Westfield and Carmel. They use a company called Precision Concrete Cutting to help repair sidewalks. This company is also used by the city of Indianapolis.

The benefits of partnering with this company are the ability to repair sidewalks, save trees, and save taxpayer dollars, which, according to Noblesville Mayor Chris Jensen, "Is always best for the entire community in moving forward." However, despite all these benefits, Mayor Jensen has turned the idea down because it does not guarantee the 20- or 30-year solution he has talked frequently about.

In 2017, the neighborhood of Oakmont was approached by the city and told that 191 trees would be cut down.

In 2018, Precision Concrete Cutting came up with a proposal and cost analysis to share with then-Mayor Distlear, Patty Johnson, City Arborists Vince Baker and John Berry, and Chris Jensen, who at the time was Oakmont's Common Council Representative

for District 2. Jensen was also chairperson on the Roads/Engineering/Traffic Committees in 2017 and 2018.

A meeting was held at Noblesville High School for Precision Concrete Cutting to present their service. City officials were invited; however, they did not attend.

In 2017, the city decided to walk away from repairing sidewalks, and now, the City of Noblesville seems to be walking away from a method that would benefit the city and the taxpayers. Despite urban deforestation being touted as the best method, residents of Oakmont have not been provided with a complete cost analysis, documentation of an environmental impact study, or reports that show the city researched other alternatives to sidewalk repair.

One would ask, if this method is good enough for the cities of Carmel, Westfield, and Indianapolis, why is it not an option for the City of Noblesville? These cities seem to use this method frequently to make sure sidewalks are safe and ADA compliant. Also, if this option will save taxpayer dollars,

why is it not being utilized by the City of Noblesville?

Do these cities care about mature tree canopies more than Noblesville? Do these cities care about saving taxpayer dollars more than Noblesville? Or is there another reason why the administration has decided to move forward?

At the writing of this letter, the neighborhood of Oakmont is well on its way to losing 133 mature side street trees in phase one. The neighborhood of Sommerwood is slated to lose over 100 trees, and it seems that South Harbor, Lockhaven, Forest Hill Estates, and West Haven are also projected to lose trees this year.

The administration likes to paint tree removal as the only option in moving forward, but it is not, and it is not the norm. Other cities across the country and some who are right next to us are able to come up with sensible solutions for their communities, but ONLY IN NOBLESVILLE does every innovative option fail.

Sure is curious.

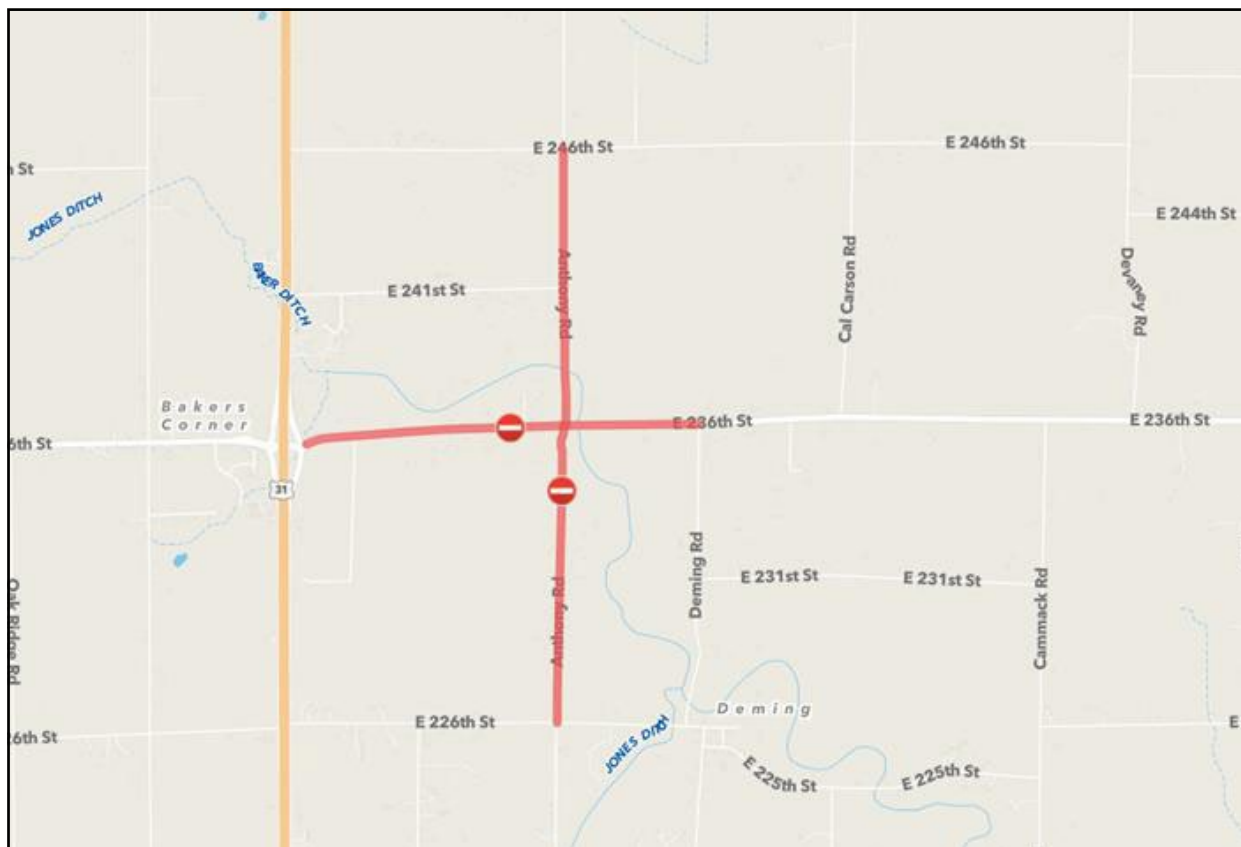

Robb released from hospital, cleared to race in Toronto

AJ Foyt Racing announced on Tuesday afternoon that Sting Ray Robb was cleared to race in this week's INDYCAR race in Toronto.

Robb was injured in a four-car crash during the last lap of the NTT INDYCAR Series race last Sunday afternoon at Iowa Speedway. The crash also involved drivers Alexander Rossi, Ed Carpenter and Kyle Kirkwood.

Robb went airborne after hitting the back of Rossi's car out of turn number two. He then slid down the backstretch upside down.

Kirkwood and Carpenter each lost control their cars in an effort to avoid Robb and Rossi. They would each hit the inside wall. Carpenter's left rear tire actually ended up on top of Kirkwood's aeroscreen.

Rossi, Kirkwood, and Carpenter were okay. Robb was injured in the crash, the Associated Press said Monday.

Robb, a driver for A.J. Foyt Racing, was airlifted to a local hospital "out of abundance of caution for further evaluation." He would soon be released after "further assessment at Mercy One Des Moines Medical Center."

A post from A.J. Foyt Racing on X, formerly known as Twitter, added that

"Sting Ray's family and AJ Foyt Racing would like to extend our gratitude to the AMR Safety team for their quick response, to INDYCAR medical staff for their thorough care and INDYCAR for the high safety standards of our race cars that allowed Sting Ray to walk away from a horrific accident today. Thank you to everyone for your well wishes. We appreciate your support!"

Right before 4 p.m. on Tuesday, A.J. Foyt Racing posted another statement on X. It said, "After a final evaluation by INDYCAR Medical, we are happy to share that Sting Ray has been cleared to compete this weekend in Toronto. He's looking forward to getting back behind the wheel of the No. 41 Goodheart Vet / Pray, com Chevrolet. Thank you to everyone who's reached out and showed their support."

Ninety minutes later, Robb followed that up by posting the following on X: "My family and I are so appreciative of the outpouring of well wishes, support and prayers received. I'm also thankful that no other drivers were injured in that wreck and we've all been cleared to race in the @hondaindy."

Robb has a local connection. He is engaged to Hamilton Heights graduate Molly Mitchell; the couple talked to The Reporter about the story of their meeting. You

Team Penske's Will Power ultimately won the Hy-Vee One Step 250 on Sunday afternoon. News 8 Sports' Andrew Chernoff spoke with Power on *SportsLocker Sunday* and asked him to share his thoughts on the safety of the cars after hearing about the accident.

He said the cars are "significantly safer" with the aeroscreen.

"When you look at the thickness of that glass, and then also the halo device, you could call it – that big frame – that is an incredible

structure to break through," Power said. "Compared to our heads, used to just be hanging out there. Much, much safer situation."

It was Power's second victory of the season and moved him into second place in the current standings. He is 35 points behind Chip Ganassi Racing driver Alex Palou for the championship lead.

The NTT IndyCar Series will race on the Streets of Toronto this upcoming weekend. The Ontario Honda Dealers Indy Toronto takes place Sunday, July 21 at 1 p.m. EDT.
