On Friday, Sept. 6, one Hamilton County woman is organizing an opportunity for people to let Wright know how important he is to the community.

Lisa Blair is a manager at the Culver's in Noblesville. She reached out to The Reporter because she has arranged for an easy way for people to show support for Wright at the Culver's he frequents, which is located at

17651 Sun Park Drive, Westfield.

This Friday from 10 a.m. to 10 p.m., you can stop by to sign cards expressing either your wishes for quick recovery or your appreciation for Wright's 59 years coaching Sheridan football. Blair is calling it "Bud Wright Day."

There is no obligation to buy anything at Culver's if you want to stop by and write a message to Wright.

Blair assures The Reporter there will be a display with photos of Wright throughout the years of his Sheridan football tenure and at least one large card for patrons to sign, thus it should

I see her wearing the cape. It's not a cape she pulls out of her closet. It is invisible. She wears it every day, 24/7.

Only those who have worn the cape can recognize it. They understand its strength and its beauty. They have been caregivers.

She is given the assignment. She will have many questions that no one seems to be able to answer. She will question her decisions ... over and over again. Will she feel it is ever enough that she can do? No. She has to learn to do her best and know that's all she can do.

I was shopping at Horton's Home and Garden in Tipton when I found this book, *Prayers of Hope for Caregivers*. Oh, my goodness. I wish I had this book when I was caring for my mother. The author, Sarah Forgive, writes about how it feels to be a caregiver. She has worn the cape.

As I read the list of chapters, I felt checkmarks being checked. Been there. Done that. Felt that.

When you become a caregiver ... You look around, and everyone seems to be living their life as if nothing is wrong. You, however, are over here trying to figure out how to navigate a life that is out of your control.

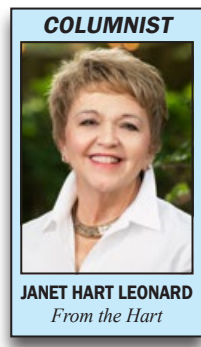
You cannot control what you are not equipped to control. Read that again. You try to do the next right thing ... whatever that is.

You walk into the bathroom, grip the sink counter, and stare into the mirror. The lady looking back at you looks tired and sad. You smile. That smile is a liar. It tells the world you are OK when you are anything but OK.

Your to-do list consists of things you need to do and things you no longer have the time to do. That "normal" life you were living is no longer your normal. There are not enough hours in the day. You are in caregiver survival mode.

Now, everything you do revolves around a new schedule, a new worry, and not being able to make it all better.

Deputies Rumer & Firks save man's life

On Saturday, Aug. 3 at approximately 5:30 p.m., Hamilton County Sheriff's Deputies Austin Rumer and Michael Firks were patrolling the blue parking lot at Ruoff Music Center when they were alerted to an unresponsive male. Upon finding him not breathing and without a pulse, Deputy Rumer administered Narcan, reviving the man. Seals Ambulance medics provided further aid, and he was transported to the hospital. This incident underscores the importance of quick action in life-threatening situations and highlights the vital role that Narcan plays in reversing opioid overdoses. Thanks to the swift response from Deputies Rumer and Firks, a life was saved that day.

Sheridan church unveils life-saving NaloxBox for public use

Sheridan First Christian Church recently installed a NaloxBox in its East parking lot off Main Street, located at 107 W. 3rd St.

This new resource provides free, 24/7 access to Opioid Rescue Kits, which include intranasal naloxone spray and instructions on how to use it to reverse opioid overdoses.

The NaloxBox initiative is a vital step in combating the opioid crisis, providing life-saving tools to the community. Each kit contains naloxone, a medication designed to rapidly reverse opioid overdose, along with clear, step-by-step instructions to ensure effective administration during critical moments. The box also contains fentanyl test strips and xylazine test strips, which are

essential for detecting dangerous substances in drug supplies.

To ensure that the NaloxBox remains fully stocked, it is monitored three times weekly. This diligence ensures that these critical resources are always available to those in need. The next nearest NaloxBox to Sheridan is located 10 miles away; additional sites can be found at overdoselifeline.org/naloxone-indiana-distribution.

Growing tomorrow's teachers at Heights today

Hamilton Heights students interested in a career in education can get an up-close and personal look into the profession through Tomorrow's Teachers: Growing Our Own program at Indiana University Kokomo (IUK).

This year marks Heights' third year to participate in this innovative program designed to identify, encourage, and prepare individuals in their own community who are interested in becoming an educator or educational professional.

The program matches students interested in education with the resources to help them launch their career while still in high school. Courses can be utilized for dual-credit purposes and as part of a graduation pathway. IUK faculty bring the classes to Hamilton Heights giving juniors and seniors the chance to get a head start on college, explore teaching to see if it might be the right career choice for them, and learn skills that prepare them to be a successful college student.

Through the program, students enjoy a blended format that includes school-based field experiences as well as meetings at the high school. These are hands-on and intentionally sequenced in P-8 classrooms that are coordinated and supervised by district educators and integrated into IUK education courses. They will experience direct engagement activities on campus where they'll build community and network to gain a better understanding of the profession.

"This program gives them a chance to learn some of the intricacies about the field and opportunities to spend time in the classroom with students to see if this is a career they want to pursue after graduation," explained

Lori Hippensteel, who has been one of the program's biggest cheerleaders. "We have long had opportunities for high school students to assist in classrooms in the role of a peer facilitator or cadet teacher, but tomorrow's Teacher program kicks it up a notch connecting high school students from other schools with similar career interests to work together and take college-level classes related to the field of education."

"Through this program, we encourage students to explore all areas of education, daycare, preschool, elementary school, middle school, special education, and specials (music, art, PE) and especially the librarian," continued Hippensteel, who with 18 years of experience in education, admits she is a little biased. "The program exposes them to the profession and challenges their prior conceptions about teaching and learning. We also expand their knowledge beyond the brick-and-mortar buildings to include online teaching,

providing continuing ed for companies such as Beck's and Gaylor, and even showing them how organizations like the DNR utilize educators in their profession."

Three of Heights' current program participants took a few minutes to share what they learned or liked best about their first field day experience. Junior Averie Scott said she enjoyed learning how to enter grades. Senior Max Bowman liked reading to students, and Jackson Cantlon liked the opportunity to use the whiteboard to teach the kids math.

Hippensteel says this program is of utmost importance as it plays a crucial role in educating the next generation of teachers.

"By providing real-world, firsthand experiences, students can better decide if this is a profession they would like to pursue or not," she added. "At the same time, students are earning college credits that will count toward their college education to teacher licensure. It's win-win."

You wrap the cape around you at night, hoping it will comfort you while you sleep. Heroes need their sleep. Yes, my friend, you are a hero. You tighten the cape around your shoulders every morning as if you are going into battle ... because you are.

You are covered with the guilt of "not enough." Nothing you do seems enough because you cannot make it all better.

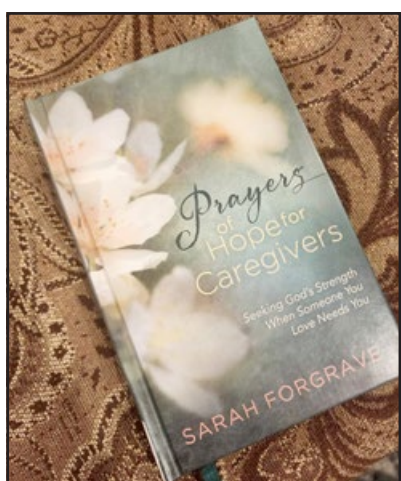

Westfield's 2025 budget focuses on public safety, infrastructure & economic development

The Westfield 2025 Civil City budget was introduced to the City Council at its Aug. 26 meeting. The budget will be eligible for adoption at the Sept. 9 council meeting.

The 2025 proposed Civil City budget totals \$124,630,158, with an operational budget of \$78,265,507, which excludes bond payments.

Mayor Scott Willis's budget aligns spending with revenue forecasts to maintain a flat tax rate while serving Indiana's fastest-growing community.

There has also been a significant change in the financial planning strategy for the upcoming fiscal year. Department leaders were tasked with implementing zero-based budgeting rather than adjusting based on the previous year's spending.

Zero-based budgeting is a strategic approach requiring a fresh evaluation of all expenses incurred during the budget cycle. It ensures the budget closely aligns with the strategic objectives outlined in Mayor Willis's Advancing Westfield vision. This will ensure the budget yields the highest value for residents and the community.

“By going through this process, budget items that had been unused for years were reallocated appropriately to economic development, infrastructure, and public safety investments,” Willis said. “We also consolidated line items to gain stronger purchasing power moving forward.”

Willis's 2025 proposed budget continues strategic investment that prioritizes public safety, economic development, road and infrastructure improvements, and quality of life initiatives for residents.

“The Mayor's recommended budget addresses the needs of the fast-

est-growing city in our state, the entire Midwest, and the sixth-fastest in the nation,” Council President Patrick Tamm said. “It addresses the immediate and long-term objectives and ensures strong fiscal health for Westfield. The City Council will continue to work with the Mayor productively and collaboratively as this process progresses.”

Key features of the 2025 budget include:

- Public safety**
 - Hiring additional personnel to both Westfield Fire and Westfield Police to meet the community's growing needs
 - Adding additional outdoor warning sirens
 - Designing and constructing a new police department headquarters to meet the expanding needs of the department

Roads & infrastructure

- Increased funding for the resurfacing program
- Design and construction of several Capital Improvement Plan projects, including roundabouts at 161st Street and Spring Mill Road, 181st Street and Wheeler Road, and expansion of 191st Street from Tomlinson Road to Grand Park Boulevard

Economic development

- Acquisition of land for downtown parking garages
- Funding for a streetscape project for the Park Street area
- Acquisition of land near Grand Park

Quality of life

- Funding for new community initiatives, including a Neighborhood Grant Program for improvements
 - Continued funding for community events such as Westfield Rocks the 4th, Jams at the Junction, and Westfield in Lights
 - Completion of Simon Moon Park Phase 2
 - Constructing permanent restrooms at Freedom Trail Park
 - Funding for a new park

Hamilton County Health Department launches interactive food inspection map

The Hamilton County Health Department has launched an interactive food inspection map on its website. This new tool allows residents to easily access and review food inspection reports for over 1,200 food service establishments, including restaurants and food stores operating within the county.

The food inspection map provides a user-friendly platform where individuals can enter their location, view nearby food

establishments, and click on specific restaurants to pull up detailed inspection reports.

“Food safety is a top priority for the Hamilton County Health Department, and we are committed to ensuring that our community has access to the most current and relevant information,” Hamilton County Health Department Administrator Jason LeMaster said. “This new

feature allows consumers to make more informed decisions about where they dine or shop. By making these reports readily available, we hope to increase public awareness and encourage all food establishments to maintain the highest standards of food safety.”

The Health Department conducts regular, unannounced inspections of food establishments based

on a hazard risk assessment, and all inspection results are made public 10 days following the completion of an inspection. In addition to inspections, the department offers food safety training for establishments upon request, further supporting the community's health and well-being.

The Interactive Food Inspection Map is now available on the Health Department's website at hamiltoncounty.in.gov/256/Food-Establishment-Program.

The peace and joy of this dinner party is shattered by Goole's arrival to investigate the death of a young working-class woman.

Hyperion Director Nicole Amsler has assembled a talented cast of seven to bring audiences a tale of drama and intrigue with an ending you may be talking about long after the play is over.

According to Amsler, Eva Smith took her own life in a disturbing manner and Inspector Goole is investigating how each member of the Birling family may have pushed her to do so.

Eva's life took one unfortunate turn after another, and according to Inspector Goole, she went by multiple names at different stages of that tragic life. To some present she was Eva Smith. To others she was Daisy Renton.

As each person is questioned and the unfortunate life of Eva/Daisy is revealed, she will appear to audiences in a form that is so uncommon in community theater that it may be unique.

“The character who has died (Eva Smith / Daisy Renton) is frequently referenced but never seen,” Amsler told The Reporter. “In this production, we will

be using shadow puppetry to tell her untold story.”

According to Amsler, there is a long history of representing death and the dead with shadow puppets.

That history goes back at least to Pi Ying Xi, one of the oldest kinds of drama in China. Pi Ying Xi is said to have its roots in the Han Dynasty in 200 B.C. when Emperor Han Wudi was distraught over the death of his beloved, the Empress. An advisor supposedly invented shadow puppetry as a way to let the emperor see his lost love through shadows.

“It is considered a laborer's artform, resonating with farmers and manual laborers who could only indulge in art in the evenings,” Amsler said. “Puppetry sees reality while the audience sees illusion. European revolutions were often accompanied by underground puppet shows that raised awareness about the disparity of wealth and equality.”

Thus, it is a fitting way to show Eva/Daisy in the Hyperion Players' production of *An Inspector Calls*.

But why did Eva/Daisy take her own life?

Was it Arthur Birling's callous disregard for any-

thing other than profit? Was it Sheila Birling's casual cruelty to a young woman working in a clothing store? Could it have been Gerald Croft's or Eric Birling's ill-fated affairs with Eva? Sybil Birling's refusal to help a young woman in a difficult situation?

And will the twist ending The Reporter has been sworn to secrecy about answer

those questions, raise new ones, or both?

You'll just have to head to The Switch Theatre this month to find out for yourself.

"Meating" the Need hits new donation record

More than 5,000 pounds of meat distributed to local food banks

Hamilton County Harvest Food Bank (HCH) has sponsored its ninth year of "Meating" the Need, a partnership between 4-H Beef, Dairy, and Swine projects and the Food Bank.

HCH is a non-profit organization that supports local food pantries and meal programs year round in Hamilton County. This year, HCH purchased nine beef and 10 swine at the Hamilton County 4-H Livestock Auction on Tuesday, July 23. An amazing 84 local donors helped fund this year's Meating the Need project with over \$30,000 in donations – a NEW RECORD.

The 5,348 pounds of meat, the **most meat** distributed for Meating the Need yet, supplied 26 Hamilton County food pantries with farm fresh beef and pork raised by local 4-H members. Meat Distribution Days were Aug. 5 and 10. St. Christopher's Episcopal Church of Carmel once again helped with distribution.

The 20 4-H members who designated their animals for sale to the Food Bank helped to feed families and children in their own communities with the equivalent of 21,392 meals of good, healthy protein. Donations to this program went towards the appraised market purchase price of the 4-H animals, processing, and to the 4-H members as they pursue their 4-H, education, and life goals.

Thank you to Archers Meats and Catering and This Old Farm for processing all of the animals and the Hamilton County 4-H Staff and 4-H Livestock Auction Committee who help make Meating the Need happen

Westfield selects firm to develop Comprehensive Plan update

Westfield city officials have announced the approval of Rundle Ernstberger Associates (REA) to lead the development of a new Comprehensive Plan, Economic Impact Study, and Infrastructure Plan for the city. This significant step is designed to enhance strategic planning and future growth in alignment with Westfield's vision for a vibrant, sustainable, and thriving community.

After a rigorous selection process, the Westfield Board of Public Works signed the contract on Wednesday. This decision follows an extensive evaluation of proposals from city leaders and interviews with potential candidates. REA's team includes several national and local firms specializing in various areas, including:

- Orion Planning and Design from Missoula, Mont., specializing in land use scenario planning
- Urban 3 from Asheville, N.C., specializing in economic development and fiscal impact
- Lochmueller Group from Indianapolis, specializing in civil and transportation engineering
- Shannon Z. Creative from Indianapolis, leading the project branding

"We are excited to work with REA and their team to update and refresh our comprehensive plan," Mayor Scott Willis said. "This update is crucial for guiding Westfield's growth, addressing emerging challenges, and capturing new opportunities. We believe that REA's extensive experience and innovative approach will help us achieve our long-term goals and improve the quality of life for all our residents."

The comprehensive plan update will focus on several key areas, including:

- Land use and zoning: Reviewing and updating zoning codes and land use policies to support bal-



anced development.

• Transportation and infrastructure: Enhancing transportation networks and infrastructure to accommodate future growth and improve connectivity.

• Economic development: Identifying strategies to stimulate economic growth, support local businesses, and attract new investments.

• Sustainability and environment: Integrating sustainable practices and environmental considerations into planning to ensure long-term resilience.

• Community engagement: Encouraging active community participation to reflect the needs and desires of Westfield residents.

"We are honored to be selected for this important project," Cynthia Bowen, FAICP from REA, said. "Our team is committed to collaborating closely with the City of Westfield, local stakeholders, and the community to create a comprehensive plan that is both visionary and actionable. Our goal is to help Westfield achieve its aspirations while addressing current and future challenges."

The update process will involve in-person public meetings and workshops, and online activities through a 24-7 portal to gather input from residents, business owners, and other stakeholders. This collaborative approach ensures that the final plan reflects the community's values and aspirations. A more detailed schedule and information will be released as it becomes available.

City officials anticipate the comprehensive plan update to begin in September 2024 and be completed by spring of 2026 with periodic updates and opportunities for public involvement throughout the process.

Two new murals in Noblesville celebrate conservation & native beauty

The Noblesville Township Trustee building has become the canvas for two murals, blending art and conservation in a celebration of Indiana's natural heritage.

These murals, painted by local artist Abigail Staffelbach, highlight the importance of native plants and the impact of invasive species on the environment. The murals were created via a partnership between the Hamilton County Soil and Water Conservation District (SWCD) and Noblesville Township Trustee Theresa Caldwell.

The murals were made possible through the support of Hamilton County Tourism Inc.

The first mural invites viewers into Indiana's lush woodlands, where the Great White Trillium, Great Waterleaf, and Celandine Poppy (Wood Poppy) are brought to life with vibrant colors and intricate details.

These native plants, vital to the health of local ecosystems, are now immortalized on the walls of the Noblesville Township Trustee building. This mural serves as both a tribute to the beauty of native flora and a reminder of the importance of preserving natural landscapes.

The second mural tells a powerful story of ecological restoration. A pair of walk-

ers embark on a hike only to realize that the birds are gone, their songs silenced by the spread of invasive species. Moved by this discovery, they join forces to remove the invaders and restore the area with native plants, bringing life back to the landscape. This visual narrative underscores the crucial role that each of us can play in protecting the environment.

"We wanted to create something that not only beautifies the community but also sparks conversations about conservation," said Claire Lane, Urban Conservationist at the Hamilton County SWCD. "These murals are a visual reminder of the importance of native plants and the impact that invasive species can have on our local wildlife."

Located in the heart of Noblesville, these murals are easily accessible to the public and offer a unique opportunity to engage with art and nature. Residents and visitors are encouraged to visit the Noblesville Township Trustee's Office at 836 Division St. to experience these powerful works of art and reflect on the messages they convey.

Adapt to find your passion

I was first introduced to exercise when I was young through the form of swimming. It was a form of exercise that doctors told my parents would be safe and effective for me in supporting my muscles as well as I could. As I got older, I joined a swim team, and while I was not competitive, it kept me exercising, and my muscles working the best they could.

Doctors told my parents that I may not walk for long. They were determined to keep me walking as long as possible, and I was determined, too. I also was fortunate enough to be able to ride a two-wheel bike when I was younger. I rode it all the time which I am sure helped a lot with my muscles. I had a desire to be active, and I was. In college, I continued to want to eat healthy and exercise. I took an exercise class and learned how to lift weights. While I could not lift much, it was another way that I could keep my muscles as healthy as possible.

My driving force to adapt to different exercises and activities that keep me moving, continues to be the desire to keep walking as long as I possibly can. My disease is slowly progressive, so as I have gotten older, I have had to use my wheelchair some for getting around if I am overly tired and for going longer distances. I am an ambulatory wheelchair user.

My main form of exercise now is an underwater treadmill in my small therapy pool at my home. It is the type of pool where you can swim against a current, so I am able to swim and run in the water. Before we had this installed, I had never run before. My son who was 12 at the time taught me how to run because I did not even know how! After 44 years in and out of physical therapy, my husband and I decided to bring something into our home that I could safely and easily access and use often to stay active.

Another form of adaptive recreation that I have tried is skiing in Colorado. We were on a family vacation and wanted to take our boys skiing. I assumed that I would just be a spectator, but the lady at the Airbnb where we were staying told us about an adaptive ski program which just happened to be about 10 minutes from the house we were staying at. That is a day I will never forget. I only wish I had more than one day to ski. They packed as much training into that one day as they could, and it was exhilarating to fly down that mountain. I felt so free, and my four instructors were angels on earth!

A couple of years ago, my long-time best friend texted me about an opportunity to go adaptive water skiing, something else I had never been able to do. We went together and she cheered me on as I skied in a seated adaptive ski all around the lake. After several wipe-outs, I finally got up. Once I did, it was incredible. I ended up loving it so much that I went back for day two so my husband could see it too. It was an incredible experience.

There have been so many obstacles to staying active along the way. One, it is just

Mom told this story. A few nights ago Dad worked late. I was tired and was so sound asleep, I didn't even hear him come home. What's so unusual about that? Nothing really. I never had much trouble sleeping if he had to be out at night as I knew where he was and I could depend on him being back when he said he would.

After you children were old enough to be out without parental supervision, I very seldom slept until I heard the steps creek as the last one went upstairs. Even the winter Grandma came to live here and Dad and I slept in the front room, there was never a night I didn't hear Theresa, no matter how quietly she came in.

One time Dad was staying nights at the hospital with Grandpa. I'd been about down with a cold; Theresa had been in the hospital only a few weeks before. The two older children had gone to a party. I didn't expect them home until after 12, but they had assured me they would come by 11. Theresa and I went to sleep. * (Mother wrote up and down at the side of the page—I awakened around 11:30 or so and of course, started worrying.) About midnight the older ones came home with a very reasonable explanation.

However, they were told in the future if they did not call, Dad would come looking for them. And if he happened to be away as he was that night, a policeman would come. Fortunately, they didn't test me. I was not making idle threats; someone would have come. I wonder when I go through the pearly gates, will I be able to rest until the last one is safely in.

Preparing for the future: the new Indiana diploma

In its Aug. 19, 2024, edition, The Reporter published an article on Westfield teachers expressing concerns over the Indiana Department of Education (IDOE) proposed diploma requirements.

The IDOE wrote, "Indiana leaders proposed a vision for the future of high school that increases flexibility, personalization, and relevance, while maintaining rigorous standards for all."

The IDOE is looking to be the first in the states to redesign diplomas. On its website, IDOE claims to change the current high school diploma in order "to better prepare our students for the future." The first draft proposal received backlash during the listening sessions held around the state. Currently, the IDOE has a second draft proposal and is again holding listening sessions. To their credit, the IDOE reworked their draft proposal to cut out a second diploma and replace it with what they are referring to as "Honors Seals" and "Honors Plus Seals."

One of the priorities for the new diploma is that the course requirements "prepare every student for success regardless of their post-high school plans." I believe that as the draft proposal stands currently, the students will be prepared to pursue a post-secondary education or a trade after graduation. But, will this second draft proposal really prepare our students for the 21st-century future?

Here are three trends that should be taken into consideration when finalizing the proposed diploma:

1. Historically, 18- to 24-year-olds tend to change jobs and careers most frequently with an average of 5.7 jobs during these six years.

2. Despite the United States having one of the highest expenditures per student, the U.S. ranked 38th in math scores and 24th in science according to a Business Insider report in 2018.

3. The Organization for Economic Co-operation and Development (OECD) conducts a two-hour test every three

years to test the critical thinking of 15-year-olds in math, science, and reading in over 65 countries. Test questions don't gauge memorization of facts but demand that students draw on real-world problem-solving skills and knowledge. The last test was conducted in 2022 with around 6,300 students participating. The United States ranked 18th in overall score, unchanged from the previous test.

The second draft of the diploma reduces the credits in social studies, meaning the students are not mandated to take economics or world history. Although the honors seals require a demonstration of communication, collaboration, and work ethic, it does not mention the essential skill of critical thinking. I agree with Dawn Knight, WHS English teacher, who stated, "I think we are doing our kids a disservice if we aren't giving them the global education they need."

We all want our graduating students to be well-prepared for their future. I just believe that it should go beyond the first job or career. In addition, our graduating students should be prepared to compete with

graduates from other states. If Indiana leaders are proposing a vision for the future, that vision should include changes that will put our students on par with other developed countries.

Current state law requires the State Board of Education to adopt the new high school diploma rule by Dec. 31, 2024. Final requirements become effective for all students beginning with the class of 2029, or students currently in eighth grade.

As with most things, the devil is in the details. The new diploma requirements are the 36,000-foot view. The IDOE will set the standards for each course and then the school districts will develop curricula for each course. Educators and parents need to be vigilant to ensure that the goals of the new diploma are achieved.

Happily, I've learned my lesson. Thanks to this experi-

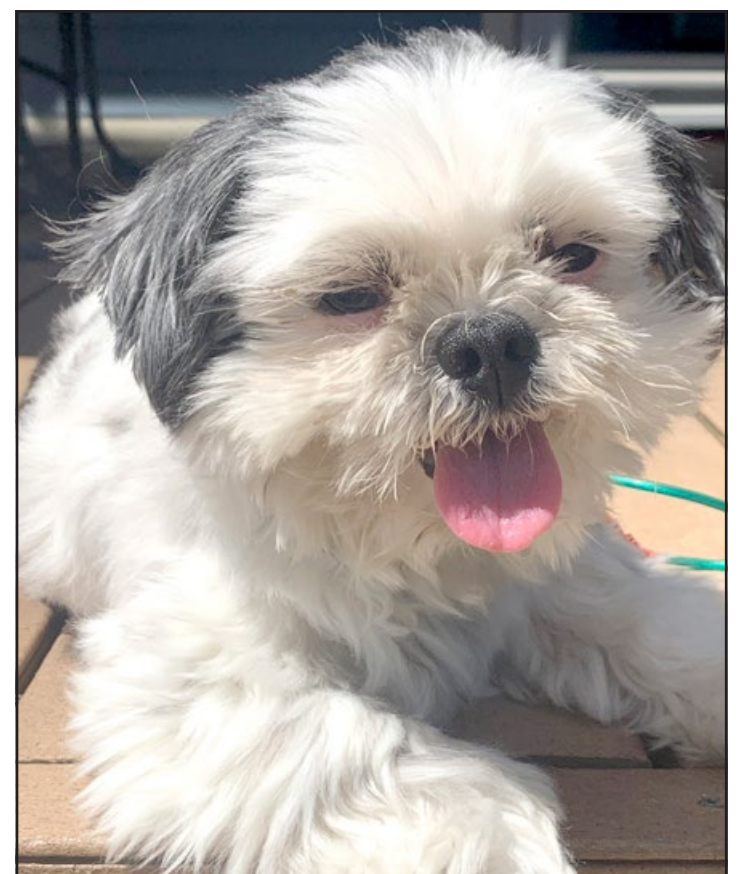

Veterans: relieve stress & inform your family about your VA benefits

More than six million Americans receive earned benefits for military service – including disability compensation, education benefits, caregiver assistance, burial benefits and more. It is critical for spouses and caregivers to know how veterans benefits are accessed and what could happen when or if a veteran dies.

Consider this scenario. A veteran has not told his spouse much about his veteran's benefits. The veteran dies suddenly. His spouse grieves and plans a funeral, which she pays for out of pocket. The \$2,500 tax-free payment from the VA for her husband's disability compensation has stopped being deposited into their bank account, which her spouse managed. Now she struggles to meet her expenses and is afraid she will have to sell their home.

Ultimately, she realizes she must connect with the VA to try to access survivor benefits. As she works her way through

the bureaucracy, she struggles to understand what she may be eligible for and knows little about what her husband was receiving. This can be overwhelming during the best of times, but during this period of loss, it adds more stress.

Surviving spouses facing this situation are often approached by agents who offer to help them with VA benefits in return for payment. Faced with what feels like an insurmountable situation, some agree, even though paying for help is not necessary as many free resources are available to assist them.

Here are some tips to help veterans prevent these types of scenario from befalling their loved ones:

- **Organize veterans benefits paperwork and information in a binder, and/or in a special digital folder that you share with your family.** Carefully organize all the documentation related to your military service, your application

for benefits, and the decision letters describing service connection. Store paper copies in a fireproof cabinet or safe. It is ideal to scan or photograph paper documentation and to also store it digitally on a computer or thumb drive.

- **Explain your current veterans benefits to your family.** Schedule a day and time to talk one-on-one with your family about the benefits you receive. Get out your binder and digital files and explain to them how the information is organized. Help them understand the situation as it is today.

- **Discuss what happens to these benefits after you die and what additional benefits the family may receive.** Disability compensation payments stop after a veteran dies. Additional survivor and burial benefits may be available after a veteran's passing. You can learn more by checking online at va.gov/family-and-caregiver-benefits or with a veterans service officer (VSO) at tinyurl.com/MilitaryVSO.

- **Plan ahead for possible financial shortfalls.** Even if a survivor benefit is awarded

to a widow or widower by the VA, the payment for this benefit will typically be lower than the disability compensation the veteran received while alive. One way to address this income shortfall before the veteran dies is to purchase life insurance that will provide additional income for the spouse.

- **Give your family contact information for your VSO.** Ideally, your spouse should be introduced to the VSO, so the spouse knows who can assist with applying for survivor and burial benefits after the veteran dies.

While these conversations can be tough for many, they can better inform and relieve stress for our families in the future. You want for the people you love to be taken care of after you are gone, so do not delay having these conversations.

Misinformation leads to distrust of vaccines

Vaccine misinformation and politicization abound in America. Social media and internet sites are packed with both from vaccine critics.

According to the Centers for Disease Control and Prevention and other public health entities, a significant portion of Americans are distrustful of vaccines and fear they commonly cause autism and other serious untoward effects. Some are convinced there is some kind of conspiracy between pharmaceutical companies, scientists, and the government. Others are vaccine hesitant from the diffusion of this misleading information into our society.

The very success of immunization – the relative nonexistence of diseases that once ravaged the world – has created complacency. One does not appreciate the absence of what one does not see; smallpox, polio, diphtheria, tetanus, and meningitis are good examples. Immunizations are indeed medical miracles that changed the world forever.

These factors result in very poor adult vaccination rates. CDC data reveal only a relatively small fraction of adults have received many recommended vaccines including COVID boosters, RSV, shingles, and influenza. Young children and adolescents are only saved by school requirements, and for those immunizations not required, vaccination rates are disappointing. Examples are human papilloma virus and influenza immunizations.

Sources of vaccine misinformation include the intentional or non-intentional misrepresentation of medical-study data. For instance, a report might state that there are a large number of deaths associated with a vaccine in a clinical trial. But what is not reported is that the placebo group had a similar number of deaths. Another major tool of antivaccine activists is to create concern using the Vaccine Adverse Event Reporting System. Most of what follows regarding VAERS is based on an excellent May 2024 *Journal of the American Medical Association* article.

VAERS is a passive national self-reporting system managed by the U.S. Federal Food and Drug Administration and the CDC. The system makes it evident that a reported potential adverse medical event occurring after an immunization does not signify that the vaccine caused the event. It collects such reports from clinicians, pharmaceutical companies, health systems, and the public. The agencies want all potential events reported on the chance, however small, that a causal relationship exists. As a result, many reports contain inaccurate, coincidental, and unverified information.

Aggregate data from a large number of these reports are paired with well-designed studies that investigate the case details. Background incidence of the medical condition in the general population must also be determined for context. This combined information can determine a potential association or likely causal relationship between a vaccine and a subsequent medical condition.

Information spreads quickly in the electronic era. Unfortunately, misinterpreted VAERS and medical-study information are used, frequently by design, as confirmation that immunizations are a significant cause of morbidity and mortality. This serves to diminish vaccine confidence and promote misconceptions and distrust, especially after the COVID-politicization experience.

A 2022 Annenberg Public Policy Center survey found that 60 percent of Americans are unsure if VAERS confirms cases of vaccine harm, and that increasingly people believe that it does.

The JAMA article suggests that the name of VAERS be changed to more clearly and accurately reflect what VAERS is "an early warning system and not a catalogue of confirmed cases." It also suggests that VAERS contain more detail clarifying the nature of the data and how it should be interpreted.

Cast a critical eye on reports regarding VAERS and medical-study data, and carefully consider who created them. Many are deceptive.

Beware large 401(k) withdrawals' impact on Medicare prices

Many people retire and are not sure what to do with the money in their 401(k) from their former employer. Do not withdraw all the money out of your 401(k) just because you can.

There is no tax PENALTY for withdrawing after age 59 1/2, but if you are age 63 and take a large amount of money out and just sit it in your savings account, you might have made a big mistake as far as Medicare is concerned.

Why would Medicare care about your 401(k)? Most people don't realize that the cost you pay for Medicare Parts B and D are based on your income (not assets). The rich pay more for Medicare. You may not be rich, but your 401(k) and regular IRA withdrawals become taxable income, and you may look rich to Medicare. If you take

out too much tax-deferred money, it can cause your Medicare monthly premiums to go up. This is called IRMAA (income related monthly adjustment amount). I call it the "rich tax."

What does Medicare consider to be "rich"?

Medicare will not look at your savings account or stock portfolio. This is not an asset test. The Medicare IRMAA is based on your modified adjusted gross income from two years prior. If you are turning 65 this year, look at your 2022 tax returns. If you earned over \$103,000 as a single person or \$206,000 as a couple, then you'll pay the IRMAA surcharge for one year. You only have to be over the limit by \$1 to trigger this surcharge.

There are currently five IRMAA brackets which I have

listed on our website, TheMedicareFamily.com. It's a moving target since the government adjusts these amounts annually. For people retiring in 2025, we don't know what the exact dollar amounts are until November 2024. You could pay a little extra each month (\$80) or you could pay almost \$500 extra per month depending on which bracket you fall into.

Educate yourself on Medicare IRMAA if you are within two years of starting Medicare because there are other things that can trigger it that you may be able to avoid with some planning, such as selling a property. Those profits often cause IRMAA. If you can, plan to sell that property at age 62 instead of age 63. Capital gains from the sale at 62 won't impact you since Medicare doesn't begin till age 65. When you take withdrawals out of your 401(k) and IRA, stay below the expected IRMAA limits in the future.

Medicare IRMAA does not only impact you when you turn 65.

It can impact you every year that you are enrolled into Medicare. Age 65 is just the first age people find out about this extra cost. Every year that you are on Medicare, they will cross reference with the IRS to see your Modified Adjusted Gross income from two years prior, and if you are over the limit, they charge you more each month for one year.

This is not a permanent increase. If you sold a house and it caused you to pay more for Medicare, it's only for one year.

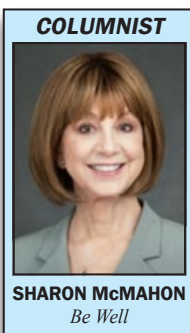

"So, if I'm cooking, I'll be steaming vegetables, making some nice salad, that kind of stuff." – Paul McCartney

When I envision celebrities' lives (which I seldom do) I imagine that they are using the services of a professional chef who serves them their delicious meals on fine china, etc. Possibly that is true for some, but most of us familiar with Sir Paul's lifestyle are not surprised by his quote here. While I imagine he enjoys a lifestyle that affords many perks – among them a personal chef – I believe he also eschews deep-fried foods in favor of a more natural eating plan on a consistent basis.

So, what about us? I sometimes do not know whether to

laugh or cringe when I see those restaurant menu items which include deep-fried veggies. We feel good about ordering a menu item which, ostensibly, is supposed to be good for us although the item is soaked in who-knows-what type of cooking oil.

In general, Americans consume about 40 percent of their diet in fried foods according to the National Library of Medicine. In particular the frying of starchy foods makes the chemical acrylamide which is linked to different types of cancer.¹

Some of us have turned to air fryers to enable us to enjoy the flavor and consistency of the fried foods we have come to know and love over the span of our lives. (My grandmother fried everything it seems, and

those Sunday comfort food dinners were quite tasty although I was already on my way to the "dark side" of becoming a vegetarian. "Fried chicken? Uh, no thank you, Grandma!") Air fryers can certainly take up the task of providing the alternative to oil-based frying but essentially should be used in moderation.

Back to Sir Paul ...

I agree with his choice of steaming vegetables. This will enable the food to retain the necessary nutrients which your body not only needs, but truly craves. Steamed vegetables will provide the complex carbohydrates and vitamins such as C, B, and other antioxidants. Enjoying steamed vegetables will provide you with soluble fiber and make that fiber more easily digested. Steaming is actually quite simple, and most vegetables can be prepared in that manner. You may use a steamer

which you purchase, or simply use a wire basket over the simmering water and your vegetables will soften and retain their flavor. Combine your dish with a spice you like and your palate will thank you!

Of course, a fresh salad with a good quality lettuce or other greens and possibly some protein source as well should be a part of our eating plan. Tofu is one alternative, or if you add chicken or seafood, I encourage you to identify your source to ensure that it is cleanly raised and antibiotic free.

was able to modify it and adapt it to fit my needs.

Unfortunately, the world we live in does not always accommodate those with disabilities. In some ways it is getting better, but there will always be obstacles. I have had to be creative in staying active and adapt in a way that works best for me.

I will continue to push through these obstacles with humble courage to keep exercising, staying as active as I can. That is the key to keeping my independence, which is so important to me. I am looking forward to what is next for me in adaptive recreation and continuing to challenge myself to stay as

strong as I can.

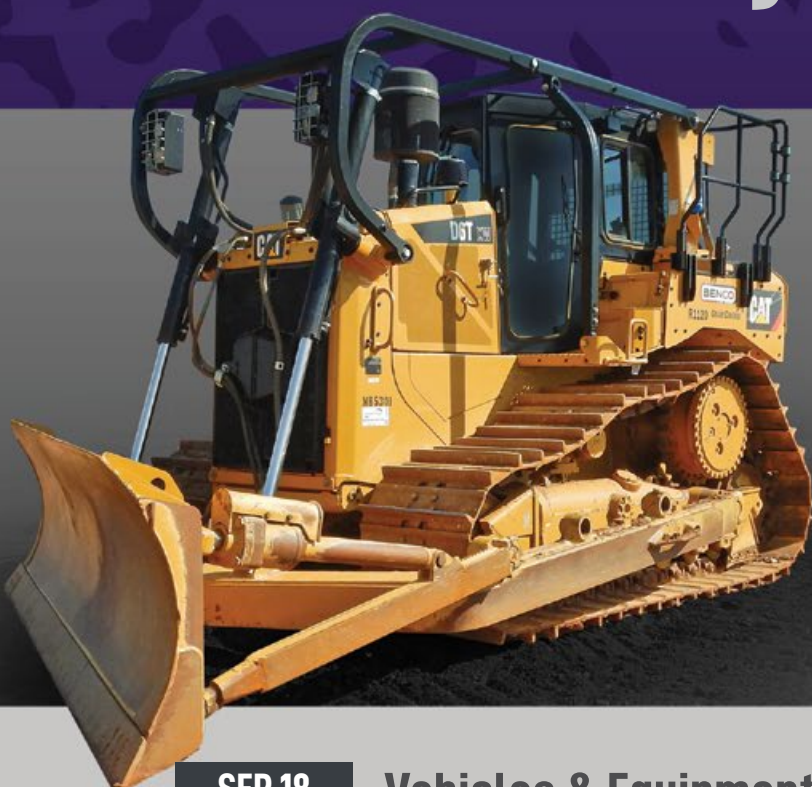
Honoring the victims of Fox Hollow tragedy

 Tony Cook was a multisport athlete who

excelled in football, basketball and baseball at Hamilton Heights. He was named all-county in all three sports and was rewarded as the Hamilton County Outstanding Player of the Year in 1968. He led the county in football points scored his senior year and was also the first quarterback to pass for 1,000 yards and rush for 1,000 yards. After graduation, he played football and baseball for four years and was a leader on the NAIA National runner-up team.

1970 Undeclared Football Team

The Hamilton Heights football team scored a perfect 10-0 in the 1970 season. The team scored 329 points on the season (32.9 points per game average) and held their opponents to 63 points on the season. (6.3 points per game average). The 6.3 points allowed per game in the 1970 season set a school record that remains to this day. The team was coached by Indiana Football Hall of Fame Coach Ted Huber.

Tracey (Money) Million
Hamilton Heights High School Class of 1988

Tracey (Money) Million was a multisport athlete winning 12 varsity letters in her career (four each in volleyball, basketball, and softball). However, she was best known for her success on the softball diamond. She was all-county and all-conference in softball for three years. She was also the Hamilton County Player of the Year in 1986. In that season she led Hamilton Heights to their first ever softball sectional championship. She pitched in all three games to clinch the championship. She went on to pitch collegiately at Kentucky State University.

Zack Bardonner
Hamilton Heights High School Class of 1998

Zack Bardonner had one of if not the most decorated track and field careers in Hamilton Heights history. As a sophomore, he was part of a school re-

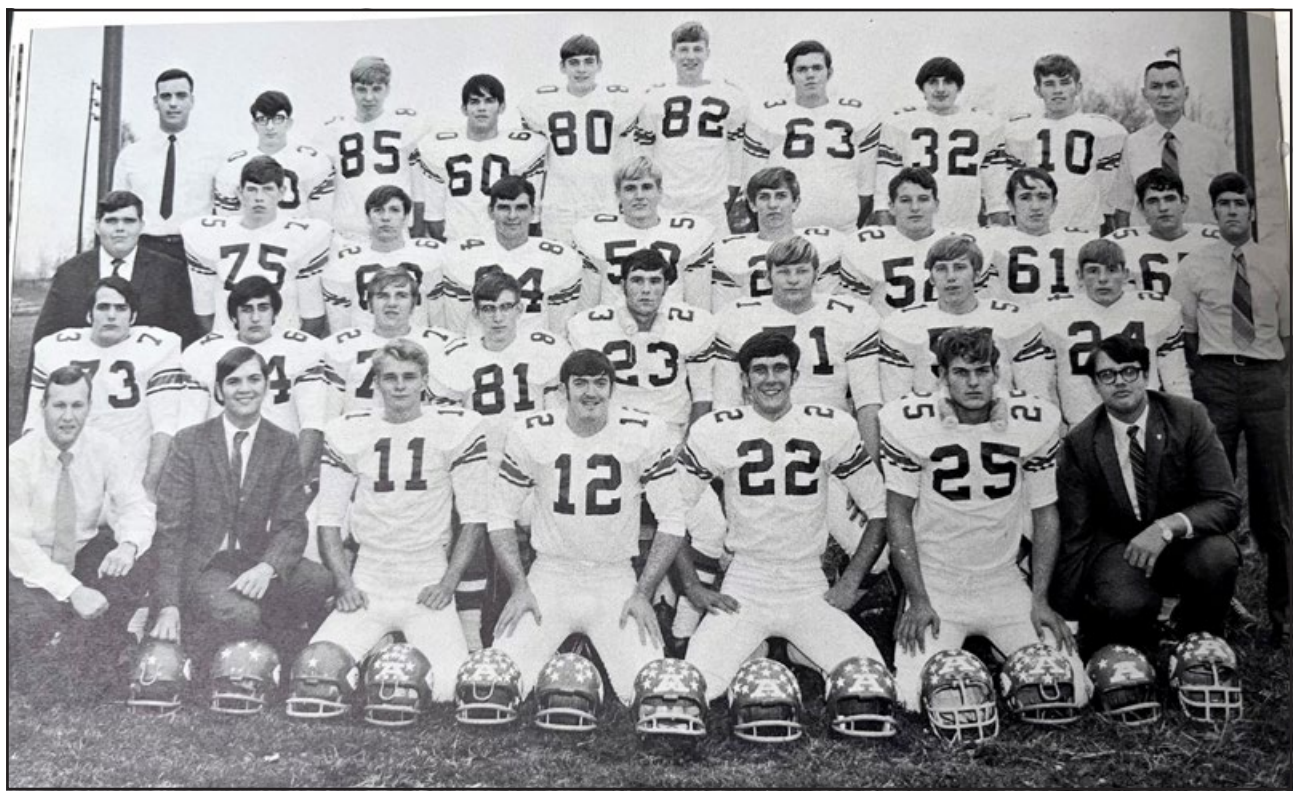

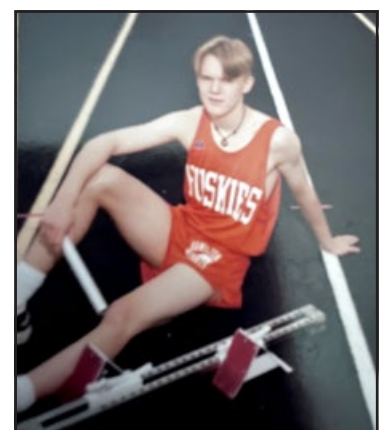
Austin Etherington

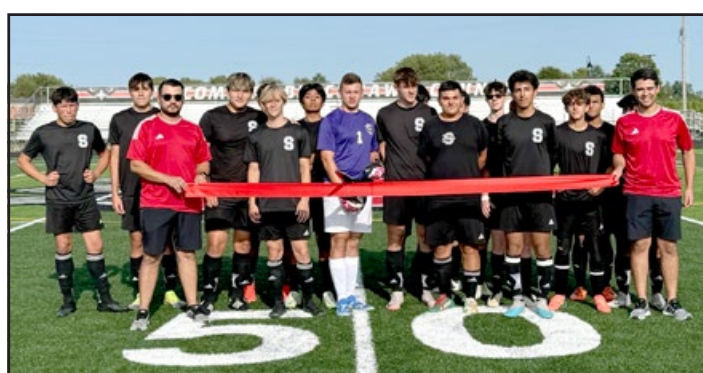

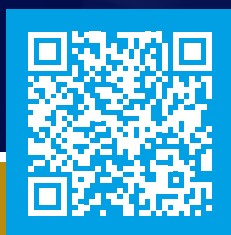
