In this instance, I can’t recall doing anything to have caused my latest issue. This is frustrating because the first thing people ask is, “What did you do?” While I did some deep cleaning last Saturday, it was in two small rooms, and there it didn’t involve any heavy lifting or strenuous activity.

Since Sunday, I’ve been relying on my husband John and my son Jacob for anything that requires bending over. But when they’re not around, I have to think outside the box.

I’ve been using my foot to do atypical tasks like shutting the dishwasher door, opening the recycling lid, and much more. I’ve been performing unusual contortions holding firmly onto the wall and balancing on one leg to reach things. And you should see my creativity with the “grabber” (sadly, yes, we’ve had this item in our household for a few years now).

I shared a saying on my social media recently that I saw on a church sign,

Hamilton Southeastern Schools expands enrollment to include out-of-district students

Hamilton Southeastern Schools (HSE) announced Tuesday evening that for the first time in its history, families living outside the district’s boundaries will have the opportunity to apply for enrollment. This decision, approved by the Board of School Trustees, opens the door for more K-12 students to join one of Indiana’s top-performing districts.

Applications for out-of-district enrollment will go live Friday, Feb. 21 and will follow a process based on eligibility criteria and campus availability at select schools.



“This is an important moment for Hamilton Southeastern Schools,” Superintendent Pat Mapes said. “By welcoming students from outside our district, we are able to expand access to the high-quality educational opportunities that define HSE while strengthening our ability to

serve the greater community.”

The change in policy reflects HSE’s commitment to adapting to the evolving landscape of public education, ensuring financial stability through maximized enrollment and re-

source allocation.

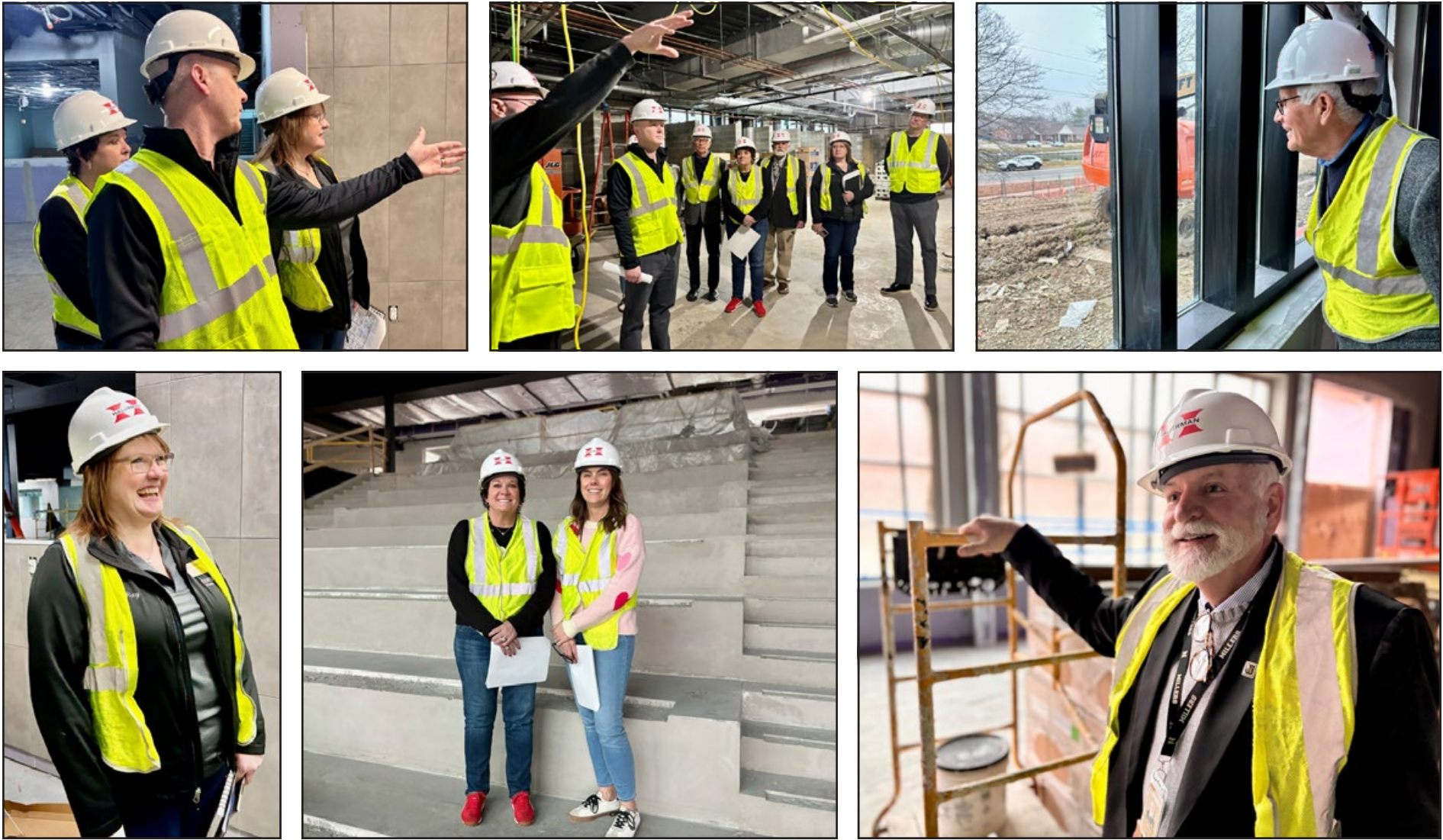

ties during her first year as commissioner, highlighting how locally based decision-making is a central tenet of HFI as health departments know best how to address the needs in their communities.

Prior to her appointment, she had served since Feb. 3, 2020, as the chief medical officer for the Indiana Department of Health (IDOH), where she helped to lead the state's pandemic response by spearheading the development of the statewide lab testing network to expand COVID-19 testing capacity in Indiana and led the statewide distribution of COVID-19 vaccines and therapeutics.

Dr. Weaver is also an assistant professor of clinical emergency medicine at the Indiana University School of Medicine and continues to practice emergency medicine at Methodist Hospital in Indianapolis.

She earned her undergraduate degree in biology at the University of Kentucky and graduated from the University of Louisville School of Medicine. She received residency training in emergency medicine and fellowship training in hospice and palliative medicine at Indiana University School of Medicine, and she completed a fellowship in ethics at the Charles Warren Fairbanks Center for Medical Ethics at Indiana University Health.

Dr. Weaver and her husband have five daughters.

Advocates urge lawmakers to take action to reduce tobacco use

Roughly 500 advocates, including 300 students, from across the state traveled to the Statehouse on Wednesday to meet with their elected officials during Tobacco Free Indiana Advocacy Day. They told lawmakers that Indiana can and must do better to reduce the toll of tobacco on Hoosiers.

Advocates met with lawmakers to ask them to increase the state's cigarette tax by \$2 per pack and the tax on all other tobacco

products, including e-cigarettes, parallel to the new cigarette tax. Increasing Indiana's cigarette tax by \$2 per pack would generate over \$318 million in new annual revenue, keep 7,000 kids from becoming adults who smoke, help 32,400 adults who currently smoke quit and



save 9,900 lives.

Furthermore, advocates shared that lawmakers should increase the state's investment to \$15 million for programs that prevent tobacco use and help those already addicted quit. In taking these actions, Indiana will take a decisive step towards reducing tobacco

use and its devastating toll on our communities.

Over 42,000 Hoosiers will be diagnosed with cancer, and over 14,000 are expected to die from the devastating disease this year. A total of 33.8 percent of those cancer deaths will be caused by cigarette smoking. Those gathered at the Statehouse Wednesday called on Indiana lawmakers to change this by taking steps to prioritize the fight for a healthier Indiana by reducing tobacco use.

Dr. Weaver was re-appointed Indiana State Health Commissioner by Governor Mike Braun on Jan. 13, 2025, having been named to the position by Governor Eric J. Holcomb in June 2023. She brings to the role a passion for improving the health of Hoosiers through a focus on prevention, data-informed programming, and access to care in all corners of the state.

Hamilton County is undeniably bipartisan

Not long ago, Hamilton County, Indiana, was a GOP stronghold with uncontested general election races and a long-standing political monopoly. Today, we are undeniably a bipartisan county that is politically balanced. We have grown into a richly diverse community with a variety of perspectives.

Democrats in Hamilton County are no longer invisible, they are expected. They are seen as active contributors to our community, just like Hamilton County neighbors are – dedicated to local service, bipartisan balance, and good government for all.

Balance is a requirement of good government that serves people well. A long-standing political monopoly of any party jeopardizes transparency, openness, and accountability. Although Democrats haven't yet achieved all the Hamilton County election victories that are hoped for, there are many facts that prove our county is achieving bipartisan balance. MSNBC highlighted Hamilton County as one of the top 10 counties in the nation that has shifted most to Democrats, +28 since 2012. *The New York Times* showed that Hamilton County was one of only 319 counties in the country (11 percent) that did not

increase Trump support from 2020. Notably, the Democratic Presidential candidate won both Carmel and Fishers for the very first time in 2024. Reversing a national trend and consistently moving toward Democrats for the past 12 years in our red state of Indiana is remarkable. This momentum is not simply the result of our growing population. This consistent shift to Democrats is the result of more strong Democratic candidates who bravely run for an office that has been held by Republicans and hours of hard work from volunteers.

When Hamilton County citizens voted in 2024, they saw one of the most competitive ballots in the entire state. These Democratic candidates won strong support from a cross-section of voters – Deborah Pickett, Joel Levi, Matt McNally, Josh Lowry, Chris Hartig, Stephanie Jo Yocum, Keely Gladieux, and Tom Wilson. The Democratic incumbent on the ballot was State Representative Victoria Garcia Wilburn and she won her reelection decisively. Indiana was one of only four states in the nation that reelected all their Democratic office holders. Representative Garcia Wilburn

won the cities of Carmel and Fishers for the first time and represents all Hamilton County residents as a Democrat in the statehouse.

Overall, Democratic candidates did very well in Hamilton County amid statewide GOP dominance. For the first time in 20 years, Indiana's gubernatorial candidate won Hamilton County cities. Jennifer McCormick made Hamilton County one of the top priorities in her campaign, even generously sharing her HQ office space with the other local Democratic candidates.

The Hamilton County Democratic Party launched its largest countywide Get Out The Vote campaign ever in 2024. This campaign was

activated by over 235 volunteers across the county. Over 44,000 Hamilton County Democratic voters were reached during the fall campaign. For the second year in a row, Hamilton County Democrats canvassed the most doors in the state. That distinction proves engagement of local Democrats who directly impacted voter turnout. In 2024, overall voter turnout in Hamilton County was 71 percent – one of the highest voter turnouts for the 2024 general election in the entire state. Additionally, Democratic straight-ticket voters in Hamilton County reached an all-time high, while Republican straight-ticket voters in Hamilton County declined.

The first several weeks

of 2025 has brought early fundraising successes, and new Hamilton County Democratic Party members join daily. The Hamilton County Democratic Party will elect new county party officers in March. This new leadership team will ensure that the momentum continues and will guide the party into the next election cycle with new ideas, strong outreach and energetic teamwork. The outgoing county party officers have served the growing Democratic community well. Dayna Colbert led the way in Hamilton County for three years as county party chair and currently serves Democrats statewide as the Executive Director of the Indiana Democratic Party.

Hamilton County, In-

diana, has grown into a bipartisan county with political balance. It is a pleasant and healthy place to live where different political viewpoints can coexist in a neighborly way. Ultimately, balance helps remind us how special our county is and how much we share.

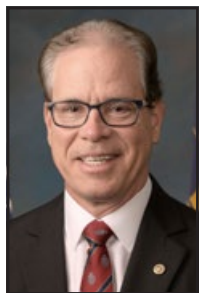
Gov. Braun says state departments collaborating on avian flu monitoring

Governor Mike Braun
issued the following statement regarding avian flu monitoring in Indiana.

"Hoosiers can rest assured that state government is monitoring the Avian Flu situation. At my direction, there is regular collaboration between the Indiana

Board of Animal Health (BOAH), Indiana Department of Agriculture, Indiana Department of Natural Resources (DNR), and Indiana Department of Health (IDOH) and I receive regular interagency briefings.

"The Indiana Department of Agriculture, working with the Board of Animal Health, is engaging with poultry producers, whether large scale or hobby farms, to ensure close communication and cooperation. DNR is monitoring the situation as it impacts recreation, hunting, and sports. IDOH is responsible for monitoring potential human

exposure to the Avian Flu.

"I am grateful for the cooperation and leadership of Lt. Gov. Micah Beckwith; Cabinet Secretary Suzie Jaworowski, Office of Energy and Natural Resources; and Cabinet Secretary Gloria Sachdev, Office of Health and Family Services, as they coordinate these efforts."

While the health risk to the public is classified as low, Hoosiers and poultry owners who notice sick or dead birds should not touch the bird and instead contact their veterinarian or the Healthy Birds Hotline at (866) 536-7593.

House supports Jeter's legislation to add courts & magistrates in Hamilton County

The Indiana House of Representatives on Tuesday unanimously advanced State Rep. Chris Jeter's (R-Fishers) legislation to establish two new superior courts and appoint two additional magistrates in Hamilton County.

According to Jeter, Hamilton County currently has 11 judges but needs 15. [House Bill 1144](#) would allow for two new Hamilton Superior Court judges to be elected in November 2026. It would also allow Hamilton County judges to appoint two additional magistrates.

"Due to the steady and continued growth in Hamilton County over the last decade, there's a need for more judicial officers," said Jeter, who chairs the House Judiciary Committee. "This is a proactive step to ensure our court system has the resources needed to continue serving Hoosiers with timely access to their constitu-

tional rights."

According to the Indiana Judicial Branch's 2023 [Weighted Caseload Study](#), Hamilton County ranked first in need of judicial officers.

Jeter said unlike judges who are elected, magistrates are hired to preside over minor civil and criminal cases and conduct preliminary hearings. They also assist with judicial caseloads by administering oaths, compelling the attendance of witnesses, setting bail, conducting hearings and trials, and imposing criminal sentences.

HB 1144 now moves to the Senate for further consideration. For more information, or to watch session and committees live, visit iga.in.gov.

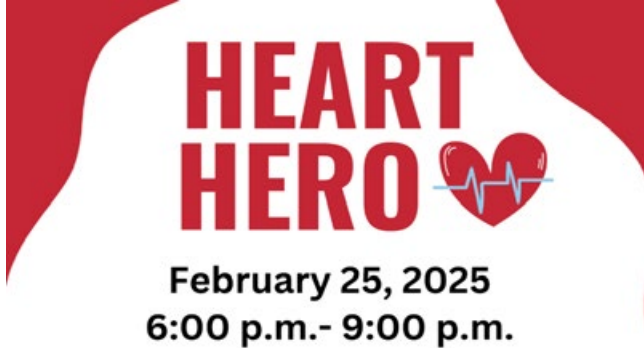

Fraudster sentenced to 10 years, ordered to pay nearly \$2M

Indiana Attorney General Todd Rokita worked with the Federal Bureau of Investigation to take down a southside Indianapolis-based serial fraudster, James Henley, and secured an order for him to pay back nearly \$2 million in restitution.

Henley has been sentenced to 10 years in federal prison, followed by three years of supervised release after pleading guilty to aggravated identity theft, conspiracy to commit access device fraud, two counts of money laundering, and eight counts of wire fraud. He has also been ordered to pay \$1,887,426.63 in restitution.

Henley reportedly told federal agents, who worked alongside Indiana’s Homeowner Protection Unit, he was inspired in part to commit mass fraud after watching a crime TV show.

“Our attorneys and federal investigators made sure this man was prosecuted for these flagrant and insidious criminal acts against regular Hoosiers,” AG Rokita said. “I’m certainly proud of everyone who works in our own Homeowner Protection Unit for their role in helping bring this blatant perpetrator of fraud and theft to justice. We will con-

tinue holding accountable all those who aim to enrich themselves by illegally deceiving and exploiting innocent victims.”

As part of his fraud schemes, Henley registered five fake businesses (On-Track Real Estate Solutions, LDI Investments Corp, Lucario Investments, 317 Traffic, and Henley Real Estate Solutions) with the states of Indiana and Kentucky, claiming to serve as the Chief Executive Officer for majority of them – yet none of the businesses were legitimate. He used the businesses to mask his identity, make his schemes appear more credible, and launder the stolen money resulting in a total loss of \$2,927,758.95 to individual homeowners, an Indiana attorney, a bank, and 10 state governments.

Henley’s schemes are broken down as follows:

COVID-19 fraud

Between May 2020 and March 2021, James Henley, his wife Jameka Henley, and his associate Jimmie Bickers used the stolen personally identifiable information of 76 real individuals to submit 120 unemployment insurance applications to 10 states during the COVID-19 pandemic. Once the applications were approved, the trio used 65 unemployment

insurance debit cards to make purchases at retailers and withdraw cash at ATMs in the Evansville and Indianapolis areas. The states paid a total of \$1,119,426.63 in unemployment benefits in connection with the group’s fraudulent applications. In July 2020, Henley used funds withdrawn from ATMs to buy a Chevrolet Camaro for \$22,801.

Bickers and Jameka Henley have been formally charged for their roles in this scheme but have not pleaded guilty.

Home title fraud

Between December 2021 and May 2023, Henley stole five homes in Indianapolis by filing fraudulent deeds with the Marion County Recorder’s Office. Through the filings, Henley claimed that the homeowners had sold their homes to his fake businesses, but, in reality, he had never even spoken with the homeowners. Unbeknownst to the victims, Henley filed these fraudulent deeds and then sold the homes for significantly less than their market value, pocketing more than \$260,000 in profits.

Henley also attempted to steal and sell an addition-

al 14 homes in Indianapolis and Evansville. With one exception, the individuals who bought the homes from Henley took possession and ultimately kept the homes.

For one homeowner, the property Henley stole was her childhood home. She purchased the home while her mother was in the hospital with the hope that, when her mother’s condition improved, her mother would be able to live out her remaining years in the house.

Mortgage fraud

In November 2021, an associate of Henley’s purchased a home in Indianapolis using a mortgage loan from a bank. In April 2022, Henley filed a fraudulent document with the Marion County Recorder’s Office to make it seem as if the mortgage loan had been paid off, when it had not been paid. Henley then filed a deed naming himself a joint owner of the home. Henley and his associate subsequently sold the property for \$255,000, pocketing all the proceeds, even though the bank should have received the majority of the funds.

Auto loan fraud

In March 2023, Hen-

ley purchased a Dodge Durango in Indianapolis for \$71,479, using an auto loan from Everwise Credit Union. A few months later, in June 2023, Henley purchased a Chevrolet Silverado in Plainfield for \$54,270, using a second loan from Everwise Credit Union.

In October 2023, Henley connected a JPMorgan Chase bank account to his auto loans, via Everwise’s online payment portal. Henley falsely represented that the Chase account belonged to Jimmie Bickers, and that he had authority to make payments on his loans using funds from the Chase account.

The Chase account was actually an Indiana attorney’s Interest on Lawyers’ Trust Account (IOLTA), which is a highly regulated bank account used by lawyers to hold client funds. The interest earned on IOLTA accounts is used to fund grants for nonprofit groups that promote pro bono and access to justice programs. Henley did not have the attorney’s permission to access or withdraw funds from the IOLTA account.

Between October and November 2023, Henley used the IOLTA account to make two payments, totaling \$98,000, toward his auto loans.

Henley has prior felony convictions for financial crimes, including theft, forgery, and fraud.

“I would also like to thank HPU Investigator Lynn Wilkins for her respective role in assisting the FBI in uncovering the deed fraud,” AG Rokita said. “We are lucky to have public servants like her working every day to ensure that our office does everything that we can to protect Hoosiers.”

The Homeowner Protection Unit remains dedicated to protecting the rights of tenants and ensuring equal access to safe housing. This victory underscores the commitment of the Office of the Indiana Attorney General to uphold the law and protect Hoosiers from deceptive practices.

The mission of the Homeowner Protection Unit is to protect the rights of all individuals involved in the housing market, including tenants, homeowners, and aspiring homeowners, by investigating and redressing deceptive acts in connection with mortgage lending and violations of relevant state and federal laws.

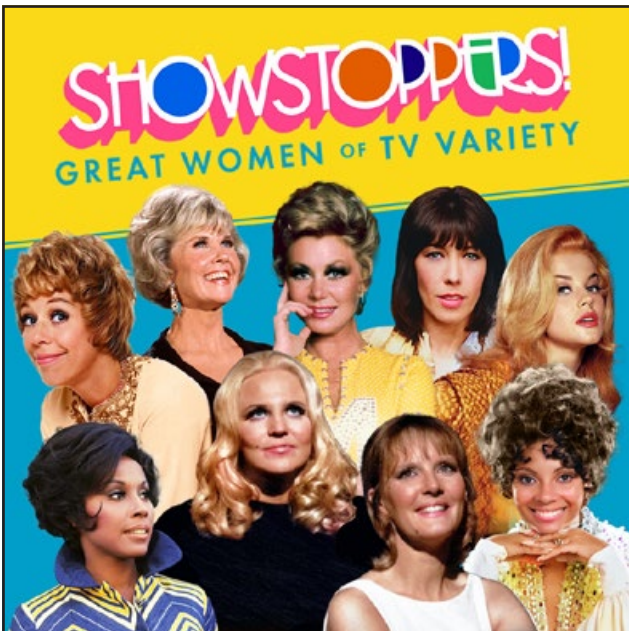

Regional championship preview: Class 4A, Marion Southeastern set to play Homestead

No. 3 Homestead (24-2) vs. No. 1 Hamilton Southeastern (25-0)

Class 4A No. 1 Hamilton Southeastern takes its unbeaten record into a regional championship matchup at 7 p.m. Saturday with a very good third-ranked Homestead (24-2) team in Regional 4 at Marion's Bill Green Arena.

The Regional 3 matchup at 4 p.m. features McCutcheon (23-3) vs. Fort Wayne Snider (13-11). The IHSAA will draw for semi-state the matchups and locations on Sunday.

Head coach Brian Satterfield is in his fourth season with a record of 81-15. The prior 20 seasons before that, Satterfield coached the boys at Southeastern to the tune of 322-151. The Royals won three sectionals in that span.

Satterfield coached back-to-back Mr. Basketball recipients Gary Harris (2012) and Zak Irvin (2013).

HSE won its fifth sectional title at Noblesville last week with victories in the title game over Westfield (46-38), semifinal over Zionsville (59-40) and first round against Fishers (46-30).

It took a little longer for the Royals to counteract what Westfield brought, but once they turned it around,

there was no stopping them.

"I think it took a little bit longer than we wanted to, but we were able to do it. But you got to give Westfield credit," Satterfield said. He also said the Shamrocks were "still building off what they did the night before" when they beat Noblesville in the sectional semifinals.

The Royals overcame and made a 19-point turnaround to come back to defeat Westfield in the Sectional 8 championship, but it wasn't easy.

"As you go through the tournament, you're going to have teams that make runs at you," said Satterfield.

The coach said the biggest thing for his team is to "figure out ways to get the tide turned."

The tide turned on the Shamrocks and HSE mounted a comeback of all comebacks. Junior guard Antonette Green nailed a big three late in the third, starting a run that Westfield couldn't stop.

"Ant hit that big 3. That gave us some energy. I thought our crowd was huge. We were more efficient offensively, once we settled down," said Satterfield.

Along with a perfect 7-0 league mark in the Hoosier Crossroads Conference, the Royals found ways to win in convincing fashion over many quality opponents throughout the season.

Opening the season with a win over Lawrence North, Chicago's Fremd, Pendleton Heights, Plainfield, Center Grove and Pike. In mid-season, the Royals won the Hall of Fame Classic in New Castle over 2A's top-ranked South Knox (67-59) and the championship over then-No. 1 Lawrence Central on a buzzer-beater (52-50).

The Royals are led by Indiana commit, all-star, all-state and Miss Basketball candidate Maya Makalusky. She scores 22.3 points and brings down 7.0 rebounds per game and shoots 50 percent overall and 41 percent from three-point range, while also knocking down 80 percent at the foul line. Junior all-state candidate Kennedy Holman is at 11.6 points, 5.1 boards and 5.8 assists per game. Fellow junior Kayla Stidham is the third Royal in double-figures at 10.1 per contest and grabs 4.5 rebounds and dishes out 2.3 assists.

Homestead grabbed its 19th sectional crown last weekend and are in search of their sixth regional title in program history. They've won two semi-states with the latest in 2017 resulting in a state championship over Pike. The Spartans also were state runner-up to Columbus North in 2015.

Regional championship preview: Class 2A, Lapel Sheridan will face off against Lewis Cass

Lewis Cass (19-6) vs. No. 11 Sheridan (24-1)

Sheridan is back in the regional for the second straight season and is out to make a statement. The Blackhawks are on a 22-game winning streak, with just a three-point loss at home to Brebeuf Jesuit in the third game of the season.

The nightcap at 7 p.m. at the Class 2A Lapel features the Lewis Cass Kings and Sheridan playing for the Regional 20 championship. The two teams have only met once previously. Lewis Cass won the only meeting between the two and that was in the 2002 sectional. The 4 p.m. Regional 27 title tilt pits Monroe Central (20-6) vs. Lafayette Central Catholic (22-4) in Class 1A.

The IHSAA will draw for semi-state the matchups and locations on Sunday.

Head coach Jaidlin

Bradshaw is in her seventh year with a 101-52 record at Sheridan. The Blackhawks are having their best season historically. Last weekend won just the third sectional title and Saturday they aim for their second regional crown in a row. Sheridan fell in the semi-state semifinals to Eastern Hancock in overtime, 62-54 in 2024.

The Blackhawks have big wins in this 22-game streak over Eastern Hancock, University, Lapel twice and Clinton Central. Sheridan also went a perfect 8-0 in the Hoosier Heartland Conference.

At this point in the tournament, it's all about keeping your focus on that one game at a time mentality.

"There's a good chance they might throw something different. Teams, us included, are pulling out everything. We're trying to keep our kids mentally focused and prepared for whatever anyone might bring our way," said Bradshaw.

Sheridan took advantage of hosting sectional and cruised through their first round and semifinals with dominating wins over Frankton (58-26) and Tipton (62-12). They took the sectional championship over Lapel, 54-47.

The approach to Lewis Cass will be no different than any other opponent.

"We watched a couple games from them this year," Bradshaw said. This week "has been a ton of preparation on what they do, what their kids individually do" and how the Blackhawks can find a way to beat the Kings.

The Kings don't give up many points per game, just 31.6. So, it will for sure be a challenge for the Blackhawks.

"They are a very disciplined 2-3 zone defense team. That's pretty much the only thing we've seen from them," Bradshaw stated.

"Their rotations are great out of the 2-3 zone. A big point of emphasis has been how do we beat them, and then preparing just in

Epic lineup announced for 2025 Indy 500 Coors Light Snake Pit

Headliner Illenium joined by Sammy Virji, Two Friends, Kayzo, Oliver Heldens May 25 at IMS

Dance producer Illenium will headline an all-star lineup of global electronic music artists at the Indy 500 Coors Light Snake Pit on Sunday, May 25 at Indianapolis Motor Speedway.

Sammy Virji, Two Friends, Kayzo and Oliver Heldens also will perform at the Race Day concert during the 109th Indianapolis 500 presented by Gainbridge. Performances begin early in the morning on the stage located in the infield adjacent to Turn 3 of the IMS oval, with specific set times to be announced.

"The Indy 500 Coors Light Snake Pit continues to attract some of the world's top talent in dance music, and it is one of the best events of the year for fans who attend," IMS President J. Douglas Boles said. "More than 20,000 people find their Indianapolis 500 Race Day experience in the infield where the sound of the 33 racing INDYCAR SERIES cars provide the backdrop for friends, music and dancing from an unforgettable location – the Snake Pit."

General admission and VIP wristbands for the Snake Pit are on sale for \$55 and \$160, respectively, at [ims.com](https://www.ims.com). VIP amenities will include access to a raised viewing platform located beside the stage, a private cash bar and private air-conditioned restrooms.

All Snake Pit ticketholders must be at least 18 years old and hold a valid Indy 500 general admission or reserved seat ticket. Ticket holders should be prepared to show proper identification to enter the concert.

Packages that include Race Day general admission tickets and Snake Pit wristbands are available. A package featuring general admission to the Indianapolis 500 and Snake Pit is \$105, while a Race Day general admission and Snake Pit VIP package is \$210.

Snow Snake Pit concertgoers are encouraged to buy tickets now, as prices will increase as May approaches and limited quantities of admission wristbands are available.

Nick Miller's 10-year run as dance producer Illenium has been nothing
