
Huskies' art on display at Dark Side Coffee House

Lynette Duvall, a case-worker and legal secretary in the Prosecutor’s Office, was the most senior employee recognized this year, marking 45 years of service to Hamilton County. She began her career as a receptionist at just 20 years old.

When local funding shows up just in time

Early on a brisk Saturday in downtown Noblesville, two dumpsters caught fire in an alley behind one of the oldest buildings on the Square.

It's the kind of sentence that makes your stomach drop when you live nearby. That building has stood since 1880. It has outlasted different owners, recessions, and the constant churn of modern life. Bluntly, it exists today because people before us chose to preserve it – and because, in this moment, a downtown resident noticed something wasn't right.

They made the call, and within minutes the Noblesville Police and Fire Departments were there. The fire was contained. The building was spared. The sun came up and life went on.

It's tempting to chalk that up to good fortune, but it wasn't. It was consistent investment.

In Noblesville, we place a high value on public safety. In our **most recent budget**, more than half is dedicated to police, fire, and emergency services so that when something goes wrong on an otherwise quiet December morning, our firefighters are able to respond – quick-

ly and professionally.

That capacity exists because our community has consistently chosen to fund it. It's also why conversations about local government funding deserve more nuance than they often receive. Local government isn't a private business, nor should it be run like one. Guardrails matter. Indiana's constitutional tax caps are important, and I support them. They protect taxpayers and force discipline, as they should. Those limits are part of what makes Indiana fiscally sound.

The conversation that ultimately led to SEA-1 began in that same spirit: how do we ensure government lives within reasonable thresholds while respecting taxpayers? In practice, SEA-1 reshapes how local services are funded, especially in growing communities.

But there's a difference between discipline and bluntness. When reforms reduce local capacity without reflecting local realities, or remove tools that allow fast-growing cities like Noblesville to keep pace as population and service demand rise, the consequences don't stay theoretical for long.

Noblesville is growing. With growth comes more calls for service, more emergencies, more responsibility. Fire protection, police coverage, and EMS response don't scale neatly or slowly. They spike when you least expect them to. Removing mechanisms that recognize growth doesn't reduce those demands; it simply makes meeting them harder.

At the same time, our community has made clear choices about what we value. In 2022, we passed an ordinance to protect historic buildings on and around the Square because we believe preservation matters. We invest in our downtown because it's the heart of our city.

But as that morning showed, preservation without protection is incomplete.

Saving historic buildings isn't just about preventing demolition. It's about ensuring we have the people, training, and equipment to protect them when something goes wrong – whether that's a storm, an accident, or a fire in an otherwise quiet alley.

I'm not trying to unwind decisions made at the Statehouse. Here at home, we're already making difficult choices in response. Noblesville is one year into a multi-year budget tightening process that reduces our

budget by just under \$9 million each year. Starting next year, we will end the Federal Hill ice skating rink. We've delayed projects like roundabouts on the east and west sides of Noblesville – right where growth is headed. And we're stretching the time between road repaving cycles across our community.

Tradeoffs are required. But with a gap measured in the tens of millions over the coming years, the real question is whether communities like ours will still have the flexibility to fund the priorities that matter most to the people who live here.

As state leaders consider tweaks in the session ahead, I hope they recognize that moments like this reveal local funding isn't abstract. It isn't a line item on a spreadsheet or a talking point in a campaign mailer. Sometimes, it's the difference between a close call and a catastrophe. Between a building that stands for another century and one that doesn't make it through the night.

That morning, things worked the way they were supposed to. A neighbor noticed. First responders arrived. History was preserved.

That's not something we should take for granted. It's something we should protect – thoughtfully, responsibly, and with the understanding that strong communities depend on the ability to fund local priorities.

HH at Chang's

Another Wednesday, another Happy Hour.

This time we checked out a restaurant we have been to many times – it's one of our favorites, P.F. Chang's. Located in the Fashion Mall at 8601 Keystone Crossing, we have enjoyed dinner at this place on special occasions, with casual groups, and with family and friends – but we never knew that they had a Happy Hour. It runs Monday through Friday from 3 to 6 p.m.

They do keep it a secret. I couldn't find a HH menu anywhere on their website. When we walked in at 4 p.m., I told the hostess we were there for the Happy Hour and she said, "Would you like to sit at the bar or at a table?" We chose a table, and given the normal raft of menus (dinner, drinks, specials), but none were for HH. Our server Hadiya had to go back to the hostess stand and get us the proper menus. She was very informative, and was a nice presence throughout our meal.

We both ordered wine – our choices were Chardonnay or Merlot (\$6.99 for a six-ounce pour). Mrs. K. took her usual Chardonnay, and I tried the Merlot. Her drink was okay – good "on the rocks," which is how she likes her wine, and the Merlot was pleasant – mellow and tasty.

Other drink choices were available – Beers for \$5.99 and Special Cocktails – Cosmopolitans or Margaritas for \$8.99.

The menu had four choices of Appetizers: Chang's Lettuce Wraps (\$7.29), Ribs (BBQ or Northern Style – \$7.89), Crab Wontons (\$6.89), and Dumplings (Pork or Shrimp – \$6.89). Hadiya told us that

these are half-orders, so for everything but the Lettuce Wraps, we'd get servings of three.

We had often ordered the Lettuce Wraps on our frequent visits, so we opted to try all the others. We got BBQ Ribs, and Shrimp Dumplings. They were on our table very quickly, probably because the kitchen was not very busy.

Did I mention that the restaurant was nearly empty when we got there? Only two other booths were occupied, and the entire dining room was unusually quiet. We figured it was because we were there kind of early, and indeed a few more Wednesday night diners came in before we finished.

The food was great, especially with the sauces each was plated with. The Dumplings were presented on a very hot plate and Hadiya poured a "light chili sauce" over them which made for a sizzling steamy serving. The ribs were tender, meaty, and quite yummy. And the Crab Wontons were drizzled with a wonderfully tasty coating. We shared and enjoyed everything and decided to get another order of ribs, since they were our favorite.

All in all, it was a nice surprise. Everything on the limited HH menu was top-notch. Now, we know some new appetizers to order next time we come in for dinner. The service was great – thanks Hadiya. The tab came to right around \$50, plus tip. We'll be back.

ISP trooper injured after being struck by drunk driver on I-465 eastbound

An Indiana State Police (ISP) trooper is recovering from injuries suffered last Saturday morning when his car was struck by an alleged drunk driver.

At 4:07 a.m. Saturday, an ISP trooper and an off-duty Fortville Police Department officer were at the scene of a jackknifed semitruck on I-465 eastbound near Allisonville Road. The Fortville officer came across the jackknifed semi while off duty. The officer remained at the scene to assist the trooper with the crash investigation and traffic control.

While blocking the lane with his police vehicle, the trooper was rear-ended by a pickup truck. The ISP trooper suffered serious but non-life-threatening injuries in the crash and was



transported by ambulance to a local hospital. The Fortville officer's police vehicle was also struck during the crash, but the officer was not injured.

The driver of the pickup truck, identified as Juan Cuatlatl, 21, Indianapolis, showed signs of impairment and was arrested for operat-

ing a vehicle while intoxicated — causing injury.

The trooper has been released from the hospital and is recovering at home. This crash marks the third time in his four-year career that he has been struck and injured by an impaired driver.

Indiana extends health plan enrollment deadline amid high engagement

The Indiana Family and Social Services Administration on Thursday announced it's extended the open enrollment period for the Healthy Indiana Plan and PathWays programs through Dec. 24 to give eligible Hoosiers more time to choose a health plan.

The extension comes after FSSA announced in November that that MDwise will no longer serve as a managed health plan for Indiana Medicaid's Healthy Indiana Plan and Hoosier Healthwise programs. MDwise's participation in Indiana's Medicaid program will end on Jan. 1.

FSSA says it's seen what a news release issued Thursday described as high engagement from Hoosiers seeking assistance with their health insurance coverage.

The Healthy Indiana Plan is the state's Medicaid expansion program, offering health coverage for ages 19 to 64 with incomes up to 200 percent of the federal poverty level.

PathWays is a managed Medicaid program for Hoosiers 60 and older.

Hoosier Healthwise is Indiana's Medicaid program for children younger than 19 and pregnant women with low incomes. It provides health coverage for doctor visits, prescriptions, dental, vision, mental health, and hospital care, often with low or no costs.

Healthy Indiana Plan and PathWays participants who do not select a plan by the Dec. 24 deadline will be automatically enrolled in a plan that closely matches their current coverage.

Sheridan announces \$1M in infrastructure improvements

The town of Sheridan announced on Monday, Dec. 15 infrastructure investments of more than \$1 million in the town's roads, bridges, and resurfacing priorities.

The Indiana Department of Transportation (INDOT) awarded Sheridan \$836,076 through its Community Crossings Matching Grant Fund Program, and the town is contributing more than \$200,000.

"The incredible progress we've made since

the 2024 reorganization, including the completion of the Monon Trail, continues to the benefit of our residents, visitors, and businesses," said Silas DeVaney, president of the Sheridan Town Council. "We are making the critical investments to improve our quality of life, attract jobs, and spur economic development."

Additionally, Sheridan will conduct chip-and-seal road maintenance in the rural district. This marks the start of the annual rural district routine road resurfac-

ing program, during which the Town will resurface 10 miles of road.

The Community Crossings Matching Grant Program provides funding to cities, towns, and counties across Indiana to make improvements to local roads and bridges. Community Crossings is a partnership between INDOT and Hoosier communities, both urban and rural, to invest in infrastructure projects that catalyze economic development, create jobs, and strengthen local transportation networks.

State approves \$3M loan for Arcadia housing development

The Indiana Finance Authority (IFA) board recently approved more than \$29 million in residential infrastructure funding to be distributed through the Residential Infrastructure Fund (RIF) program.

Locally, the Landon Crossing project in Arcadia will receive \$3 million in low-interest loans to finance infrastructure projects that support residential housing development. Communities were selected based on the need for additional housing inventory to accommodate local job growth.

The IFA prioritizes loan applications from communities with housing-friendly zoning and provides a set-aside of 70 percent of the funding for those projects in communities with a population of less than 50,000.

"Increasing Indiana's housing supply is essential to supporting our growing workforce and strengthening local economies," Governor Mike Braun said. "These investments will help communities keep pace with job growth, attract new talent, and ensure more Hoosier families have access to safe, affordable

places to live. When we expand housing opportunities, we're laying the foundation for long-term economic success in every corner of our state."

In 2023, the Indiana General Assembly established the RIF revolving fund program with an initial appropriation of \$75 million to be awarded to local residential-development projects in Indiana. The state legislature appropriated an additional \$50 million in the biennial budget for the 2026-2027 fiscal year.

State Rep. Garcia Wilburn honors Sandy Hook victims & calls for common-sense gun safety measures

State Rep. Victoria Garcia Wilburn (D-Fishers) hosted a Sandy Hook Remembrance Day event on Monday, Dec. 15 at the Statehouse to honor the victims of school shootings and advocate for stronger gun safety laws to protect Hoosier children.

The event, held in advance of the 13th anniversary of the Sandy Hook Elementary School shooting this weekend, brought together lawmakers, advocates, faith leaders and community members to remember the hundreds of students who have senselessly lost their lives to gun violence in schools across America.

"Thirteen years ago, 20

children and six educators were murdered at Sandy Hook Elementary School, Garcia Wilburn said. "Since then, countless more young lives have been stolen by gun violence in school shootings, on the streets and in homes. Indiana has made it easier, not harder, for guns to fall into the wrong hands."

"The state legislature eliminated permit requirements for carrying handguns allowing more guns to land in the hands of the wrong people, like those who have taken the lives of precious school children."

"Today was about remembering lives lost and

recommitting ourselves to creating a future with fewer of these preventable tragedies. We should not have to accept school shootings as the new normal or hold our breath for the next tragedy. The defeat of the mid-decade redistricting bill this week showed Hoosiers that bipartisan, common-sense wins are possible if we use our collective voices.

"We can protect Second Amendment rights while being serious about gun safety. It's time for Indiana to pass common-sense gun laws – because remembering victims means taking action to prevent the next tragedy."

The event featured remarks from advocates and lawmakers, music, multi-faith prayer, opportunities to connect with gun violence prevention organizations and a children's shoe drive benefiting Grace Care Center in memory of children lost to gun violence.

According to Everytown for Gun Safety, more than 4.6 million children live in homes with at least one loaded, unlocked firearm and nearly 360 children unintentionally shoot themselves or someone else every year. Research shows that safe storage laws – which require firearms to be stored securely and inaccessibly to children – significantly reduce unintentional shootings, youth suicides, and school shootings.

After achieving this scale, Tom ensured long-term stability by thoughtfully designing an employee-owned ownership structure, preserving independence and opportunity for generations to come.

Tom believed that leadership carried a responsibility to serve others, particularly individuals experiencing homelessness. His longstanding support of Gennesaret Free Health Clinics reflected this belief. Through Carpenter Realtors' charitable initiatives, millions of dollars have been contributed over the past three decades, reminding Carpenter's agents that they work for a higher purpose. These accomplishments were made possible through the dedication and loyalty of countless agents, managers, staff, and vendors whom Tom respected deeply throughout his 46 years of leadership.

Perhaps the traits that drew people most to Tom were his authenticity and unique sarcasm. Success never changed him. He remained approachable, grounded, and deeply loyal to those around him.

Above all, Tom loved his family. He purchased Bare Bottom Lake in Nashville, Ind., so extended family and friends could gather. Fishing, swimming, rope swings, bonfires and legendary Thanksgiving feasts created lasting memories.

He was preceded in death by his parents and his brothers, Dan and Bill (also a Vietnam Veteran). Hounds bite back, end losing streak to Millers

Greyhounds' last win against Millers was two-game season sweep in 2022

CARMEL – The Carmel Greyhounds are looking to change the narrative this season.

On Friday, Dec. 12 inside the Eric Clark Athletic Center, the Class 4A seventh-ranked Hounds (3-0) made their first statement and scored a little revenge in the process.

Locked in three ties early against Noblesville, Carmel took control behind a 19-5 run in the second quarter to defeat the 4A Millers, 64-52.

The Greyhounds finished with a 10-13 record last year and lost to the Millers (1-4) during the 2024-25 Sectional 8 tournament, 51-32, but with a healthy 6-foot-8 senior Evan Harrell this time around, Carmel halted its four-game losing streak against one of its primary rivals.

"I've never beaten Noblesville. This is the first time in my basketball career, so this is big time," Harrell said. "They've beaten us those last three years, so we kind of had a chip on our shoulder to come in and beat them."

Carmel had four players reach double figures on Friday, shot 59 percent from

the field and logged 17 assists as a team with Harrell setting the pace.

The Bellarmine University commit had a team-high 15 points, including a trio of dunks, and added a team-best six assists, 11 rebounds and eight deflections.

"He's turning into a leader and a leader by example. He's doing a lot of good things that makes his team better," Carmel coach Ryan Osborn said. "He's been great, and we're go-

ing to need him to be great."

Harrell was limited last year due to an ankle injury. Against Noblesville, he had eight points in the first half, highlighted by an alley-oop dunk assisted by senior Julian Vogt off a Millers' turnover in the final seconds to end the second quarter ahead, 32-20.

"I was very impressed with the way we shared the ball. We had 17 assists on 25 field goals. It's a credit to them. We challenged them this week," Osborn said.

"That's what we're trying to do, dive in and lift people up and play team basketball. That shows when you're able to share the ball like we did tonight."

A bucket by Vogt, who had seven points and three assists, tied the game 15-15 to open the second quarter.

One of senior Ben Bremer's two 3-pointers broke the final deadlock, as Carmel capitalized on Noblesville's five second-quarter turnovers and eight overall.

The Greyhounds' last win against the Millers was on March 4, 2022, when they completed the two-game season sweep with a 64-41 victory at sectional. For a program held without a sectional title since 2021, the early season win echoes the Greyhounds' hopeful theme. "The football team reemerged, and I think we're on the reemergence as well," Harrell said.

"We've had a quarter every game that's not been well. Usually, it seems like the third, but tonight was the second," Noblesville coach Scott McClelland

said. "I mean, it started from the get-go. They were tougher. They were more physical."
